# Message From The Chair

The year of 1967 marked the beginning of political action for the Mexican American people as a united group in the County of San Diego. For the first time Mexican American organizations, through the leadership of MAPA, were called upon to participate in a conference with the City Mayor, as well as Federal Government representatives to discuss and petition vital issues affecting the Mexican American.

On October 13, 14, and 15, 1967, MAPA State Executive Board held its Fourth State Executive Board Conference here in San Diego. Delegates from all over the state participated. Resolutions were passed at the conference to better the living conditions of the Mexican American as well as education, security and civil rights through legislation, petitions and demands via our government representatives.

It was also resolved to effect unity with other minorities, emphasizing unity with the Negro to form a coalition on the political front. Guest speakers included the Mayor of San Diego, a representative from the Governor's office, members from the State Legislature and U.S. Senator J. M. Montoya from the State of New Mexico. Other speakers were from labor organizations—local, state and national. Speakers ranged from the most conservative to the most progressive. This conference was indeed the highlight of MAPA in San Diego during the year 1967.

MAPA's State Executive Board Conference Brochure was also an outstanding contribution, and brought praise from our State Board. We wish to thank all the advertisers for their co-operation and contribution to the success of the Brochure as well as the Brochure committee who worked so hard on it.

In spite of organizational problems, including the inexperience of new chapter officers and the lack of knowledge among the vast majority of Mexican Americans concerning the role and aims of MAPA, we have been able to organize five chapters in the County of San Diego with the possibility of organizing chapter in El Cajon, Linda Vista and Solana Beach.

The main tasks ahead of us are voter regis-

# Judge Upsets Ban On Aliens In Public Jobs

A 52-year-old state labor code section banning city, county or state hiring of aliens was ruled unconstitutional Tuesday by a Santa Barbara judge.

The decision favored 17 city employes, all resident aliens, who were fired last September 22 when the statute was invoked following the complaint of a painting contractor about city hiring of non-union help.

In handing down his ruling Tuesday, Superior Judge John S. Westwick called the code's section 1941 unconstitutional "in that it denies to lawfully resident aliens the equal protection of the law guaranteed by the 14th Amendment to the Constitution."

The 17 employes, some of whom had worked for the city five years, are still on the payroll because of a temporary restraining order obtained after they got their two-week notices last September.

Four of the fired workers are women, six are natives of Canada. They include library and park employes, a mechanic and a painter.

In his ruling Tuesday, Judge Westwick cited a 1948 U.S. Supreme Court decision involving the constitutionality of a California statute denying the right to a commercial fishing license to persons ineligible for citizenship.

The Supreme Court held that aliens lawfully admitted to this country could not be prevented from earning a living in the same manner that other inhabitants earn their living.

The high court ruling noted that immigration and naturalization are federal matters regulated by Congress and that states are not given these powers or the right to add or detract from the conditions imposed by Congress in matters of admission to the country.

Until recent years aliens not eligible for citizenship (mostly Orientals) were not permitted by law to own land in California.

Last fall a painting contractor protested the hiring of non-union painters by the city of Santa Barbara. The complaint led to the old statute being invoked to fire the 17 non-citizen employes.

They represent seven countries: Canada, Mexico, England, Scotland, West Germany, France and Indonesia.

Asst. City Atty. Don Vickers said he saw the possibility of the case going to a higher court. The city has 10 days to answer.

# Mexican-American Casualties In Vietnam

American servicemen of Mexican descent have a higher death rate in Vietnam than other GI's. Analysis of all combat and non-combat deaths between January 1, 1961 and February 28, 1967, indicates that a large number of young people from this minority group reach the Southeast Asia theatre of war and that a considerable number of them are involved in hazardous duty.

Servicemen from the five southwest states of Texas, New Mexico, Arizona, Colorado and California suffered 1,631 deaths in the aforementioned six-year period. Of these, 19.4 percent had Spanish surnames. This figure appears high when compared with the share of the Spanish-surname population in the total for the region (11.8 percent in 1960). It is still high when the comparison is based on males of military age, i.e., individuals between age 17 and 36 years in 1967 (estimated at 13.8 percent).

While these figures are estimates, they are sufficient to indicate orders of magnitude. If one were to project birthrate, immigration and other factors, the statistical relationship would not be substantially different. Spanish-surname individuals would probably be slightly more numerous.

War deaths by branch of service suggest that relatively large numbers of Mexican Americans are involved in high-risk duty. For example, Spanish-surname individuals represented 23.3 percent of all Southwest Marine Corps deaths, 19.4 percent of the Army, 9.1 of the Air Force and 7.3 percent of the Navy. Marine Corps deaths, which are high in all the five southwestern states, include a substantial number of casualties of presumed Mexican background. In New Mexico, for example, 13 of the state's 25 Marine Corps casualties had Spanish surnames. In Colorado, 37 Marines died for both combat and non-combat causes. Nine of these had Spanish last names.

The Department of Defense classifies casualties as combat and non-combat. (Only deaths are included in our analysis.) There were 1,335 combat deaths of Southwest servicemen in Vietnam in the period under discussion, and 296 non-combat. Over 20 percent of all servicemen dying in combat and 14 percent of the non-combat casualties had Spanish surnames. Combat deaths result from illness, accidents (as in the case of the U.S.S. Forrestal), and similar causes.

# Support

As we begin our second full year of activity, we have found ourselves confronted with the realities of our mission. We have planned a number of activities and projects for San Diego County MAPA for 1968. Past experience tells us that our involvement in the various community and MAPA activities costs money. Therefore, we have attempted to forecast and pre-plan our activities and their cost for 1968. It is estimated that at least \$7,500 is needed to carry out the work for 1968. In order to make this a reality a membership and fund drive is scheduled to be launched together with our first meeting of the new year. Our goal is \$10,000 . . . here's how we intend to do it:

We have three means of raising money. First, membership dues; Second, money raising activities such as dances, raffles, etc.; Third, contributions from members and persons sympathetic to our cause. A committee is already coordinating this work and I can assure you that your co-operation will be appreciated. Already, several members and friends of MAPA have either given direct cash contributions or have pledged a specified amount over whatever period might be convenient. We hope to have pledge cards in your hands in the near future. Help in whatever capacity you can. Your efforts will be appreciated and it all contributes to our goal of \$10,000. If you know of someone who would like to co-operate with us, please let us know and we'll promptly get in contact. Aside from the usual administrative expenses we have, remember that it costs to register voters and also for our new citizens project. To our knowledge, no other Mexican-American group has undertaken such an ambitious project. Now that we have undertaken this endeavor, give us your help so that we can be successful. Keep in mind that this is for the benefit of all MAPA Chapters in San Diego County.

# CORONA RESIGNS

January 9, 1968

Dr. John A. Hanna, Chairman The U.S. Commission on Civil Rights Washington, D.C. 20425


Dear Mr. Hanna:

It is with regret that I am submitting my resignation as a member of the California State Advisory Committee to the Commission. The events that force me to resign are those primarily due to the Commission's unwillingness and inability to become truly involved and concerned about the Civil Rights of the Mexican-American and other Spanish-speaking people in America.

For two years the Mexican-American Political Association and I have been attempting to cause the Commission and its staff to deal with the serious violations of Civil Rights that have been the lot and history of our people since 1835 in Texas, and since 1847 in the rest of the Southwestern States. Specifically, we have been urging for hearings and actions on behalf of the conditions of life of our people in the farm areas of California such as in Delano, the San Joaquin, the Sacramento, the Coachella, the Salinas and the Imperial Valleys in California and the Lower Rio Grande Valley in Texas. To date the Commission and its respective State Advisory Committees which are really moved by the staff, have done nothing significant about the serious violations of the Civil Rights of Farmworkers at the hands of Deputy Sheriffs, Texas Rangers and other law-enforcement agencies and bureaus of the government.

To date you have failed to even show an interest in the whole matter of the encorceration, harassment and continued violations of the Civil Rights of Reies Lopez Tijerina and the members of the Alianza Federal De Pueblos Libres in Northern New Mexico, although MAPA through myself has repeatedly requested and demanded that attention be paid by the U.S. Commission on Civil Rights to the repeated serious violations of the Civil and constitutional rights of these Mexican-Americans by Ithe Civil and State authorities of the State of New Mexico and the U.S. Forrest Service.

You have refused or have been unwilling to deal with the whole matter of "Police Brutality" against our pepole and particularly our youth in

such areas of California where it has led to continual killings and beatings such as: Blythe, Calexico, Riverside, Corona, Stanton, Compton, Los Angeles, San Jose, Hayward and other cities of California during the past year.

I have continually kept pointing out to the staff of the Commission the gross violations in the arraignment, pre-trial, trial and sentencing procedures of Mexican-Americans and other Spanishspeaking Americans who cannot speak or understand English in the Courts of California: Hundreds of these persons now find themselves serving unduly harsh and unnecessarily long sentences be-— MAPA— . . . # The Will To Constructive Power

The following is directed primarily to those typically pessimistic individuals amongst us who despairingly declare that our problems as an ethnic minority are insurmountable because we have inherited generations of poverty, illiteracy, disunity

and a general lack of leadership.

An analysis and study of significant historical periods, reveals a basic pattern underlying the movement of various peoples from a survival level of existence to a stature of dominance. Just what were the dynamics that enabled men like Otto Von Vismarck to raise the Germans from conditions of political disunity, general illiteracy, and rural living (in the second half of the 19th century, to the awesome power they became in this century? What was it that impelled the men who inspired the humble, stooped peons of Mexico, in 1910 to stand up straight and shake their fists in unprecedented defiance to demand their rights as human beings rather than beasts of burden?

Education, work and language skills and civic involvement are all necessary elements in achieving full participation in our democracy. However, efforts in these areas will be shallow and lacking in lasting impact unless we can saturate these same strivings with a spirit, or a mystique that is analogous to the spirit that drove Bismarck, Zapata and Churchill. What can we call this spirit that seems to be an amalgamation of confidence in the future and a striving for positive, dynamic strength? It is the spirit that tells us to stop being "underachievers" and followers; and that demands that we strive to do our best in order to obtain the highest rewards for our labors. I believe an appropriate name for this spirit, which is possible for us to achieve, should be "the will to constructive power!"

hind prison bars in such penitentiaries as San Quentin, Folsom, Soledad and others in our State. Yet, so far, no interest nor movement by the Commission has been evidenced. Finally, the whole discriminatory pattern of employment against the Mexican-American and other Spanish-speaking people by the U.S. Commission on Civil Rights itself trample upon the sincerity and true purposes of the Commission itself not to mention the Civil and employment rights of our people. As of this date although the U.S. Commission on Civil Rights has close to 200 employees there are but 6 of Mexican-American or Spanish-speaking origins.

We have a folk saying in Spanish that reads: "Taparle el ojo al macho," which means to keep the beast blinded and fooled. I can say that I am fully satisfied that this is the role of the Commission on Civil Rights in terms of the Spanish-speaking people in the face of the many violations of their civil and constitutional rights that they suffer almost daily from New York to California and from Michigan and Washington state to the Mexican

Borders.

The Mexican-American Political Association will continually expose this nefarious role that the Commission seeks to play in this area of such vital concern to our people. We will continually point out that the U.S. Commission on Civil Rights is there merely to take away the focus upon our own strength and unity an dto continually divert our emphasis and efforts away from our own mobilization by the continual offering of false promises and distant hopes. We will not permit our people to be fooled by such "study" and "tokenism" tactics as the Commission offers in place of real redress of grievances and fullest enforcement of the Bill of Rights and Constitution of our country for the Mexican-American and other Spanishspeaking peoples, as is the Idue and birthright of all Americans. The Mexican-American Advisory Council (MAAC) announces that its federally funded progrom for on-the-job training (OJT) is establishing an early record in placing disadvantaged persons.

The MAAC Division office indicates that employer response in the city and county areas has improved. Employer participation has been by the increase, resulting in a greater number of contracts

and a greater number of job openings.

The MAAC Division program subsidizes the employer for training given to persons eligible for this program. The length of the contract and the employer-reimbursable amount are established by the entry-level occupation at which the trainee will be hired under contract.

A new concept has been incorporated in this pilot program. This is the available services of a professionally trained social worker, who is assisted

by two graduate school social workers.

Robert Peer, MSW, has stated that, whenever necessary, community resources are activated in order to help the trainee resolve his problems.

At present the MAAC program has 45 institutional trainees, who receive cash grants weekly, under MAAC's coupled program. Initially, these trainees were monolingual but have been able to learn sufficient English so that they have become functional in the language. A tour of a local aircraft plant was recently made by these trainees. Such was the response evoked from the aircraft plant officials that it is expected that the more advanced trainees will soon be under an on-the-job contract.

In order that a person may know whether or not he or she may qualify for this OJT program, contact should be made at the office below. # POLICE PROTECTION!

Since January 24, 1968, a series of related incidents has taken place in National City which the National City Police Department has seemed to ignore. These incidents have contributed to the complete family harassment, by neighboring individuals, of the Greg Amador family which lives in the northwest part of National City. In requesting police action, the Amadors have been given the "run-around" by the police department.

On this particular Wednesday evening, January 24th, Mr. Amador arrived home after visiting his mother. As he approached his house, certain neighbors across the street, and others, began yelling and intimidating him. He entered his home and the intimidators continued. Viewing them from within the Amador house, the roudy bunch could be seen yelling and drinking beer. With disgust and fear for his family, Mr. Amador returned to his car and proceeded back to his mother's house to call the police.

As the police arrived in the neighborhood, the harassers went into the house and doused their lights. The patrol car waited ten minutes. Nothing happened, so they drove off. The harassers' lights went back on and the yelling and laughing started up again.

During these past weeks, these "fun-seekers" have continued to harass Mr. and Mrs. Amador and their six children. When Mrs. Amador walks her school children to the bus stop, three or four of the uncouth-looking women harassers come out and shout obscenities. This has been observed by other uninvolved residents. And where are the police?

Friday, February 16, the children of one of the harassing mothers went to the Amador's home to help with their mother's little game. As Mrs. Amador opened the door, the little heckler yelled out, "my mother told me to call you a bitch!" Following this incident, both Mr. and Mrs. Amador called the police individually from neighborhood houses.

When the officers arrived, the Amadors gave their story about the incidents occurring within the past weeks and that evening. During the discussion with the police, one of the women harassers was seen coming out of the apartment of a male harasser and crossing the street to where she was supposed to be baby-sitting! After discussion with

some of those involved in the harassment, the

police left. Nothing was done!!

Sunday, February 18, the showdown. About 4:30 that afternoon, two women came to the Amador's door carrying cans of beer. Upon opening the door, Mrs. Amador was asked to step outside. She refused. The women invited her to their party and again she refused. They insisted she have a drink with them at their house. Mrs. Amador refused and explained to them that she did not indulge.

As this event developed, ten to twelve partygoers came to see some "action." Mrs. Amador's mother was present and Mrs. Amador asked them to leave because her seventy-four year old mother had a heart condition and couldn't stand the excitement. They responded: "we don't give a damn about your mother!" The harassers threatened to commit bodily harm the next day. As they mingled outside, Mrs. Amador pleaded with them to leave. She tried to reason with them and was pulled down from her front porch by one of the women. In selfdefense she engaged in a struggle with her helpless husband looking on. In response to a desperate plea to end the struggle by Mrs. Amador's seventyfour year old mother, the elderly woman was grabbed by the hair and thrown back, while one of the agitators poured beer on the weakening Mrs. Amador. In ensuing moments, Mrs. Amador lay beaten and unconscious.

Finally, the great enforcers of law and order came. While treating Mrs. Amador's wounds, they were told of what had happened. In reply, one of the officers remarked, "don't blame it on us." Other investigating officers were seen talking and laughing with the "invaders." Thereafter, Mrs. Amador was taken to the hospital.

On returning to the Amador's house later that evening, the police were asked for some course of action to be taken against the harassers. The Amador's were given the "run-around" and were told that the "laws have been changed" and that the Detective Department would have to investigate before they could sign a complaint.

Friday, February 23, one month after the police were initially notified, and five days after the unjust and brutal suffering of bodily harm by Mrs. Amador, **still** there was no action from the National City Police Department. And **still** the harassment

# Notes On State Board Meeting

Here are some notes on the State Board meeting in San Jose:

Presented by Ruben Gonzales, Metro Region Director, the NEW Chino Chapter was approved as a bonafied chapter.

President Bert Corona reported on the Convention in Albuquerque of La Alianza Federal de Pueblos Libres; the voter registration drive in Los Angeles County; meeting of La Raza Unida in El Paso; the recent Legislative Issues Conference in San Antonio, Texas.

Administrator Louis Flores reported on the past year's State Legislature (very bad record as far as the Mexican-American is concerned) and the coming Legislative Issues Conference in Sacramento (March 8-10, 1968). We need to keep and support our Legislative Advocate in Sacramento. Donations will be accepted as usual.

The Southern Region Director reported on the new Board: Gloria Harrison (San Bernardino), Secretary; Ray Villa, Treasurer; Phil Usquiano, Vice-Director; Chris Carlos, Director. He mentioned that he has set the goal for TEN new Chapters in the Region before April, 1968. The Newsletter, published by the San Diego County Council was shown to the delegates and met with enthusiastic approval. Voter registration drives have started in San Diego County and in Riverside. Invitations were extended to all delegates to attend a rally and demonstration Saturday noon (1-20-68) at the Blythe City Park protesting current and part discriminatory practices of Blythe City authorities against minorities.

Resolutions passed by Board members included the fields of manpower (New Careers, OJT coupled, skills centers, MDTA institutional); education (bilingual approaches); housing and urban development (Alviso); legal (CRLA, police brutality). The Board decided to boycott and demonstrate against the Nuevas Vistas workshops throughout the State and the Committee of Fifty Conference in Los Angeles, unless a broader cross-section of community people are invited. These events are sponsored by the State Dept. of Education.

The Site Selection Committee reported preference for Los Angeles County as the site of the next State Convention (June 14, 15, 16, 1968). Orange County was second and San Diego third in preference. The Board approved the site priorities.

Dr. Y. Arturo Cabrera, newly-announced candidate for the 25th Assembly District (San Jose), addressed the State delegates. He was very well received.

We continue to be impressed with the comradship and fellowship of the MAPA members, as well as ithe warm reception afforded them by the local Chapter members and the members of the Club Recreative Azteca.

The next State Board meeting will take place in April in San Bernardino.

# Civil Rights

Welfare recipients have the same rights as anybody else to refuse admission to their home to people who wish to conduct a search without a valid search warrant. This is applicable to all searches as distinguished from visits and applies in the day time as well as during unusual hours.

A number of steps have already been taken to prohibit searches "in the middle of the night or early in the morning."

- a. The federal regulations in Section 2220, Item of the Handbook of Public Assistance Administration require compliance with the constitutional rights of recipients. These regulations became binding on the states on July 1, 1967.
- b. Department Bulletin 624 of the State Department of Social Welfare of California, as revised on August 5, 1963, in Section V.B., prohibits searches of the homes or property of recipients by welfare department staff for the purpose of obtaining evidence of fraud without observing the requirements of due process of law.
- c. The Supreme Court of California, in a case entitled, Prarish v. Civil Service Commission of Alameda County, 57 Cal. Rptr. 623, 66 A.C. 253 has held that "early morning mass raids on homes of county welfare recipients" had to comply with the constitutional requirements governing searches and seizures in that a failure of such compliance would constitute a denial of the constitutional rights of the recipients involved. The case was decided on March 27, 1967.

In the unlikely event a search is conducted in violation of these principles, it should be reported to the Director of the State Department of Social Welfare, Mr. John C. Montgomery, P. O. Box 8074, Sacramento, California 95818.

# Mexican-Americans Given Challenge To Up Lot In Life

A challenge for Mexican-Americans to better their lot in life was flung from San Antonio over the Great Southwest Saturday in the first meeting of La Raza Unida.

The challenge came from genteel, soft-spoken Dr. Ernesto Galarza of San Jose, Calif. Dr. Galarza, counsel to the U.S. House of Representatives' Labor Committee and consultant to the Ford Foundation, delivered the keynote address to the some 1,200 attending the meeting.

Those attending came from Texas, especially Southwest Texas, California, Arizona and New Mexico.

It was indicated the San Antonio meeting will be the first of several which will follow, some in other cities.

Meeting in all-day session at Kennedy High School, the conference heard two major addresses, studied in groups, and filed an official report on conclusions reached.

Topics considered by the several study groups were political action, education, community services, icivil rights, war on poverty, Mexican-American identity, and confrontation with the gringo, his system and his evil doings.

The latter topic differentiated between the evil gringo and the "Anglo-Saxon" who co-operated and helped make the lot of the Mexican-American a better one.

"I believe the voice of the most humble person is important," master of ceremonies William Elizondo told the crowd, inviting them to make themselves heard.

"Problems have come about because the dominant group has created them," he declared, then added, his voice rising, "Viva la huelga!"

The crowd roared back, "Viva."

"Viva la causa," Elizondo shouted, and a roaring "Viva" from the crowd followed.

"Viva la Raza Unida," he shouted, and the crowd came back with another "Viva."

Dr. Galarza had the audience in the school auditorium laughing and chuckling . . . then applauding.

Dr. Galarza called la Raza Unida a pause in things to come. "It is not a fight," he said, "for that will come; it is not projects, for they will come."

Until recently, he declared, the "barrios" (neighborhoods) where Mexican-Americans reside, were in their regular state of "paralysis—facing the usual social and economic problems."

Now, however, said Dr. Galarza, he detects an

awakening in these barrios and that an air of expectancy existed.

Economically, la raza—the working Mexican-American—is a third-class citizen. He said the government estimates it required \$9,000 a year for a family of parents and three or four children to have the essentials of life.

"But thousands of our people exist on incomes under \$3,000 a year—that is one-third of \$9,000 and that is why I say they are third-class citizens," Dr. Galarza declared.

"You have heard of speculation in money and business, but we also have speculation in sweat the sweat of the workers, the majority of which are our people," he said.

On this note, Dr. Galarza turned to the United States-Mexico border. "You know what that is—it is conducted and administered on a Hong Kong economy, and includes such cities as San Antonio, Laredo, and Mexicali."

His reference was to low incomes in the areas.

Dr. Galarza criticized "the phenomenon of super planners, state and local," who do not have the remotest contact with the poor.

He lashed out at what he called "two types of violence," one legal and one illegal.

The legal type, he said, was administered by the state to aid and abet private interests to break strikes and disrupt unions.

With his statements hitting close to last summer's Starr County strike and Texas Ranger activity, the crowd gave him sustained applause.

"This was the law, and this was done legally," he declared. On the other hand, when people carry violence into neighborhoods and streets, this is illegal.

"We have a black panorama of problems, and our feeling of inferiority and helplessness is a product of these problems," he told the audience.

"To solve these problems we must study, ponder ,and arrive at conclusions.

La Raza Unida is a reply to provocations, it is a protest asking not turtle speed for solutions, but a 'paso doble' to bring about needed changes," he declared.

# Good Worker

Robert Garnica, a Mexican-American with a Mexican accent, was discharged from his job as spray painter from a shipbuilding company in San Diego. He was told by his foreman that he was going to be discharged because of an unsatisfactory probationary period.

Robert gave us this story:

"When I started working under this man, he was always pushing us and using foul language and telling us "all wetback Mexicans should pay a dollar to cross the border to work here". The foreman also, according to Robert "used to always pick on the Mexican-Americans, never on the Anglos. First they take our land, now we have to beg to support our children and beloved ones."

Robert who lives here with his wife Frances, and six children, urges all Mexican-Americans to speak out whenever anyone discriminates against

our people.

Because of his accent, his foreman thought he

was a Mexican National.

Robert, who has eleven years' experience in spray painting, feels he has been discriminated against. His case is now being reviewed by the F.E.P.C.

He feels that the report on his discharge papers will eliminate future jobs for which he might apply. Never before has anyone been dissatisfied with Robert's performance on the job.

I would like to thank Mr. Deddeh and Leo Perkins for their support and concern that they have for the ethnic minorities.

# POLICE PROTECTION—PART II

Although Mexican-Americans have for many years been classed as a group of people who do not "follow through" with our support for certain actions or ideas, it is time to bury this old myth.

The Mexican-American has been "a long time coming." It has been slow. For some—too slow! But he's gradually gaining ground and making himself noticed. Why this movement, and for what reasons? For those who know and understand the needs of the Mexican-American, well and good. For those who ponder the question, it is suggested you read on!

In following through with our coverage on the Greg Amador family which headlined our last issue, we would like to briefly note a few important points. After three months of continued harassment to the Amador family, it would seem that some legal action could be taken. And it would be in bad taste if we were to question the National City Police Department's policies. But we do not want the run-a-round that is handed to us when the problem should be dealt with and the time to deal with it is now.


Mrs. Amador signed a complaint against one harasser and was told by the D.A.: "Let's get one and then see what happens." This complain was signed nine days after Mrs. Amador's beating. In the weeks to follow, the "hearing and arraignment" of the lone harasser were to have excluded the Amadors. But Mrs. Amador happened to be on the scene and was told that her complaint was invalid and she would have to sign another complaint.

Since the harassment continues sporadically, the Amadors are without peace of mind. On one occasion, Mr. Amador retaliated with shouts to the harassers and was served with a subpoena. The charge: "disturbing the peace." And it only took them one day to sign a complaint.

In meeting with the Mayor of National City, the Amadors were offered his sympathy. "You have a very bad situation here. I feel sorry for you, and can only advise you to move," he said.

Well, Mr. Morgan, you're damn right! There is a very bad situation here!! If the Mayor and the N.C P.D. can only give sympathy and not action, then we may presume that we should take the law into our own hands. Also, if you give excuses like "the hands of the police are tied," then it's time somebody loosen the ropes.

# DEMANDS MADE

Students listed thirty-eight (38) grievances and demands for sweeping educational changes as a result of the boycotts and demonstration at the predominantly Mexican-American high schools in East Los Angeles last month.

They represent the inveterate dissatisfaction among students, parents, community leaders and teachers with the way Mexican-American youngsters are being educated in the Los Angeles school system. A few of the specific demands are as follows:

- (1) Compulsory bi-lingual and bi-cultural education for teachers and administrators.
- (2) Textbooks and curriculum revision to show Mexican-American contribution to society.
- (3) Counselor-student ratios reduced and counselors must speak Spanish and have a knowledge of Mexican cultural heritage.
- (4) Schools guidance program for counseling students on past high school endeavors must be improved.
- (5) Students must not be grouped into slow, average, and rapid ability groups according to the present testing procedures.
- (6) New teachers should be required to live in the community where they teach during their probationary period.
- (7) School facilities be available for community activities for children.
- (8) Community parents be hired as teacher aides.
- (9) Student body offices be open to all students and a high grade average should not be a requirement for eligibility.

The important aspect of the boycotts is that they were organized. One of the leaders included Sal Castro, a Lincoln High School teacher who walked out with the students.

# Bilingual Instruction Declared Part of Communist Plot

HUNGTINTON BEACH—Bilingual instruction for Mexican-Americans is just a part of a great Communist plot, says Alfred Ramirez, state coordinator for Spanish Surname Citizens in California.

Ramirez, 41, of La Mirada, made this and other charges as guest speaker at the Wednesday night meeting of the Huntington Valley Young Republicans at the Sheraton Beach Inn.

Ramirez called it the "Mexican-American Fraud in America," whereby the Communists are trying to establish that people of Mexican descent or birth, and especially the young, are not strictly Americans.

He said that the Communists know that more than half a million youngsters under 21 living in the Greater Los Angeles Basin are citizens of two countries, born here and U. S. Citizens, but also Mexican Citizens because of a change not many years ago in that country's constitution.

He said the minors with Mexican background do not know of their dual nationality, but that the Communists, who are now able to start an uprising of "black, brown and yellow power" of epic proportions, know of the dual citizenship and threaten the youngsters with it.

A harsh critic of Cesar Chavez, this week visited by presidential aspirant Robert Kennedy, Ramirez outlined what he called terror tactics used on women and children in the Delano area during the past two years of farm worker unions strife.

He told of beatings and assaults on men workers after the unionization, and when that did not work," the Communists turned to assaulting the women and children." Ramirez said, including threats of deporting the young.

The involved plot, Ramirez said, included the takeover of the Channel Islands, including Santa Barbara and Catalina Islands, by Mexico when the Communists start the uprising that will have Californians asking of a police state, he said.

Mexico never ceded the Islands in any treaty, Ramirez said, and the Communists know this. They will instigate the uprising getting the Mexicans angry, and Mexico will ask for the seven western states back, he said. The U.S. will negotiate and retain the states, giving up the islands, and install a police state because of the pressure, Ramirez said.

His charges took in the 155,000 member California Teachers Association, calling it a "bureacracy" that is being paid off by \$6.5 billion in federal funds for the bilingual program.

"Show me the bodies" of those Mexican descent children who can speak enough English when they start school so that they would be required to learn in Spanish", said Ramirez.

"I am an American, and English is our first language in this state," Ramirez said.

"The last thing a Mexican parent wants is to have his children learning a language they can learn at home," he said.

He called the University of California at Los Angeles a "Communist cell," saying that Chavez lectures there, and that the campus is responsible for pouring out "massive publications" to "pound home" the Mexican-American label.

He linked state Superintendent of Instruction Max Rafferty to the plot, not because of direct participation, but because "he knows better."

Ramirez said the bilingual program costs so much that "a whole schoolhouse could be built for every Mexican child supposedly in need of instruction in Spanish."

He included former Governor Edmund G. (Pat) Brown in the plot, saying that Brown once sent Chavez a telegram during the farm worker's try for unions that said "Viva La Huelga" (long live the strike).

He said that State Sen. John Schmitz, R-Tustin, is caught in the middle because he is at the same time a teacher and member of the John Birch Society, with diametrically opposed ideals. But he made it clear that Schmitz is not doing anything to further the plot as outlined.

He quoted Schmitz as saying that all the members of the teachers association are behind the bilingual instruction program.

# A MESSAGE

When I was elected President of the Escondido Chapter of the Mexican-American Political Association, MAPA, it was one of the greatest things that could have happened to me. I became so interested and sold on what MAPA has to offer, not for myself, but for the betterment of all Mexican-Americans, that I am convinced MAPA is our answer.

The Mexican-American has a new outlook on life. From now on he is on the move. The Mexican-American is tired of being looked upon as another Leap Year and only being recognized by the Politicians every four years when election time comes around.

Politics is our way of life and the sooner we recognize it and build a political voice for our people, the sooner the Mexican-American will no longer be classed as second citizenry, as Robert Kennedy said. United in MAPA, we will have an effective political voice, and we will be heard.

# MAPA ENDORSES DEDDEH

The South Bay and National City Chapters of MAPA voted Friday, May 10, to endorse Assemblyman Wadie Deddeh, 77th Assembly District, for re-election at a public forum sponsored by the chapters. MAPA members and guests heard Mr. Deddeh and his primary election opponents speak and answer questions that concern Mexican-Americans and their community.

Mr. Deddeh promised to continue working to pass legislation that would extend unemployment insurance benefits to farm workers and to support the bill that would allow United States taxpaying aliens the right to work on public jobs. This includes not only Mexicans, but Canadians, Germans and others. Mr. Deddeh is now pressing for the passage of AB-108, which provides housing loans for low income families. These bills mentioned are just a few of many which he has fought for on the Assembly floor.

Being a former-educator, Mr. Deddeh has seen the need for higher and better education for Mexican-American children. MAPA feels he has worked diligently for the entire 77th Assembly District. He has done an outstanding job in the two years he has served as a junior Assemblyman.

# MEXICAN-AMERICAN LEADER BLASTS NEWSPAPER, POLICE CHIEF, TUNNEY

COACHELLA—A leader of the local Mexican-American Political Association in an interview here yesterday took to task Rep. John V. Tunney, Coachella Police Chief Lester O'Neil and the Coachella Valley Sun newspaper for anti-Mexican-American sentiments and acts.

erican sentiments and acts.

Raul Loya, 30, a school teacher of 82-264
Oleander, Indio, denied that his group has harassed merchants following the arrests of four members of MAPA by Cochella police on charges of
holding a "clap-down" against Tunney during his
July 4th talk here.

Also denying the harassment of merchants was James Caswell, a credit collection agency employee of 81-909 Interstate 10, Indio, who has been identified with the Loya group.

**LOYA AND CASWELL** said the arrests themselves constituted police harassment of Mexican-Americans.

The two, active in liberal causes in the Coachella Valley, are among five persons charged with disturbing a public assembly. Police say the five clapped so loudly during Tunney's public talk that he could hardly be heard. City councilmen also say they were heckled.

Leaflets passed out at the time of the talk attacked Tunney for not taking a stand in favor of the attempt by the United Farm Workers Organizing Committee (AFL-CIO) to organize field grape workers. The union effort, underway during the recent grape harvest, was supported by the Mexican-American Political Association.

Tunney, D-Riverside County, says that as a lawmaker he thought it would be wrong to take a stand in favor of the union or management.

Most of the five charged by police are directly connected with MAPA Police still seek one of the suspects, Ramses Noriega, a former Coachella Valley art student and union worker.

**SUBSEQUENTLY**, Loya and Caswell have been accused of harassing some merchants here in an effort to squash the complaints and to get the weekly Coachella Valley Sun to print "their" side of the story. But the Sun said it received no statements to print.

Editor Gale Ellis yesterday said he had not received a statement released by Loya and Caswell Tuesday to the press. Asked to comment on the statement, Ellis said:

"I wouldn't waste my time answering this clown (Loya)."

Ward Grant, publisher of the Sun, replied:

"The actions of Mr. Loya and his friends may appear ridiculous, but as far as The Sun is concerned the Indio High School teacher has been doing a good job as a promotion man (for The Sun).

"SINCE THE SUN has been singled out as a target, we have received a flock of new subscriptions as well as new advertising—not to mention dozens of phone calls commending us on our stand.

"I really should say (to Loya), 'keep up the good work.,"

Some merchants last month said they were told that if they advertised in the Sun they would be picketed "and the town (would be) closed up." The merchants asked to remain anonymous.

# IN TUESDAY'S statement, Loya said:

"The recent headline story published in the Coachella Valley Sun, 'Picket Threat in Coachella,' is a prime example of the irresponsible-reporting that has reduced the paper to what it is today..."

Caswell said, "The publisher, Ward Grant, apparently forgets that his editor Gale Ellis said, 'Jim, as long as you are associated with Cesar Chavez (head of the organizing committee) and his kind I will never print anything you bring me. Don't even put your foot in this place!"

Loya continued: "The wild accusation made by the editor and publisher so distorted the facts that I welcome this opportunity to set the record straight.

"The committee (MAPA plus a Mexican-American scholarship group) represented many groups that have long been concerned with the Sun's attacks on individuals and groups that have tried to help the minority causes.

"THESE GROUPS are very concerned that Coachella does not obtain the image of Delano. In Delano, the Mexican-American is next to nothing. The people are intimidated by the police.

"The merchants are boycotted and Chavez has a cooperative gas station and store, and in three months they will further develop their 40-acre area into a union hall, medical clinic and offices."

Loya said many of the merchants in Delano have gone bankrupt and "Chavez even has his

# WHY ESL INSTRUCTION?

by Herb Ibarra **Project Director** 

The American of Mexican descent has not been able to achieve his rightful share of "equal opportunities in education." The high percentage of dropouts and low percentage of those receiving higher education attest to educational underachievement among Mexican-Americans. "barrio" children come to our schools with the inherent handiçap of a different cultural background and a language other than English. The language deficiency must be corrected and the cultural differences understood if there is ever to be an expectation of economic and social success for them.

English as a Second Language (ESL) is a nec essary program for every child that comes to school with any degree of language deficiency. These Children cannot be subjected to the 120-year old "sink or swim" method. ESL is a systematic approach to language development by which the learner acquires the four communication skillslistening, speaking, reading and writing—to a level which will enable him to compete successfully in the traditional curriculum. Bilingual instruction as a component of ESL instruction capitalizes on the child's native tongue by using it to explain concepts necessary to acquire the language skill. Some bilingual programs are designed to develop the Spanish and English languages fully for the learner so that he may become truly bilingual.

These programs must be encouraged as sup-

ported by the following individuals:

Vice-President Humphrey noted that there are one and a half million Spanish speaking U.S. citizens in schools today and the nation is fortunate in having a vast reservoir of bilingual Americans at a time when we need to communicate with the two hundred million other Spanish-speaking Americans who share the hemisphere.

Dr. Sabine Ulibarri of the University of New Mexico states that the best bilinguals in Spanish and English are coming out of the Spanish-speaking Southwest. This is a human resource which government and industry are utilizing and it must not be allowed to dry up. He emphasizes, "If we wish to hold on to the cultural heritage of the Southwest, we must preserve the Spanish language."

Vincente T. Ximenes, Chairman of the Inter-Agency Committee on Mexican-American Affairs, commented that bilingual education would benefit all residents, not just Mexican-Americans, by moving away from the narrow horizons of a single culture.

Equal opportunities can come to the American of Mexican descent if the schools first provide the firm foundation of ESL for all persons that have a language disadvantage.

# FOUR PLEAD INNOCENT IN TUNNEY 'CLAP-DOWN' CASE

COACHELLA—Four of five suspects who allegedly took part in a "clap-down" during the July 4th talk here by Rep. John V. Tunney, D. Riverside County, pleaded innocent here yesterday. Judge D. B. W. Alexander of the Coachella

Justice Court set 9:30 a m August 27 for the start of a jury trial. Judge Alexander of the Mecca Justice Court is sitting in the absence of Judge Tom Cross, who is on vacation.

The jury trial was requested by attorney John Simon of Palm Springs, who is representing Raul Loya, 30, an Indio school teacher and president of the local Mexican-American Political Association, 82-264 Oleander, Indio, and these three others:

James Caswell, 48, a credit collection agency employee, of 81-909 Inter-state 10, Indio; Albert Figueroa, 32, of 464 Carleton, Blythe, a MAPA leader there, and Thomas P. Kay, 22, an organizer for the United Farm Workers Organizing Committee (AFL-CIO) from Lamont, in Kern County.

Police still seek a fifth suspect, Ramses Norie-

ga, 24 of 1557 Fourth, Coachella.

The five are charged with disturbing a public assembly. Leaflets passed out at the time of Tunney's talk attacked the lawmaker for not taking a stand in favor of the attempt to organize field grape workers by the organizing committee. five are all farm union sympathizers, police say.

Officers at the time said the five were identified by witnesses as part of a group of about 30 persons who clapped so loudly during the talk by Tunney that he could hardly be heard. City Councilmen also were heckled.

Tunney says that as a lawmaker he thought it would be wrong to take a stand in favor of management or the union.

own newspaper known as El Macriado."

"When we saw the movement of many of the local merchants and citizens signing a petition to close the park to our local farm workers, and now the Woman's Club has indicated that they will no longer return their facilities to the farm workers. many of the local farm workers started to ask Cesar Chavez how to develop a 40-acre plan as he has in Delano," Loya said.

HE ADDED THAT since the Mexican-American people in Delano have boycotted and stopped their subscriptions to the Delano paper, the "local business people have no way of reaching the Mexican-American population through the normal advertising channels.'

Loya said this kind of a movement already

has started in Coachella.

He said that if the newspaper does not change its policy toward the Mexican-American "we predict that in a short time they will have no Mexican-American readers...

Loya said these are the reasons "why we were

calling on the merchants."
"If they all want to stand by and see a Delano situation develop, we don't," Loya said.

Commenting on the "clap-down," Loya de-

scribed it as "spontaneous."

"Now they think we're criminals because we clapped," Loya said. "This is intimidation of the Mexican-American people and harassment. Who is (Police Chief) O'Neil trying to intimidate?"

CHIEF O'NEIL said yesterday neither he nor his department is "intimidating" anybody with a clear-cut violation such as this," the chief said. He said Loya may be "grasping at straws."

Loya also quarreled with Chief O'Neil's use of the word "troops" in referring to the men in his

department.
"What is this, a police state, that he (Chief

O'Neil) thinks of his men as storm troopers?" Chief O'Neil yesterday replied: "I even refer

to my men as 'troops' (not storm-troopers') in talkto them."

The chief added that the word "troops" is a slang term used by many in and out of law enforcement and in various branches of the military service and in private enterprise

Said Loya, "I know that he (Chief O'Neil) has a red flag with a white circle and in the circle a

black swastika displayed in his office.

To this the chief replied, "I don't think anyone has ever seen such a flag displayed in this office." He said such a flag was found flying over an elementary school here and the material resembled that used in union flags. The flag itself was found flying over the school June 23 during the recent farm union organizing effort, police

IN TAKING Tunney to task, Loya charged that the congressman is not enforcing the law on the 160-acre water limitation. Tunney could not

be reached for comment.

(A Cochella Valley County Water District official said it was the job of the Bureau of Reclamation to enforce the law, which applies to lands where the bureau supplies water through federal dams or canals. Under the law, a farmer is limited to 160 acres for water from a bureau project.

(The water district spokesman said he knew of no violations in the Cochella Valley. The law does not, he said, prohibit farmers from leasing more than 160 acres and using water from a bureau project. In addition, he added, each member of the same family may hold 160 acres, so a family of six might hold 960 acres.)

LOYA ALSO CALLED on Tunney to take a stand on the supported boycott of California grapes. He added:

"When it comes to backing farmers, Tunney takes a stand, but when it comes to backing up Mexican-Americans, the poor in the 38th Congressional District, he doesn't respond in any manner.

"Sen. Ted Kennedy, with other senators, had introduced a bill to prevent Mexicans living in Mexico to cross the border to take away the jobs and depress the wage scales of local workers.

'Here it is straight out of the Daily Enterprise—Tunney came out against the bill," he said
