Please let me know what arrangements can be made to pay all or a part of this note at your earliest convenience. I am needing the money very badly, and want at least \$500.00 by the 7th of March. I can let the rest run for a while, if desired.

I was in San Francisco, and believe I have made some headway in getting a reasonable adjustment with the Southern Sierras Power Company and hope to have a definite proposition from them in a few days. Have you written Mr. Paul Shoup, or have you seen Mr. Spreckels to have him get in touch with Mr. Shoup regarding this matter?

Whatever is agreed upon as a reasonable cost of the lands, or rights of way from the Southern Pacific, I think I can get the Southern Sierras Power Company to advance the money. Mr. Albright could not expect the Southern Pacific to give up its rights on the stream and several miles of rights of way, together with power site for nothing. The Southern Pacific is entitled to some reasonable compensation. This is the only thing that is holding up the Southern Sierras Power Company, and I do not want to force the issue with Mr. Shoup until you have used your influence either thru Mr. Shoup direct or thru Mr. Spreckels.

In regard to the former two, I wrote at once to Mr. Hartke requesting him to attend to the business for me. It is very difficult for me to know what is best to do, so far from legal advice but it is my plan now to go up to Los Angeles for a few days or perhaps to Riverside or San Francisco

If I knew just what to say to Mr. Shoup I would not mind writing again but it seems necessary that I should be more familiar with the subject than I am at present. I have asked Mr. Hartke to arrange with Mr. Shoup if possible a time and place of meeting so that they could go

over the proposition together.

Much valuable time is being lost by the delay in getting the rights of way across the property of the Southern Pacific and I want to do everything in my power to assist, but as Mr. Hartke is representing both my husband and myself in the management of the estate I think he is the one to see Mr. Shoup. Personally I do not wish to ask favors. I believe however that there is usually a difference between what is asked for property and what an owner is willing to take - and the way is left open for an offer from the would be purchaser.

Answering yours of the 11th, will say your attorney. Mr. Hartke, wrote me asking for a conference and over the telephone informed me that he had written to you that I should see Mr. Shoup at the earliest possible date. It is true ghat much valuable time is being lost and Mr. Shoup should be seen immediately, and the only question is, will you see him, shall I, or do you think Mr. Hartke is the best man to see him. If you desire to have me go with you to San Francisco to see Mr. Shoup I will do so.

I still believe matters can be expedited and arrangements made to have the Southern Sierras Power Company put up all of the money and Mr. Albright pay half of it, to be deducted from the amount that is coming to you under your contract with the Southern Sierras Power Company. Mr. Albright owning one-half interest in the property that would be acquired from the Southern Pacific and the Southern Sierras Power Company owing the other half interest in the property, subject, however, to their having the exclusive right to go shead and make the power development and having usual rights of way. I would suggest this as a compromise and hope to get the Southern Padfic to agree to sell all of this property outright at somewhere between \$15,000 and \$20,000. You would not have to put up a cent. The Southern Sierras have been ready to build this power plant for months. They have now commenced the Mill Creek Power plant, and are not so anxious.

My advice is to do business while they are in the mood.
