# Governor Gray Davis Praises California Institutes and University of California

In a recent interview with UCSD Connect Newletter Editor Max Donner, Governor Gray Davis shared his thoughts about the role the new California Institutes for Science and Innovation and UC will play in the future growth of California's economy. A summary of his oberservations follows:

"The billion-dollar, multidisciplinary effort represented by the Institutes for Science and Innovation will focus resources and expertise from the public and private sectors to, literally, invent our future. These institutes will open the doors to new understanding, new applications and new products through essential research in biomedicine, bioengineering, nanosystems, telecommunications and information technology. For example, the California Institute for Telecommunications and Information Technology - located at UCSD and UC Irvine - will research and develop prototype technologies to extend the reach and capacity of the "new Internet."

Local businesses won't just be spectators. They will be partners. Industry partnerships will help move early-stage research developments into the commercial R&D pipeline. Small businesses can also benefit from the institutes' scientific and engineering expertise through service on scientific advisory boards. Access to UC's scientific leadership will also strengthen the firms' R&D plans and help them attract investors. The institutes were designed to combine the resources of the State of California and the University of California with the scientific expertise and entrepreneurial talents of hundreds of the State's cutting-edge businesses. Small businesses and startups will be an important part of the mix.

As Alan Greenspan noted a few months ago, the New Economy's R&D innovations benefit traditional companies, as well as the new high tech and dot-com businesses. New technologies have applications for companies that provide more traditional products and services. For example, online business practices have improved productivity and expanded their reach into new domestic and international markets. One of the benefits of the institutes will be to offer traditional companies further avenues for incorporating new technologies into their everyday business practices.

Furthermore, the institutes can provide a platform, or testbed, for the most advanced ideas in communications and IT that are central to the success of these industrial sectors. The new institutes will benefit the mainstays of California's economy in many ways, from the training of the next generation of digital artists to the development of new defense equipment.

Innovative high-tech and biotech partnerships between California scientists and entrepreneurs - many of which were spin-offs from the University of California's southern campuses - played a significant role in this recent economic boom. These entrepreneurial partnerships will continue to be vital to

sustaining and expanding business growth in the next five years.

California's technological innovations created new companies and, in some cases, entire new industries. Over the next five years, we can look forward to continued growth in these new industries similar to the advances experienced by San Diego's wireless communications firms. If businesses continue to incorporate new technologies into their practices, California will retain its worldwide competitive advantage."

# Milken Institute Sees Bright Future for San Diego Area

San Diego scored consistently high marks in presentations at the Milken Institute's 2001 Global Conference, held March 20 and 21 in Los Angeles. The San Diego region ranked second on the Milken Institute's list of "Places to Watch" as a technology cluster with future potential as well as second among major metropolitan areas as one of the best places in America to do business, bested only by Atlanta. Georgia. San Diego was also listed as one of the most-recession proof regional economies, thanks to its diversified economy and stable base of contract research and government contractors. San Diego came in third place as a regional center for biotechnology. Austin, Texas and Boise, Idaho were also highly rated in several rankings, but San Diego had the distinction of being the only metropolitan area which rated highly in all of the Milken Institute's measures of high-technology clusters.

The San Jose Metropolitan area, center of the Silicon Valley technology community, dropped to 31st place on the Milken survey of best business climate, conducted jointly with the editors of Forbes Magazine. An overextended infrastructure and exceptionally high real estate prices were cited among the drawbacks limiting the area's future growth. The Institute's research also showed that Southern California's "Tech Coast," encompassing San Diego, Orange, Los Angeles and Ventura Counties has surpassed Silicon Valley in total output of high-technology goods and services. The Silicon Valley area remains the capital of venture capital, however, accounting for half of the venture capital invested in the U.S. last year.

Recent Milken Institute studies presented at the Conference also showed California ranked second in the Institute's "New Economy Index," a composite of measurements which track conditions best suited to high-technology business. Massachusetts earned the top spot in the ranking. Connecticut. Colorado and Washington were the other states ranked in the Top 5.
