THIS CONTRACT, Entered into between the Helix Mutual Water Company, the party of the first part and the Cuyamaca Water Company, party of the second part, WITNESSETH, as follows:

The party of the first part hereby sells and transfers to the party of the second part the pipe line which leads from the main line of the Cuyamaca Water Company's pipe line about eighteen hundred feet (1800 feet) below Eucalyptus Reservoir, and extends Eastward about 1300 feet to El Cajon Boulevard, with all rights of way and easements.

The consideration for this is the sum of Two Hundred Fifty Dollars (\$250.00), to be paid by the party of the second part, receipt of which is hereby acknowledged by the party of the first part.

It is further agreed that the party of the first part shall and hereby does concel all stock in the Helix Mutual Water Company of all users of above pipe line, and relaces them from all future assessments of said Helix Mutual Water Company.

A minute of the meeting of the Board of Trustees of the Helix Mutual Water Company authorizing this sale is herewith attached.

The Trustees of the Helix Mutual Water Company, was called in La Mesa by the President, to consider the report of the committee, Messrs. Warren and Hawley, who were appointed to confer with the Cuyamaca Water Company, relative to their purchasing that portion of the Helix Mutual Water Company pipe line, situated about 1800 feet on the main line from the Eucalyptus Reservoir, and extending in an easterly direction about 1300 feet to the El Cajon Boulevard. The Committee reported that through Mr. Fletcher they had an offer of Two Hundred Fifty Dollars (\$350.00) for the property; and that all users of water on that pipe line shall be released from further assessment by the Helix Mutual Water Company and that the stock certificates be canceled. On motion, the terms of the sale were accepted, and the committee was authorized to draw up a contract on the terms proposed.
