Jamaica To know all men by these presents That I Thomas Hall of the parish of Saint James in the said Island of Jamaica
Stand Made Ordained Constituted and appointed And Do by these presents Make Ordain Constitute and appoint Samuel Blaney
of the parish and Island aforesaid my true and Lawfull Attorney for me and in my name and for my use to make Grants
within these and Following Grandfather's any Land so which I may hereafter have right all or near the North side of Montego Bay
I Grant the Right afts to the Sea / to the person or persons who have already erected any Buildings thereon Or to any other
person or persons who shall do diverse of Building on the other parts thereof Which said Grants so to be granted by my said
Attorney shall for his Consideration of five Shillings Coway and Confirm to such person or persons A Right during their Lives
to the Land upon which they have already or shall build And upon the Death of such persons the said Land and Buildings thereon
erected shall Return to me Without any Consideration to be paid by me for such Buildings or any Improvement which may
happen to be made on the said Land Giving and by these presents granting to my said Attorney my Full and Whole
power and Authority in the Execution and Performance of the premises at full and ample in Every respect as if my self
could do if were personally present Ratifying and Confirming All & Whatever my said Attorney shall lawfully do
or cause to be done in my name by virtue hereof It witness Whereof I have hereunto set my hand and seal this
Ninth day of May in the year of our Lord one thousand seven hundred and fifty seven
