The Graduate School of International Relations and Pacific Studies at the University of California, San Diego will sponsor the first in a series of seminars on financial management, August 23-25 at the Rancho Bernardo Inn, 17550 Bernardo Oaks Drive, Rancho Bernardo.

The first seminar, Executive Education Program for Money Managers, is designed specifically for Japanese money managers responsible for decisions about investment, diversification and strategic planning. The topics will be: Diversification and Active Portfolio Management, APT (Arbitrage Pricing Theory) and CAPM (Capital Asset Pricing Model), Volatility and Program Trading, Politics and Financial Markets, Market Mechanisms and Strategic Behavior, Pension Funds and Mortgage-Backed Securities.
