Dear Pauline:

I am sure our desire is pretty much the same as your own. Both Bob and I want you to be where you will be the most productive and the most happy. All three of us should think hard about your coming because it is a vitally important decision for everyone concerned and for the success of our first year program as well.

From our point of view we need to be reassured that you are genuinely intrigued by the teaching possibilities and by the music making potential here. We certainly would be disappointed if you proved interested in only your own bag and how this school could support it. Above all, we are in real need of some imaginative teaching in this first year of our undergraduate major and graduate program. We see you as being oriented in certain directions that would give us such imaginative and committed teaching in full measure.

Probably because you are wrestling with the pros and cons of retaining directorship of the Mills Tape Center, the impression came across during your visit of reluctance to get involved as a teacher. Our curricular program must depend upon faculty enthusiasm because only imagination and committed involvement will keep it from falling on its face. We think you ought to give this particular aspect of making your decision very careful thought for our good as well as yours.

To help clarify things for you, let me describe your probable teaching load next year, should you come. We see your involvement in the Music l Course as follows:

- 1. Supporting Bob's tape music project in the fall quarter (weeks 1-2-3)
- 2. Supporting an improvisation project in the fall quarter (weeks 8-9-10)
- 3. Directing a tape music project in 2nd quarter (weeks 1-2-3-8-9-10)
- 4. Directing an improvisation project in 3rd quarter (weeks 1-2-3-8-9-10)

This would total a working load of two courses.

We would also ask you to handle a graduate seminar in electronic sound generation and modification (Music 204). We would expect the two Buchla Boxes and (hopefully) the Moog Synthesizer to provide most of the equipment support for your seminar, which is scheduled for the winter quarter, I believe. You would also be asked to direct the spring quarter of Music 202 which carries the long title "Advanced Problems and Projects in Recording, Editing and the Specialized Use of Electronics in Performance."

Your remaining teaching obligation would be to support the "music theory" junior level and/or the lower division musicianship training areas. We expect to handle these with a surfeit of graduate TAs working in close touch with the faculty.

So you can see that we would want you to get in there and pitch as far as teaching is concerned. If you have time to drop me a note reflecting your reaction to this aspect of things, please do.

It's very possible that you will remain uncertain of tying in permanently to a more formal college relationship until you have tried it out for awhile. And I know the timing is awkward for you because of the possibilities of the Mills Tape Studio. Ideally, you would probably want to continue as Director of the Center a second year and then join us as visiting lecturer or assistant professor in 1968-69 -- or so it would seem from this distance.

Should that seem the most ideal decision from your point of view, you should know that Doug Leedy is enthusiastic about joining us next year and that we won't face any particular teaching hardships except at the graduate seminar level in the electronics area. So relieve yourself of concern over our filling Ken's position in 1967-68 as you think this over from various points of view.

No guarantees can be made by a department chairman concerning rank and salary. As I told you Thursday, the salary offer will probably fall somewhere between nine and ten thousand collars and the title will be either that of lecturer or assistant professor. I must make a decision about these things in order to write my letter of nomination according to the materials on hand and in terms of known university precedence. Then we sit back and hope for approval by faculty review committees.

My guess is that a higher salary figure can be more safely requested at the lecturer level. Your college teaching experience is minimal and you carry no PhD. Davis found this propitious for appointing Tudor and Stockhausen this year and the University has insisted on this particular title for Jim Campbell. The contract could conceivably come out at \$8,900 or \$9,200 but it is 98% sure that something near 5% additional salary can be expected in 1967. This would be added to your contractual salary and so we are probably speaking of something around \$9,500.

Let's hear from you soon by phone or mail. Your honorarium, covering travelling costs primarily, will be in your hands soon. It was great to see you again, Pauline.
