



INTRODUCTION.

This patrol covered in part that srea known so the Middle Jimi. Commencing from TARINOGA the patrol proceeded through SWINUN, WUN, NURNGA, KUNNE, KOROB, MARCHUL and return TABINUGA. This area is enclosed by the Jimi and Ganz rivers and the Wahgi Divide, and through which the Tasu river - otherwise known as the Targan river at its headwaters - flows and acts as the basin for smaller streams in the region.

The main objects of the patrol were a census check and seneral administration of those villages omitted by Jimi Fatrol No.I of 1959/60, due to the lank of time available. The patrol proposed to cover as much of the area as possible, however on the lith October the pairol received word of the arrival of the Supress from MERCHARL to TABLEUGA via active foot pad. Novertheleds the objects of the patrol were accomplished and the villages omitted by the previous patrol visited. As it was not explored to complete the antire area only a pensus sheek was carried out of these villages visited. A ratrol later in this financial year will complete a

HATTYS ANDATES.

The native situation throughout the area visited is satisfactory, and as all group meeting places the patrol was well received. This was particularly noticeable at both MEINER and FSENGA where there was quite an anthusiastic veloceme. Ample food was supplied to the patrol glthough food was not plentiful during this period.

The Eutherna Mitsish has suishished a station on the brake of the River SAL about i an how from NANGA. This station is under the cure of a Morobe Rission teacher and from shat can be gathered its influence is quite a trong in the area. Some months ago mass beptiems were hold at this station, many people in the vicinity taking part in this cervity. However one of the premarriage, or should be have more than one wife then to dilvorte one or more of them. This situation are sife then to dilvorte when only she wife of a polygarous marriage sould occe forward on the family being called. Then this matter was enquired into the people said that unless they discarded polygarous marriages they would not be accepted into the church.

When we consider the case of a man whe has been married to two women for twenty years or more, and has had a family a each, then suddwaly he has to choose which one to diverge I think it might be realised how serious this situation is. Such a dese is mentioned above did come to my notice; here the man and women concerned were well advanced in years, too old to work and took old to marry again, yet one of the women had to leave the household if they were all to be accepted by the church.

At a meeting of all TSERICA people it was explained that the Government respected native custom and they were under no obligation to discard their polygamous marriages, and those who had two or more wives should consider the matter very carefully before diverge especially if they had had children off each of their wives. It is not be interferred with, if the Mission wishes to set up a monogenous system then approach those who are yet to marry. One would think that in such cases the Mission would make allowances for the elder people who still live by their former customs.

Portunately such diverces are still in the minority, but the mumber is noticeable. On the other hand a few mases of young men entering into polygamous marriages were noted.

The roads throughout the srea patrolled were in good condition. These walking tracks are for the most part well graded, and during the time of the patrol at least were clean and well kept. Likewise bridges were in

As it was necessary for the patrol to retarn to the station in order to ittend the Supreme Gourt Hearings at MOUNT Hadden, a direct route from MARGINUL to PARIMUMA had to be taken. This route could scarcely be called a walking track as it is seldom used by the people themselves and had not been in use for some time. Molking along this route it takes five hours, and at no time is there even a comblence of a road. This is not a regular route therefore no instructions were given to make or maintaid a road hare.

GLESTS.

One of the main surposes of the patrol was to conduct a cense, check of all villages oxifted by Jimi Patrol No.1 of 59,60. This was successfully carried out and the following information gathered from these villages

TILLAGE AND VOLLAGE OFFICIALS.

These people do not live in villages rather they live in small scrutered haslets and having a control apot where they gather for consus etc. Their houses are rectangular in shope, about 20 feet by 10 feet and standing four to five feet high and generally divided into three compartments. These how are built of shatever naterial is avaiiable in the region. neually timber, burk and kurni. These houses are situated in small scattered comparisies about the countryside.

RESTROCKES.

All Resthouses in the area patrolled are in first class condition, except the one at MUX. These WUZ people are the amaliest group in the area and thereby may have some excuse for having the pocreat Besthouse, however instructions sere lef's for it to be improved.

MISSIONS.

The Reserver Wission has now established itself in the Jimi River at SINGUROPA a little over an hoar away free REDIRUGA on the road to Ewinon. It is in this tree that good panelity benance, pay page and piercyplet were seen.







Is the Spper Jini, particularly the Hot area, these people have had contact with patrols for about the yearst thereas in the Emoga surth-rest of Jini Patrol Post, the people have only experienced patrols since about 3956. Further to the morth-west over the Birmark Bange from SINGLI Fatrol Post. there are several groups of people who were contacted as recently as April 1960.

The people of the ROL region grooted the patrol much the am as must people who 'know' the Government. That is the entire grout turns out, surpluses of food are supplied, and in general it is stire group considered a gain day. However these in the north-cost of the Emmon and with less contact are sot to be a little apprihenaive and subplaces. Hare not of the people remain in the bash and food supplies are at a minimum; these people have still to get to hnow the Covirgnment better. However on no secureles was freshis encourt by the patrol, and at all group monting places discussions with the people and village officials were completed in a friendly manner.

Throughout the area treakle seems to show from two courses. These are marriages and pige. Somerning marriages it was emplained to the people that the Soverment accepted the customs of the native people regarding marriage, however at each group meeting place the mass troubles and problems were presented to the patrel. There are three ressons for this:-(a) "Marked" females who are foreed into marriages

- with man they do not want.
- () Failure on the brideground part to puy for his
- bride, or only paying a part of what is due. (c) Failure by the bridogroup or brids to complete some coremony or obligation associated with the serriage.

MISSION AND EDUCATION.

APPENDIX C.

I have grouped these two exctions together because except for the ideinistration school at TABINGGA, all other schooling in the area is carried out by Missions.

There are three Histions groups in the area patrelled and each group is endeavouring to earry out some form of education or other. These groups are Angliass, Cathelie and Lutheren. The Angliann Rissian extend across the Jini Niver on the marth size from SORION through to MINDAI. The Cathelie and the Latheren Histions extent their influence through much the same area. This being around SCL on the south side of the Jini Niver. I believe that the Anglianny and Latherens have some to an agreement thereby meither intends uncreaching on the other's 'berritory'. From all accounts the mark is set at SURION village.

At the present most education carried cut by these Minsion is of a rather elementary stage, slobsuch the Anglican Mission has recently appointed on English speaking tracher, she bas bis certificate, to BOAFAL. From discussions with Father Me Persent of the Catholic and New Jusker of the informat Mission I gathered that both Missions intend to establish Reglish teaching schools during 1961. In (b) and (c) it was found that no evert not was conditied by natives towards the Hisrica representatives, but that only words vere exchanged conversing the non attendance of and 'ren at school. Both men who supposedly made the threats were inter med, and it was found that they became annoyed when the Mission endervoured to force their children to school. It must be remembered that these people are still rather primative, and as a result I offered these two see a job as carriers for the patrol in order that they may get to know the Government better. It was explained that they would receive pay for their work and insteed rations for the deration of the patrol. Both agreed to accompany the patrol, havever the mart morning the man from GINJIGI had run away, but the man from K-pair angen had remained. However it is pleasing to note that when the patrol arrived at GIRJIGI it was presented with a pig from this man. Belatives brought the pig in with a message to the effect that the Government had looked after his and faed his well during the course of the investigation, and new it was his term to lock after the Government. Although he was called for the man refused to come to the pairol, and likewise refused by sessage any pay for the pag which he insisted was a present. His relatives were given a small and to give to his in payment for the pig.

For other pen from KONPIAIN who accompanied the patrol throughout was pled off on the return to the station.
