## **THE EVELYN GOLD MINING COMPANY**

Has been formed with the object of working and developing the COLUMBINE MINING CLAIM, situated two-and-a-half miles from Columbia, the famous old mining center of Tuolumne Co.

The mine is located on a spur of the Mother Lode in what is generally conceded to be one of the richest mining districts of California.

### **PROPERTY**

The EVELYN GOLD MINING CO. owns, without encumbrance, its property consisting of one full claim of 20 acres and one mill site of 5 acres. The mine is surrounded by paying properties.

### **CHARACTER OF THE PROPERTY**

The course of the vein is easterly and westerly. The formation is granite. It has been traced the entire distance of the claim by open cuts and shafts, all of which show quartz, carrying gold. Stanislaus River and continues along its banks for 600 feet, we can have water power at all times from that source. The river is from 4 to 15 feet deep all the year round.

There is also an electric power plant  $1\frac{1}{2}$  miles from the mine, so that we can have electric power, if required, which is supplied at very reasonable rates.

### TIMBER

The entire claim is covered with sugar pine and oak timber, both suitable for mining and fuel purposes.
