Expediente moved by the citizen, Baron, Mr. Julio Morner, as legal representative of Mr. Ricardo Palacio, in solicitation of the lands of The Ex-Mission of Santa Catarina - year of 1858. Seal second. "Four Dollars" Years One thousand eight hundred and fifty-six and One thousand eight hundred and fifty-seven.

In the city of Colima of the state free and sovereign of the same name on the eleventh day of the month of December, One thousand eight hundred and fifty-seven, before me the Attorney-at-Law, Antonio Garcia Perez, Judge of first instance and having charge of the public offices of the state besides the instrument that will be herein-after named, appeared, Mr. Ricardo Palacio of lawful age whom I personally know and said that the Supreme Covernment National granted to him on the twentieth of December, One thousand eight hundred and fifty-five, the property of the lands belonging to The Ex-Mission of Santa Catarina on the frontier of Lower California, as it appears from the communication of the Ministry of Fomento that I acknowledge to have before me and the instrument is as follows:

Ministry of Fomento,

Colonization Industry and Commerce of The Mexican Republic.

SECTION FOURTH. Having informed His Excellency, The President substitute of the Republic of your solicitation asking the concession of the property of the lands that belonged to the Ex-Mission of Sta. Catarina on the frontier of Lower California, he has been pleased to accord the concession of the rights that the Supreme Government vests upon said lands, resting on your account to protect them in case of opposition and also the expenses for the survey - possession and other necessary expenses under the condition that at no time you can bargain or convey to

no individual or individual foreigner not naturalized in the Republic, until surveyed, under the understanding, that if it is so done, for the said act it will annull said concession, and the said lands will again be the property of the Nation. The same has been accorded by His Excellency that the same punishment be imposed in case that at the termination of the three years from date of said concession he may have neglected to have taken possession of the same and commence to build after the marking and the correspondent survey of which operations he will give due notice to this office when the same are verified. All of which by the Supreme order I notified you for your knowledge, and as the result of your referred solicitation manifesting to you that with this date notice has been given to the Political Chief of the territory of Lower California, this resolution for its proper understanding God and Liberty, Mexico the twentieth of December, One thousand eight hundred and fifty-five .- Siliceo. Mr. Ricardo Palacio. And for to take possession of the said lands and being unable to attend personally, he authorizes that he give his ample power complete and sufficient as much as it may be required by legal right and be necessary and can be made good and valid to Mr. Baron Don Juan Julio Morner, naturalized citizen in the Republic, residing at present in the City of Mexico, for the purpose that in the name of the owner and representing his person, rights and actions he may practice all agencies and steps judicial or ex-judicial that may be necessary to accomplish and effect the line survey, assessment and all that may be necessary to comply to take the possession of the lands, waters, timbers and other

privileges that the Supreme Government has conceded in Lower California, known as The Mission of Santa Catarina. Complying, the said Attorney-in-fact, with the condition mentioned in the said communication, and resting on the said Attorney-in-Fact, the payment of all expenses incurred in the above mentioned operations, receiving in recompense from the owner in property and under the same terms that he has acquired the fourth part of the mentioned lands, or what is the same, the fourth part of the whole, as it could not be made of equal proportion if the said lands were divided in a mathematical survey, owing to the different quality and the situation of the said lands. And for the compliance of the operations mentioned, I authorize him so that he can name assessors, surveyors and intelligent experts; refuse or accept on this particular what he may think convenient without limitation and without cause for failure in clause requisite or circumstance not herein expressed be an obstacle to comply with its effects for all powers necessary are hereby granted as if single expressed, same as would the said owner confer if he was present, consenting to ratify as legal and lawful the acts of the said Attorney as if already performed. And if on the particulars heretofore mentioned law-suits should be instigated he may appear before the Tribunals Superior or inferiors having jurisdiction and before them previous the conciliation of law in the necessary cases, can bring suits. Answer the opponents and perform the pediments, requirements, attachments and other steps necessary.

He may present writing and other documents; present witnesses; oppose and object those of the opponents presented, refuse, swear or decline. Ask for time or re-

fuse it. Ask for all kinds of documents and present

them when important, and in case of necessity answer with the regular protest. Hear claims and decision indefinite or definite from the favorable he may accept and from the adverse appeal and act follow his pleasure or desist from it, and finally perform all other acts, agencies and requirements that judicial or extrajudicially may be important, as for all said the annexed instrument and power confers to him ample power without limitation as the case may require with free, open and general administration and power to sue, swear and substitute singly or jointly, revoke substitutes and appoint others with the duties and obligation by rights necessary. And to acknowledge as firm, legal and subsistent what in virtue of this power is performed. And the grantor binding himself and his present and future property and with all, he surrenders to the law and jurisdiction of the Judges and Tribunals of the Republic from what they may know of his business in conformity to what is right, so that in the performance of the same they may compel and reward as if a definite judgment had passed by the competent judge, and it was accepted, not appealed and passed as authority of a judged case, renounces the laws in his favor and defense with the general decree in form. So he acknowledged and signed in this office being the instrumental witnesses. Mr.Antonio M. Solorsano, Mr. Julian Pizarro, and Mr. Palacio Gomez Palmira, present and neighbors. Taken from the office on the following day of its acknowledgment being on a paper of the second seal with one of the third seal in the middle and the same witnesses served when the documents were compared. In the City of Colima, on the eleventh day of the month of December, One thousand eight hundred and fifty—seven, the Licenciate, Gaspar Antonio Ochoa, first Vice Judge of the Court of this District actuating with witnesses of assistance for the absence of the clerk, certified, that the signature of the Licenciate—at—Law, Mr. Antonio Garcia Perez, the same with which this testimony is authorized, is the same always used by him in all cases and business, civil and criminal, as Judge of First Instance of the State. Julio Morner as the Attorney of Mr.Ricardo Palacio to take the possession of the lands that were to him granted by the Supreme Government in the extinguish Ex-Mission of Santa Catarina in compliance to said superior order prays that you may decree to grant me the judicial possession of the referred lands by the compe- . tent Judge for which I will receive justice. I swear to all necessary &c, admitting this in common paper for being without the seal one. Sausal de Camacho, August 7th, 1858. J. Morner, Sausal de Camacho August 9th, 1858, A seal of the Sub-Gefatura Politica. The situation of

of the lands being in the jurisdiction of S.Antonio the interested party appeared before the Judges of this jurisdiction so that associated with the surveyor expert of this frontier, Mr. Cecelio Zerega to proceed and give possession judicial according to the dispositions of the authority superior of this territory and those of the Supreme Government that with its antecedents has referred under this particular Castro. Constitutional Court of the minerals of San Antonio, August 10th, 1858. Seeing the decree of the Political Sub-Gefatura, dated the 9th inst.. ordering the giving of the possession of the lands of the Ex-Mission of Santa Catarina, let it be performed and executed whatever is required. Proceeding to make the necessary surveys and requirements for which object the party will present his title and other papers necessary, under which order of the adjoining neighbors they shall proceed to take information and identify both before the sight of said land, and also for it marking and surveying. So, I, the Judge, of San Antonio, have resolved and determined before the witnesses of assistance with whom acting for not having the Clerk or Public Notary. Attest: Juan Memdoza. Assistant, Eugene Montenegro, assistant Reyes Rodrego. Immediately the same date, month and year, I, the judge notified to the referred act of Mr. Julio Morner, as Attorney-in-Fact, of D.Recardo Palacio to his person whom I know and after hearing and understanding him. He said that in conformity he exhibited the deeds and papers of his land that he owns in this jurisdiction and lands that belongs to him so that in conformity to the said paper they may proceed to the survey of the lands that in the same are declared and he gave as his answer final, and conclusive, signed with the Judge and Witnesses of his assistance.

In continently on the same day, month and year, seeing and reading the papers concession and presented instruments by Don Julio Morner, resident of the capital of Mexico, in virtue of the notice handed to him setting forth that the said lands had been granted to him by the Supreme Government, and owing that until the conclusion of the survey, the member of sitios cannot be known, as all the lands which belong to the said Ex-Mission have been granted to him so that he may proceed to the survey as ask by these presents, or ordered to be executed, take notice of the identity, information and the witness to be examined possessing any knowledge of the said lands, the terminus and lines, so as to mark the mentioned lands and to provide for the said survey, whatever may be convenient. So has the acting Judge provided, said and signed with those of his assistance according to rights. Attest: Juan Mendoza. Assistant, Eugenis Montenegro. Assistant, Reyes Rodrigo.

Incontinently on the same date, month and year to proceed and gather information of identity that he is determined to receive as it appears in the referred act, appeared before me the citizen, Eleuterio Gilbert, resident of this jurisdiction; profession, Doctor. Married. Forty years of age. I took his oath in form that he made for God our Lord and the Holy Cross under which he promised to say the truth. Being asked if he knew the Exmission of Santa Catarina, her lands, sites and springs, said: that for eleven years he has known said Ex-Mission and that her lands are San Miguel, San Pablo, San Joaquin, La Huerta, of the South side; San Salvador, Santa Isabel, Jesus Maria, Agua Caliente and several other smaller springs and that there is no one adjoining, and that it is for

these reasons that he does not know its demarcations, or lines, and that all he has said is the truth, under the oath that he has taken which he affirms and ratifies declaring that the issues of the law does not interfere with the owner of the lands, and he signed with me and those of my assistance. Attest: Juan Mendoza, Eleuterio Gilbert. Assistant, Eugenio Montenegro. Assistant, Reyes Rodriego.

On the same date, being present the citizen, Francisco Castro, whom I had summoned, and said, His name as already stated; resident of this frontier; married; sergeant, retired from these colonies, I took his oath in form that he made in the name of God Our Lord and the Holy Cross for which he promised to say the truth in all he should know, and was asked. Being asked if he knew the Ex-Mission of Santa Catrina, her lines, sites and what time since he has known them; he answered that he knows the said Ex-Mission and that her lands are the Cienega, San Miguel, San Pablo, San Joaquin, LaHuerta del lado del Sur San Salvador, Santa Isabel, Jesus Maria, Agua Caliente and a portion of a spring in different places, and that her boundaries he does not know where they are as it has no adjoining neighbor, and that for over twenty years he has known the lands, that for a long time he was stationed on the said Mission; that what he has said is the truth under the oath that he has taken, and he affirmed and ratified the same, stating to be forty years and that the issues of the law do not touch him with Mr. Julio Morner nor with his grantor and he signed with me and the witness of my assistance. On the same date mentioned the citizen Jose Maria Nicochea, whom I had summoned, appeared and said: His name as already said, resident of this frontier. Married. Occupation, Farmer. I took his oath in form which he took for God Our Lord and the Holy Cross for which he promised to say the truth in what he knew, and was asked. Being asked if he knew the Mission of Santa Catarina, her boundaries, sites and what time he has known the said Ex-Mission; he answered: That he knows the said Ex-Mission, that her lands are the Cienega, San Miguel, San Pablo, San Joaquin la Huerta del lado Sur, San Salvador, Santa Isabel, Jesus Maria, Agua Caliente, and a number of springs in different places, that her boundaries he does not know as there is neighbors adjoining and that he has known it for nine years. That he has stated the truth under the oath that he took and the same he affirmed and ratified, declaring to be over twenty-five years of age and that the issues of the law do not touch him with Don Julio Morner, nor with the grantor and he affirmed the same with me and the witness of my assistance. Attest: Juan Mendoza, Jose Maria de Necochea. Assistant, Eugenio Montenegro. Assistant, Reyes Rodrigo. In the mineral of San Antonio on the eleventh day of the month of August, One thousand eight hundred and fifty-eight, the Judge of this place determined to summon the Surveyor. Appointed Mr. Cecilio Zerega as that in company with the witnesses and the parties interested they may proceed to acknowledgment survey and to delineate the map of the lands embraced in the Ex-Mission of Santa Catarina. And in testimony that I have so ordered, I signed with the witnesses of my assistance. Attest: Juan Mendoza. Assistant, Reyes

On the thirteenth day of the same month and year, I the Judge of this acts in company with the Surveyor, the party interested and the witnesses of my assistance being on the Ex-Mission of Santa Catarina under my jurisdiction and without an adjoining neighbor, as there is none and being placed on horseback in company with all the parties and witnesses already mentioned, I ordered that they should mark for me the sites, terminus and boundaries of the mentioned Ex-Mission of Santa Catarina. Seeing and recognizing the lands which are known as belonging to the mentioned Ex-Mission of Santa Catarina and according to the title and concession that the Supreme Government has already made of the same to Don Ricardo Palacio, I ordered to proceed to the survey of the already mentioned lands, and in testimony that I so ordered and authorized, I signed also with those of my assistance. Attest: Juan Mendoza. Assistant, Francisco Castro; Assistant asked by Don Jose Hermandez, Reyes Rodrigo.

The fourteenth day, the sixteenth, seventeenth, eighteenth, nineteenth, twentieth, twenty-one, twenty-two, twenty-four, twenty-five, twenty-six, twenty-seven, twenty-eight of the same month and year being in the camp and lands of the Ex-Mission of Santa Catarina of the property of Don Ricardo Palacio, I, the judge of these acts ordered the survey of the square leagues which comprised the mentioned lands belonging to Don Ricardo Palacio, according to his deeds and orders presented and obeying the same, I again measured and exmined the chain, giving the start to the said survey from the last part of the canada, known as La Huerta del Sur taking all the said canada to the descending lands of the Rio Colorado, where the first monument was made, and from the said point in direction to the S.W.

they were measured sixteen leagues and five hundred Mexican varas to the summit of a rocky mountain, where the second monument was fixed, and from said place and forming a direct angle, and passing the whole length of the mountain we measured twenty-one leagues and one thousand Mexican varas to the summit of a mountain that stands to the S.E. of the canada of San Salvador, and at a distance of six leagues from said canada where the third monument was fixed and from said place forming a rectangle and pointing to the N.E., we measured sixteen leagues and five hundred Mexican varas, taking the canada (canion) of San Salvador and crossing the Pinal mountain to the about one and one-half leagues to the N.E. of the descending lands of the Rio Colorado and to the N. 1 N.E. of the place of Santa Isabel where the fourth monument was fixed, and from said place forming a rectangle and pointing to the S.E. we again measured twenty-one leagues and one thousand Mexican varas to the place where the first monument had been fixed. Finishing the said survey, and the lands forming a right angled parallelogram of twenty-one leagues and one thousand Mexican varas in length from N.W.to S.E. and sixteen leagues and five hundred Mexican varas in width from N.W. to S.W., equal to an area of three hundred and forty-one leagues and eight, twenty-fifth parts (8/25) of square leagues, and in conformity to said survey and the map or plat of the referred map of the Ex-Mission of Santa Catarina made, the Surveyor declared that Mr. Ricardo Palacio had full knowledge of the lands belonging to the mentioned Ex-Mission of Santa Catarina, according to the title and concession that he has of them, and without injuring no third party for which I ordered that due notice should be given to Don Ricardo Palacio, that for the establishment and cognisance of the boundaries already

mentioned, he should at his own expense build some monuments of lime and rock to the height of more than one
vara, so that at all times, they will be kept observed
and recognized as the terminus and boundaries of his
lands and for the knowledge of neighbors around and
also to prove that the said survey was made peaceable
and quiet and without contradiction from any person
and so that it will always so appear, it will be signed
by the present Judge, the Surveyor and the Witnesses, of
which I attest: Juan Mendoza, Cecelio Zerega, Assistant
being asked by Don Jose Hermandez, Reyes Rodrigo, Assistant, Francisco Castro.

In the jurisdiction of San Antonio, on the thirteenth day of the month of August, one thousand eight hundred and fifty-eight, after finishing the survey and boundaries and finding the lines of the lands belonging to the Ex-Mission of Santa Catarina, I, the Judge of these acts granted to Mr. Juan Julio Morner, Attorney-in-Fact of Don Ricardo Palacio in the name of the Mexican Nation, real, actual corporal of the lands mentioned in these acts so that he may enjoy peaceable and quiet possession, his heirs, successors, or whoever will represent him or his with its incomes and expenses, springs, grass, timber appurtenances and improvements and other things to it annexed, that legally to it may belong, and in testimony of the truth of possession, I took him by the right hand and performed all acts necessary to take uncontradicted possession from all persons and in these I will support him and prohibit all persons to annoy him before having first obtained legal judgment and before being able to take quiet and peaceable possession, and for its everlasting memory and testimony, I have so authorized and signed with the assistant witnesses with whom I act in

Substitute President of the Republic of your solicitation, asking for the concession to him of the property and lands that belong to the Mision of Santa Catarina on the frontier of Lower California, he has been pleased to accord the concession of the rights that the Supreme Government has on said lands resting on your account to defend the same in case of opposition, and also the expenses incurred in the survey, possession and other expenses necessary: With the condition that at no time they can be conveyed or sell to no individual or individuals who are foreigners and not naturalized in the Republic. Under the understanding that if it is so done, for the said act alone, the said concession will be made

null and the said lands will return and be the property of the nation. So has His Excellency ordered that the same punishment be imposed in case that at the third year from the date of this concession he may not have taken the possession and commence to build also the marking and survey which correspond, of all which operations he will inform this Secretaryship when so verified. All of which by the Supreme order I give due notice to you for your knowledge, and as the result of your referred solicitation informing you that with even date the same is communicated to the Palitical Chief of the territory of Lower California, this resolution for its proper performance.

Witness the definite acts and judgment of the said case: Adopt that which is favorable and appeal from the adverse one as he may see fit to do., And finally perform all the

other acts, agencies and requirements that judicial or extrajudicially are important as for everything said in the annexed instrument an Power of Attorney, I confer ample power without limitation as the case may require and demand with free, open and general administration and faculty and power to sue, swear, substitute in all or portion, revoke substitutes and appoint others with conditions and obligations in his rights necessary. My Dear Sir and Friend:

With four months behind time owing to the great desret that exists between la Paz and the frontier and the great difficulties to remit any correspondence whatever, I have received a letter from the General, Mr. Jose Mat Blancarte, dated at 1856 La Paz, on the 1st of December last for the object of appointing or authorizing me to appoint you according to his own disposition to take the possession of the lands that the Supreme Government has to you granted and which are known by the name of Sta. Catarina, with which letter they forwarded to me the expediente mentioned and corresponding orders for this authorities and they also authorize me to defray the expenses incurred as much for Mr. Blanearte as for Mr. Zenteno who also recommended to me the mentioned transactions. On this last subject I am bound an feel obliged even against my desire to speak frankly as is from me required. As soon as I received the documents already mentioned I appeared before the authorities asking for the said possession believing to be a matter of small expense and that I could very easily pay, but being informed by the Judge of the great amount of lands belonging to the said Mision of Santa Catarina and the steps necessary to perform to make the survey and all other indispensible steps, we came to the conclusion that all the expenses would at least be \$800. Of this amount then it is that we are lacking totally. And as this country is so scarce in money

it is impossible to get on the whole frontier this money. Then knowing that the parties who recommended to me this business have left La Paz, and not knowing the place of their residence, and to avoid more dalayance that may injure your views, I have thought convenient to write to you and expose what I have said, so in case you may wish to provide for all this obstacles that I have before me, by remitting me the money to do so at the return of mail with order on some house of commerce in San Francisco, as it is impossible without this money and it is an utmost impossibility to do anything owing to the reduced circumstances of the Judge, and more, as there is a number of parties interested, ready to interfere in some way the possession, owing to the fact that Santa Catarina are the best lands of all of Lower California. Whatever your determination may be write without failure as direct as follows:

I am determined to leave this country about the beginning of July and if to that time I have not yet received your answer I will without failure wait for it. For two years I have been in Lower California, employed at the Custom House of La Paz having charge of the same and with \$1000 yearly, and I am here as commision of the visitador, Senor Don Jose M.Estera and having charge of the maritime office of this port that it has been supplied temporarily for the foreign commerce, making the exportation of the products of salt which abounds here, but as there is only about 300 inhabitants on the whole frontier there is no

commerce and consequently there is no incomes to the Gustom House, not even to pay my salary, and this is the reason why I intend to soon leave, and to this purpose I recomend myself to you, with the view that if there is a vacant in the one under your charge and you believe me capable for its discharge, you will please, owing to your influence, to reserve it for me. I would like to know the price for which I could sell in Manzamillo or immediate ports a ton of salt in rock of the best quality known to this day in case I could take some, notwithstanding there is abundant quantities in the cost. I hope you will keep well and remit your orders to your affectionate friend,

And His Excellency has also been pleased to confirm the titles that appear in the State which you have forwarded in your communication and being a copy of the one forwarded to Washington to his Excellency the Plenipotentiary Minister, Mr. Jose Maria Mata by the commission of that Political Gefatura, Baron de Morner as long as the possession of the same will comply with the conditions of the concession and to whom will be forwarded by the Government new titles printed, having examined each one of the already given ones which will be sent for examination. And it has also been disposed by His Excellency the President that the product of the referred titles and also that of Guano which you will remit to that of the Consul at San Francisco you will employ in sustaining your authority, applying it to the construction of a municipal house and jail in Santo Tomas, the silver deposited of the ancient missions. All of which I communicate to you in answer to yours in relation to the same for your knowledge and proper ends, offering to you the securities of my distinguished consideration.

Having informed His Excellency the President Substitute of the Republic with your solicitation, indicating that they may grant him the property of the lands which belong to the Mission of Santa Catarina in the frontier of Lower California, has been pleased to accord the granting the rights which the Supreme Government may have on said lands being at your expenses to attend to them in case of opposition as well as all the expenses for it, marking, taking the possession and all things necessary with the condition that at no time he can convey or transfer to no individual or individuals foreigners not naturalized in the Republic with the understanding that if he should so do, with this act alone the concession will be null and the said lands will again return to be the property of the Nation. He has also accorded that the same punishment be imposed in case that at the third year, counting from the date of said concession he may not yet have taken possession of the same and commence to build, as also the marking and corresponding survey, of which operations he must give due notice to this office when so verified. All of which, by the Supreme Command, I communicate for your knowledge, and as the result of your referred solicitation, manifesting to you that with even date it has been communicated to the Political Chief of the Territory of Lower California this resolution for its due purposes.

out failing on account of clause, requisite or circumstance that here may not be referred, fail to answer its purposes for as many as it may be necessary he grants as written as if they effectually were, and that the said grantor would grant if present as in any way which he may practice the same in the same way he approves and ratifies from today. I give, devise, and bequeath one twenty-eighth of all the property I may die possessed of, to my brother Vincent Milatovich; one-twenty-eighth to my brother Andrea Milatovich; one twenty-eighth to Adolpho Givan-ivich; one twenty-eighth to Anna Marchina, sister of my deceased wife; one twenty-eighth to Emilio Polack; one twenty-eighth to Maria Groseta, my sister, and to the church of the Virgin Mary at Stolivo, Austria, one twenty-eighth of the same.

I give, devise and bequeath to my only son, Joseph Milatovich, one-fourth of all the property that I may own at the time of my death, to be delivered to him when he shall arrive at the age of twenty-one.
