

## "Law and California Society: 100 Years of the State Constitution" day-long program at UCSD

## October 23, 1979

A day-long program of lectures, capped by an evening address by California Supreme Court Justice Frank Newman, is planned for Monday, Nov. 5, in a University of California, San Diego symposium on "Law and California Society: 100 Years of the State Constitution."

The symposium, sponsored by Warren College, is designed to provide historical perspective on the California constitutional system on the occasion of the centennial of the 1879 constitution. It will also provide analysis of contemporary problems in state law.

In addition to bringing distinguished lecturers drawn from the California judiciary, the bar, and academic institutions, the symposium will bring to the UC San Diego campus a group of high school and community college teachers of history and social studies, together with selected honors students from San Diego schools who will be the university's quests for the day.

The symposium has been named the Earl Warren Memorial Symposium in honor of the late United States Chief Justice. In connection with the symposium, the California Council for the Humanities in Public Policy has made a grant to KPBS-TV for a pilot television project on the state constitution.

Justice Newman will speak at 8 p.m. in room 2722 of the Undergraduate Sciences Building on the Revelle Campus. The public is invited and admission is free.

"The California Constitution and the Federal Courts: The Second Half Century, 1929-1979," Justice Arthur L. Alarcon, State Court of Appeal, 3 p.m., Humanities-Library Auditorium. According to Dr. Harry N. Scheiber, professor of American history and chairman of the symposium planning committee, the symposium will offer a fresh analytical approach to the subject of constitutional law at the state level. Rather than concentrating on technical legal issues, the lectures will deal with topics of broad social and cultural significance - areas of historical and contemporary change in which the interaction of law and other factors can be probed. "Despite Proposition 13 and the recent problems of the California supreme court," Scheiber said, "few of us are much aware of how deeply California's state constitutional law affects our daily lives and our institutions. We are hopeful that the symposium will contribute to informed public discussion of the issues."
