KOKOPO PATROL No. 7-66/67

For your information please find attached Mr. Nalau's report on the recent D.D.A. visit to the Central Bainings in conjunction with a joint land survey patrol.

Mr. Nalau's observations on current attitudes towards possible extension of the Warangoi settlement scheme should be given the fullest consideration.

I believe the point raised by the Bainings people that the Administration already have bought and left undeveloped large areas of land to be well taken.

In short we may do well to utilize fully Administration land and reserves that we have and to this end I believe some consideration should be given to the fullest possible utilization of Kerevat forest lands for agricultural pusposes.

To purchase further Central Bainings land for the sake of possibly settling a further one hundred settlers at the expense of the Central Bainings people in the long term must only create more problems than it solves in this rapidly changing society.

Mr. Nalau's report and claim for camping allowance are now forwarded to you for your attention.

As you have already visited the area in question, I am sure you will be in a position to give valuable assistance to this patrol and report on the native situation and attitudes in this area to the proposed extension If land resettlement.

I wish you every success on this patrol and look forward to your report on your return.

RE VISIT TO CENTRAL BAININGS

Your patrol instruction 67-2-3 dated the 16th June, 1967 refers.

On the 19th June, 1967 I was accompanied by Mr. D. Shepherd D.A.O and three trainees from Vudal Agricultural College, Mr. K. Gee, Land Settlement Officer, Mr. E. Tuckwell, Regional Forestry Officer and Constable Laman of Kokopo Police in visiting the Central Baining areas of Lower and Upper Warangoi to investigate and report on the suitability for land settlement purposes and the attitudes of Baining people on the proposed scheme.

During the five days visit to the area the following villages were contacted and everyone was advised and it was explained to them what the Administration thought would be the best project to develop in this area economically that may give better help to Bainings and the Territory as a whole. The villages visited were RIET, ARABUM, MARAJAGI and LAMENGI.

In all the villages visited, people were wondering what comes next efter the Copper Prospecting in their areas and all were anxious to know the reason for this visit.

On our arrival at the village, people were advised on the aims of the visit and and asked them all to think and talk it over with their friends and give us their views at nightly meetings. In all villages people were hesit at to give us their attitudes but wanted a meeting of the four villages before they considered any furth purchase of Bainings land.

At ARABUM village, over one hundred male and female adults from the four villages gathered to give us their views. The answers to the projosal was absolutely negative.

Their reasons were that:-

- (a) We don't want Tolais in our area, the reason for this being traditionally the Tolai forced them off their land.
- (b) We sold areas in the Warangoi to the Administration and do not intend selling our remaining land.
- (c) The land which was previously sold to the Administration is still largely undeveloped. We do not understand the pressing need to buy more land.

To comment "C" it was explained that Administration has already decided what to do with that land but the hold up was the financial situation.

DIARY OF THE PATROL

Monday - 19.6.67

The party finally met at Kokopo Sub-District Office - further discussion with Mr. Dickinson A/A.D.C. and then departed for RIET per Land Rovers.

Further discussion with the villagers re the proposed scheme.

Tuesday - 20.6.67

Departed RIET 0800, arrived ARABUM 0920. Further discussion re land settlement and proceeded to MARANAGI.

Arrived MARANAGI within 2 hours walking, talked to the villagers re land settlement and moved on to LAMENGI.

Arrived LAMENGI an hour's walk, further discussion with the villagers re land settlement.

Camped.

Wednesday - 21.6.67

Departed LAMENGI 0830, back to MARANAGI where the party then split. The other half proceeded to ARABUM and to RIET the next day, while myself and Mr. D. Shepherd spent a night at MARANAGI.

Visited coffee gardens and further talks on land settlement.

Thursday - 22.6.67

Departed MARANAGI 0830 back to ARABUM. Over 100 people from LAMENGI, MARANAGI, ARABUM & RIET turned up and discussed the proposed scheme.

Their attitude towards the proposed was absolutely negative.

Camped.

Friday - 23.6.67

Departed ARABUM through wet and slippery track to RIET and then proceeded to PUBUANA Plantation in order to be picked up by car.

Picked up 11.30 by cars and back to Station.

END OF PATROL

During the five days observations, Mr. D. Shepherd, area might discourage the growing of cocomuts and cocoa but

Mr. K. Gee recommended that the area surveyed is sufficient for a hundred settlers or may be more.

Mr. E. Tuckwell, during his forestry observations, said logging. There are several KAMARERE found along the river banks and the foothills which is of great interest, but communication is the problem.

The full reports on the survey will be submitted by the patrol.

In summing up, I personally believe that none of the Bainings would like to live next to a settlement area nor would they apply for the blocks as the example is seen from Warangoi Settlement where only three Bainings have applied for blocks. There is a definite distruct where Tolais and land is concerned. If further land is purchased the Central Bainings people would be left with only mountainous ridges and no agricultural future of their own.
