Receipt of the abovementioned Patrol Repart is anknowledged with thanks.

It seems that the people regard money as something with magical proporties and they are keen to acquire it because of this.

I think the scheme of the Councils making payments for road work from funds made available through the Administration is sound and should be followed.

The Wadag people have a bed name with employers. They will have to redeem themselves if they wish to have opportunities to obtain cash. Mr. Cawthorn appears to have made good use of his time in meeting the people and showing an interest in their problems.

Extended visits such as this to areas are much more effective than a patrol which just passes through the area, remaining overnight only.

## MABAG PATROL REPORT No. 3/1962-63 - AMBUM GRAGUS DIVISION. MR. W.A. CAMTHORN.

Your memorandum 67-1 dated 22nd November, 1962 refers.

However in many respects they have brought this upon themselves. Firstly, about a year ugo they had the opportunity to cut bridge decking and some six pitsaws were obtained on loan from the Londol Mission for this purpose. They did not cut any timber notwithstanting the fact that the same price is paid throughout the Wabag area for timber. Secondly, by their laziness and riotous nature they have closed, for the time being, their avenue of bringing money back into the area through employment in the Highland Labour Scheme. A year ago active recruiting was taking place in the Arbum in an endeavour toffill the Highlands Labour Scheme requirements. Since them not one has been recruited. Meetings to discuss this serious situation will be held next week and I would suggest that the Ambum leaders at least join the meeting at Nubelis.

Fear of taxation is not warranted. If the people in the area are really poor them a special rate can be struck for them. I homest ly do not consider that they are worse off than people above Kubalis in the Upper Lai and Lai Headwaters Census Divisions.

The regment for road maintenance is small but all that can be afforded. The pay ent made by Mr. Cawthorn would be a quarterly and not a yearly one. When the area is placed under Council Control the road maintenance payments will be made in a lump sum to it, as in Mount Hagen. These sums look quite respectable when brought up in Estimate Council Meetings.

I cannot see any point in appointment of Village Officals at this late date. They have only six months to serve.

A comprehensive report covering the patrol which accomplished all it set out to do. The Anthropolégical report is very interesting. Appendices covering other departments have been brought to their attention.

Vith the funds available for he is mainten ance, I feel they would be better spent in payment for get specific jobs, such as bridge repairs, rather than a flat rate payment to all econom, which as Mr. Cauthorn points out, results in an economy payment of a milling or so. As these roads are secondary replay the provinces of the Seas Maintenance Ordinance require maintenance to be form as a duty by landounces along the roads.

The contact value of a read patrol a.ch as this is considerable, and of more value probably that a routine conses patrol which normally is only in a particular area for a day or so. Mr. Saythorn appears to have made good use of his time in meeting the people and showing a relinterest in their problems.

#### DIARY

#### Puesday, 26th. June, 1962.

#### WABAG - TSIKIRU

Left WABAG at 11.0 a.m., by car, for TSIVINU Rest House in the AMBUN Taggs Valley.Arrived there at 12.45 p.m.Settled in and later spoke to all village officials in the area advising them of the reasons for the patrol, and informing them of their respective tasks on the road. Inspected TSIETRU Aid Post.

TRIKINU - 6,800 ft.above sea level.

Wednesday - 27th June, 1962.

#### AT TSIKINU

Started off for MONOGAN at 8.30 a.m. to inspect the read. Sew what work there was to be done and instructed the various village officials, who were all at their respective sections. While returning in afternoon spoke to all class concerned in the readwork, who were assembled at their read sections. Arrived back at INIKING at 4.30 p.m.

#### Thursday, 28th, June, 1962.

#### -> ISIKIBU

Worked out the amount to be paid to each group in the AMBUH Valley for read maintenance. Then set off in the direction of VARAG inspecting the read. Not the c.B.O., Mr.G. Hardy, on his way to TSIKIRU, continued on Returned to TSIKIRU at midday. In afternoon all local people assembled at TSIKIRU Heat House to listen to Mr.G. Hardy speak to them about Local Government.

#### Friday, 29th. June, 1962.

#### AT TSIKING

A.D.O., Mr.G. Hardy, moved on to MONOGAM. Inspected road as far as EUNDIS.

Left the road there and walked up to the EALAP Ridge to see how work was
progeosing on the sawnill road. Then returned to EUNDIS and back along the
AMBUN road to INIKINU, arriving there at 6.0 p.m.

Heard some petty disputes in the evening.

#### Saturday, 30th. June, 1962.

#### AT TSIKIRU

Walked as far as MONOGAM inspecting the read, returned midday. Rain early afternoon, later supervised work on the read in the vicinity of TSIKIMU.

#### Sunday, 1st. July, 1962.

#### AT TSIKIRU

Observed at TSIKIRU. Witnessed traditional local ceremony associated with initiation of youths. (See Anthropology appendix).

#### Monday, 2nd. July, 1962.

#### AT TSIKIHU

Walked again along the road as far as KUNDIS. On return assembled each group in turn and spoke to them re future work on their respective sections or road.

During evening heard another dispute between some people from the MARAMUNI, disputents sent into WABAG.

#### Tuesday, 3rd. July, 1962.

#### TSIKIED-MOROGAM

Departed TSIKIRU at 9.0 s.z. Inspected road on the way, much improved Arrived MCNOSAN 11.30 s.m., paid carriers off. Sept word along road as far as LONDOL for all village officials to assemble t MCNOSAN. Inspected Aid Post. During aftermoon spoke to assembled village officials and explained purpose of patrol, all told to wait at their road sections tomorrow.

Heard some petty disputes in the evening.

MONOGAM - 7,050 ft.above sea level.

#### Wednesday, 4th. July, 1962.

#### AT MONOGAM

Walked as far as LOHDOL inspecting the road.Explained to each and must be done to improve their respective sections of road.Extur MOGAN by 5.1; p.m. Heard some petty disputes in the evening.

#### Thursday, 5th. July, 1962.

#### AT MONOBAN

spected work on road towards fSIKIHU. Talked to all groups sted all re further work. Also inspected work on part of re

#### Friday, 6th, July, 1962.

#### AT MONOGAM

Assembled two groups, from the area near TSIKIEU, who had been fighting on the road yesterday and spoke with them to ascertain the reason for their dispute. Evidently it was ever the cetting of a tree for use in a small bridge on the road. The fight was not particularly serious, only with sticks and stanes, however the main offenders were sent into WARAG for trial to discourage any more rioting in the future, later inspected the road between TSIKIBU and MONCGAN again.

Beard some more petty disputes in the late afternoon.

### Saturday, 7th. July, 1962.

#### AT MONOGAM

Inspected road on either side of MONOGAN. During afternoon witnessed re-enacting of an old traditional ceremony by some local natives. (See the re-enacting of an o. Anthropology appendix).

#### Sunday, 8th. July, 1962.

#### AT MONOGAM

Observed. During afternoon walked in the vicinity of MONOGAM inspecting houses and gardens.

#### day, 9th. July, 1962.

AT NOTOGAM

Walked to PSIKINU inspecting the road. Parts of the road new finishe completely. During afternoon inspected road on the other side of HOMOGAP, and told one group to start clearing g an area of ground for the new Res House to be built at HOMOGAN.

#### Inesday, 10th. July, 1962.

#### AT MONOGAM

Walked to LCHDOL inspecting the road and giving further further instructions re the road work. Returned about 3.0 p.u. and heard petty disputes for the rest of the afternoon.

#### Wednesday, 11th. July, 1962.

#### AT MOROGAM

Inspected road on either side of MCNOGAM. Marked out plan of new is at NCC-SAM. Instructed those groups which had finished work on the start collecting materials for the new Best House.
Heart some were putty disputes in the evening.

#### Proceed 7, 12th July, 1962.

#### MCNOGAM-LOWDOL

Left for ICHDOL at 9.15 a.m. Inspected road on the way and stopp talk to all groups working on the road. Arrived LONDOL at 10.45 a.m. After Ismoh walked from the Best House at LONDOL to the end of amount road, at the Cathalie Mission, and gave instructions re improving All groups assembled for work All groups assembled for work
Had informal discussion with local village officials in the eve

#### Pricey. 13th. July, 1962

#### AT LONDOL

Walked towards MCHOGAM inspecting work on road. Received note from D.O., WABAG, ordering return of patrol to WABAG, Heavy rain all afternors at standatill.

#### Saturday, 14th. July, 1962.

#### LONDOL-WARAG

During morning packed gear them supervised work in vicinity of Rest House, Car arrived at 3.0 p.m. and so departed for WABAG, leaving some patrol gear at LONDOL.

The next two weeks spent with Agricultural Officer, Wabeg, collecting information for the Land Vae Survey.

#### Buenday, 31st. July, 1962.

#### WARAG-MERATMANDA

Left WARAG by our at 9.15 a.m. for MERATMANDA, on the KOMPIAN road. Inspected road as far as the POGERA Ck., on the WARAK-KOMPIAN boundary. Instructions to all s re further work on their road. During evening spoke with local village officials.

MERAIMANDA - 7,700 ft. above sea level.

Sent all goar on to YAMFU at 9.30 a.m. Followed later with village officials and paced the rest of the road as far as the AMBUN road, accertaining the size of each section. Then worked out the payments due to each group on this road.

Buring afternoon assembled all local natives. Counted them also and spake to them on what work they night expect to do on their road in the

future.

YAMPU - 6,600 ft.above sca level.

Friday, 3rd.August, 1962.

YAMPU-YABAG

Inspected road work in the vicinity of YAMPU. Heard some petty disputes. Then into WABAG by car suring afternoon.

Weekend spent in MOUN' HAGEN.

Vednesday, 8th. August, 1962.

WARAG-LONDOL

Departed W/BAC at 10.0 a.m., by car, for LCNDOL, arrived midday. In road between Rest Rouse and the Cathalic Mission, found to be in good Inspected Aid Post, not completed but should be in only a few days. Sp al the natives working on the Aid Post and told them to have it finished. week. Talked informally with the local natives in the evening.

Thursday, 9th, August, 1962.

AT LONDOL

Walked to MONOGAM inspecting the road, nearly completed. Fointed out to all what work still remained. Inspected amount of material collected for nearest House, told to have enough collected by Tuesday. Inspected a section of road on the other side of MONOGAM, also in good order. Then returned to LONDOL.

Arranged carriers to take into the MARAMUNI Valley tomorrow, in accordance with instructions given verbally by the A.D.O. in WARAG. Exchanged a Tul-tul's insignia to a younger member of a clam at the request of the former holder, and at the A.D.O.'s instructions.

Friday, 10th. August, 1962.

LONDOL-NUNGUS ZANZ(Bush Camp)

Actual Walking Time : 8 hrs. 40 mins.

Set off, with 10 carriers and am 1 policemen, from LONDOL at 6,20 a.m.

WOILEP - 6,000 ft. above sea level.

Sunday, 12th, August, 1962.

WOILEP-IDAPCGARES (Bush Camp)

Actual Walking Time : 7 hrs.

Started back to LONDOL at 6.30 a.m., arrived SUI River at 8.30 a.m., crossed and rested. Moved on up the ridge at 8.30 a.m. Rested at the end of the elegand track at 10.16 a.m., a substantial het was built here. Moved on a 10.35 a.m. Arroved large grass patch at the ridge top at 12.20 p.m. and rested. Heavy rain so noved on at 12.45 p.m. Arrived shelter where lunch had been eaten on Friday at 1.40 p.m., so rested and ate here. Rain stopped. Moved on a 3.0 p.m. Orossed AMBUN River at 3.30 p.m. Arrived at well made shelter at 4.5 p.m., camped here as rain had started again.

IDAPOGARES - 9,600 ft. above sea level.

Monday, 13th. August, 1962.

IDAPOGARES-LONDOL

Actual Walking Time : 3 hrs. 5 wins.

Broke camp at 7.30 s.m. Rested on mother ridge top at 8.35 p.m. Moved on at 8.45 s.m. Arrived junction with KAVIMTOK track at 10.25 a.m., rested.

Moved on again at 10.35 s.m., arrived LONDOL at 11.5 a.m.

Inspected Aid Post, which had not been finished yet. Spoke to the assembled natives at the Aid Post.

Heard some petty disputes during the evening.

Dassday, 14th. August, 1962.

LONDOL-MONOGAM

Left for MONOGAN at 9.0 a.m. Sent all gear shead and followed after, inspecting the road. Practically finished now. Those officials whose sections were not completely finished were told to have them finished by the end of the week. Road maintenance payments were given to those groups who had completed their sections.

During the afternoon started work on the new Rest House at MONOGAM.

Heard some petty disputes during the evening.

Wednesday, 15th August, 1962.

#### AT MONIOGAM

Worked all day on new Host House. Gave instructions to all groups re collecting more materials.

Thursday, 16th. August, 1962.

#### AT MONOGAN

Inspected road towards LONDOL, now completed except for two bridges. pleted all road maintenance payments in this section. Rebuilt a bridge continued on the Rest House.

Friday, 17th August, 1962.

#### AT MUNOGAM

Worked all day on Rest House, framework now completed. Reard some petty disputes during the evening.

sturday, 18th August, 1962.

#### AT MONOGAM

Continued work on Rest House.Mr. N. Davis, E. M. A., arrived here, from Lon patrol. End informal discussion on land matters with local natives during the

Surday, 19th. August, 1962.

AT MONOGAR

Observed. A wet, dismal day.

Monday, 20th August, 1962.

#### AT MONOGAM

Mr. H. Davis moved on to TSIKIRU during the morning. All groups assembled in force for work on the Rest House today, bringing the rest of the materials to make the it. Work continued on it all

Thesday, 21st. August, 1962.

AT KONOGAM

Work continued on Rest House takey today and by end of day it was nearly finished.

Wednesday, 22nd Angust, 1962.

#### MONOGAM-TSIKIRU-KAKK

Sent all gear shead to TSIKIRU at 9.0 a.n.Stayed on to supervise work on Rest House for the morning. Received note from O.I.C. Wabag, ordering the patrol to return there today. So set off for TSIKIRU paying all groups on that sections of road their road maintenance money. Road between MONOGAM and TSIKIRU now completely finished.
On arrival at TSIKIRU paid all proupsies far as KUNDIS, their road

is also now completely finished.
Returned to WARAG late afternoon leaving all goar at TSIKIRU.

#### Thursday, 23rd. August, 1962.

#### TSIKIRU-WATIAG

Tractor sent from WABAG to collect all patrol gear and personnel in the morning Next few days spent in WABAG and MOUNT HAGEN,

#### Monday, 27th. August, 1962.

#### WARAG-MCNOGAM

Set off back to MONOBAM by car at 10.15 a.m. On arrival moved into new Rest I was, now nearly finished. one more work done on Rest House during afternoon.

#### Tuesday, 28th. Aug. st, 1962.

#### AT MONOGAM

Worked on Rest House, bemboo flooring finished and doors made. Roud maintenance payments given to all groups on the KOMPIAN road. Payments for planks and logs given to their wners.

#### Wednesday, 29th. August, 1962.

#### AT MONOGAM

Work continued on Rest House, only concerned with finishing off now. Some petty disputes heard during the evening.

#### Thursday, 30th. August, 1962.

#### AT KONOGAM

All groups athered at Rest House and cleaned the surrounds. House completely finished today. Payments for all bridge materials completed today also. Spoke to assembled people during the afternoon re looking after the road in the future.

#### Friday, 31st. August, 1962.

#### MONOGAM-WABAG

Prepared all patrol gear for removal to WABAG. About midday car arrived and took complete patrol back to WABAG. Patrol anded.

END OF DIARY

This patrol was not of a routine nature, and so the whole of the AMBUM Census Division was not patrolled. The patrol spent most of its time

between TSIKIRU and LONDOL doing roadwork.
This part of the AMBUM Valley road was completed in June, 1961, however it was never ir very good conditionand the local natives did not take very good care of it. Lately a number of complaints were received at WARAG due to the very condition of the road; it was often impassable due to landslides and most of the bridges were in a bad condition. Consequently this patrol was launched at the end of June to try and improve this situation.

This was the main purpose of the patrol. However there were other jobs to do, such as the building of a new Rest House at MONOGAM, the investigation of a new entry route into the MARAMUNI Valley with a view to its improvement, the building of a new Aid Post at LONDOL, and the paying of road maintenance money to all groups on the AMBUM and KOMPIAM roads. Some days were also spent on the KOMPIAM road in an effort to improve it.

No great trouble was met with on the patrol, the natives were, on the whole, co-operative. Unfortunately the patrol was often broken, hence its long duration, however this did not interfere greatly with the work, as whenever the patrol left the area the inhabitants kept working.

Most road natrols are usually unorthodox in that a long time is

Most road patrols are usually unorthodox in that a long time is spent in the one place, the focus of the attention of the patrol is on the road, not much is seen of the surrounding area, and quite often the patrol's welcome wears thin, owing to the fact that while the patrol is in the area it means work for all the local inhabitants. However there are also advantages to this type of patrolling. The fact that one spends a long time in one area ennables one to get to know the inhabitants of that area; the usual diffidence with which a patrol is usually greeted by the people is dispersed greatly when one spends a time in their midst. During this patrol some native ceremonies were attended by the writer, at the request of the ratives, and often informal discussions were head with them on various subjects. Consequently a more friendly atmosphere was maintained between the patrol and the natives than is normally met with on routine patrols. This ennabled the writer to understand these people better, and them to understand the government, through it's representative, better.

By the end of the patrol all it's aims had been carried out successfully. Fowever the road still needs constant maintenance to keep it

successfully. Kowever the road still needs constant maintenance to keep it

up to standard.

#### Native Affairs:

The native situation in the AMBUM is good and it seems better than in most mass places in the LAI Valley. During the two months spent in the area no serious trouble was met with. Actually the only trouble occurred while the patrol was at MONOGAM. Two small groups, while working on the road, had quarreled over a tree which had been cut by one group for use one a small bridge. The quarrel had turned into a fight during which both groups threw stones et each other until one of the groups turned and fled. Both groups were assembled at MONOGAM where the cause of the fight was ascertained. The casualties were negligable, one man had a split lip another a fairly badly cut head. Six men, the ringleaders, were sent into WABAG with & policeman where they were charged and convicted. The rest were reprimanded and one of the groups told to work on the road near MONOGAM so that the dispute would not flare up between them again. Apart from this incident the only other trouble encountered was two disputes over the positioning of road marks between different groups. However these were quickly settled before they assumed any importance.

As regards work on the road not much trouble was met with. When the road marks until they were completed. In addition they were all told what had to be done to their marks to bring them up to a suitable standard. All groups then continued to arrive for work each day until their particular road marks were completed. No trouble was met with re absenteeism on a large scale. Only at LONDOL was their any trouble with work and that was only with work on the Aid Post. For instance, while the patrol was in the MARAMUNI none of the natives arrived for work on it, however on the patrols return they were spoken to and they then finished the Aid Post by the end of the week. The LCNDOL people are perhaps the worst group in the AMBUM Valley,

they are very disobedient and reed costant supervision ing a job of work. Until recently their section of the AMEUM Valley road was disgreceful, often impassable.

The AMIUM road is still "settling", that is it is still finding its level. Where it has been cut into a steep slope, the slope continually slides down towards the river, covering the road. At times of rain it becomes much worse, a single area can be cleared as much as five times in ane week. Some areas of ground bordering the road have a break as much as from twenty to thirty yards from the road, consequently there is a tremendous area of ground continually sliding over the road, clearing it only clears the way for now ground to force its way over the road. Under these circumstances any lack of enthusiasm in this area for roadwork can be understood. However, despite this, attendance for work was always good, and the work was finished as quickly as possible.

At the moment the main interest of these people is in money. In the near future this could become a source of annoyance, and even trouble, to the Administration here. Of course all ENGA people seem to think of nothing else but money, but with these people it seems more of an obsession than with most. The reason is that they are not near enough to WARAG to benefit from the sale of vegetables, etc., to the station, however they are near enough to "civilization" to feel keenly the lack of money. Now, with must talk of the coming of Local Government Councils, they are wondering how they are going to pay their taxes and are becomming quite worried over this. It was explained to them that they did not necessarily have to pay taxes in money, however the knowledge did not change their attitude. Some trouble was met with in obtaining firewood and fresh vegetables as they all wanted money for them. They also expressed dissatisfaction for the amount they received for logs and planks used in building bridges. It seems possible that in the future they may even refuse to supply such articles, unless they receive adequate payment for them. At the moment this provides their only income, a very precarious one. The sale of fresh vegetables is limited to the few missions in the area and the occasional patrol. Work on the coast is now shut to them, there seems to be no other form of income oper, to them. It will not be suprising if in the near future, seeing the increasing need for a person to have money and not having any way to obtain it in sufficient quantities, they have occasion to make a strong protest in the on the government has put them in Because before government centrol they had no accasion to use money and so did not riss it; however now the government has improved their lot and has brought a host of new things in its train, which it is essential for them to buy to remain maintain their self-respect in a vastly superior community, they have no money to buy them with thes supplied them with the means to lose it.

This outlook is not a purely materialistic one, that they want more money to buy better things and live easier, it goes deeper than this. They just do not think that there is any future for them at all without money in this "new" world they now live in.

The AMBUN people are of ENGA type stock, consequently not a particularly good type. However there is every reason to believe that they would be more co-operative if they could get more personal and material help from the administration.

#### Roads and Bridges:

The section of road worked on this patrol, was approximately half the AMBUM road, from LONDOL to KUNDIS, and the WABAG part of the KOMPIAM road, from the WABAG-KOMPIAM border at the POGERA Ck. to where the road joins the AMBUM road, past IAMPU.

When the patrol arrived in the area the AMBUM road, especially between LONDOL and MONOGAM, was in a very bad condition, often impassable due to landslides. Also, near LONDOL, the bridges were particularly bad. Between TSIKIHU and KUNDIS the road was moderate, mainly due to a lack of gravel on its surface.

The patrol started at TSIKIRU. Work on the road from there to KUNDIS consisted only in spreadin gravel over those parts of the road which were lacking in it, and also renewing the numerous small bridges over the drainage ditches, These small bridges are a great hazard on this road as,

for the most part, they are bailt on a different level to the road and are not made at all well. All these bridges were renewed and were covered with earth and gravel, and levelled off with the road; this proved a great improvement. Only one of the larger bridges on this section of the road was renewed

Between TSIKIRU and MONOGAM the work was mainly the same, that is gravelling and renewing culverts. However on this part of the road a few lasslides occur, and consequently a large part of the work consisted in removing the unstable ground, rather than have it fall onto the road at a later date. One large bridge was renewed on this section also, the logs and the newly-cut planks were paid for. There is no great trouble with the road in this section either.

The last section, from MONOGAN to LONDOL, was definately the worst. First of all the landslides were cleared off and all unstable earth removed. Then gravel was spread on the road and all culverts were renewed. All the bridges on this road are not at all good; the approaches are hazardous, the planks are badly cut and often rotten, on some the bearer arm logs are to fatte adequately carry the weight, often some of the logs have sunk down making the approaches dangerous and sometimes tilting the bridge, also none of them had roofs built on them. The approaches were remade as much as possible in the time available. All available planks in the area were bought and were put on those bridges needing new ones. Two bridges were completely remade and three were straightened by lifting and strengthening those logs which had sunk. All the bridges had covers built over them; these keep the rain from rotting the logs and also makes the planks less slippory on wet days.

This part of the road follows up the AMBUM Valley very close to the river, consequently there is also the trouble of the river undersetting the road. In many places on this section the edge of the road often breaks away. However only in one or two places is this serious. One place in particular, between MONOMAN and LONDOL is particularly bad. Here the river comes in a curve against the road, nearly on a level will with the road. Then in flood the full force of the river hits the edge of the road, so far it has taken about 10 yards out of it. Added to this there is a large stone in the cliff on the other side of the road, hence a car must cram between the out-thrusting rock on the one side and the in-thrusting river on the other. Some months was an attempt was made to divert the river past this corner and it not with some success, however at times of flood it continues to cut into the road and the rock was broken back level with the cliff. Grups in the area were then told to gather at this point and work on the new river bed to divert the river past this point. Unfortunately the patrol had to leave the area before the work could be supervised. Ferhaps the next patrol to the area could make sure that this manner. is done.

There does not seem to be any way to overcome the problem of the continuous landslides in this area. The only thing to do is just to continue to clear away the ground as it covers the road until the ground finds a level of stability.

About five days of this patrol was spent on the KCMPIAN road supervising the work there. It consisted mainly of putting stone on the road. Most of this road follows along the ridge tops, consequently there is not much trouble with landslides, also the bridges are few and far between, However they, too, have their troubles. In their ase it is the scarcity of gravel in the area. It is actually non-existent except near the WARAG-KOMP-IAN border. These people have to dig stone cut of the ground at a place about 2 miles away from the road. Actually it is not even stone but a type of hard ground which, in time, will be absorbed into the road. Consequently it will be a continuous job to stone this road. Also the fact that here there is a very small population makes the job doubly hard.

While in the area the whole of the road, from the FOGERA Ck. to the AMBUN road, was paced, to ennable the calculation of their various road maintenance payments to be made. The length of the road is 6% miles, the total male working strength is 185 persons. This gives each man an average 2.8 chains of road to maintain.

On the AMBUN and KOMPIAM roads, road maintenance payments were made to all groups by this patrol. In all cases they were wholly inadequate.

actually it would probably be better not to make the payments at all, but to have the groups maintain their particular sections of road as a necessary chore, until the administration would take over all road maintanance. However irksome the work way be to them they would still be content to do it, as they have been doing it for some years, and would realize it was a necressary colors. However, now that they get paid for this work, they will regard it as a sort of job and, if they think the pay is too low, they will probably refuse to do it. Even with this first payment they were a little embarassed at its paucity, in a year or two it is improbable that they will

embarssed at its paucity, in a year or two it is improbable that they will work for such pay.

On the AMBUM road each man averaged 1/- for a years work on a pin piece of road averaging i chain per man. This does not include the women, who also work on the roads. On the KOMPIAM road each person, including the women, averages 6/8 per year for a section of road averaging 1.3 chains an These payments are ridiculous, even for WABAG natives. In the time the path was in the area (approx. 2 months) each person did enough work to warrant a payment of at least £1 each. It was almost embarssing to have to distribute money which they did receive. It would be much better to either stop to payments or to increase them considerably. Surely this money could be put better use at the moment!

During this time the patrol went to WOILEP, in the WARANGENI Valley, to investigate a new access route into the MARAMUNI from LONDCL. However a this route is more concerned with the MARAWUNI people than with the AMBUR the MARANINI.

#### Village Officials:

There are no out/tanding officials in the area visited by this patrol, like all most WARAG officials they are only medicere. This is due

patrol, like air most WARAG officials they are only mediocre. This is due mainly to their timid approach to their job, they are scared to exert their authority in case they lose popularity with their clamsmen or are accused of "bignoting" themselves. A ded to this, the ordinary people tend to play each official against another.

The large number of officials in the area do not make for efficiency, as often they will controlled one another. However a suggestion which might overcome this difficulty is the appointment of one Iuluai in each area (LONDOL, NONOGAM, TSIKIRU) as the head man there, not a paramount Iuluai but just the chief Iuluai in each particular area. He could have the last word on all the petry disputes which aren't settled by local officials, and could also be a person on whom an officer could rely while patrolling his area. It would also tend to lessen the emphasis on separate Clan and Sub-clan envirety which personal officials tend to make. In the LONDOL area the ideal man seems to be Iuluai EMAPA, in the MCHOGAM area Iuluai IUBI", a very hard worker, in the TSIKIRU area Iuluai TAKALIR. worker, in the TSIKIRU area Luluai TAKALIR.

While the patrol was in LONDOL, in accordance with the A. D. O. Wabag's instructions, the WAINARA-NALYA Clan was assembled and fultul IPI's badge was givens to YANGARI-ANEP, elected by unanizous assent. IPI, at his own request, was relieved of his badge, he was becoming to old to perform his duties adequately. Perhaps the next patrol in the area could confirm, or otherwise the appointment of YANGARI-ANEP in IPI's place.

#### Missions:

The predominant Mission in the area is the Roman Catholic Mission, followed by the Lutheran Mission(Missouri Synod) The Seventh Day Adventist Mission has some native evangelists in the area.

The Roman Catholic Mission has European missionaries placed strategically right down the valley, at LOY DOL, TSIKIRU, YAMFU and PAR. Apart from these places there are native evange ists throughout the valley.

LONDOL - A Buropean Father here. He has a school which teaches as for as Standard 2 and a large church. All buildings are grass and pit-pit.

TSIKIRU - Has a European Pather stationed here. Also a school, which teaches to Standard 3, and a church, All the buildings are made from permanent materials, the murch is under construction.

YAMPU - Two European nuns and a European missionary are stationed here, they run a Hansenide Colony. All buildings are made from native materials. There is also a small school and Aid Post.

PAR - A Buropean Father is stationed here also. There is a fairly large school, which teaches to Standard 3, and a church. All buildings are made from permanent materials. There is also a small airstrip.

MONGAN - No European Father here, it is run from TSIKIRU. A large native material church is being built and two school rooms to teach up ton Standard 2.

The Lutheran Mission has a station at KUMDIS with a Buropean Missionary. There is a school there, teaching to Standard 2, and a church. At the moment a permanent material schoolroom is being built there and it is hoped to eventually teach as far as Standard 6. There are no other Buropean missionaries from the Lutheran Church in the AMBUN Valley.

Most of the Nissions have been in the area for some years are settled well in. The natives have accepted them well and conseque there is no trouble with them over Mistaons. The Missions seem to be a lot to help the natives of this area.

#### Law and Justice:

Buring the patrol numerous petty disputes were brought before the writer for arbitration. The main cause for litigation was , as usual, land. Practically the only others causes for these disputes were woman (that is wives) and pigs.

They do not have much ability to settle domestic troubles and often bring them to the patrolling officer, in his role as marriago comer. Approximately five of these domestic disputes were brought before the writer during the time spent in this area, in all cases the wives were claneouring for separation. When speaking with them the trouble always set to boil down to an uncooked neal for a hungry husband, some time being with relatives, or hasty words during a quarrel; usually only small reasonable not say much for these peoples self-sufficiency when slight do troubles are brought up for a public airing before government officers. However it does not seem to the writer that an adequate remedy for the 'petty disputes' is a refusal to hear them, this would only serve to an onise the people.

Pigs and land are the causes of great discord between these people. In the past, and even now, many bloody fights have been started by a dispute over land or a pig ruining a garden, consequently the writer holds to the view that all troubles over pigs ar land should at least get a hearing until one can ascertain their importance, although, especially in the case of land, they turn into shouting matches between the disputants. During this patrol numerous disputes over pigs were brought up for a hearing. All were settled through discussion between the ittigman litigents. In most cases all they seem to require is an ordered discussion with a 'kiap' presiding. This does not include pig exchanges connected with the local 'Te' gift exchange ceremony. Usually disputes over these are so complicated and involve so many people the only thing to do is to refer them back to their village officials for discussion and settlement. As the officials know the local customs intimately and as often they have a many ledge of the various. customs intimately and as often they have a m knowledge of the various exchanges made in a particular case, they are often a much better choice to settle the case.

At this time a land dispute was brought before the writer involving a block of land which had been fought over. by two Clans only a year of so previously. After leaving good the dispute had not been settled and it had boiled up again on a number of a occasions since. The land had been we in a fight many years previously and since then the victors had remained in a fight many years previously and since then the victors had remained on this land. Now, with the coming of law and order, the losers began agitating to get their land back, the victors naturally being loths to return it.

They were told that they could not get back this land in a court of law, and it was suggested to the losers that they buy back the land in accordance with native custom. They were warned of the futility of fighting over it, as the patrol a was leaving the area they informed the writer that they were preparing to buy back their ancestral land; so it is to be hoped that this particular dispute was will not crop up again in the future.

A case was also struck where two clans associated a road maintenance wark as an official government wark between tribal lands. Before the patrol had arrived in the area a full-scale fight had been waged over this.

road mark concerned only that area of land covered by the road, and though a
often corresponded to tribal land boundaries it not necessarily have to.
Once this point was made clear to them they ceased creating anymore disturb
ances.

This same association of road maintenance marks with government-sanctified tribal boundaries has been noticed by the writer in many places in g the Sub-District. At the best the Clans employ themselves in removing the marks and putting them where they think they should be, at the worst they fight over them. It does not seem an important thing to provide so much trouble, but, the fact that it is, only serves to emphasize the great importance of land to these people.

#### Resthouses:

Only five resthouses in the AMEN'M Valley were used by this patrol, all being beside the road.

The Rest House at LONDOL, at the end of the road, is not in good condition and needs renewing. However no instructions were given to renew it as all natives were working on the new Aid Post there. Perhaps the next patrol could look into this.

The next Rest House further down the road is at MONOGAM. The Best House here was renewed during this patrol. Then left to themselves the native do not make a good job of resthouses and seldon finish them off well. Consequently they do not last and do not even provide a modicum of confort on patrol. To make a decent job of them they really need to be supervised by either a policeman or a European. That the natives are capable of making a good resthouse when supervised is shown by the job they made of the HONOGAM Rest House. It is far superior to others in the WARAG Sub-District, and they have made it roomy and comfortable and built it to last.

At EDIFIEU the resthouse is only fair; but as here, too, the natives are engaged in building a new Aid Post, no instructions were given to them to renew it. The local officials volunteered to renew it once the Aid Post. was finished.

The other two resthouses visited by this patrol are on the KCMPIAN road, at MERAINANDA and YAMPU. The one at MERAIMANDA is new but a very "Heath-Robinson affair, however the one at YAMPU is much better and in fairly good condition.

#### Conclusion:

During the extent of this patrol practically every native man and woman in the AMBUN Valley between LONDOL and KUNDIS came into contact with the patrol continuously; some, between TSIKIRU and LONDOL, practically every day for two of three weeks. Consequently a good idea of their general attitude towards the administration was gleaned. They are generally a very apathetic people who seem to take everything as it comes. They have a natural antipathy to work, but no trouble was set with in the two months that they worked on the road. Through talking to them they seem to realize and even appreciate, though to a small extent, the way the government is helping them, but the majority seem to take this aid for granted. They are still in a comparatively early stage of government contact and this attitude could well be expected, though it does seem to be deeply ingrained into them.

They were found to be fairly co-operative to the patrol, but they

had to be hounded in their work, if unsupervised they tended to slack off.

The native situation is fairly stable on the whole, the only trouble is over that area of land which two Clans claim the rights to, this is a common cause of unstability throughout the Sub-District. Of all the AMBUM people, those around LONDOL seem to be the worst, probably because of their distance from the Administration station. In the future they could well do with a little more direct supervision.

#### APPENDIX "B"

#### Medical and Health:

The ANSUM Valley has a fairly good health coverage with Aid Posts all the way down the Valley. Only those Aid Post at LONDOL, TSIKING and MONOGAM were inspected by this patrol, however them is also an Aid Post at TIALIBUS and a new one to be built at KUBIN. Apart from these there is also a Mission Aid fost at TAMPU.

While the patrol was in the area a new Aid Post was built at LOND-OL under the supervision of A.P.O. JUI. He dids an extremely good job in the building of this Aid Post and has made it into one of the best the writer has seen. This A.P.O. is a very efficient and capable person, certainly the best in the AMRUM.

The Aid Post at NONOGEM needs a new ward and dispensary, only the A.P.O.'s house here is in good order.AF.O. PUF affirmed his intention of building a new one here once the Rest House was finished. The local people schoold be working on it now4.P.O. PUF is only of an average type, he tends to let outside interests interfere with his work.

At ISIKIRU a new Aid Post was started on prior to the patrol leaving the area, at the instigntion of Er.S. Davis, E.K. i., who patrolled the area at the same time. The old Aid Post was about half a sile from the read on the benks of the AMBUM River, not a good position. The new one is being built near the Rest Rouse at the edge of the read in a much more weighble position. A. F.O. BREKIGAN seems competent, but he is still young and is rather difficent, consequently he does not get the co-speration that a more forceful person would get. However in time he should improve.

The Aid Post at KUBIH was started on at the patrol's departure from the area. It is situated between LOHDOL and MONOGAN and is some way from the road to serve those people who live further inland.

The Aid Post at TIALIBUS was not visited by this patrol. It is further down the valley from TSIKIRU and it, also, is situated off the road.

At YAMPU there is a Hansenide Colony run by the Catholic Mission with government backing. It also supplies general medical aid to the surrounding villagers. It has a total of 16 government-employed N.W. O. s here

There are no more Aid Posts further down the valley from YAMPU. However any people who are sick in this ared only have to walk over a small mountain range to WABAG hospital.

APPENDIX "C".

#### Education:

In the AMBUM Valley the education situation is very good due to the work that the Missions are doing in this field. At the noment the schools only enter for the younger children, but in the future a higher standard should be reached by them.

The Roman Catholic Mission have schools at LONDIL MOROGAM, ISTATING, MINEY and PAR. All teach up to Standard 2, but those at THIVIEW and PAR reach Standard 3. Eventually it is hoped to bring the Standard; as high as 5 ord. All these schools, except that at MONOGAM, have Europeans in charge with native teachers, at least two have permanent material classrooms. They are all well run and disciplined.

Apart from these places the Lutheran Missian rum a school at KUNDIS which eventually will teach up to Standard 4.4 permanent material schoolroom is being built here, and in the future they hope to reach Standard 6.

There are also numerous small schools run by native evangelists up and down the valley. Although the bias is usually on religious training for the children, they provide a solid basis for further schooling of a higher standard.

The ANDUM people seem to realise the importance of education and what a large part it will play in the future of their children. Consequently all these schools have a high enrollment and are constantly attended by the local children. The ANDUM Valley has one of the best education coverages, of a lower standard, in the whole Wabag Sub-District.

#### APPENDIX "I"

#### Food and Agriculture:

At all places visited by this patrol abundant food was bought for all patrol uses. Only at LONDOL was there any food shortage as the people were planting new gardens. The hight here, and the fact that they have not been able to devote too much time to gardening in the last few months, has resulted in a fairly low yield. Although enough for their own wants there is not much food left over. The Catholic Missionary at LONDOL has felt the effects of this and is finding it difficult to procure food for his station.

Not much coffee was inspected, there is not a great deal grown in the upper half of the valley. What there is seems to be doing well and is being well looked after by its owners.

Some money is obtained by the villagers through selling fresh vegetables to the local mission stations. However the market is small and is not important, personally, to each villager. At the present time the emphasis is definately on subsistence farming only. However now an increasing number of visits to this part of the Sub-Bistrict by the agricultural Officers in Wabag whould help to improve their methods manufact and output and increase the variety and size of cash cropping here.

#### APPENDIX "E"

#### Anthropology:

During this patrol the writer witnessed two traditional native ceremonies in the AMBUM area. One is still regularly performed throughout the WARAG area, and the other is now never performed, due to its clashing with Mission teachings.

The former is a type of initiation ceremony and is known as" "planting the 'kaus'". It seems to be of great value to the natives as it encourages them to have good habits through a rigmarole of traditional

'hocus-pocus' and magic.

'haua' is the pidgin term for w.l. ginger. To the natives there are many different types of 'kaua'; the type they plant in their gardens for eating, the 'kaua' for pigs, for women and for men. The I'kaua' used in this ceremony is that which has been marked for the men. The ceremony can by erformed two or even three times a year and our only be attended by an erried male youths, between the age of puberty and about twenty years (depending on whether 'hey are married), who have a not lost touch with tribal customs. It is strictly 'taboo' for children, females, married wen, 'Europeanized'men and pigs to witness this ceremony. It is said to lose all its power if they do.

It is wholly native in concept and execution and dates back to their ancestors. It would seem to have no harmful effects at all and it definately encourages the youths of the tribe to follow good habits. Indeed it is rather amazing that the 'primitive' natives of this area have evolved a code of ethics, albeit mixed with deal of 'mumbo-jumbo', which follows so closely our own opinions of the ideal way a person should act. For instance, to be eligible to 'priest the keys's native wouth must have represt named to be eligible to ' plant the kaua' a native youth must have perfect morals, especially as regards woman. He must have had no close cortact, over a long period, with Europeans, as they feel it lowers his moral standards and his clan loyalties. And, if after the ceremony he is promiscuous, while still unpurried, he is liable to forfeit a pig to his fellows, which they will kill and eat, and in addition he will receive the censure of all.

When the time comes to 'plant the kaue', all the young and innocent wonter of the tribe are taken into the bush by article kendimon still her

youting of the tribe are taken into the bush by an'old hand'who still has not blotted his copybook. After spending the night there they congregate at a special pool which has a stream of water dropping into it, like a small waterfall. After washing themselves thoroughly they are stood under the atra stream of water and their eyes are held open while the water runs into them. After their eyeballs have turned quite white they are taken to the edge of the stream and their eyes are dried with a special leaf which has had magic words whispered to it. They then go and visit their 'kaua'. It is always planted for inside the bush so that pigs or women will not see it. They clear arround the 'kaua' and see if it is allright then they return to their house. However, a few or them who are on their third tributed. to their house. However a few of them, who are on their third trip, go area, approximately 400m yards from the 'kaua', where a certain type of liquid is kept in pieces of bamboo in the ground. This liquid was not seen by the writer but its properties were described; it is like rust-red water, but it is also like mercury in that when it is dropped it stays in drops and does not run. They say it is like nothing else they know of and they do not even know where it comes from, it has just been handed down from fether to son for generations. They inspect this 'water' also and if the bamboo containers are rotten they exchange them. They then put them back in the ground and return to their house. During the night these particular men are said to dream. They dream about the woman they will marry, or a fight, or some trouble, or anything in the future. Then for the next three days they remain in their bush house and sing and dance. The fourth day, the 'old hands' give the younger ones all the articles with which they must decorate themselves when they return to their clan. Them the fifth day they decorate themselves and return to their clan grounds where their clansmen are ready to welcome them. They then dance, and at night attend a courtship ceremony with the young women, however intercourse is strictly benned at these ceremonies. You the following five days they can only eat food gathered by the young boys. They then return to the normal life of the village.

Although this ceremony is still being performed throughout the Wabag Sub-District it is gradually losing its influence on the younger

generations, especially those near WABAG. This is unfortunate because, as well as guarding their morals, it gives them local pride and dissuades them from aping the 'whiteman' in all things.


The other ceremony witnessed during this patrol is confined to only a few places in the Sub-District, one of these is near MONOGAM in the AMBUM Valley. Before the coming of government influence in this area, each Clan had a symbol of its own which was worshipped and which was believed to look after its particular Clan in fights or just generally. Some worshipped stones or trees or wild dogs. This particular Clan worshipped a small pool of water, which apparently just came out of the ground. However, due to mission influence, they have ceased to worship this pond and have let the bush cover it in.

Whenever they wish to obtain its blessing; for a fight, or a child etc., the people would congregate in the vicinity of the pend, around a house which they would build for the occasion. The house is small, square and without walls, and it is completely covered with flowers. They then kill some pigs and cook them inside the house. Special parts of the pig. such as the liver and heart, they put aside to give to the pond. The rest of the pig the assembled people eat. Special men, whom have the knowledge, decorate their complete body with red paint and white spots, tie leaves around their waists and tie hideous masks over their faces. IN They them dance and sing before the assembled people. Eventually their leader will take the meat, spear it with a long stick and, accompanied only by his fellow dancers, will go to the pond. Here, with appropriate songs, they will throw the meat into the water. They stand well back as the water rises in a wave to take the meat and it would be fatal to get caught by the wave. Once the meat is thrown into the water they all turn tall and run from the pond as fast as they can in case the pond wishes some more meat and engulfs them also. After this ceremony they fell sure the pond will look after them.

they feel sure the pond will look after them.

Although they do not worship this pond any longer they still hold it in awe and are a little frightened of it. Recently, in a tribal fight, the tultul of this particular Clan was cut on the back of his neck with an axe. He very nearly died, but after surgery at the Wabag Hospital he miraculously recovered. His Clan attribute his good fortune to the fact that their pond was looking after him. They only discuss their pond guardedly as they do not want it to take umbrage at anything they may inadvertantly say about it. They say it has the power of life and death over each individual. Although not officially worshipping it now the impression is gained that it still plays an important part in their thoughts, especially of the older people. In times of stress one can imagine them praying to their pond, a mixture of christian teaching and traditional belief.

#### GENERAL NOTES

This latter part of the survey was net with a great deal of co operation on the part of the people and especially on the part of the officials, who did all in their power to explain and point out the situation of their land boundaries. Their attitude to the survey was far more peaceful than that of the people in other areas visited at the begining of the survey in April, and it would appear that at last the people can see that the survey will in no way affect their land holdings in the immediate future.

All the writer's fears of a tedious and scnewhat impossible task were dispelled at the method in which this survey was planned by the headquarters of the Department of Agriculture, and also to a great extent by the terrain over which the survey was conflucted. The mountainous nature of the country embled sighting of boundaries in difficult areas quickly and easily from mountain tops, whereas in featureless country many days would have been spent locating the boundaries and doing the same job. Also to the advantage of Soursey it was found that all native boundaries follow natural barriers such as mountain ridges and rivers and it was a simple natter to identify land boundaries on the ariel photographs. From these features. These advantages enabled the survey to be completed in a far shorter time than anticipated by the officers conducting the patrol.

The duties of this survey forced the patrol to cover country not generally covered by normal patrols, and because of this a closer contact was possible with the people, and far more of their dwellings and gardens were seen.

Some complaints were heard and attended to on this patrol, but in cases where the C.N.A. court decision was required the matters were referred to Wabag or Wapanamanda.

This last patrol completed the second phase of the Intensive land survey.

# MARAGUNI CENSUS DIVISION. MR. W.A. CAWTHORN. 3.P.Q.

Your Memorandum 67-1 dated 22nd Hovember, 1962 refers.

It is pleasing to see that the natives have settled down again to their old way of life now that the Missionaries have coased squabbling amongst themselves and getting their followers to do likewise.

An endeevour is being made to have the Nabag Natives once gain acceptable to applicants for Highland Labour. A number of meetings will be addressed next week pointing out to this that this will be their last chance to get themselves a satisfactory name as labourers. If they continue to act as they have done in the past then they will be isolated without any avenues of obtaining a cash income. Ir is a pity that the Haramuni people, because they are in the Wabag Sub-District are lumped together with the remniader of the Enga speaking people.

The possibilities of a road have been looked into on a number of occasions. However the distance to be covered, the height of the road above sea level, the terrain, the lack of gravel, the lack of poulation in the area through which the the road passes and the small population in a questionable, agricultural vise, rugged valley, makes a road into the area an unreasonable project. The completion of two airstrips in the near future will enable the people to become closer to civilisation.

As pointed out at least once before KUPA of KAIBMTOK is not a Luluai. He was dismissed after the Supreme Court Sittings in 1959. Arecommendation for his re-appointment will not be entertained.

A recommendation that compensation be paid to the builders of the Pasalagus Aid Post and Rest house when the airstrip land is purchased has been made. This should repay them for the effort in arouting new buildings nearby.

The natters dealt with in the Appendices have been brought to the notice of the Departments concerned. Any remarks they may make will be passed on to you.

With reference to appendix E, the airstrips are the Missions concern, not ours. As we will have permission to use them I would say that if an Officer was stationed in the area he could help in their construction with supervision. However in this case we are unable to do anything and no police are to be sent to the Valley for any such purpose.

Mr. Cawthorn has written a very comprehensive report on a Patrol well done.

# Monday, 3rd. September, 1962.

At WaBAG. Sent some gear and three policemen ahead to LONDOL today. Told to organize carriers.

Tuesday, 4th. September, 1962.

WABAG - LONDOL

Spent morning arranging remainder of patrol gear. Left WABAG for LONDOL at 2.0 p.m. by car with policeman and m interpreter and the rest of the patrol gear. Arrived LONDOL at 4.0 p.m.

Found only 20 carriers waiting there. So decided to spend to-morrow at LONDOL to arrange for more carriers.

Wednesday, 5th. September, 1962.

AT LONDOL

Spent today recruiting carriers from LONDOL and MONOGAM, eventually obtained about 60 carriers.

Heard some petty disputes during the day and inspected the Aid Post here which is very good. Did some paper work, then arranged all gear ready for an early start tomorrow. All carriers slept at the Aid Post.

Thursday, 6th. September, 1962.

LONDOL - POROMANDA.

Actual Walking Time : 10 hrs. 55 mins.

Left LONDOL at 6.25 a.m. for the MARAMUNI. From LONDOL a steady climb of about two hours to the LONDOMANDA Ridge, 10,400 ft. high, rested there. Moved on at 8.40 s.m. following along the ridge. Reached greatest height about 9.15 a.m., that was 10,650 ft. Passed previous patrols camp missite at 10.40 a.m. Rested at another old patrol camp at 12.5 p.m. Moved on again at 1.0 p.m. Crossed Alyelo Ck. at 2.30 p.m., then walked up to the LEMBO Ridge and followed it along. Intermittent rain from 3.0 to 5.0 p.m. Crossed PAKUMBEL Ck. at 5.15 p.m., from there walked up the POROMANDA Ridge on the top of which is situated the Resthouse. Arrived there at 5.25 p.m., the last of the carriers there by 6.30 p.m.

POROMANDA - 7,600 ft. above sea level.

Friday, 7th. September, 1962.

PORCMANDA - KAIEMTOK

Actual Walking Time : 3 hrs. 25 mins.

Set off for KAIEMTOK at 8.15 a.m., fine day. Pollowed along PORCMANDA Ridge, track goes down all the way into the LIANDO Valley, where KAIEMTOK is situated. Very good track nearer KAIEMTOK. Crossed the ROBILIOK Ck. at 11.15 a.m.. Crossed MERIKIEM Ck. at 11.20 a.m. At 11.25 a.m. rested and waited for all the carriers. Last one arrived at 12.15 p.m., moved on at 12.20 p.m. Arrived KAIEMTOK at 12.35 p.m., all officials and all local people assembled. All told to assemble the next day at the Resthouse for the census. Paid off all carriers except 20 which were retained for a permanent carrier line. Mr. P. Nolan, a Catholic lay missionary at present stationed in the MARAMUNI, paid a courtesy visit in the afternoon. Inspected Aid Post then spoke with village officials. Numerous people asking for work as drivers, warders, labourers, police, etc.

# Saturday, 8th. September, 1962.

#### A? KAIRMTOK

All people assembled early. Started census at 9.0 a.m. Completed census of all except two clans before lunch. Early afternoon censused the MAGAUAN Clan, the MAIRIN Clan had not arrived. Spoke to assembled people MAGAUAN Clan, the after census.

Completed all paper work connected with census by the evening. total population here is 664 people. Instructed all officials re work they must do before the next patrol.

# Sunday, 9th. September, 1962.

# KAIEMTOK - NELIAKU

Actual Walking Time : 2 hrs. 5 mins.

Set off for NELIAKU, in company with Mr.P. Nolan, at 3.35 a.m., fine morning but very hot. Crossed MARILIAK Ck. at 9.30 a.m. Crossed LIANDO River at 10.10 a.m., then straight up to NELIAKU, a steep walk. Rested for 20 mins at 10.25 a.m. while the carriers caught up. Moved on at 10.55, arrived NELIAKU 11.0 a.m. All people assembled. Track very good, a great improvement.

Sent all people off for food and firewood and sent the carriers
back to K AIESTOK. Spoke to Tultul KUBA of NELIAKU on various subjects.

Finished all village books and returned them to KALENTOK officials. Told them all to do some more work on the KALENTOK - NELIAKU track.

Late afternoon WAIRIN Clan arrived at NELIAKU. Told to assemble tomogrow, together with NELIAKU Clans, for the Census. Inspected coffee here, in good order and doing well.

NELIAKU - 4,600 ft. above sea level.

# Monday, 10th. September, 1962.

# AT NELLAKU

Took census of the two NELIAKU Clans and the WAIRIN Clan from KAIRATOK during the morning. After the census spoke to the assembled people.

During the afternoon completed all paper work connected with the census. A total of 146 people here,

# Tussday, 11th. September, 1962.

NELIAKU - PASALAGUS

Actual Walking Time : 2 hrs.

Set off for PASALAGUS at 8, 15 a.m. Crossed SUI River at 9.0 a.m. theight there about 3,400 ft. From there a steep climb up to PASALAGUS, which was reached by 10.0 a.m. The last of the carriers there by 10.15 a.m. Track in very good order, except for patches between NELIAKU and the SUI River.

Lunched with the two Catholic lay missionaries at PASALAGUS,

inspected improvements to Catholic lease there.

During afternoon spoke with local officials on various subjects and instructed them on work they must do. Filled in and returned village books to NELIAKU village official.

PASALAGUS - 5,300 ft. above sea level.

# Wednesday, 12th. September, 1962.

#### AT PASALAGUS

Finished the census of the four Claus here by widday, then spoke to local people.

During afternoon completed all figures connected with the census. The total population here is 435 people. Inspected Aid Post, in good order.

# Thursday, 13th. September, 1962.

# PASALAGUS - TONGORI

Actual Walking Time : 2 hrs. 20 mins.

Set off TONGORI at 9.40 a.m. Left some gear behind at PASALAGUS with Const WARAIA who was unable to continue because of a bad foot. A very hot, humid day, making walking uncomfortable. Arrived TONGORI at 12.0 mid-day, last of the carriers there by 12.10 p.m. All local people assembled day, last of the carriers there by 12.10 p.m. All local people assembled there and waiting. Track between PASALAGUS and TONGORI on the whole good, a definate improvement. Patches near TONGORI to repaired.

Started raining heavily at 1.0 p.m. 1 the rest of the after-

Started raining heavily at 1.0 p.m. 1 the rest of the after noon. Spoke to the local village officials informally also interviewed some local people whom wanted work of some kind.

# Friday, 14th. September, 1962.

#### AT TONGORI

All people assembled and ready for census early morning. Finished all three Clans by midday and then spoke to assembled people.

During afternoon completed all paper work connected with the census. Total population here is 297 people. Talked informally with local people during late afternoon. Purchased a large pig.

Gave a Tultul's insignia to one TAMA of MINEIN-EBES. This now makes the number of village officials at TONGORI sufficient.

TONGORI - 6,000 ft. above sea level.

# Saturday, 15th. September, 1962.

TONGORI - WOILEP

Actual Walkin Time : 1 hr.

Set off for WOILEP at 9.15 a.m. Another very hot day. Arrived 10.15 a.m., the last of the carriers 15 mins. later. Bought food for the carriers and a chicken from the A.P.O. Spoke with the village officials and gave a Tultul's insignia to LIAMBI of WOILEP whose appointment has allready been confirmed.

Paper work done in afternoon and aid Post here inspected. A large side of pig bought for 12/-.

WOILEP - 6,100 ft. above sea level.

# Sunday, 16th. September, 1962.

# AT WOILEP

Revised census of the four Clans here during the morning, then spoke to the assembled people. During afternoon completed all paper work connected with the census, then spoke with local village officials on a variety of subjects. Entered up all village books.

# Monday, 17th. September, 1962.

WOILEP - PASALAGUS

Actual Walking Time : 3 hrs. 15 mins.

Left for FASALAGUS at 8.25 p.m. HATKEN Rested at TONGORI at

9.25 a.m. for 15 mins. Very hot day. Rested at NALYAK at 11.0 a.m. for 30 mins. Arrived PASALAGUS at 12.10 p.m. Last of carriers there by 12.25 p.m.

During afterboom inspected area to be surveyed for airstrip site, cleared some undergrowth on it. Spoke with I it village officials.

Tuesday, 18th. September, 1962.

# AL PASALAGUS

Began survey of new airstrip site here. Finished survey of actual airstrip by mid-afternoon and marked length of strip with posts. Interviewed owners of land and wrote investigation report. Heavy rain from about 4.30 on.

Wednesday, 19th. September, 1962.

PASALAGUS - POGARI

Actual Walking Time : 1 hr. 25 mins.

Sent all patrol gear on ahead to POGARI at 8.45 a.m. Stayed behind to ascertain the approaches on the new strip site. Wet, dismal morning. Followed on at 10.15 a.m. and arrived POGARI at 11.25 a.m., carriers a.rived at 10.10 a.m.

Completed report and survey plan for airstrip lease. Spoke with all village officials. Entered up the PASALAGUS village books and returned them. Bought two pigs for £2-5-0.

POGARI - 5,800 ft.above sea level.

Thursday, 20th. September, 1962.

#### AT POGARI

Revised census of the two Clans here by during the corning. Heavy rain all afterhoon. Completed all census figures during cornoon. Heard patty dispute late afterhoon. Spoke to local village chicials. Total population here is 238 people.

Friday, 21st. September, 1962.

POGARI - BIANA

Actual Walking Time : 1 hr. 55 mins.

Left for Blaka at 0.35 a.m. Reached the KUMU River at 9.50 a.m., rested and bathed there. Moved on up the far side of the valley to Blaka at 10.30 a.m. Arrived Blaka at 11.0 a.m., last of the carriers there by 11.10 a.m. Spoke with local village officials and some natives from the MERE area whom had come to see the patrol.

BIAKA - 6,050 ft. above sea level.

Saturday, 22nd. September, 1962.

AT BIAKA

Revised the census of the seven Clans here during the morning. Dull, rainy day. Completed census figures during the afternoon.

Sunday, 13rd. September, 1962.

AT BIAKA

Continued work on census figures, Completed all totals for the

WNI and wrote them up. Bought more food and took the names of more calliers. Arranged all gear ready for an early start back tomorrow.

Monday, 24th September, 1962.

BIAKA - MINGARORI (Bush Carp)

Actual Walking Time : 4 hrs. 25 mins.

Left BIAKA at 8.0 a.m. over a previously unused entry route into the ARAMUNI.At 8.45 a.m. crossed the LENDA Ck. just telow its junction with the IUGWE Ck. Reached MARAMNIU, where a Roman Catholic evangelist is stationed, at 9.10 a.m. From there walked up a steep ridge parallel with the KUNU River. Reached the top at 10.25 a.m. and rested. Moved on at 11.0 a.m. walking along the side of the ridge. Arrived cleared camp site at 12.15 p.m. carriers there by 1.0 p.m. Some houses allready built by local natives who had been sent ahead, so erected tents only. Bought some food which had been carried by the women from BIAKA.

MUNGARORI - 7,700 ft. above sea levol.

Tuesday, 25th. September, 1962.

MUNGARORI - AIYOKORE (Bush Camp)

Actual Walking Time : 4 hrs. 25 mins.

Broke samp and packed sear. Set of at 7.30 a.m., at 7.40 a.m. reached the KUMU River. Here it has a very wide and stony bed. Followed up it for 1 hrs., then left it at 9.40 a.m. after a hr. rest. Then followed up the MILIAMP Ck. for 25 mins. and left it to go up a very steep ridge to the head of the main range, which was reached at 10.50 a.m. Height here was 10,150 ft. Moved on slong the ridge at 11.10 a.m., then left it at 12.6 and moved across the grain of the country. Arrived suitable camp site at 12.45 p.m., the carriers there by 1.5 p.m. Cleared the bush, pitched tents and made small shelters for the carriers.

AIYOKORE - 67558xf1. above sea level. 9,250 ft.

Wednesday, 26th. September, 1962.

AIYOKORE - TIDI

Actual Walking Time : 5 hrs. 15 mins.

Broke camp and set off again at 7.25 a.m. Crossed the grain of the country, over creeks and ridges, till ISOWAI Ridge was reached at 8.45 a.m. Followed along and then down this ridge. At 9.10 a.m. met some men from KILYA who had heard that the patrol was comming and so had cleared the track down to the inhabited areas. Reached some gardens at 10.30 g.m. and rested for 20 mans. Reached MOKOSKP River at 11.20 a.m. and crossed, then walked over small ridge. Arrived TIDI Resthouse and Aid Post at 12.50 p.m., last of the carriers in by 1.15 p.m. Heavy rain as usual.

TIDI - 6,550 ft. above sea level.

Thursday, 27th. September, 1962.

TIDI - MURIRAGA

Actual Walking Time : 5 hrs. 20 mirs.

Departed TIDI at 7.50 a.m. Crossed IANKO Ck. at 10.12 a.m. and climbed steep ridge to TOMBAIP Resthouse. Arrived there at 10.55 a.m. and rested. Moved on at 11.45 a.m. Crossed LAGAIP River at 12.35 p.m. and reached end of vehicular road at 1.15 p.m. Walked along it and finally

reached MURIRAGA Resthouse at 1.40 p.m., the carriers there by 2.0 p.m. Dined at nearby Apostolic Mission.

MURIRAGA - 7,250 ft. above sea level.

Friday, 28th September, 1962.

MURIRAGE - LAIAGAM - WARAG

Actual Valking Time : (Muriraga-Laiagam) 3 hrs. 15 mins.

Left for LAYAGAN at 8.0 a.m. Walked along the vehicular road all the way. Rested at YAGENDA Resthouse at 9.30 a.m. Moved on at 9.45 a.m. Arrived LAIAGAN by 11.30 a.m. Lunched there. Returned to WARAG by them LAIAGAN Landrover during afternoon. Arrived WARAG at 4.0 p.m. Patrol anded.

# Introduction:

This patrol was the annual census patrol to the MARAMUNI, usually launched at the end of each year. It is one of two patrols sent each year into the MARAMUNI. Apart from the annual census there was an additional land investigation to be made for an airstrip site at PASALAGUS, the various missions in the area were to be studied to see that they were preserving harmanious relations, and any queries, disputes or troubles of the natives were to be settled.

The MARAMUNI Valley is the most recently de-restricted area in WABAG, and consequently the natives there are the most backward of the Wabag natives. This is due also to their isolation, it is at least two days walk, through uninhabited bush, from the nearest settled areas. However the natives are by no means wild or recalcitrant, indeed they are probably the most amiable and co-operative of all the Wabag natives. Apart from the very hard walking, due to the mountainous nature of the area it is a real pleasure sure to patrol in the MARAMUNI because of the wholehed ted co-operation met with and the obvious welcome with which the pat was greeted by all.

The population is not large, only2,727 people and, with the large area of land in the MARAMUNI, they have no land troubles atx all. Much less than half the cultivable land in the area has allready been cultivated. In this they are more fortunate than other Wabag people and, what is more, they seem to realize it.

The patrol made leisurely progress through the valley, endeavouring to stop at least one whole day at every settlement. Contact was made with every person and all were encouraged to bring any queries or troubles they may have before the writer, actually a very few were brought up. The easy progress of the patrol and the obvious welcome which was given it made it most enjoyable.

# Hative Affairs:

The native situation in this valley has always been reported as very good, it is still. It seems even better than a year ago, due a mainly to the furth fact that any mission unrest, between the natives, seems to have dissapeared. The whole atmosphere is clearer and the people seem to be happier and more secure. Their security is shown by the great increase in the number of gardens, all near the populated areas; this also shows their trust in the governments ability to preserve peace. Previously the tendency was to build small, scattered gardens, a year before only a few could be seen from the walking tracks. Now many more can be seen all through the valley, they are all wach larger too.

The height of the valley, it varies between 3000 ft. and 7000 ft. in the habitated frees, emables a great variety of native foods to be grown. Not many bropean foods have been introduced into here, but when they are they should do well. Poods which are not grown around WARAG because of the altitude fould easily be grown here; a ready marketx for them could probably be found in the Wabag and Laiagam areas. Coffee, also, was seen to do well here. It seems to the writer that this area could be put to better use that it allready has been. The big problem is of, course, transport from the valley. At present only a two days walk will bring them to a marketable area. When the airstrips are finished they might help, but only in a small way as only light aircraft will be able to land on them. Actually the only solution would be a road, but so far a suitable route has not been found. In the section on Roads and Bridges this will be gone into further.

The previous year it was noted that the natives here were very keen to obtain money, this attitude has increased very considerably in the interim. It seems that their prime reason for wanting money is a feeling of innermity instability. When asked what they would do with the money once they had obtained some they replied that they would just keep it in their houses. The fact is they have no real need for money, they would not be able to buy much with it if they did have it. However they have heard,

probably from Wabag natives, what an important thing money is now superseding the pig in the prestige it brings) and, fearful to be left behind in the race for advancement (money being the symbol of this), they are frantically trying to geatch up to their more advanced Wabag counterparts, by acquiring more money. This feeling of instability and inferiority seems very prominent in the Valley. However they only feel inferior to the Wabag native materially, morally, they proudly proclaim, they are far superior. It also seems that this farking instability is, in turn, caused solely by their isolation. Any news about vacancies for some type of work reaches them after all the other Wabag natives have heard it, consequently vacancies are filled when they enquire for a job. They feel cut of from the world and are always afraid of losing chances of work. Actually this feeling drove 22 natives to run away to Mount Hagen, going round Wabag in case they were sent back, and obtain work for the Highland Labour Scheme. When the natives start to do this it shows just how much they feel the need for money, or stable work of some kind. Throughout the patrol numerous people approached the writer asking to be given work of any kind. The impression was gained that this could provide some trouble later on and so, if possible, something should be done about it now. About the only suggestion that can be rade is that when work is available these people should be kept in mind, and a fair percentage of jobs be given them. They seem to be a ro-olerative and hard working people and should in well in most jobs. Then the question of a vehicular road comes up again, nothing would so well do away with their isolation. They themselves approached the writer and asked what chance there would be to have a road made into the MARAMUNI. They were prepared to buy a car, they realized the price and the difficulties attended on crining a car, and would use it to collect medical supplies, transport sick people, etc.

A number of petty disputes were brought before the writer, not many but more than last year when no disputes at all were brought forward. However this is not due to an increase of litigation among them, but more due to the fact that they have more confidence in the government and are no longer too shy or diffident about asking a patrolling officer's help in helping them with their troubles. All disputes were unimportant personal ones such as the father who brought his daughter was up for being promiscuous with an unmarried man of another Clan. He only wanted her given a talking to, then married her off to the man. Another, of more importance, concerned pig exchanges between two clans. These people do not have the "Te" gift exchange but they exchange pigs when a "buying" the body of people killed in fights between them. In this dispute the litigents were confusing this type of exchange and the "Te". After talking with them they settled it misbly. They are proud of their moral superiority to the Wabag natives, and endeavour to retain it, especially the village officials. When a Wabag native evangelist comitted adultery with his wife's relative, he was quickly taken to Wabag for court action by the local bulual who was scared that such as habits would be brought into the MARAMUNI. A very good sentiment which, it is hoped, they will retain.

In the previous two patrol reports it was mentioned that there was some mission unrest in the MARAMU NI. However it seems to have died down considerably now. In fact no instances of mission-inspired unrest were met with at all. It seems that they have now settled down amicably in the valley. The natives also seem more unaffected by their teachings. In many places in the Wabag area one sees them discarding traditions and even deriding them. They also tend to play the government against the missions and adopt pseudo-pious attitudes over things they do not want to do. However in the MARAMUNI, although they seem to believe in the religions, they do not bring them up all the time as excuses to get out of work and they do not try to play the church against the government, Indeed they lo not mix them at all; they perform their religious duties on Sundays, their secular duties on the other days. That is probably why there are harmonious religious relations in the Valley. They have a much samer approach to religion than the normal run of the Wabag natives.

Although an average of two patrols a year visit these people, they asked for more visits, and even for an officer to go and stay with them for some time. Their reason is that they feel out of touch with the government and would like to see more of its representatives. It is heartening to see that they are pro-government.

All in all there seems to be a great improvement in the attitudes of the natives here, they seem to have a healthy and intelligent outlook. It would improve even more if their isolation could somehow be overcome.

### Roads and Bridges:

The system of internal tracks in the MARAMUVI is now very good, a tremendous improvement on what they were a year ago. All are of bride path standard. All have been widened and graded, and consequently all the walking between settlements has been made very much easier. The biggest improvement was on the track between NELIAKU and PASALAGUS, as far as the SUI River. It was not completely finished at the time of this patrol but instructions were given to finish it straight after the patrol left the area. There does not seem to be room for any more improvement to the tracks, consequently all the clans were told to keep them up to standard only and not to re-route them or make radical improvements. The next patrol will be able to see whether they are keeping them up to standard.

At all the settlements questions were asked about the entry routes into the MARANUNI; should they all be kept cleared, should they only concentrate on one, if so which one? The writer has walked over many every possible entry route into the MARANUNI, four in all, and it seems that the best one is definately that one from IPIKES to WOILEP. The track from LOWDOL to KAIRMTOK is very difficult to maintain and it takes two to three days to traverse it, added to this it is hard walking. The KAIRMTOK people were told to leave this track alone for the tame being. It would be better to leave this track completely, it is not a good entry route into the MARAMUNI.

While the writer was patrolling in the AMBUN Valley a g track from LONDOI to WOILEP was investigated, it is used quite often by the atholic missionaries coming from LONDOL. In its present state it is just a mody native pad which does not follow the easiest route. However it could be re-routed to follow along the ridge top and could be improved considerably. It is definately the quickest route into the MARAMUNI. If the track was improved one could walk it in one day, if a Resthouse is built on the ridge top two easy days walk would suffice. The MARAMUNI people have allready cleared and widened same of this track before the patrol arrived in the area. They were told to leave it for the time being until they received word from Wabag. It could provide an alternative entry route to the IPINDS-WOILEP track, however the fact that they both enter the MARAMUNI Valley at FOILEP is not in its favour.

The patrol left the MARANUNI by way of a track from BIAKA to MURIRAGA to Lalagam. It is not a particularly good track and it is used only by the BIAKA people. The purpose of using it was to ascertain what sort of route it was and to enable the writer to have a complete picture of the possible entry routes. It is definately not recommended.

The IPIKES-WOILEP route is at the present, as mentioned previously, the best. The trac is well cleared, has Resthouses built along in it, and is not perticularly hard walking. The only thing not in its favour is its length. From WOILEP it takes at least three days to reach either SIRUNEI or LAIAGAN, and from there the patrol must get back to WABAG, usually by car from LAIAGAN, about four days inail. Walking from WOILEP to LONDOL would be one or two days and a car can be sent to CONDOL, if not it is only a days walk to WABAG. In all two or three days on this route, and easier walking. The conclusion is that only two routes should be considered: LONDOL-WOILEP and IPIKES-WOILEP. As the latter is allready made, one must decide thether or not to improve the former route.

Now the question arises of the possibility of a vehicular road into the MARAMUNI. Again there are only two possible routes: IPIKES-WOILEP and LONDOL-WOILEP. With both these routes it would be almost impossible to bring the road right into the MARAMUNI, however it might be possible to bring it to within two hours walk from WOILEP. The track from SIRUNEI to WOILEP would be suitable except where it goes over the POIPMUNDA Ridge.

However, in the opinion of the writer, this difficulty could be overcome by re-routing the track gradually up the side of this ridge(instead of following the MOK River to the base of the ridge and then going straight up it) or by crossing the TANARIS Ridge and then along the KAIPAMUNDA Ridge(see attached map). The alternative route, from LONDOL to WOILKP, was not traversed by the writer(as mentioned the precent track follows the valley and then up and over the main range) however if the route was made to follow the ridge top it could quite probably be suitable, from what one could see. The natives, whom have hunted along this ridge, say that it would be suitable, however whether they would know is a most point.

In them opinion of the writer, then the route from LONDOL to WOILEP(along the ridge top) should be examined with a view to its improvement, and both these routes should be looked into carefully to see if it would be possible to make a vehicular road over them. Even if the road stopped short of the actual Valley, a 2 hrs. walk to the road head is nothing compared to the 3 to 4 days walk they do now. If a vehicular road was made it would be of immense value to these people, both economically and morally.

# Census:

At every point, except KAIENTOK, the census was taken without trouble. No absentees were found and everywhere the people were assembled awaiting the patrol. During the census they sat in orderly groups and in all places names were checked with a minimum of fuss.

At KAIRMTCK, the first census point, two complete Sub-clans were not assembled to meet the patrol. Word was sent out to them, and when census was taken only one of the Sub-clans had not arrived. They eventually arrived when the patrol had moved on to NELIARU and they were censussed with the clans there. One of the Sub-clans, the LAPISO-NAGAUAN, lives about half a days walk from KAIRMTCK, at WANURES on the banks of the MANAMUNI River. They thought that the patrol may visit their area and so did not come to KAIRMTCK, when told that they would be censused at KAIRMTCK they all arrived there int time. The other Sub-clan was the WAIRIN. They live a hard days walk from KAIRMTCK, at TILYA towards the TARUA hiver. Evidently the previous patrol had told them to build a Resthouse at TILYA and that succeeding patrols would visit them there. Consequently they had built a Resthouse and were assembled there to greet this patrol. As nothing was known of these arrangements they were told to come and be censused at KAIRMTCK. These people are not pure MARAMUNI, they are connected also with the WAIR-TARUA people. They were told to come to KAIRMTCK to greet the next patrol into the area, it will be up to its officer whether he wishes to visit them at TILYA.

The total population in the MARAMUNI is 2727 as against 2638 persons this time last year. This is an actual increase of 89 people and a percentage increase of 3.4%, practically the same rate of increase as last a year. This increase is due mainly to a high birthrate, 118 this year, and the low death rate, only 40 for the year. The migrations in and out largely balance out, however 16 more migrated in than out. The migrations are much lower than last year, it seems that they are beginning to settle down now. only a few new names were recorded, it seems likely that all the MARAMUNI people have been cansused now. Children dying a week or two after birth are a big problem, at least 5 were recorded by this patrol but there a were probably more.

There has been an increase in deaths from last year. This is mainly due to the number of new babies dying and the increased mortality in the over 13 bracket, from 12 to 24. This increase is due to a greater number of kenithy passian elderly people dying, it is not due to epedemic or accident.

The number of able-bodied males has sharply decreased from 536 to 476. The only reason seems to be that a greater number went over the age kimilimit in the past year. However there is a greater number of youths, they have increased from 243 to 300. The number employed outside the District is

about the same, the increase of those employed inside x the District is due to the Catholic Mission in the area which is employing some of the natives. The number of children going to achools is also static.

When subtracting the difference between births and migrations in and deaths and migrations out from last years total, one gets the figure 2732, five more than this years total. The difference was caused by a mistake in last years census when the names of a whole family(five mambers) was duplicated. The mistake was found during this census and the names were struck from the records making the totals five short, hence the correct tes total is 2727.

# Village Officials:

The Village Officials in the MARAMUNI are, on the whole, very good types they are definately the finest body of officials in the MARAGE area. They are the real leaders of the people and are generally listened to by their clansmen. They all seem to be fairly intelligent and honest. The best Inluming in the area are RAIMA of TOMGORI, KASEP of POGARI and KUPA of KAIMTOR. All are forceful types and are very pro-government. They seem to be able to settle disputes amongst their aleasens. seem to be able to settle disputes amongst their clansmen, a welcome change to the normal run of village officials in the area.

During this patrol Tultul's insignias were given to three men whose appointments had allready been confirmed but whom had not received their insignias as yet. They were

# Missions:

All blocks of land surveyed at this time last year had been bought and, at the time of this patrol, they all had native evangelists stationed on them. Only at the Catholic Mission block at PASALAGUS was there any extensive building. At approximately 16 places in the MARAMUNI native evangelists are equatting on native land. In all cases the owners of the land were willing to have them there, no trouble was met with over this.

All the blocks have only native m materials teachers houses, churches and schools, no big improvements at all. Only at PASALAGUS have the mission attempted to make lasting improvements. Here, on the Roman Catholic Mission lease, two Catholic lay missionaries are stationed. They have built a good house for themselves and are building a large school house there. They have brought ducks and goats into the MARAMUNI to breed them.

The Mission situation seems very stable now, no disputes or trouble between missions came to the notice of this patrol. Since the last patrol early this year there has been no mission troubles in the area.

# Resthouses:

There is an adequate number of resthouses in the MARABUNI.At the present they are all in fairly good order. At WOILEP the people were ordered to build a new police barracks only, the resthouse here is in good order. At PASALAGUS the resthouse is leaking badly, however the local people were not told to rebuild it. When the new airstrip here is built the whole

government station, Aid Post and resthouse, will have to be moved. Consequently it was thought that when the next patrol enters the walley to buy this airstrip site they will be able to mark out a complete new government station. This patrol, did not have the time to do this.

#### Carriers:

Some trouble was had at LONDOL to find sufficient carriers to carry all the patrol gear into the MARAMUNI. The LONDOL people are cantinually being called on to carry patrol gear, mission and government, into the valley and, partly because of the track, partly because of the pay, they are now very loth to carry. At full day was spent at LONDOL finding carriers, however enough were finally obtained here and from MONOGAM. They all wished to carry throughout the MARAMUNI, only the journey fram LONDOL to KAIEMTOK did not appeal to them. At the rate of 1/- per day each man receives about 3/- for this journey; they maintain, fairly, that it is not enough. A rate of at least 2/- per day abould be paid for this part of the patrol. However, even with better pay it will be difficult in he future to obtain carriers from here. It would probably be much better to send word ahead into the MARAMUNI, and have them assemble at LONDOL to carry the gear in.

During this patrol 27 carriers from LONDOL were retained throughout an axix additional 40 people were recruited at LONDOL and paid off at MAIENTOK. Within the MARAMUNI carrying was done on a village to village basis and food was bought for the carriers. Twenty carriers were recruited at BIANA and they, with the carriers from LONDOL were paid off at LAIAGAM. It would be better to use MARAMUNI carriers throughout and only pay those who carry in and cut of the MARAMUNI. These carriers are by far the better ones, hard working, more co-operative and stronger.

At all places ample food was obtained for the carriers. Only on two days, walking from BIAKA to LAIAGAM, were rations issued.

#### Conclusion:

Administration and Mission contact seems to be taking a much smoother course in this area than in other areas in the Wabag Sub=District. The people are happy, to-operative and industrious and seem to be doing well under administration protection. Even in the last year changes can be noticed, all for the better. The whole atmosphere in the valley seems to be clearer, more peaceful. Pirstly there are no insinuations being made over missions, natives of the different denominations seem to be living together peacefully, there is now tolerance here. Secondly the natives seem to have more confidence in the government and they seem to be eager to see more of it, they appear to be genuinely pro-government. Thirdly traditional inter-tribal fears seem t now to have practically vanished, as shown by the increased number of gardens, all in the more accessible places, and the grouping of communities. Fourthly they are now eager to retain their moral superiority over the normal run of Wabag natives, they constantly deride the "bad fashions" of the Wabag native and maintain proudly that they do not follow them. They realize how the government would like them to act and they try to act in this way.

Conversely their greatly increased desire for moneys could, in the future, prove their a unioing. Their morals could be swamped in an allencompassing desire for money. Consequently it would be to the advantage of the government if they tried to help these people to find work or to start a cash economy. The only other possible trouble would be through their isolation, this would be solved if a suitable vehicular road route could be found going into, or nearly into, the MARAGUNI.

The regular twice-yearly patrols into the MaRAMUNI have helped greatly to provide this happy atmosphere. In the opinion of the writer they should definately be kept up, and a close watch should be kept on these people to see that they continue to axaxa evolve on this way. It is such

a welcome relief to find such a co-operative and energetic group of KNGAS in the Wabag Sub-District. Every effort should be made to preserve the good nature of these people.

General Ability: Intelligent but still somewhat inexperienced. He is cometimes inclined to be lazy but should eventually make a good constable.

# APPENDIX "B"

# Medical and Health:

For its population, only 2727, the Maramini has a very good health coverage. It has four aid posts, evenly spaced throughout the valley, at KATEMTOK, PASALAGUS, WOILEP and BIAKA. There is also an aid post at WAN-URES, about half a days walk from KAIEMTOK, which was built and staffed during a small outbreak on influenza earlier in the year. However the A.P.O. has now been withdrawn from here and, although the local people wish very much to get another one, it does not seem likely that they will, because of the small population in the area, only about 50 people.

At TONGORI, between PASALAGUA and WOILEP? an A.P.O., MARINE, was preparing to build a new iid post at the patrols departure from the Maramani. He had evidently been told to build one where he saw the need for it. If a new aid post is to be built here TONGORI would be the best place to build it as the population here is nearly 300, the largest population in the Maramuni which has not an aid post.

At every census point which does not have an add post the people approached the patrol asking for one to be built. While not being a practical outlook on their part it does show that they appreciate the benefits brought to them by these aid posts. All were prepared to send a boy into Wahag to be trained as an A.P.O. and then return to their village to set up an aid post. At TILYA, which is a hard days walk from the aid post at KAIEMTCK, they were especially anxious to have their own aid post, however the population here is only 65.

Most of the A.T.O.'s here are capable and seem to be doing a good job.TULI of WOILEP and MARINK of TONGORI in particular are very capable people and they hold the confidence of most of the people in the Maramuni. The A.P.O. at PASALAGUS, IMINDI, has only been there some months now and is not particularly confident of efficient, however he seems fairly capable and should improve in time.A.P.O. TWNA of BIAKA is fair and seems to be confident enough. He was told to construct a complete new aid post at BIAKA, the present one is in a bad state of disrepair. The aid post at PASALAGUS will also have to be rebuilt as it is on the new Catholic Mission airstrip lease there. However the next patrol, in the area will be able to pick out a suitable site for it. The only A.P.O. whom did not impress was MIGA of KAILMTOK. He is not at all confident, does not seem competent and does not hold the confidence if his people. It was entirely due to the Luluai there that a new aid post was built. A rather high number of deaths was noted at KAILMTOK, 4 in the first few weeks of life. 2 in the first year, 4 n the first four years and 6 adults. A tank total of 15 people in the last year, 9 under four out of a total of 15 under four for the whole Maramuni. Whether this is due to the A.P.O. 's laxness or to co-incidence one couldn't say, however the fact remains that this person is not at all a good A.P.O. and that his particular area sustained the highest death rate for the past year in the Maramuni.

Judging from talks with all the A.P.O.'s the most prevalent diseases in the Maramuni, and the biggest killers, are dysentery and pneumonia. Malaria, various skin complaints and accidents are next in line, however they are seldon fatal. One female died in childbirth and a known total of 5 children died in the first week or two of birth, the actual total would be much higher. If something could be done in this field, such as training some local girls in midwifery, this number would definately be cut down.

In a previous patrol(No.4 of 1961/62) the birth of twins was noted and a letter concerning them sent to the M.O., Wabag. So far the parents have not received the militiple birth allowance. Could this be looked into? During this patrol the birth of twins was noted at POGARI, to WANAW-ESGLI (f) and MAIKOR-KONGOWASQ(m). The twins, LOPALA(m) and UGIA(f), were born in August 1962 and between in good health. Could the Multiple Birth Allowance be also given to their parents?

# APPENDIX "C"

# Education:

Education in the Maramuni is still not of a very high standard. There are numerous small village schools, run by native evangelists, all through the valley and certainly adequate for the needs of the whole population, however they only teach to a low standard any children wishing a higher standard of education still have to go out of the area to the Mission schools at LONDOL, PAR and SIRUNKI, or the government school at WARAG, At the time of this census a total of 8 males and 3 females were at Mission schools and 4 males were at the government school at Wabag.

At the present time the Catholic Mission are building a school at PASALAGUS. Eventually it will teach to Standard 3. It is hoped to start teaching there in a month or two when the first classroom should be finished. This will definately lift the educational standard in the area and it will be of great benefit to the people there.

# APPENDIX "D"

# Food and Agriculture:

The Maramuni Valley seems to have a great potential for a variety of foods to be grown which are not normally found in the Wabag Sub-District. It has an altitude varrying between 2,500 ft. and 6,5000 ft., and it has ample ground for experimenting with crops.

The Wabag area is not switable for tropical crops such as pineapples, bananas, pawpaws, etc., and many foods which the natives regard as
delicacies cannot be grown there. However all these crops abound, or could
abound, in the Maramuni Valley. The soil is not good but it is adequate, the
climate is warm with plenty of rain but often overclouded, land is abundant
and a fair market is assured in the Wabag-Laiagam area. The oriv drawback
for a cash crop economy in the area is the problem of transporting goods
to the markets, however this would be overcome to an extent with the building of an airfield there or a road into the area.

Not much has been done here in the past as regards introducing new plants as it is a newly contacted area. However in the last year a fair increase in european vegetables can be noticed, of course there is x room for a much greater increase. At all places adequate food for the patrols wants were supplied. The number of gardens in the area would show that the people have a surfeit of food.

All coffee in the Maramuni was inspected and it seems to be doing well. It is a good altitude and a fair climate for coffee growing, also the soil is adequate to support it. However the fact that they have no way to combat the pasts and insects takes its tell of the coffee plants. All coffee in the garea is either in the nursery stage or has just been distributed to individual growers, none is of any size as yet, So far nome has been planted with shade trees, when it reaches a better height it is hoped that the owners will adequately shade it.

As the patrol was leaving the area, Mr H. Mulder, the Agricultural Officer from Wabag, entered the Maramuni on an I agricultural patrol. His report of the patrol should throw more light on the potentials of the Maramuni than these few comments will.


# Airstrips:


During this patrol an airstrip a site at PASALAGUS was surveyed for the Catholic Mission and an investigation report was written on it. A site was surveyed here a year previously but it proved unsatisfactory and so this new site was surveyed. The only other official airstrip site in the Maramuni is at KAIENTOK. This site has been surveyed and bought and is now being leased by the Lutheran Mission. So far no work has been done on it.

Airstrips have been the cause of a great many quarrels between the missions and natives here in the last year or so. They all realize the importance of the airstrips to their future well being and consequently the natives quarrel over the position of them(they all want them in their own back yards), and the missions argue to get the best sites to aid their converts. However now this has all died down. The position is, there are two airstrip sites only in the Maramuni, one at KAIEMTOK, for the Latherens, and one at PASALAGUS, for the Catholics. However the natives now say that they think that two airstrip sites are ridiculous for their small population, they think that the one at PASALAGUS is enough for them all. Hence they say that they will all (Catholics and Eatherens) work on the one strip, at PASALAGUS. This is with the exception of the KAIEMTOK people who say that they will stick to their own strip. They are all reger to have a policeman or D.K.A. officer in the area to organize them, or at least start them off, on working on the strip.

There should be no trouble as regards labour on the PASAL AGUS strip, only the one at KAIENTOK may take a while ton build. If a policeman could possibly be spared to help them start the strip, the work would certainly be done quicker. All the arguments and talk over strip sites here seems largely to have died down now, the people are only waiting for the go ahead to start work on them.

#### INTRODUCTION:

The MARAMUNI Census Division is a very meantainous but most impressive area. It is a series of river valleys, the main two being the SUI and MARAMUNI river valleys.

The area is completely surrounded by high mountain ranges except for the outlet of the MARAMUNI river to the Borth West. The Rurges Meuntains are to the West, the Maramuni-Arafundi Divide to the North and to the South and East are Two unnamed ranges. Because of this rugged terrain the people live in scattered groups, which makes the crossing of rivers and mountains necessary.

The population of this area is close to 3000. It berders on the Sepin Bistrict boundry and was derestricted in 1960.

#### DIARY:

Thursday, 7th Pobruary, 1963.

LAIAGAN - LANGINTABUS

Left LAIAGAN by car at 1015. Left the car at 1100 to walk to LANGINTABUS, arriving at 1240. Organised a carrier line for the patrel's duration. THERE was no shortage of fixed here. Fine day. Walking time - 1hr 40m.

Priday, 8th Petruary, 196].

LANGINTABUS - PORES

LEFT LANGINTABUS at 0630 and proceeded to walk to PORMS via the MUG river valley. It was a well cleared walking track except for the last hours walk into PORMS. Arrived PORMS at 1120. There are very few natives in this area as it is very high and celd. Patrel stores issued. Rain during the night.

EASTER BUSINESSES

#### Tuesday, 12th February, 1963.

PASALAGUS - POAGARE

Left PASALAGUS at 0610 and arrived at POAGARE at0740. Line: the natives for the compiling of the Common Rell. Completed at 1150. Afternoon spant talking to the people and observed that they were very friendly and helpful. The carriers are moving along well and as yet we haven't had any complaints from them. Walking time - 1hr 30m.

Ample food available. Another fine day.

Wednesday, 13th February, 1963.

POAGARE - BIAKA

Meved of from POAGARE at C555 and arrived at BIAKA at 0820. Again lined the natives for the Common Rell. Ample food was purchased. Fine day. Walking time - 2hr 25m.

Thursday, 14th Pebruary, 1963.

BIAKA - PASALAGUS

After leaving BIAKA at 0612 the patrel passed through POAGARE at 0820 and arrived at PASALAGUS at 0950. Helped survey a section of land for the extension of the Lutheran Mission Lease. During the afternoon continued the murder investigation by visiting the murder scene and sketching this. At 1900 the N.M.O. from WOILEP came to the rest house to make a statement concerning the metive for the murder. Also two other natives came up to make statements. Finished at 2010. Peed plentiful. Another fine day.

Walking time - 3hr 38m.

Friday, 15th Pebruary, 1963.

PASALAGUS - NELYAKU

Departed PASALAGUS at 0615 and arrived at NELYAKU at 0805. Compiled the Common Rell. Talked to the natives generally and I am convinced that they are a very friendly people. Fine throughout the day but some rain that night.

Saturday, 16th February, 1963.

NELYAKU - KAIMYETOK

Left NELYAKU at 0605 and arrived KAIMYETOK at 0800. Compiled the Common Rell and finished at 1415. There is a new rost house here which is very good. Fine during the day but during the late afternoon there was a heavy rain sterm.

Sunday, 17th February, 1963.

KAIMYETOK - PASALAGUS

Departed KAIMYETOK at 0610 and arrived PASALAGUS at 1020. Finished murder investigation at 1320. Rest of Sunday ebserved. Fine again today.

The Native Affairs position in the MARAMUNI Census Division seems very good .

. 4 .

Two points steed out about these people. The first point is that they are extremely peaceful. There was not one dispute of any kind. We land disputes, which are usually the main werry of the Highlands peoples, and no criminal or other civil disputes. The lack of land disputes is probably due to the fact that there is ample land in the area for such a small population.

The second point is that they are very helpful, which could be put down to the fact that they are willing to improve themselves.

Food is very plentiful in the area. There was no trouble getting enough food for the carriers. The people are becoming very conscious of money as there was very little food bought with salt and other trade goods. There are three ways that money is available to them and they are:1. By selling their produce to pairels moving

through the area

2. By the young men joining the Highland Labour Scheme, but this depletes the streaty small labour force in the area.

3. By selling produce to the missions that are established there.

New that the Reman Cathelic Missien and the Lutherum Missien have agreed to build an airstrip jointly, at PASALAGUS, the people will so paid for the work they do on the strip. So the airstrip will have a two fold effect on the people. Firstly, they will receive their ments and secondly, it will give them closer contact with the Administration and the outside world.

The Common Rell/wagmade up without any trouble. This want a Census, yet most of the people came to hear Mr. Hardy talk to them on the signifigance of the Common Rell and the Changes it will mean for the people of Papua and New Guinea in general.

I feel that the people did not fully understand the election of their ewn people to The Esgislative Council. This are is so isolated and does not have the contact with the Administration as away say the people living in the close preximity of a Government Station. This position may improve when the airstrip at PASALAGUS is completed.

#### VILLAGE OFFICIALS.

The Luluis and Thatks Tultule in the MARAMUNI, are very helpful and have good centrel over their respective lines. They had the people waiting at the rest house before the patrol arrived in their area for the compiling of the Common Rell. When this was completed, the Luluais and Tultule organized the women of their line to sell food to the patrel.

#### REST HOUSES.

Most of the rest houses were in very good condition. The one at KAINYETOK really steed out due to the that there was no pitpit in the area and weven bambee had to be used. This house was a real credit to the people. The rest housesat PCAGARE, NELYAKU and TONGORE were in a dilapidateted state and are now being rebuilt.

#### TRACKS AND BRIDGES.

A THE RESIDENCE OF THE PARTY OF

AS the weather was mostly fine while the patrol was in progress it was noticed that the walking tracks were in excelent cendition.

On all sections of the track, except for about four miles on the WOILEP side of PORES, the walking, although hard because of the terrain, is vory pleasant.

This section out of PORRS will have work done on it as seen as the PASALAGUS airstrip is completed and the people of Woller can devote their time and attention to its main/enumee.

The bridges on all the tracks are in reasonable condition. There are many small streams and drains to creat so these bridges have to be kept up to standard so as the local people can move from point to point without any trouble.

#### EDUCATION.

The three Missions have some small schools in the MARAHUNI where the fundementals of Health and Education are taught. I found that at NELIGARU the children must be taking notice of the Health side of their training as they appear to be semewhat cleaner and tidier than the children of other places that were visited.

#### CONCLUSION.

The patrel was a routine and no untoward incidents occurred. The objects of the patrol, mainly Routine ideinistration and Compilation of the Common Rell, were satisfactorily poccuplished.

#### MEDICAL and HEALTH.

The MARAMUNI population is recieving medical attention as good as anywhere inthe Vestern Highlands, as there are five Aid Posts strategically placed in the area to give medical attention to the 3000 inhabitants.

The patrol was accompanied by the N.M.O.'s namely THI and KUMRASTI. The main job of these N.M.O.'s was to administer Triple intigen injections to all the children between the ages of 3 nenths and 5 years. All told there were 719 injections given. Also treatments for Septic seres, Scabics, Empetige (mestly in bables) Boils, Tropical Wicors, Comjunctivities and 9 cases of Emlarged Spleans due to Maloria.

TEI, who was the senior of the two E.E.O. a was a very valuable member of the patrol. He is a very conscientious and hemost worker . KUWRANTI, who was the other N.M.O., although very quiet, was a hard and tireless worker and was a great asset to the patrol.

#### AGRICULTURE and LIVESTOCK

The MARAMUMI people seem to have sufficeint supply of the staple crop "Kankau". This is probably due to the vast area of land for such a small population. Other staple crops available are corn, banamas(cooking and cating), tare, yams, and sugar came.

The cash crops produced in the area are tenatees, casumber, beans, cabbage and peanuts. The peanute produced are very important as they have a high protâin centent which is essential in the native diet.

There is a small amount of coffee grown here, but it seems to be badly tended and it is planted in inaccessable areas. All the plants are immature and are not producing. When the airstrip is eponed ,it could give the people an avenue of cake , by back leading small amounts of coffee on Gesma charters.

Hr. Wilson's impressions of the people in the Opper AMBER are those of every Officer who has patrelled this area. Although coming from the worst endowed area of the Division, they are the most hopoless as far as ambition goes.

As the Council Tax Rule has been passed, apprehension regarding high rate of taxation should now cease.

Officials. The alleged misconduct by newly elected Councillors was investigated, but nothing warranting Court action could be substantiated. All have been instruced in their duties, but no doubt, as in other areas, growing pains will be encountered.

Common Roll. The Preliminary Lists for the AKBUM were satisfactorily completed.

This was Mr. Wilson's first sole patrol, and he applied himself to his tasks with enthusiase. As he is now at Mapenswanda, he should receive considerable patrol experience during the remainder of this year.

## Monday, Ist. April, 1963.

#### WARAG - PER

Left WARAG at 0930 for MAR heat House in the Ambum Gensus Division. Arrived there at 1030 hrs. After settling in I spoke to all the people on the Common Poll and the proposed new Legislative Courcil At 1203 hrs. I commenced to compile the Common Roll There were no disputes, either minor or major, to be heard.

## Tuesday, 2nd. April, 1963.

#### PAR - YAMPU

Laft PAR at CS30 hrs. and proceeded to walk to YANGA Rest House, arriving there at 0900 hrs. Settled in and then spoke to the people on the Common Roll MIX. etc. I then common to compile the Common Roll. At ISIO hrs. Mr. P. Maroney and Mr. R. Glover arrived to give a talk on the Native Local Government Council.

### Wednesday, 3rd. April, 1963.

#### YAMPU - MERIAMANDA

Left MANFU pt 0030 hrs. and arrived at the Rest House at MERIMANDA at 0925hrs. After tacking to the people, I then talked to all the people on the road maintenance that had to be carried out on their section of the KOMPIAN fload. This talk completed I present commenced to compile the Common Roll. Their were since disputes or complaints from the people here.

### Thursday, 4th. April, 1963.

#### AT MERIAMANDA

Commenced read maintenance on the three worst sections of the Kospian read today. Walked down to the PORCHERA River in the sorning and in the afternoon to see how the work was progressing.

#### FRiday, 5th. April, 1963.

#### AT MERIAMANDA

Continued with the road maintenance and finished the three sections started yesterlay. (See Roads and Briger Section).

#### Saturday, 6th. April. 1963.

#### MERIAHANDA - MOBOGAN

After telling the Inlusis and Tultuls what was required of them for the upkeep of the road, I proceeded to YAMPU Rest House arriving there at 09%5 hrs, after leaving MEXIAMANNA at 0900 hrs. After receiving a message from MARAG, I set out for MONOGAN by par, arriving there at IIOO hrs. I settled was minor disputes and sent another less to WARAG.

#### Sunday, 7th. April, 1963.

#### AT MONOGAM

Sunday abserved.

#### Monday 8th April, 1963.

#### AT HONOGAM

Commenced road maintenance on the section of road between LOMIXL and MONOGAM, where the road and the bridges are in bad condition Supervised this section during the norming During the afternoon organised the responsible for the road between MONOGAM and "SINERO".

#### Ruesday, 9th. April, 1963.

AT HONOGAM

Continued the maintenance of the road between TSIKERU and MONEGAM and botween LONDOL and MONOGAM. Heard a number of minor disputes during the late afternoon and evening.

#### Wednesday, 10th. April, 1963.

MONOGAM - TSIMERU

Left MONOGAM at 0800hrs by car and arrived at TSIKKRU at 0820hrs. After settling in I advised the Daluais and Tultula of the road work required between TSIKERU and KURDIS. I then started the people working on this section of the road. No disputes or complaints here today.

#### Thursday, the IIth. April, 1963.

AT TSIKKRU

Road maintenance continued today. The road is getting better here but some bridges need major work done to them and others need replacing. The car from WARAS arrived at about IASO hours and I proceeded to MARAS for the Easter holidays ,arriving there at ISSOhrs.

From the 12th to the 15th, of April at WARAG.

Tuesday, Toth. April, 1963.

WARMS - YAMPU

Left WADAG by our at 1730hrs, arriving at YAMPU at 1800hrs.

Wednesday, 17th. April, 1963.

AT TAMPU

Commenced on the read and pridge maintenance of the MANTAL -KUNDIS section. During the afternoon, answered questions on the W. L.G.C. and the Legislative Council.

Thursday, 18th. april, 1963.

AT YAMPU

While i had some people from here working on the MANPU-KUNDIS section of the NYAD, Started another group on the MANPU - MERIAMANNA section of the KOMPIAM road.

Priday 19th April, 1963.

AT YAMPU

Continued work on the two sections of road. During the afternoon I called in the Inlusis and Tultuls and reminded they of their responsibility for the maintenance of the roads.

Saturday, 20th. April, 1965

TAMPU - TIALTHUS

Left MANPU at 0800hrs., arriving at TIALIPOS Rest House at 0845hrs.. I had saked the people to assemble here at 0900hrs, but about half are Seven Day Adventists, so I could only compile a portion of the Common Roll. During the afternoon I heard two minor disputes.

Sunday, 21st. April, 1963.

Observed at TIALTPOS.

Monday, 22nd. April, 1966.

PIALIFOS - TIAKAMANDA

The rest of the people arrived at 0900 hrs. and after giving a talk on the Common Roll and the new Legislative Council I was able to

complete the Common Roll here by IN-Shri-I then moved on to TIAVAMANDA arriving there at ILOOhrs. I gave a talk to the people on the Common Roll etc. . Just as I commenced the compilation of the Common Roll it started to rain and this continued all afternoon. I talked to the Village Officials on various sub--jects during the afternoon. Tuesday, 23rd. April, 1963. AT TIAKAMANDA All the people arrived here early today and I was able to commence compiling the Common Roll at 0830hrs. and I had finished by It 30hrs. During the afternoon I heard a rumber of petty disputes. Wednes/sy, 2 th. April, 1963. TIAKAMANDA - KASI. Loft TIARAMANNA at OBOThrs. and arrived at MASI at OFIShrs. I gave the people assembled here a talk on the Common Roll sto. and I was able to finish the Comment Roll by 1215hrs. I then forwarded the equipment to TSIXXXI and I started to walk down to KUDIS. I arrived there at 15 50hrs, after talking to the people working on the road. The car from WAPAG arrived at 1530 to transport me into WARAG for Amuse Day. Thursday, 25th. April, 1965. AT WARAG Annac Day observed. riday, 26th. pril, 1963. WARAG - TSIKERU Left WARAG at OSIShre by car, arriving at CSIMERU at 0905hre. The people had been asked to arrive at 0900hrs but they did not arrive until

IIX hrs. I then gave a talk on the Common Roll and then commenced compiling the Common Rell itself. I finally finished it by ISOOhrs. There were no complaints or disputes here.

Saturday, 27th. April, 1963.

TSIKURU - YEARAG

The people from RAKAMANDA and MALYENDA had been asked to assemble here tolay they all arrived early and I was able to commence with the Common Roll talk at 0800hrs and was able to finish the compiling of the Roll at T600hrs. The our from Light arrived at INTH ISOURIE and I then proceeded to WARAC.

The patrol was broken for a period of three weeks as the HXX writer had to priseed to the WAPENAMANDA Administrative area to carry out argent road and bridge saintenance on the MT. HAGEN - WARAS ROAD.

Thursday, 23rd. torik, 1963.

WARAG - MONOGEM.

Left Walag by traptor at IIBOhrs. arriving at MONOGAM at IL Whrs. Settled in and then talked to the people. I heads two minor dis sutes during the evening.

Friday, 24th. 1990, 1963.

AT MONOGAM

Assembled half the people here today. After giving a talk on the Counce Rell, I consenced compiling the Roll. During the afternoon, I heard a number of complaints from the people concerning the new Commcillers. I will relay the compaints to the ADO tonorrow.

Saturday, 25th. May, 1963.

#### MOROGAM - MABAG

At ILECTION and the Common Rell here today and was able to finish at ILECTION. I then seved into WARG and talked to the ADC on the complaints to me yesterlay.

Sunday, 26th. May, 1963.

#### TABAG - MONOGAH

Left WARAG by oar at ILJC hrs and arrived at Wonogam at ISKhrs, Settled two disputes during the late afternoon.

Moreany, 27th, May, 1963.

#### MONOGAN - LONDON

Left M/NGAN at CHOChro, after waiting for one and a half hours for carriers to arrive. And wol at LOHDOL at 1015hrs. Commonded to talk to the people on the Common Roll and had the Rel completed at 16 Khrs. Later, while walking in the area, I found f new playing "Lacky". These new were sent to NABAS for Court action.

Tuesday, 20th, May, 1963.

#### AT LONDOL

Pinished the compilation of the Rell at 15 Shors. I then talked to the people on various satters and during the afternoon a thed two migor disputes.

Wednesday, 29th May, 1963.

#### LONDOL - HARAG

During the norming, I broke comp and sent the patrol goar into TARAS in charge of the Police. I talked to the people until the car arrived at 1600 hrs. Arrived WARAS at 1930hrs. Patrolemiet.

EED OF DIARY.

The main purpose of this patrol was to compile the Common Rollin the AMENUM Consus Division. The secondary purpose was to do road maintenance on the EMMPIAN and AMENUM roads which were not up to standard.

The Coumon Re'l and the Legislative Councilwas met with a good reception when explained to the people. They seemed to have a better understanding of the Legislative Council that the people in the MARANUMU Census Division, as they are closer to the minimistration Station at WARAN and they also have a representative from the WARAN area in the Council.

This patrol was often broken but this did not interupt the work of the patrol.

By the end of the patrol all its sime had been carried out. But the read and bridges between TSIKERU and ICHNAL need constant attention to keep them up to standard.

#### NATIVE AFFAIRS:

The Native Affairs situation in the ANRIM Consus Division remains good. During the month the patrol sent in the areathere was no serious trouble encounted. There were numerous pett, disputes heard by the writer, but these were settled without difficulty.

As the patrol proceeded towards LONDOL it found that the people tended to get larier in regard to work around the Rest Houses, work on the roads positivity and panotuality when assembling for the Juneou Roll. But everything was completed on time and no serious hold-ups occured.

As other patrols have found, the main interest is in money. With a new Mative Local Government Council coming to this area, the people are wanting money more than ever to pay their taxes. It was explained many times that the Council tax will be very little, but the people, who have spent some time down on the corest, bring back stories of the high Council tax paid by the coastal people. This worries then because they think there is just one taxation rate for the whole Porritory. It was found that to buy fresh vegetables here, nowey had to be used almost exclusively, for as the people sind "We cannot pay taxes with sall". An example of this money hungry attitude was at MONOGAM, where a small pig was brought up to the patrol and the owner wanted £7-TO-O for it. The reason he gave was that he needed the money for the Council tax, which he thought would be at least & P.A.

I think that it all boils down to the fact that the people see Police, Interpreters, etc. Foods at a store with money earnt by them, and the people for from the waitlying areas are uncertandibly jealous of this. If the Administration, in some way, can open up a way for these people to sell their produce in greater quantities, then the people would be happier and no doubt, be willing to co-operate with the Administration with more real than they now do.

#### ROADS AND HRIDGES:

There are two main roads in the ANEUM Ceneus Division - the road to KOMPIAN Patrol Post and the road to LONDOL.

The road to KOMPIAN was worked on furing the first week of the patrol. The trouble with this section of road is that there are appreciately I50 men to maintain and look after about four wies of road. The three worst sections were worked onand the work completed. To bring this section up to standard I would suggest that about two hundred laborers be employed by the Administration for a number of weeks so that semething constructive can be scheived. I cannot see the people up on this section spending wheks on the road without being paid for the work. With laborers , we could then be sure of the work being finished and also be sure of a regular work force on the road every day.

Another difficulty on this road is the lack of stone for the surfacings the road. At the moment there is a small supply of large rocks whichhave to be broken up to put on the road. This is not a very satisfactory way of road surfacing. The road to LANDOL had using days work spent on it. The road surface itself is not toobad now but some of the bridges and small culver's need major work done on them. To do this work I would suggest that the road be closed for two or three days so that the work can be completed.

In a number of places the road KANA between MONOGAM and LONDOL could be widehed, as there have been landslides on both sides of the road cutting the width of the road considerably.

For all this work, bridge replacing and road widening, labourers would be best employed.

#### VILLAGE OFFICIALS:

The time of the Indusis and Tultule is nearing an end. I did not neet any outstanding officials but most seemed very willing and helpfull as the patrol passed through their area.

There have been a number of complaints concerning the newly elected Commeillors. These complaints were investigated and all were denied by the Councillors. I suggest though that the duties of the Councillors be clarified by the Patrol Officer in charge of the WARAG Native Local Government Council for I think that the Councillors have the wrong idea of their duties. These duties have been explained numerous times by myself and by the other officers in WARAG. If not supervised closely, I imagine that these con will try and exploit the people in the Council area.

#### MISSIONS:

The Roman Catholic Mission is the most predominant in the area with four stations staffed by Europeans. The Lutheran Mission (Missouri Mission have one station staffed by Europeans and the Seven Day Adventist Mission have no stations staffed by Europeans, but a number of small stations staffed by Mative Evangelists

The four main Roman Catholic stations are LANDIL, TSIKERU, YAMPU and PAR. All stations have schools teaching up to standard 2 excepting PAR, which goes to standard 3. At smaller stations in the area, the Missions have Native Evangelist who do a small amount of teaching.

The Lutheran Mission is situated at KUMDIS. At present standard 2 is taught but it is hoped that in the near future that standard 6 will be reached.

As the Missions have been in the area a number of years, the Matives have come to accept them and the patrol had no complaints by the natives about them. The Mission: seem to be doing a good job among the natives, especially with Biucation.

#### LAW AND JUSTICE:

Of the numerous disputes brought before the writer, all causes were , as usual, land women and pigs. These disputes were settled with little difficulty and to the satisfaction of the parties involved.

During the patrol I sent two men into WARAG for Court action. The dispute started with anargument over pigs. While smiting for the writer to X finish another dispute over pigs,a fight developed between the two men outside the Rest House at MONGAM-I then broke this fight up and sent the two men to WARAG in charge of a Imlusi.

While at LONDOL, I was walking around the area near the RestHouse when I caught sine men playig "Dacky". As I approached they all scattered leaving their cards behind. One man was aprehended and he gave the names of the other eight players. Six of them works for the Catholic Mission at LONDOL where I later found out from the Father there that he does not allow cards of any sort on his station. The players were then sent to MARAG for Court action.

Other than these to incidents the situation, as far as

#### REST HOUSES:

All Rest Houses in the NMRM Census Division were visited by the patrol.

Next were found to be in very good condition and more had to be replaced. At TAMPU new grass had to be used for the roofte bring it up to standard. At MCROCAN the Rest Mouse was excellent, but the Police Parracks were a disgrace. The Barracks were renewed during the Patrols stay there.

#### COMCLUSION:

Other than the minerous land disputes, the native situation in the ANHUM Consumplivision remains good. The people seem to have an idea that the Government is trying to help them. The people in this area particularly, want a bigger mometary return from the Administration.

The people from ICHTOL are the worst people I not on this patrol. I gut this down to the fact that they are not in such close contact with the Administration as are the people further lown the valley.

#### MEDICAL AND HEALTH:

With the number of Aid Posts in the Ankan Valley, the health coverage for the people here is very good. These Aid Posts are situated at LANDOL, NORGAN, TSLEWNU and TIALINOS, with a Massion Aid Post at MAMPU. All Government Aid Posts were visited by the patrol.

By far the best Aid Post visited was the one at LONDOL with A.P.O. Jul in charge. He seems very efficient and his Aid Post is run the seme way.

The Aid Post at MONOGAM was found to be very clean and tidy. A new dispensary was completed just before the patrols arrival there.

A.P.O. PUN seems an average type He has been having trouble with the people in the area in regard to the supply of food and firewood. The people were given a talk on the importance of an Aid Post and I think that in future the A.P.O. will not have any further trouble in this respect.

The Aid Posts at TSIKERU and TIALIPOSwheninspected, were found to be clean and tidy. The A.P.O. &s at these places were found to be average.

I was informed during my stay at TSTATEU that there has been an outbreak of Propical Ulcers in the area. Other than this , the health of the people seems generally good.

At all stations visited by the patrol ,ample food was bought for the patrol, except for YAMPU, PAR and MENCAMANDA where the people take their produce into NAMAG for sale to the Administration.

Of the coffee inspected, all seemed to be well and is being well leved after by the owners. There is not much coffee grown at the IONDAL end of the Valley because of the height, which is 7,500ft above sea level.

At present, the people sell fresh vegetables to the Mission stations and this is their only form of income. At this time the area is being patrolled by an Agricultural Officer, who should be able to give the people a few hints or how to increase the size of their harvests.

#### EDUCATION:

The Missions are doing very good work in this are in the field of Education. There is a good education coverage throughout the whole Valley, but at present this mainly caters for the younger children up to Standard 2.

The Roman Catholic Mission at TSINERU and PAR reach Standard three, While at LONDOL, MONOCAM, and TAIPU, the standard reached is Standard 2. It is hoped later, when accommodation becomes available, to bring the former two schools up to Standard 5 or 6. All these schools, except the one at MONOCAM, have Europeans in charge.

The Lutheran Mission school at KUNDIS, at present, reaches Standard 2, but it is hoped to bring this up to Standard 4 when accommodation becomes available.

Apart from these stations, the various Missions have small schools run by native Evangelists, who give the children a good background for future education.

The job was being done by local grow residing in the near vicinity. It entailed the sutting out of many tens of earth, and under supervision the natives worked well.
