In accordance with our conversation of yesterday, the following is my suggestion as to the nature of a letter which you might write to the Mortgage Guarantee Co. in behalf of the Grossmont Park Co. and Mr. Fletcher:

"On January 9, 1931 a check of the Grossmont Park Co. for \$539.58, drawn on this bank in your favor, was returned unpaid. Ample funds were on deposit for payment of the check which was returned due to an inadvertence in this office.

Upon our telephone request, the check was again presented and paid January 15, 1931.

We are writing you at this time so that your records may be cleared without prejudice to our mutual client."

The Mortgage Guarantee Company's number of the Grossmont Park loan is IB 44971, which might aid them in properly locating the account.

It would be my suggestion that you use your own judgment as to whether you care to reimburse the Grossmont Park Co. for the \$6.66 in delinquent charges which they had to pay. I don't believe the company is particularly concerned about the charges. Their chief interest in the matter has been to have the Mortgage Guarantee Co. records clear of any reflection on their company.

If a letter is written to them, you may forward a copy of it to Charles G. Fletcher, in care of this office, and one to the Grossmont Park Company, San Diego.

The above needs no explanation. I am enclosing the data regarding same, and suggest that the Grossmont Park Company send their check for \$6.66 to the mortgage guaranty if it has not already been done. Then we shall await developments from the bank which I am sure will be satisfactory.
