KLEINDIENST & HERB KLEIN ARE FAKERS

Since 1948, the U.S. Dept. of Justice which is supposed to stand for LAW & ORDER, has been the cause of the flooding of the United States by narcotics, marijuana, and other dangerous drugs. In recent years, I have been putting out homemade Newsletters telling what is going on. For instance, there is a Newsletter dated January 14, 1966 which is entitled IMMIGRATION SERVICE HELPS SMUGGLING OF NARCOTICS.

These pamphlets have been distributed all over the United States and particularly to officials and news media in Washington, D.C. They have proved to be very embarrassing to the NIXON REGIME which decided to remedy the situation. The Nixon Administration inherited the problem.

BUT RICHARD KLEINDIENST, THE DEPUTY ATTORNEY GENERAL (SECOND HIGHEST OFFICIAL IN THE DEPT.) AND HERB KLEIN, DIRECTOR OF COMMUNICATIONS FOR THE NIXON ADMINISTRATION, ARE JUST DOING A WHITEWASH SO THAT THE SAME FLOODING OF THE U.S. WITH NARCOTICS, ETC. IS CONTINUING UNSTOPPED.

A few basic facts must be known to understand how the U.S. is being flooded by narcotics and marijuana. The Immigration And Naturalization Service is a part of the U.S. Dept. of Justice. The U.S. Border Patrol is a part of the Immigration Service.

RAYMOND FARRELL, COMMISSIONER OF THE IMMIGRATION SERVICE IN RECENT YEARS, IS THE PERSON PRIMARILY RESPONSIBLE FOR THIS FLOOD OF NARCOTICS FOR I HAVE REPEATEDLY TOLD HIM HOW IT COULD BE STOPPED BUT HE HAS NOT TAKEN ANY ACTION.

Farrell, has been in collusion with big ranchers, factories, hotels, mines, etc. etc. to have a big pool of Mexicans who live in Mexico to cross the border and work in the U.S. for cheap wages. Elected officials from states along the Mexican border, have been taking payoffs in the form of campaign contributions, to keep the pressure on Farrell so that he keep on having this pool of Mexicans to live in Mexico and cross the border to work for very low wages.

A Mexican farmworker makes only 15 cents per hour while a factory worker makes only 20 cents per hour in Mexico. Their scale of living is 1/8 that of the average workingperson in the United States. You can easily see how these Mexicans will work for 50 Cents per hour in the U.S. while living in Mexico. Under such conditions they are very high priced workers in the eyes of the average Mexican. BUT FOR PEOPLE LIVING IN THE U.S. AND TRYING TO GET WORK, IT HAS BEEN MISERY AND FRUSTRATION WITH RAYMOND FARRELL BEING THE CAUSE OF THESE SERIOUS CONDITIONS.

Now these poor people from Mexico cross and see what Americans have. So they want more. This is how thousands of them become "runners" for drug smugglers by carrying the narcotics across when they go to work or cross supposedly to buy or visit.

An average lipstick container can hold 6 grams of morphine or heroin, two drugs addiction to which is very serious. The average dose of morphine for a shot for legal medical reasons is 15 milligrams. This means that out of 6 grams of morphine, a physician can give 400 shots and if the physician charges \$5.00 a shot, it means collecting \$2,000.00. The average dose for heroin is $7\frac{1}{2}$ milligrams or just half of the morphine dose and at \$5.00 a shot, would give \$4,000.00. (Heroin is not used in medical practice because the danger of addiction is too great).

Addicts would gladly pay \$5.00 per shot if they got the pure morphine or heroin for in the illegal drug traffic, the narcotic is "cut" which means it is adulterated with other substances so that the 6 grams in an average lipstick, becomes 24 or 30 grams in the U.S. But to be conservative, a lipstick container of heroin is worth \$5,000.00.

Many of these Mexicans who are called "greencarders" who cross to work, or "72 hours crossing card holders" who supposedly cross to visit or buy (but who in reality go to work) are runners of narcotics. In 1966, I saw 1,404 persons cross in one hour and none were searched.

Since Sept. 22, 1969, Richard Kleindienst with Herb Klein putting out the publicity have been brainwashing the American public into believing that most persons and autos from Mexico crossing into the United States are being properly searched. THIS IS NOT TRUE.

I HAVE GONE TO THE BORDER SEVERAL TIMES AT CALEXICO AND FOUND THAT NO REAL SEARCH OF PERSONS OR AUTOS ARE BEING DONE.

A search of a person takes 5 minutes. It must be done in private. Look in your wife's or girl friend's purse. You will find that she has 2 or 3 lipstick containers in her purse. I have watched at the border and Mexican women cross without the purses being looked into. A Mexican woman can cross with 3 lipstick containers having \$15,000.00 worth of heroin and she is being paid \$5.00 to cross and give it to a "collector" who is on the American side. Just 66 Mexican women doing the same thing in one day and you have \$1,000,000.00 heroin in the U.S. before it is "cut". These women have to have their clothes searched for the heroin is wrapped in papers and sewn into the linings. You can see that 5 minutes in private is needed to search women.

The same holds true for the men. I have seen them cross without their lunchboxes being searched or having to empty their pockets.

Marijuana is a different matter. For real commercial smuggling, it has to be done by auto or airplane. The usual marijuana slab which weighs a kilo (2.2 pounds or 35 ounces) is 11 inches by 7 inches by 2 inches. You can see this is too big to carry on one's person for real smuggling. Marijuana at the border "uncut" sells for about \$15.00 per ounce so a kilo slab sells for \$525.00. Compare this price of the large slab of marijuana with a lipstick container of heroin weighing 6 grams which conservatively sells for \$5,000.00 "uncut".

For an auto, one half hour is necessary to search for marijuana which is large but more importantly for heroin and morphine which is so small and can be hidden in many places and which are very dangerous.

As it is being done now, there are lines of people waiting to cross the border and autos also wait. I told Farrell 3 years ago, that "green carders" must be told that they must live in the U.S. This will stop the necessity to search them and their autos. The Immigration Service must run a spot ad over radio and newspapers for people to call the Border Patrol to catch "72 hours crossing card holders" who work. As soon as they see they can not get work they will not cross.

Mexicans working in Mexico do not earn wages sufficient to buy American products by crossing the border. It is the "Greencarders" and "72 hours crossers" working in the U.S. who can buy some things in the U.S. Stop these 2 groups from crossing and any Mexican who has a legitimate reason to cross will not have to wait and will get a prompt proper searching and the flood of narcotics, etc. will be stopped.

Kleindienst and Klein have Senator Goldwater, (Rep.), Cong. John Tunney, (Dem), Senator Geo. Murphy, (Rep.), Gov. Reagan (Rep.) etc. pressuring them to let the Mexicans live in Mexico and cross to work cheaply.
