This letter is to reiterate the Mexican American Political Association's position in regards to the proposed enlargements of the Casa de Salud building and the enhancement of programs therein.

As a long time resident and public servant of the City of National City you are surely aware of the historical and social significance of the Casa to the Mexican American residents of National City and particularly to those who reside in the west side of National Avenue.

The Cas, has long been the focal point for many, many, social, civic, and recreational activities initiated by and for the local residents. In the truest sense of the word the Casa is an institution within the social setting and the life of the West side residents.

It is with in this context that we in MAPA address ourselves to our current effort to revitalize the activities within the Casa. Our efforts to reactivate a variety of programs and activities there are motivated because of our genuine concern over past and current social problems which adversely effect our community, particularly as they effect the young people in the area.

Secondly, realizing the important role that the Casa has played in not only the young people's lives, but those of many of their parents as well, we feel that if solutions are to be found, and if remedial action is to be initiated then we must begin there; the natural and social center of activities for the area.

Further, our efforts are directed to envolve parents, the young people's peers; concerned persons who are personally familiar with the problems and aquainted with the youths.

In analysing our own needs and capabilities we have come to realize several factors which impede our attainment of our goals.

1. Physical limitations

A. The space distribution is inadequate for effective planning and implementatation of programs for a variety of age levels and programatic interests.

B. Current space allocation prohibits the utilization of any segment of the Casa for specific uses on a permanent basis.

C. Storage space for specialized equipment is minimal at best.

2. Budgetary limitations

A. Inadequate salaries have served to deny hiring of professionals especially trained in working in disadvantaged areas or with group of differing social and cultural background.

3. Staffing

A. Should be compensated according to the complexity of duties and the time difference allocated to the center.

We feel a further deteriment to our efforts is the attitude manifested by both elected appointed and staff officials as to our objectives sincerity and integrity. We can see a marked difference in the response and receptivity to our plead for co-operation in carrying out our programs. We look with dismay and a great deal of resentment at the negative response to our efforts and the blatent favoritism shown to others making similar requests.

We cannot furnish you with specific denographic data at this time, but I am sure such information is available to you from a variety of sources.

In short we are offering alternative to drug usage, juvenile delinquency and violent social reactions, we feel that with help we can accomplish goals which can be beneficial to the total community.

We further ask that you accept this as our position and work with us from that premis.



On November 11, 1971 the infamous Dixon-Arnett Bill was signed into law. On March 4, 1972 this law went into effect. We are asking you to help us protest this law on the grounds that it is:

- 1. Unconstitutional Immigration is a federal matter not a state matter. California is famous for passing this type of racist laws when it finds itself in an economic recession. Examples: the Anti-Mining laws in the 1950s, aimed against Mexicans; Coolie laws aimed at Chinese, 1860; Okie laws aimed at Anglos, 1930. We must not let the deportation that occurred in 1932 and 1954 when millions of Mexicans were deported happen again in 1972.
- 2. It is highly discriminatory In theory it says all illegal aliens, in reality it is estimated that 95% of all people without documents are Mexicans. How do you distinguish an American born Chicano from his brother born in Mexico? In order for this law to be enforced, every Chicano will have to prove his citizenship. Will any other segment of society have to do this? We know that the answer is no. Our Raza will have to pay the price by being subjected to further harassment, interrogation, shake downs, and overall violation of our civil rights not only by the immigration but by the sheriff, police, district attorneys, and all other enforcing agenciwe.
- 3. The problem is not black and white. We have people who have been here 10, 20 up to 50 years who have never gotten their citizenship papers because of various reasons language differences, cultural differences, bureaucratic red tape and an overall general fear of the Immigration Department. We are tired of families being broken up by inhuman and immoral laws. This law has been ruled unconstitutional in Los Angeles County. It will only be a matter of time before this law will be judged by the California State Supreme Court. The worst thing that we can do is to stay quiet.

At approximately 8:30 p.m. of the evening of February 6, 1972, an incident occurred at the home of Mr. & Mrs. Martin Gonzales, 858 Pecos St., Spring Valley, CA., 92077, which we are bringing to your attention for corrective action.

Once again we have the timeworn issue of police malfeasance and the diminutive power of the individual to defend himself. Listed in chronological order are the events which led to this complaint.

Mr. & Mrs. Martin Gonzales hosted a baby shower in their home which ended approximately at 8:30 p.m. at which time Martin and Harry Gonzales, brothers-in-law, got involved in an argument. Martin's wife, at this time, called the sheriffs office and asked that a sheriff be sent in order to prevent trouble.

Soon there after, four (4) sheriff's and a German shepard police dog crashed into the Martin Gonzales home without knocking. Martin told the sheriff that everything was settled and Mrs. Martin Gonzales who had registered the complaint nodded in agreement. Martin then asked if the sheriff had a warrent to which the sheriff replied, "I don't need one." At this point Martin and Harry asked the sheriff to leave, everything was settled. THIS STATEMENT WILL BE RELEASED ON MARCH 2, 1972

We have come here today to voice our concern about the adverse affects of a recent alien employment bill passed by the California State Assembly, and signed into law by Governor Reagan on November 11, 1971. The law is titled, The Dixon Arnett Law, which states that any employer who knowingly employees aliens not entitled to legal residents in the United States is liable to 200 to 500 dollars fine. Since the law was announced and even prior to its implementation on March 4 thousands of aliens have been laid off, causing harmful affects to themselves and their families. Many of these people have a constitutional right to be in this country since they have children, spouses or parents born here or who have permanent visaes.

As time goes on and the law is put into effect on March 4 of this year we know and fear that even more dire consequences will result. We believe that all law must be accutely promulgated and designed for the common good of all citizens. Any law that does pursuit harm to one sector of our society cannot be condoned even though it might be designed to help another sector of society.

Pope Paul VI, has recently stated in two documents, The Spiritly Care of Immigrants and a Call To Action, that immigrants have certain basic rights, among which are the rights to immigrate for their survival to work, and support their dependents in the mother country. His Holiness ask's that these people be welcomed by the country to which they migrate and that their rights be protected by law.

We join with him and with all men of good will to demand exceptional treatment of the immigrants. We demand that the Dixon Arnett law be repelled, changed, or delayed in its implementation so that the human dignity and God-Given rights of these aliens be protected.

These are Chicano community leaders which have expressed deep concern over AB-528 and the detriment which it would have on the Chicano Community.

At approximately 8:30 p.m. of the evening of February 6, 1972, an incident occurred at the home of Mr. & Mrs. Martin Gonzales, 858 Pecos St., Spring Valley, CA., 92077, which we are bringing to your attention for corrective action.

Once again we have the timeworn issue of police malfeasance and the diminutive power of the individual to defend himself. Listed in chronological order are the events which led to this complaint.

Mr. & Mrs. Martin Gonzales hosted a baby shower in their home which ended approximately at 8:30 p.m. at which time Martin and Harry Gonzales, brothers-in-law, got involved in an argument. Martin's wife, at this time, called the sheriffs office and asked that a sheriff be sent in order to prevent trouble.

Soon there after, four (4) sheriff's and a German shepard police dog crashed into the Martin Gonzales home without knocking. Martin told the sheriff that everything was settled and Mrs. Martin Gonzales who had registered the complaint nodded in agreement. Martin then asked if the sheriff had a warrent to which the sheriff replied, "I don't need one." At this point Martin and Harry asked the sheriff to leave, everything was settled. Up until this point, it may be noted that neighbors who will testify had not seen nor heard any disturbance. Martin was then attacked by four sheriff's and beaten with a flashlight by one of them. Harry was told to sit down which he did. Shortly thereafter, one sheriff asked another, "What about Harry?" The sheriff replied "take him in."

The wives were then threatened when they asked why their husbands were being abused. At no time did the victims either abuse or threaten the sheriffs. The wives were verbally insulted, "We are tired of cleaning up trash on this street. I do not take anything from you trash." Harry's

wife was grabbed by the arm and pushed across the room and threatened with a flashlight while she held a baby in her arms. Harry was told that if he testified that Martin had struck a blow at the officers, he would be set free. The sheriff with the dog told Mrs. Gonzales that her husband was being arrested on a felony and would be incarcerated for a long time. Another sheriff told her that Martin ad Harry could be bailed out in two hours, which they were. In conclusion, Ars. Martin Gonzalez called the sheriff in order to prevent trouble, not cause trouble. Neighbors were not aware of any disturbance until Martin was attacked in his home. Sheriff's entered without knocking and used a dangerous animal in the presence of children.

The actions of one sheriff in particular, he had to be calmed by others, were imprudent and indiscriminate. He displayed a lack of professionalism and training in the performance of his duties. These types of actions create much anomosity towards police officers and in consideration of all those involved, we feel that immediate corrective action should take place.



Board of Supervisors:

It has come to our attention once again that the Sational City Council, San Diego County, and "professional de-gooders" (South Say Ouidance Clinic), are once again up to their traditional games of seeking simplistic solutions to the complex problems in the Chicano community.

On January 1971, the Chicano community of National City expressed their disdein on the South Bay Guidance Clinic coming into the Casa de Salud on the west side of National City, and experimenting on our youth and serving their own self interest by trying to expend their statistical base in hopes of enlarging their financial status.

The principle of denying the Chicano community in National City any imput or direction into what is relevant to its needs, has once again resurfaced.

The issue of drug prevention is one that obviously concerns us all, but to approach it on the basis of expanding ones statistical and financial base is to perpetrate a farce on the total community and presents a very negative solution to the Chicano community. The services to the Chicano community provided by so called "professionals" (rapping, counseling, and pscho-analysis) has proven to be a complete historical failure as far as the Chicano "drug problem" is concerned. If the city and county are seriously concerned with the problems of "drug prevention" they are then going to have to start addressing themselves to the social and cultural differences that exist within the Chicano community. Sational City is 40% Chicano.

Mr. Morval Richardson, director of the South Bay Guidance Clinic, a year and a half ago stated that "he would meet with representatives of the Chicano community." To this day this has not been done.

The city of National City once again has shown a great insensitivity to a large portion of its tax paying constituentcy, and has done a great injustice by

providing office and resources in an area that is predominantly Chicano (90% on the west side).

The county, as a funding source of the South Bay Guidance Clinic, has under the guise of modal (modality) had a pattern of spreading the legalized poison of methadone. We have been opposed to methadone and methadone maintanance and will continue to oppose it because of the unpredictable dangers involved in dealing with a drug that no one has any empirical data on it.

Due to the seriousness of the problem, we are requesting that since the county (as a funding source) and the city of National City (in providing office space) look into the structural, programmical, and financial make-up of the South Bay Guidance Climic in its relation to the Chicamo community.

Please rest assured that this very serious matter has our complete attention and action will be forthcoming.

It has been brought to my attention that you are now the person who is either directly or indirectly responsible for the Economic Opportunity Commission of San Diego County. Therefore, I am writing this letter to express my concern over a memorandum directed to the EOC Board of Directors from the committee to select the future "Ad Hoc Committee" that will deal with the reconstruction of the Economic Opportunity Commission Board.

As I read the memo over, it became apparent that the Chicano population of San Diego County was not taken into consideration. The names that are listed under recommendation number ONE does not include a Chicano.

Mr. Panarisi, I am sure that as the Chief Administrator of Human Resources for the San Diego County, you are well aware that we (Chicanos) represent the largest minority group (well over 250,000 (16%) in population). Therefore, it seems to methat the people who were selected to make the recommendations are either insensitive to the Chicano peoples' cause or are unaware of the Chicano population in this County. In any case I feel the Recommending Committee should be made aware of their inequities. Such inequities will not and are not tolerated by the Chicano people any longer; especially, when the County, the Cities, and our school districts have implemented affirmative action programs. In the mist of all this an organization which supposedly is working to solve the poverty of our people recommends that the Chicano from the "Barrio" not participate in reconstructing the Economic Opportunity Commission Board.

THE MEXICAN AMERICANS-NE-GLECTED FELLOW CITIZENS

A NAMED OF THE AREA OF THE PROPERTY OF THE PRO

Mr. CRANSTON, Mr. President, on Saturday, April 3, 1971, the distinguished Senator from South Dakota (Mr. Mc-Govern) spoke before the California Democratic Council in Santa Monica, Calif., on the subject of our grievously neglected fellow citizens, the Mexican Americans.

Despite the fact that there are esti-mated to be some 7 million Mexican Americans in the United States today, these individuals continue to be the unfortunate subjects of much abuse and neglect. It is astonishing, for example, that the U.S. Census Bureau failed to count Mexican Americans in the 1970 census. This unjustifiable oversight may have lasting political repercussions if efforts are not made to insure that legislaave redistricting provides more adequate political representation for Mexican Americans, Further, the lack of equal opportualty for Mexican-Americans in employment and education is well documented, yet the Federal Government continues to ignore the procedures it might employ and the laws it should enforce in order to open the doors of opportunity for Mexican Americans.
It is disgraceful that such hypocrisy

exists in this great Nation. I believe that Senator McGovern has examined the extent of the problem and has recommended solutions with his usual insight, candor, and sensitivity. I commend his speech to the attention of Senators and ask unanimous consent that it be printed in the RECORD.

There being no objection, the speech was ordered to be printed in the RECORD. as follows:

OUR MOST NEGLECTED: THE MENICAN-AMERICANS

(Speech by Senator Grosce McGovern)

In view of my long opposition to the disaster in Indochina, you might have expected me to devote my remarks today to another strack on this incredible and unjustified

But on reflection, I have decided that such a speech to this group would be carrying coals to Newcastle-roughly comparable to w temperance lecture to the W.C.T.U.

No person with enough humanity to attend

convention of the C.D.C. needs any further convincing that the war in Indochina is sheer madness.

Nor do I need to stress the obvious truth that the sentencing of Lt. Calley does not assuage the national burden of guilt and shame we must all carry until this monstrous slaughter is ended.

Nor do I need to belabor the common sense of the McGovern-Hatfield Amendmen!- except to say that I fully expect the Senate to engot this Amendment cutting off further military operations in Indochina beyoud December 31 of this year.

Today, I want to talk about another issue that is not as much on our consciences as it should be-the treatment we accord our Mexican-American citizens.

More than a century ago, the California Constitution was drafted and signed in both English and Spanish. Almost one-third of the signers had Spanish surnames.

This Constitution guaranteed Mexican-Americans equal rights. Yet, given their reiative position among the nation's minorities-second only to blacks in terms of population-Mexican-Americans can only be described as the most invisible of all our minority groups.

America is a country addicted to hard figures. Statistics are everything. All of our social planning is predicated on the flow of hard figures that come churning out of the Census Bureau every ten years.

Imagine my surprise, then, when I learned recently that the Census Bureau, which literally counts almost everything in this country that is living and inanimate. from people to electric canopeners, did not count Mexican-Americans in the 1970 Cen-

Symbolically, anyway, Mexican-Americans in America apparently don't count. Whites count. Blacks count. Indians count. But due to the inexplicable ways of the bureaucracy. Mexican-Americans don't count.

It's a good thing Mexican-Americans keep track of themselves; otherwise, nobody else would know how many of them there really

The President's Committee on Opportunities for Spanish-Speaking Americans has estimated that there are a minimum of seven million Mexican-Americans in the country today.

The quartion of equal treatment for Mexican-Americans is especially pertinent for Californians. There are an estimated three million Mexican-Americans in California, the largest single minority group in any State in the Union.

And their number is growing. Public school figures for the fall of 1970 in California show that 18.5% of all first grade students are Mexican-Americans; 15.2% of all sixth grade

students are Mexican-Americans.
In Los Angeles County, 18.1% of all public school students are Mexican-Americans, and approximately 20% of sixth grade students are Mexican-Americans.

Furthermore, these figures probably understate the size of the Mexican-American school-age population because of a higher dropout rate and the fact that one out of every five parochial school students is a Mexican-American.

These figures are pregnant with political meaning. They tell us that very likely one out of every six new California volces in 1976 will be Mexican-American. And they raise the question of who these voters will have the opportunity to cast their ballot for.

I am a firm believer that when it comes to equal opportunity, the first opportunity must be for equal political power. For it is from that fundamental opportunity, that all others spring. As Chalman of the McGovern Reform Commission, I have fought for that kind of power within the Democratic Party itself and I sincerely hope the results will be visible at the 1972 convention.

I see no reason why the same principle should not extend to every sphere of political activity, including representation in local and state government. Mexican-Ameri-cans comprise 14% of California's population; yet they have only two representatives in the state's Assembly and none in the state Senate. By my calculation, if Mexican-Americans were to be fairly represented, they should have a total of 17 seats in the legislature-12 instead of two in the Assembly, and

five instead of none in the Senate.

Frankly, I can see no reason why every effort should not be made to facilitate this kind of equal representation for Mexican-Americans. And I would suggest that the California Democratic Party bend every effort to assure that the redistricting of the legislafure redect this need as a primary concern If the Democratic Party is to mean anything in the future, it must now mean permitting all Americans to fully represent themselves politically. Mexican-Americans want to represent themselves. And that time has surely come.

This is not simply an altruistic position for the Democratic Party to take. It is necessary for the survival of the Democratic Party as a party of all the people. If the Democratic Party does not take positive steps to include America's minorities in—and not just with rhetoric but a full share of power—the day will surely come when those minorities will leave the Democratic Party out in the politi-

A second area of equal opportunity for
Mexican-Americans I would like to talk about
is employment. In this case, my remarks are aimed primarily at the United States Government.

When it comes to employing MexicanAmericans, our government ranks as the
most hypocritical of institutions in the
country. The government is perfectly willing

to impose employment goals and quotas on private industry, as in the Philadelphia Prin. But when it comes to imposing goals and quotas on itself, that is another story.

The Federal Government is the nation's largest employer, and California's as well. The latest available figures indicate that 2 601,639 persons are employed in civilian capacities by the Federal Government. Only 2.8% of those employees have Spanish surnames, and that includes Puerto Ricans.

The percentage can be put in perspective by the fact that between five and seven percent of the nation's population have Spanish surnames. Clearly, on a population basis, Mexican-Americans are grossly under-employed by the Federal Government.

The President has the power today to issue an Executive Order setting a specific goal for employment of Mexicon-Americans by the Federal Government. If that goal were set at five percent, that would mean 55,900 additional jobs for Mexican-Americans.

But total number of jobs isn't the only Issue here. What level Jobs is also an issue. Mexican-Americans have historically been excluded from management and supervisory positions. At this moment, only 35 Jobs, or one-third of one percent, of the Federal Government's top 9.286 Jobs are held by persons with Spanish surnames. Only 133 of the top 24,300 Jobs are held by persons with Spanish surnames.

Spanish surnames.

In Californis, the Federal Government employs these times as many persons as the State. The Internal Revenue Service in the state employs 4.487 persons, only 108 of which or 2.4%, have Spanish surname. That is really taxation without representation! The Department of Sealth, Education, and Welfare employs 5.429 persons in the state; only 234, or 4.3%, have Spanish surnames. Further, 189 of the 234 are paid poverty level wages by the government.

This failure of the Federal Government to provide equal employment opportunities to Mexican-Americans transcends Republican or Democratic Administrations. The low level of employment has held steady since the early sixties.

And California itself is not doing much better than the Federal Government. Of the state's 117,481,000 jobs, only 4,239, or 2.64% are held by Mexican-Americans. And the average pay for Moxican-Americans is \$1,176 lower than the average pay for whites—a gap that has widened by 26% since 1960.

This unfair treatment by both the Federal

This unfair treatment by both the Federal and State Government persists in the fact of grievous unemployment among Mexican-Americans, Once again, unemployed Mexican-Americans, as such, are not specifically counted by the government. But reliable estimates place average Mexican-American unemployment at 18%. In especially impacted areas like East Los Angeles the figure is probably over 20%. Can you imagine what 55,000 jobs would mean for these unemployed people and their families?

The time is long past to end the hypocrisy of equal employment opportunity practiced by the Federal Government since President Fiserhower issued the Arst Equal Opportunity Executive Order in 1955. It is time for the Federal Government and the state of California to follow the principle of employment of Mexican-Americans, and other minorities, commensurate with their percentage of the total population.

Eight days ago, at their annual steckholders meeting, the President of Pacific Telephone announced that his company, the largest private employer in the state, would achieve that objective by 1975. If Pacific Telephone can do it, I don't see why the Federal Government and the state of California can't.

All it would take is a stroke of the pen. The Civil Service Commission has recommended it. In July of last year, five major

Mexican-American organizations asked for such an Executive Order. Yet the President has yet to pick up his pen.

I assure you that it I were sitting in San Clemente today, that pen would be picked up and an Executive Order signed. And I would invite Mexican-American leaders to come and watch in person. I think it is extremely unfortunate—though not unexpected given their overall treatment—that leading Mexican-Americans, despite formal requests to personally visit with the President, have not yet had the opportunity to do so.

have not yet had the opportunity to do so.

A third area of equal opportunity for
Mexican-Americans that I would like to discuss is that of culture, specifically respect
for the Mexican-American culture. It seems
to me that this country, which is in danger
of becoming completely homogenized culturally, should prize the diversity and uniqueness of the different peoples that are
Americans.

Mexican-Americans have a unique contribution to make to the country, especially in the language area. The sparkling gift of the Spanish language is a resource we should reward, not penalize, as is so often the case today.

It is no accident that Mexican-Americans do not benefit as fully from available programs as other minority groups. The language barrier screens them out. As simple a thing as the fact that all government forms are printed in English causes innumerable nardships.

Yet this barrier could also serve as a bridge. We could employ thousands of Mexican-Americans as translation aides in hospitals, employment service offices, welfare agencies, in any number of divisions of government. We might even employ them in the Census Bureau so that from now on we could count Mexican-Americans along with everybody else. And we could pay a special premium for the skill of being bilingual. At least as much as the \$15 a month being paid by Los Angeles County to its bilingual employees.

We could also use this gift of language in our relations abroad. In the Western hemisphere alone 183 million persons speak Spanish. Americans are notorious for falling to speak the language of other countries. Yet we have millions of native-bern Americans who already speak Spanish. This resource should no longer be permitted to go unused.

Finally, there is a fourth area of squal opportunity for Mexican-Americans that needs attention—the chance for higher education. I have been increasingly concerned lately with the difficulties facing veterans of our ill-conceived involvement in Vietnam. The unemployment rate among returning Vietnam veterans between 20 and 24 years of age is 12.4%.

These difficulties are even worse for veterans from minority groups, including Mexican-Americans who have contributed more than their fair share to this war. Fifteen percent of California's casualties, and 10% of all casualties in the southwest, have been Mexican-Americans.

What Mexican-Americans want to know is why they are first in war but last in peace? Why are they good enough to lead men in combat in Vietnam, to carry the heavy responsibility of life and death, but not good enough to handle a desk in Washington?

I think it is unconsciouable that these

I think it is unconscionable that these young men are not being guaranteed either work or equation upon their return home. No viceran of this wer should be shunted around from place to place looking for work, or be derived of the chance to go to college because he lacks sufficient funds.

We need to reinstitute a genuine GI Bill of Hights for our Vietnam Veterans, providing benefits equal to or even greater than those granted veterans of wars post. I am working on a legislative formula that would guarantee every Vietnam veteran either a

good public service job, or a generous opportunity for a college education at public

I believe further that we should extend the guarantee of higher education to any minority student who has the ability to absorb the education. And if a student is willing to repay the guarantee by several years of service to the community from which he came, then the cost of his education should be free. Serving America in peace should be just as important as serving her in war.

There is one last thought I would like to express regarding the opportunity for higher education. Unlike other minority groups, Mexican-Americans do not have an institution of higher education they can call their own. The creation of such an institution would be of enormous benefit, not only to Mexican-Americans, but to all Americans. Such an institution would soon help fill the need for Mexican-Americans with professional training in all kinds of disciplines. It would be a constant source of leadership for the Mexican-American community. It could be a repository of Mexican-American culture, and as such would be a national resource.

The Federal Government has a proud history of fostering higher education, beginning with the land grant colleges. I see no reason why the government could not sponsor the founding of a college specifically for Mexican-Americans. When the nation had a land gap to fill, it gave the railroads the land they needed. Why shouldn't the government bridge the culture gap by giving Mexican-Americans the land and whatever other resources are required to establish an institution to serve their needs as well as America's.

Let me say, in conclusion, that I appreciate having the opportunity today to share my feelings with you regarding the needs of our fellow citizens of Mexican descent. I think we all know that their need for an equal opportunity is really America's need as well—the need to fulfill the promise upon which the nation was founded and without which it would cease to be an inspiration to mankind.

Let us rededicate curselves to the following propositions.

Mexican-Americans can no longer be taxed while remaining politically unrepresented.

Mexican-Americans can no longer be first in war casualties and last in civilian jobs.

And billions can no longer be spent to

And billions can no longer be spent to enrich the culture of other countries while zero is spent to assist the Indigenous Mexican-American culture.

And we, white Americans and the Democratic party, the institutions that have benefitted most from the Mexican-American, must be the first to correct the injustices of the last 100 years.

We endorse Peter Schey because he is experienced and aware of local problems, but we also support the hiring of more experienced bilingual attorneys.

A few days ago we met a bilingual employee who was recently hired by you. According to what he told us, he is not yet an attorney, he is inexperienced in community legal problems, and his past political affiliations were not with people we consider sympathetic to our problems. Had we been consulted, we would have preferred to have seen a few para-legal Chicanos from the community hired to assist Mr. Schey and receive training in immigration law.

Our Model Cities funding was first reduced and then split in half between criminal and civil law effective July 1, 1973. We have both contractual and community demands to employ minority attorneys. These two factors have made even Mr. Schey's continued employment problematical. This is a deplorable position, personally, to place Mr. Schey. There is some hope. We may get a bilingual Reggie attorney to replace Mr. Sanchez. I have received several letters from community organizations commending Mr. Schey and, if it were the community's desire to continue with Mr. Schey rather than to replace him with an inexperienced bilingual attorney, of course, I would consider that in making a decision. From my conversations with Chicano community leaders in San Diego, it is obvious to me that most organizations have already communicated to you their desire to have Peter A. Schey hired at Legal Aid in a permanent position to work on immigration-related problems.

It is difficult to understand why the situation becomes "problematical" when the Chicano community finally sees fit to support someone who we know and trust. We have not been consulted in the past on this matter, and the thought of "an inexperienced bilingual attorney" is not exactly appealing. Furthermore, Mr. Schey is studying Spanish and soon will be bilingual.

From what we can learn positions are available with Legal Aid and as recently as a few weeks ago a Chicano law-graduate was hired with no input from the community that I have heard of.

We have sufficient problems to deal with in our community without having to face the possibility that Legal Aid is unresponsive to our needs. It certainly will not establish a new policy for Legal Aid to hire another white attorney, but it may begin to establish a new policy for you to hire someone we have specifically recommended.

I am writing to you about the services provided by Mr. Peter Schey as the representative of your office in the area of imigration law.

Until recently Mr. Schey resided on Imperial Ave., in the Model Cities neighborhood. While living in this part of San Diego, and working at Legal Aid, he has made an effort to meet the leaders and organizors of all the local Chicano agencies that have an interest in immigration problems. In this respect, he has been a unique member of your staff.

At the present, Mr. Schey provides legal counselling at the Chicano Federation every Thursday afternoon. He has worked for about a year with Juan Morrison and others at our organization, handling a variety of legal cases and training people in how to deal with imigration problems.

While Peter and I have spoken of the need for an organization totally dedicated to immigration problems faced by Chicano people, until such a goal can be realized I would recommend that you retain his services in a permanent capacity.

Mr. Schey first became involved in immigration problems as the coordinator of the Free Legal Clinic at Neighborhood House. His cooperation with the Chicano Federation and other local agencies has extended over a long period of time. This involvement has provided us with the only source for help when faced with complex immigration cases. He has also been important in identifying for us situations in which our rights are being violated by governmental agencies.

We enforse his active involvement, and feel that he must be given all the support and essistance that your organization can offer in his continuing efforts to help our community.
