# PATROL NO. TALASEA 1 - 1968/69

Your reference 67-1-1 of 27th August 1968.

- I acknowledge with thanks receipt of a Special Report by J. R. Ellem, Cadet Patrol Officer in relation to a patrol to the Daci Settlement area, Bola Census Division.
- 1. No map was received with this report.
- The report did not adequately cover the situation as required by my 67-1-0 of the 21st June 1968 paragraphs 3-6 inclusive Part III in particular. Undoubtedly junior officers will need to see situation reports by senior officers before they can be expected to be competent on this regard.
- Insufficient detail has been reserved about the alleged riot at San Remo (and Numendo?) its causes and results. Previously in my 37-8-17 of the 28th December 1967, the need for the immediate reporting of such incidents was pointed out. This is necessary even though the defendants were discharged.
- 6. Naviria village must be visited by census patrols. The economics of this cannot be considered to be a bar.
- 7. It was pleasing to note that the roadworks achieved by the patrol were very good and that Mr. Ellem has done a commendable job.

#### TALASEA PATROL No. 1 of 1968/69

Thank you for Mr. Ellem's report on his special patrol to the Dagi River Settlement and adjoining areas and for your covering comments.

I have inspected the road work done and consider this is very good but more needs to be done as soon as possible.

I have put the report into Patrol Jackets. If you have none please see they are ordered. The report has been very seriously delayed and for this I can see no excuse. District Instructions are quite explicit on this matter. Your staff situation is good. Mr. Ellem had no other ergent task. The report should have been submitted promptly. Please ensure this is always done in future.

I believe Mr. Ellem could have spent much longer in the area to good effect. Nothing in the report has allayed my fears expressed in memorandum 67-1-1 to you dated lat August. Mr. Ellem may have been chort of labour for the Dagi Read project but I do think that other aspects of his Patrol Instructions were rather cursorily dealt with. It was a wonderful opportunity to spend time withpeople in the area and to make a start in overcoming some of the adverse features mentioned in the report such as lack of respect for the Council. I would like to know a lot more about how these people feel about the proposed development at GIGO, whether they want to participate in the harvesting of nuts, what has been done about it, what are the problems of the area and so on. A lot more information could and should have been obtained about the Dagi Settlement project. What did Mr. Ellem do to stimulate village copra production? What are the reasons for lack of effert? One gains the Ampression that Mr. Ellem was in a hurry to get back to Talasea.

I am not abbliever in building rest houses that are not used. I do believe our officers must remain more frequently among the people. Whether this is in a rest house (centre of operations) or in a good village house is immaterial tome. I am certainthere are more than 17 people inland from TALASEA, not accounted for in the census. I should have more information on this when a Haskins patrol into the inland returns in about 10 days time.

Concerning road work; (i) Why were the pipes not delivered?

Surely Mr. Ellem could have supervised this and you have ample funds to hire transport if necessary (ii) Why were settlement labour resources not used? In my discussionswith them (in the presence of Mr. Haywood) they appeared more than ready to participate on a partly paid basis. They should be encouraged to do so (iii) re the grader. This has been discussed with Mr. Max Wright and I can assure you ha is just as concerned about his grader operations as you are about the operator. Mr. Ellem could have sent a message or gone himself to see Mr. Wright who is willing to go to the scene of operations of his equipment at any time to resolve difficulties. This is what should be done infuture. Also note that we cannot expect a grader to do a bulldezers work.

I think you should place an officer to work in this area for a month. He should complete the settlement road project and also interest himself deeply in other settlement affairs such as the new school buildings, improving the aid post and assisting the settlers generally. He would also work with the adjoining villagers, broaden their understanding of our efforts



and simulate their own endeavours. He should also explain to the people what is going on at GIGO and keep an eye on the situation generally in the's

I have taken up the matter of the power saw with P.W.D.

Mr. Ellem's efforts are very much appreciated. He has done a very good job. I am satisfied with the standard of work but more needs to be done to complete the project and I have suggested how this can be done.

Claim for camping allowance, duly approved, is returned herewith Patrol days have been amended to 14 (6 for camping out).

#### TALASEA PATROL No 1 - 1968/69

Attached please find the abovementioned Patrol Report and Claim for Camping Allowanco.

I have since inspected the work done on the roads and was most impressed with both quality and quantity when considering time spent and strength of labour force.

The majority of the able bodied males in the area work either at GIGO for Kimbe Constructions or MOSA Plantation for Harrison and Crossfield. The remainder are not interested in labouring. The cause could be the presence of plenty of money in the area as a recult of recent land purchases. In time when Efforts have been the money runs out they could be more interested. made to try and get labourers to come from Talanea but although 50 were promised non turned up - this was with the added incentive of free transport to and from Talasea for the week end. Settlers - many of whom want to work - are somewhat handf.capped because they have to put in a certain number of days on their blocks and this is rigidly enforced by the DASF Project Manager.

I have already commented on the grader and the quality and quantity of work by the operator in my 10-5-6 dated 15th August, 1968. I feel that an inspection should be made of work completed to date.

The lack of resthouses in the area has been brought about by officers in the area not using them. All the villages between Talasea and the Dagi River can be reached by car in 75 minutes. Non DDA officers do not camp in the villages and if it is necessary for DDA officers to camp they can always use tents. This eradicates the necessity for the villagers to build and maintain Resthouses that are used once or twice a year.

of the 68 pipes constructed for the roads only 12 have down to date. The others will be sent down in the near been sent down to date. future.

The pig rule for the Council has only recently been Prosecutions have commenced and already have had some effect in diminishing the pig population inside the village.

The patrol had to be curtailed when the detainees being used on the road were released.

Another creditable effort by an energetic and hardworking officer.

## RE:TALASEA PATROL NO. 1 OF 1968/69. SUPERVISION OF ROAD WORK ON DAGI SETTLEMENT ROADS.

#### DIARY.

4/7/68.

0900 Departed Talasea by Landrover for Dagi Settlement to supervise road work.

1030 Arrived at camp sight (1 mile from Dagi river) and set

1300 Inspected the road work being done by the detainees. 1330 Received in ation of a riot on Sanremo Plantation

and went to investigate. Stained facts and details and arranged for went case to be held at Kila on following day.

1445 Obtained chain saw from P.W.D. Gigo for use on logs

which lay jumbled on the proposed roads in the settlement area. The writer was horrified when examining this saw to find it in such a poor state. Xt max 1630 Returned to Camp.

0745 At Numundo Plantation to report riot to Assistant District Commissioner at Talasea.

0800 Returned to Sanremo and insured that all who were involved had departed for Kilu for court case.

0900 inspected road work then departed for Kilu.

1100 Mr. A.R. Haywood A.D.C. arrives from Talasea - Case dismissed.

1330 Back at Dagi supervising road work.

1600 Depart dagi for Talasea.

1730 Arrived Talasea.

8/7/68.0900 Daparted Talassa for Dagi settlement.

1030 Arrived Dagi settlement and inspected road work. 1300 As no villagers had made themselves available for employment, the writer proceeded to near by villages to ascertain their reason.

#### INTRODUCTION .

The main purpose for this patrol was to

supervise the construction of the access roads in the Dagi settlement.

The main access road into the settlement area had previously been constructed to the point where it meets the main interior road at block 71. Thus the labour force was not required to work on this road.

The main interior road was passable by vehicle from block 71 to the Agriculture centre. Before this road could be gradered numerous logs and stumps had to be removed.

It took just on six days for this clearing to be completed.

The entire labour force, which consisted of 14 detainees, then commenced clearing the road which is situated between the aid post block and block No. 71.

The detaineds worked for three weeks on this road and managed to clear the road to as far as block No.77.

Although this distance is small, when one considers the amount of material removed and labour strength which started at 14 detainees and dwindled to as few as 6 at the and of three weeks and a few labourers on for a few days, the result is satisfactory.

LABOUR. It was planned at the commencement of this patrol that the detainees from the Talasea corrective justitution together with as many villagers as could be recraited for -75c per day were to work on these roads under the writers supervision.

However after numerous efforts only a few labourers, who were willing to work for a few days only, could be recruited.

The village officials claimed that all the caperable men were employed at either Mosa of Gigo. However, during various meetings in Morakia, Ruango and Kulungi villages it was pointed out that approximately 50 men from these villages were not engaged in any employment.

At Kilu village 28 men were involved in a riot with Sanremo labourers and they also were not employed by any one.

In the above cases, when it was pointed out to the village leaders, that there were many men in their villages, the village leaders stated that the men did not wish to work on the roads and if they didn't want to they didn't have too.

EQUIPMENT. The equipment provided for this work consisted of

axes, spades and bush knives. chain saw was also obtained, from Public Works, but on receipt of this saw the writer was horrified to find it in such a shocking state of neglect.

Not only had previous opperators been using it as a plough but also an incorrect sized file had been used to try to sharpen the chain.

No equipment was available to rectify the above. These two factors alone caused the saw to function poorly.

After approximately two hours use the motor out out and on restarting would not develop sufficient power to rotate the chain whilst attempting to operate the saw.

The saw was returned to Public Works Talasea and it was suggested that this saw be given a complete overhaul.

a grader was hired at the rate of \$16-00 per hour to grade these sands.

With the operator Mark Kulawaro of Samarai, Papua, who shows a lack of ability, interest and concern for his work and the roads. It is obvious to the writer that \$10-00 per hour would be a more reasonable rate of hire, when considering the finished product and the time taken to produce it.

The operator, ignoring instructions given by the writer, managed to get the grader bogged in the gully which crosses the road between block Nos. 38 and 61.

It took the entire force of detainees two days to dig this grader out of this gully.

The detainees were used for this task in the writers absence and thus without his permission.

Previously this gully was passable for vehicles wishing to proceed to the Agriculture station. Now one has to carry a push bike across this gully.

One would think that if this operator bogged his machine by ignoring instructions and unable to solve the problem himself, was given assistance by the government, that he would be willing to repair the camage that he did to the road.

When the writer asked the operator if he was going to make this area passable to traffic his reply was that it was not his job and the Government could hire a bulldozer to do it.

### 2/ CULVERTS.

Only 4 of the 68 pipes were received and as these were off loaded in the wrong area, an culverts were constructed.

3/REST HOUSES.
Of the villages mentioned in this section of the Patrol instructions only Ruango has a rest house. In discussing this with the villagers and the a/Assistant District Coamissioner Talasea, the conclusion was reached that any patrol personal wishing to stay a night in any of these villages that tents could be used. This would save the construction and maintenance of Rest houses that would only be used a few times each year if at all.

### 4/COPRA NUMBERS AND PRODUCTION.

A meeting was arranged in the villages listed in this section to dispuss copra numbers and estimate the production for each village.

The following is a list of information obtained from these villages. The production figures were estimated on the villagers word and may not be very accurate.

a/ MORAKIA

1/Has not got a copra number,

2/ Nould like to have a copra number for the 3/Present production 2 to 3 bags every month. L/Ruango

a/Has a copra number T655. b/Present production 7 bags every month.

c/Kulungi.

a/Has a copra number 1769 b/Present production twenty is thirty bags each

With a,b &c above, the villagers would prefer to have their copra shipped from Sanremo, Gigo or Numundo, rather than have it transported to Talasea.

d/Kilu.

a/ Has no number.

b/ would like a number for the entire village.

c/ Present production & bags each month.

e/Patanga No. 1.

a/Has no number. b/Would like a number for the entire village. c/Present production 11bagseach month.

f/Patanga No. 2.

a/ Has no number.

b/ Would like a number for the entire village.

c/ Present production 1 bag each mouth.

g/Garilli No.1.

a/has no number. b/Would like a number for the entire village. c/Present production 8 bags each month.

h/Ga-1111 No.2.

a/Mas no number. b. Would like a number for the entire village. c/Present production 1 bag each month.

1/Bois. b/Would like a number for the entire village. c/Present production 10 bags each month.

Although the above production figures are low they will increase considerably within two years. This increase till almost double the present production but it is still far low what it could have been if these villages were willing to do a little work.

5/Villagers from Naviria. 6xxxxxxxxxxx.

The villagers from Naviria total about 17 in all. The men who are caperable are being employed at Mosa plantation. The women are remaining in their area to care for their gardens.

Whilst the majority of these people are being employed away from their village it would not be economical for a patrol to go into this area.

#### POLITICAL.

I feel that the political situation in the Dagi area can be ascertained when considering their willingness to work for the Government (Dagi Roads). During this patrol it was observed that several men returned to their village from Mosa and Gigo. After spending one week in their village/again applied for employment at either Mosa of Gigo. Those who were not employed returned to their village and showed no interest in the offer of employment in the Dagi settlement.

These villagers have no respect for their Local Government Council and its rules. An example of this is the Fig rule which states that all pigs shall be disallowed in the villages.

The writer sighted several pigs in various villages and gave warnings to the owners of the pigs. Since these warnings two men have been charged for disregarding this rule and allowing their pigs to roam through their villages.

#### Settlers.

The settlers on the Dagi blocks are mainly From the Rabaul area.

The majority of these settlers spend a lot of their time in Rabaul, thus the development and maintenance of the established areas is very little.

On the higher percentage of blocks young coconut plans are overgrown with bush and vines and little attempt is being made to control this.

At present the settlers have an abundance of Taro which they are selling locally at Nahavio and Gigo. This is providing the settlers concerned with an average of \$2-00 to \$3-00 each week.

The writer returned to Talasea as no villagers were willing to work on these roads and with only 14 6st sinces and no chain saw there was little work to supervise.

As various detainess completed their time in prison their numbers dwindled to as few as six. At this stage 2/8/68 the remaining detainess were withdrawn to Talasea.

### PATROL INSTRUCTIONS TALASEA PATROL NO. 1 OF 1968/69

Twis is to confirm the verbal instructions already given regarding the above patrol. I regret that you did not have these written instructions prior to your departure on the 3rd July 1968.

#### Objects of patrol

- 1. Supervise detaines and any local labour you can recruit (at 75 cents per day) on the Dagi Access Read and when that is completed continue on reed clearing inside the Settlement including new reads. You can recruit up to 50 casual labour and charge Vote 31-2-1 NG, W/O S 6703, Project ET 4790L/ The balance of funds on hand is \$ 2338.23.
- 2. When you receive the cement pipes from the Talasea Council allocate sufficient to the actual access road and stock-pile the balance (out of 68 pipes) ready for use on other roads inside the settlement.
- 3. Visit the following villages in the general area and ask the people if they are prepared to build rest houses. I am particularly concerned that there are only 4 rest houses in the whole of the BOLA Census Division.

# GARILI, KILU, KULUNGI, MOROKIA, PATANGA.

4. Check on the following villages and try to obtain the names and copra numbers of individual native producers and also the estimated production per month (in bags) - RUANGO, MOROKIA, KULUNGI, KILU, PATANGA, GARILI, BOLA. You can explain that the Talasea Council is acting as handling agent for native growers and wants to provide a service of collection by tractor. If there are no registered producers then find out just what happens to the copra being/ not being produced.

5. Depending on time available I would like to establish contact with a group of nomadic people living in the headwaters of the DAGI River - formerly censused at a place called NAVIRIA which has apparently been abandoned. These people have not been censused since 1964. If you can establish contact then I suggest you try an select a meeting place in order to carry out a census, and build a rest house. At this stage I do not expect you to visit the NAVIRIA area but merely try and get someone from there to visit you at the DAGI Settlement. # TALASEA PATROL REPORT - No 2/68-69

The abovementioned report is acknowledged. I regret the lateness of your initial submission which has been further delayed due to misfiling here. I re-iterate however that it is encumbent on reporting officers to complete their reports within four days of return from the patrol.

Council You have recommended the establishment of a separate Council for the Kombe. In view of your area study, doubt that this should be done. However the operation is solely prepared to go ahead on an on/off basis. Staff is now fully prepared to go ahead on an on/off basis. Staff is now fully who can undertake this? Though I believe the Council can be effectively supervised on a part time basis after establishment, officer be there for the first six months, at least. I do not believe that we can undertake any further Council expansion with our current staff, and the Director is also of that opinion in respect of the Territory. Explanations should be given that, as soon as staff resources permit a Council will be established in the ombe.

Economic production is still low, though there appears indications that more copra is being disposed of through local plantations. Following Mr Haywoods last visit to the Komb I understood that arrangements had been made to establish centralized pickup points for copra. Has this been done? Is the 'Aimar Garnet' assisting to clear bottlenecks? It appears there is considerable room for expansion from existing groves and this should be encouraged. I expected to hear that this was in operation. Was this brought up again in discussions during this trip?

Both of the above should be covered in the Course you are scheduling for November to impress the need for active participation by the people who are now more obviously looking to Councils to provide organization. Please advise me of firm dates and the Course content as soon as convenient. It will almost certainly be necessary to vary the content from that of the Talasea course. One essential point is the necessity to explain priorities and how these must be determined in any given situation.

Social. You mention Mission school establishments but your area study fails to give any indication of the numbers attending each of the existing schools. Please ensure the information, which should show as an appendix, is collected on the followup patrol of the area.

Please ensure that Census Statistics forms show clear on the heading, the Census Division, Sub District and District It is certain that once detached from the report, personnel at Headquarters will not readily identify the area without the above information.

## SITUATION REPORT . KOMBE CENSUS DIVISION

### Political

There are no Local Government Councils in the area. This patrol was mainly a Census Patrol to bring up to date the census figures of the area. An Area Study was conducted too. Approximately 61% of the people residing in the Kombe area wish to participate in a Local Government Council. The remaining 39% vary from being rabidly anti-council to 'slso rans' whose loyalties vary from day to day.

years I'm of the opinion that the sconer a Council is established in the area the better. A Council will be an unifying force in the Kombe and should lift their past efforts even higher. The opposition to the Council can be won over through education courses. If the establishment of a Council is delayed than the opposition will have time to consolidate - like on Bali Island - and our task will be more lifticult.

The establishment of a Council would mean that an officer could be detached to look after the interests of the Kombe and this officer would be able to concentrate on Education Courses held in the various villages

To the Kombe the House of Assembly is something that comes around every four years. The various candidates visit the area just prior to election time and they aren't seen till the next election. The only exception being the present Ministerial Number for Public Works Mr Ashton who has an interest in a copra and cocoa plantation in the area. At the last election 90% of the votes cast went to MAUS BALA (a kombo) and the other 10% went to AKAI (chinese trade store owner at Talasea).

At the last election a Kembe - MAUS BALA - steed as a candidate. He polled well. His normal work is as a small ship's Master based at Talasea visiting the whole North Coast.

A political education campaign was carried out prior to the 1964 House elections and spasmodic efforts have been made over the years. During the last elections the majority of the Kombe people had to be assisted to record their vote. It is hoped to conduct an Education Course for the Kombes in November - after the next Talasea Course - and this will be held at a central Kombe village and representatives will be sought from all Kombe villages.

There is no real understanding of the preferential system of voting. When people are assisted to cast their votes - or at least record them on the ballot papers - the officer assisting them asks them whether they have any other preference after the first and usually to whether they have any other preference after the first and usually to whether they have any other preference on the other hand there keep him happy they call out another name. On the other hand there are some old women who come up and rattle aff all the names in their order of preference. Have they really worked out who they like or is it done 'with pins'?

Economic

There is no general rural development in the area.

There has been little patrolling of the area by Development pepartments in the past. The last DASF patrol to the area was about 12 months ago. To date there has been no investigation of the fishing potential of the area although there have been rumours of such investigation.

The Department of Trade and Industry is unable to extend its activities to the Kombe area due to lack of staff. There are no co-operatives in the area.

The copra produced in the area is makek marketed in two ways - by sale to Lingalinga Plantation and Tooki Plantation as trade copra and by shipment direct into Rabaul to the Copra Marketing Board. The latter method is hazadous and depends on the mood of the ship's Haster. As has happened in the past the Master of the only ship servicing the area was anneyed with a particularity Kembe village and refused to uplift their copra. Countless bags of copra were left to rot in the villages until the Administration decided to help by using Administration vessels to bring the copra to Talasea.

Only one village - NUTANAVUA - is interested in extending its cash crop activities. The other villages are not interested. Why should they extend their activities? They don't pay any tax, their reeds are few and simple therefore there is no need for money. The establishment of a Council would galvanise they into some activity.

Non indigenous act ty in the area is limited to one plantation and two mission stations. The plantation purchases 4-5 tons of copy per month and hirer a small amount of local labour. The plantation produces approximat 1, 40 ton of copya per month. The Manager also purchases crayfish and crabs for sale in Rabaul where they fetch a very good price.

Social

There are no Administration schools in the area. The seventh Day Adventists run a school at SILAVUTI and the Catholic missions run achools at SASAVORU, KIKIVIA and KAKASI. Each village has its own mission school which caters for preps and Std 1.

There is one administration Aid Post at MOPOTU. A few years ago there was another at NUKAKAU but the local people did not look after the APO - wouldn't take him into hospital when he was very sick with hepititis - and as a result the aid post was closed down. Their attitude to hospitals and aid posts is that they should be used only as a last resort. On my recent patrol I discovered a very sick man suffering from meningitis and wanted to bring him into the Hospital at Talasea. The village 'Witch Doctor' requested that they be allowed to try their own modicine first and if that did not succeed then they would bring the man in. The Kombe area is well known for its sorcery - and the villages of SUMALANI, WOGEWOGE, RANGIHI, GUHI, MULIASINI and TARAUA/NUKUHU are rife with sorcery.

There are we other services provided by the Admiristration cush as a fortnightly shipping service between Gloucester Patrol Post and Volumei (Talasea), malaria control spraying etc..

There are no Women's Clubs in the area and no Community Education Courses have been held. It is hoped to rectify this matter in November when the Kombe is visited again. The Kombe women who live on Talasea and other large stations join in the Women's Club activities available

Mr. Ellem did his task well. He need not be discouraged about the slow progress - it was certainly achieved much more expeditiously than culverts undertaken by the P.W.D.

Concerning the GANEMBOKU road the first task with any project is to asses what has to be done. I am opposed to much work being done on any road until the feasability of the route is established. I assume this has been done for all but the major gullies by Mr. Lee. The next step is to see that the project is put forward as a Rural Development project along the lines already spelled out for you. I remind you of my 10-37-0 dated 12th September 1968 requiring submissions on Rural Dovelopment Works listed by the next D.C.C. meeting on October 10th. Finally I am certain best results are obtained when the village effort is supervised and you should be able to place an officer in the field to do this. Working with the people and remaining among them must have other very beneficial results in getting to know and understand the people.

1/ The purpose for this patrol was to construct culverts at various places of need along the road from Waro to Namova School at Narunegeru village.

Several culverts had previously been constructed but owing to high rain fall in this area and the texture of the soil, several more culverts were obviously required to maintain this road in a servicable condition for most of the year.

At all places requireing a culvert one was constructed.

A total of fourteen culver's were constructed within seven days. Although this is a low daily average, when one considers the work required for drainage, time lost whilst waiting for pipes from Talasea and working with men from the Talasea area, the result is satisfactory.

These culverts will play an important part towards keeping this road serviceable throughout the year.

As this road has recently been graded there may arrise a need for additional culverts in the future if erosion takes place.

At the time of future gradings, the writer suggests that the operator be requested to grade all portions of this road, which is upon a slope, in such a manner as to give the surface a falling pitch towards the inside drain between the road and hill.

If this is carried out satisfactory all rain water will travel for a maximum distance of 24 feet along the road surface. This would save extensive damage caused by water gussing down the road.

#### LABOUR.

Ten men were employed from Ganemboku village to construct these culverts. After one week an effort was made to employ some men from Buluwara without response. These two villages were chosen to supply the labour as it is hoped that in the near future new roads will be constructed into these villages, and it was planned to use this patrol to train these villagers how to construct a culvert.

The men employed are;

Topia/Ipa, Joe/Reiu and Pake/Poli being the best and most reliable workers.

Several attampts were made to see if these men had any worries or wished to ask questions about the administration, self government or other things. All attempts were in vaim and the men showed little interest in the matters.

2/ GANEMBOKU ROAD.

The men from Ganemboku village are very keen to have a road constructed into their village.

At this moment the number proposed road sight for this road into Ganemboku has been cleared of all timbers and rubbish. The only work required before this road is serviceable includes four extensive cuttings.

The Local Government Engineer Mr Julian Lee has inspected this road and has made arrangements for a surveyor to survey this road where the cuttings will be required.

## PATROL REPORT - TAL. 5/68-69

The abovementioned report summitted by Mr Geri, Patrel Officer, and your covering memorandum 67-1-1 of 11th instant, are acknowledged.

I am disappointed in the report. I had expected that, with the a dvantages of a reasonable education Mr Geri could turn out a better job. He has almost failed to give any time to stating what was actually done on the roads in the period spent. He states that about 3/4ths of a mile were completed. Does this mean up to grading standard, or for actual vehicle movement. I understood that the task was the organized clearing of road lines preparatory to the use of the grader. Is this in fact the case?

I can understand the thinking of the settler elements at the Dagi who are seeing what is done in advance at the Palm Oil, but it must be clearly stated to them that their own contribution towards assisting with access will largely determine when such access is available. Further that when finally completed each blockholder will be responsible for the regular cleaning of his frontage. As advised separately there seems a great liklihood of heavy equipment being available to clear the balance of the read up to the funds availability remaining. I have little doubt that most of the ettlers are aware of the advantage which the will have from their nearness to the new town at Gigo.

Mr Geri states a situation pertaining in the villages of Ruango, Morakia in respect of sanitation. If such is the case, what action or recommendations did he make? The Council has rules covering both sanitation, and pigs (I have noted recent cases in your Court records) and surely action should have been taken to bring this to the netice of the Council executive.

The situation re the Dagi school is in hand. Work has already commenced on the construction of a permanent classroom and teachers houses. Construction is being undertaken by students from the Moramora Vocational School. This should relieve some of the problems at the Dagi. I realize that the initial buildings were on a completely salfhelp nature.

I await Mr Heuston's report when he completed the road sections now being cleared as to the complete progress made in supplying access to more of the blocks in this settlement.

Camping Claims for Mr Geri have been processed and are returned for payment.

DAGI SETTLEMENT ROAD

Attached please find a report submitted by Mr.Jerry Geri, Patrol Officer - cavering his recent patrol into the area. He accompanied Mr.7. Heuston (A.D.O) but was recalled due to his extra activities. You have been fully informed on this score.

The original report submitted by Mr.Geri was unacceptable and I returned it and requested that he re-submit it along certain lines that I set out for him. This will explain the delay taken to forward the report to you.

My comments are as follows:-

- (1). I am still not satisfied with the typing, presentation and spealing of the report. Mr. Geri has had adequate time and could have prepared it with more care. In view of the delay, however, I am forwarding the report.
- (2). The report has no overall continuity, it presents a series of facts, and little or no attempt at analysis has been made. What has been done is very superficial.
- (3). The second paragraph of the conclusion is incorrect. In fact approximately(%) the third of the settlers are willing to work, however due to the fact that for two weeks of each month, they are working at San Remo during this period no settlers work on the road. This situation is unsatisfactory, but as three general meetings have been held with these people, and the remainder of the settlers refuse to change their attitude, unless some success is obtained in recruiting labour from outside, the work will only proceed slowly and in fits and starts if settlers labour alone is relied upon.

Constant supervision of this project will be required to bring it to satisfactory completion. I estimate that one more month's work should see the road opened and ready for grading and completion of this project. Approximately 60% of the funds have now been spent, requests for L.P.O.'s for use of the Council tractor and purchase of pipes will be forwarded to you as soon as bills are received from the Council.

#### REPORT ON ROAD WORK.

### INTRODUCTION:

In 1962,60 blocks of land were prepeared and settlers from the Gaselle Peninsula in Rabaul were brought into the Dabi Settlement. Of All of the 60 blocks were allocated but only 40 - 45 blocks are actually occupped. All the settlers are from Rabaul except BAKUK, a Sepik man with 2 sons and 2 daughters and a Tolai wife, at the settlement.

The main reason for read work is provide access roads in the settlement to help the settlers to trade their produce, and also to trade their copra at Gigo when its in production in the very near future.

Labour is recruited from the two villages, Ruango and Morekia and the Degi Settlers at 75c per day. Both males and young females were recruited. It was noted by the writer that the village people were easily obtained but the settlers were a little of a nuisance. It takes much effort to get them to work.

The village people were very punctual and would turned up in full everyday. The settlers were difficult. Some days they turned up but other days the writer has to look for the. The average attendance were 25 to 30 labourers and the result of the ampunt of work they did turned out to be satisfactory.

#### EQUIPMENT.

The equipment used for the construction of the road were picks, crowbars, shovels, axes and sticks that were cut from the bush neraby. Small sticks and ropes were also obtained from the bush to mark the width of the road.

Some of the above tools were issued by the Administration but mit others were brought to work by the labouerers.

No grader was employed as the road itself wasn't ready for grading.

#### CULVERTS:

No culvert was laid during the patrol was in the area. There were six places along this road where culverts have to be put. Only four cement pipes were delivered.

#### SIZE OF ROAD:

The road is 18feet wide with 3 feet allowance on each side for drainage. Greek Curves are allowed at various places but the width is all the same or about the same. Writer beleives that this width is sufficient to allow two vehicles to pass without accident.

TERRAIN:

The terrain is mostly flat with the exception of two slopes across the road. The first one has is under construction by the village labourers and the second has been cleared. There are places with drainings but this can very easily be covered by the grader, but otherwise the terrain is not very difficult.

The Tolai settlers are very unenthusiastic in their approach to of doing something for the Government. The golden rule of self-help is unknown to them and they have got the feeling that the Government must do everything for them. At one of the meetings with the settlers, the writer was told that why should they build the road because before their arrival at the Dagi Settlement, the Government had promised them that such things as school, Aid Post and roads will be built by the Government. Now that the Aid Post is not in operation, and the school not very well managed, they seemed to make resign from their trust for the Administration. Some thinking that the services in Rabaul are better than Dagi, left for Rabaul and as the result their blocks are covered with bush and creepers.

Only a hand full of them realized the importance of the road and turned up but only for something in return.

#### VILLAGE PEOPLE.

George KVLV, Councillor for Ruango, Morekia and Kulungi, an ex-Council Clerk, is a very influential man and to get labour through him proved to be impossible. It needs some convincing and if he gives it in he made quite sure that he gets something in return. The village peoply were quite surexesx copyative and there was no trouble with them.

#### CONNCIL.

The Dagi settlement and the villages mentioned above are in the Talisea Local Government Council.

the settlers who came from a place where Local Government Council has been in existence for a long period, do not have the respect of this Council. The Tolai Councillor spends most of his time in Rabaul and as a result he's usually absent at Council meetings.

(b) The villagers seemed to recognized their Council but the Council's Pig Rule has been ignored. This illustrates the number of complaints brought to court every week of pigs roaming around the villages.

#### POLITICAL; (Settlers)

The writer feel that the political situation in the Dagi Settlement can be ascertained when considering their unwillingness to work for the Government on the Dagi roads. It was observed during this patrol that the settlers were employed at Mosa or Gigo plantations and were substituted by a fresher group each week. They then apply again for employment at either of the two plantations but those who didn't just stayed at home and showed no interest in the employment of the mm road work.

#### ECONOMICAL. (Settlers)

The majority of settlers spent alot of thier time in Rabaul, so the development and maintenance of the established area is very little. Many of their young second trees are evergrown with bush and vines and little attempt is being done to control this.

At present the settlers are selling some of their produce locally at Tamba, Nahavio and Gigo. This is providing the settlers concerned with an average of \$3.00 to \$4.00 each week.

In the next two to three years copra production will be close to full production.

At Ruango there are two outboard motors in operation and four dinghys of which two have motors. Many cances are owned by the villages but none of them has motors.

There are two schools in the area - (a) Dagi Primary T School which is run by the Administration and (b) Rusago Primary T School run by the Catholic Mission.

- (a) The Dagi Primary T School enrolment is 84 students with 58 boys and 26 girls. There are three teachers at the school. 14 students out of the 84 are village students from either Morekia or Kuango.
- (b) Ruango school has an enrolment of 83 students with 49 boys and 34 girls There are four teachers. This school serves the three villages; Ruango, Merekia and Kulungi. (e) Condition of schools;
- (I) The Dagi Primary T School is an untidy state with rotten timbers, corrugated irons pulled off and grasses are seen growing every -where. There's only one classroom without roof and two other classes held underneath the teachers' residence. The place is all in shambles and this explains itself when one looks very carefully at the school. During windy and rainny days the school is closed down because there are no walls to protect the students from above. The teachers' houses are in unsafe was condition and they are likely to fall down during rainy days and earthquakes
- (ii) The Ruango school is in good condition and the class-rooms are well arranged and divided in their respective classrooms. The teachers live in the villages in houses built by the villagese free of charge.

No assistence is received from the parents of the pupils and as are sult we any work that heas to be done is carried out by the pupils and the teachers themselves, at both schools.

#### MALA. (Villagers)

The health of the people is very good and their dist is good. The people is general turned out to be clean and tidy but their houses in the villages are dirty and not in proper arrangement.

The houses are so closely built and no windows can be identified .

and theres a danger of fire spreading from house to house.

The writer suggest that these people must be encouraged to build their houses in lines and with windows in them like some of the coastal villages in Papua.

Morekia Village has 4 tanks but of no use as the result of tipe damages. None at Ruango Village. The mains/visited a sater place very much like a well, and found that pigs are always at this places and their excreter of shit is very evidable.

Water is sometimes obtained from Sanremo Plantation a mile away and sometimes from saguag .

#### CONCLUTION.

During the period this patrol was in the area, three quaters a mile of road was constructed with the average labour of 25 to 30 people As was pointed out earlier of settlers unwillingness to turn up promptly for work, there was a slow progress but the result was satisfactory.

There is not one settler who is willing to work on the me road as was informed by Mr.A.D.O Terry Meuston, who is still carrying on with this work at the Dagi Area.



I am not pleased with either the report or the results contained by the patrol. The delay in submission is inexame. Cinexcusable and I am certain that the report would not yet be submitted had not pressure been put on Mr. Heuston from this H.Q.

No written instructions were given to the patrolling officer as required. This is a pity as it is hard for me to follow just what Mr. Heuston was expected to do. His work seems to have lacked direction and achievement considering the time spent in the field.

Before work is resumed on the Dagi settlement roads I would like you to study previous correspondence on this matter, visit the area, consider how you think the remaining funds can most profitably be spent and discuss the matter fully with me on the spot. Broadly we have some funds to assist in the work; I expect the settlers to contribute some effort. It has never been expected that all roads needed could be completed but what further needs there may be and for which additional assistance may be necessary - these should be submitted as Rural Development projects through the Talasea Council.

Mr. Heuston's report is general on many matters rather than specific. I could have written the "Economic" section myself merely from general knowledge. I would like to know more facts concerning new plantings, driers, fermentaries, production figures etc. Other sections of the report hint at much but tell nothing - for example the prostitution at GIGO. Is this fact? If so what has or is being done about it? What are the facts and background to the prospective entrepreneurs that "rush headlong into ventures" and the others that "rely unduly on helpful DDA and transport officers...."? The report contains far too many vague generalities and insufficient facts and concise well documented information.

What action is being taken concerning the housing, hygiene and village deficiencies? Surely this should be taken up through the Council and its appropriate Committee.

Mr. Heuston tends to excuse deficiencies on lack of staff and specialist officers. Welfare officers, business advisory officers plus more DDA staff would help meet the situation. I am frankly more concerned to see concrete plans of action to effect improvement where necessary with the resources we have. We certainly could do more with more staff but I also think we should be achieving more with the staff we have. We must also make the utmost use of the Council and its Committees. I hope that when you have settled into the Talasea subdistrict you will be able to give more purpose and direction to what is being done than has been evident for some time.

Mr. Heuston's claim for camping allowance is acknowledged and will be forwarded for payment as soon as possible.

### INTRODUCTION.

The Talasea Local Government Council Area comprises the entire BOLA Census Division (with the exception of two samll hill villages of NEVIRIA and REFENGI, of whome the last Patrol to the area noted:
"the villagers from Neviria total about 17 in all ... whilst the majority of these people are being employed away from their villages it would be une conomical for a patrol to go into the area.")

The Bola Census Division consists of the volcanic Willaumez Peniusular, and the swampy base of the Peninsular from the Dagi River due West as far as KANDOKA.

The objects of this Patrol were:

(1) Familiarisation

Collect information for Ward Development Programmes.

(3) Work on Dagi Settlement Roads.

The major part of the time of the Patrol was spent on the third object of the Patrol. Approximately one and a half miles of access road into the Dagi Settlement Blacks were cut, cleared and formed ready for grading. Work was by hand labour and progress was slow due to lack of any mechanical equipment availability, and a chronic labour shortage - the fact that the majority of settlers were unwilling to lend a hand on these access roads also contributed. Most settlers hold the attitude that the Administration is responsible for the provision of these roads, and that the Administratica should build them, without calling on the Settlers for work as paid labourers.

With respect to Familiarisation, when opprtunity arises, a further Patrol will have to be mounted to those other villages in the Bola Census Division which were not visited, during this Fatrol. This Patrol will be combined with collection further details for the setting out of Ward Development Plans, with the ultimate Object of drawing up a FIVE YEAR Plan for the Talasea Council, in accordance with the Commissioner for Local Government's Requirements for Council Development Programmes.

Information in respect of Ward Development Programmes has now been gathered in the following villages and areas.: Dagi Settlement, Ruango, Morokea, San Remo, Kulungi; Wangu Wangu, Buludava, Bulumuri, Woganakain Kandoka, Garu, Kambili, Bagum, Bagum Sawmill - together with the information from the villages not yet visited, this information (which includes the peoples own requests for Development Projects in their Villages and Wards) will have to be collated with a considerable body of information available in Lands and Agricultural Files at Talasea, in the next six months or so, in order to provide the basis for intelligible Ward Development Plans. As a consequence the information collected during this Patrol is not included with this Patrol Report.

The area Patrolled is a Part of the Talasea Local Government council Area which comprises the BOLA Census Division with the exception of two small hamlets of semi-nomadic mountain people (locally known as kaulons, and of similar habits to the Mokolkols, they have not been contacted very often, however they are peaceful and often seek work as labourers on coastal plantations both at Talasea and in the Kandrian Sub District on the other side of the range).

The Bola Local Government Council was originally commenced in 1958. There was strong opposition from a number of villages to the new Council due to the strength of the "Kivung" Movement. In 1960 Morokea Village was included. In 1965 Kandoka Village, on the border of the Kombe was included. In 1968 Kilu, Garrilli, Bamba, and the remaining section of Waro was included, and at the same time the Council was renamed the Talasea Local Government Council, and became Multi-racial with the inclusion of Talasea Township and Plantations into the Council. The "Kivung Influence" - an effect of Nakanai Cargo Cult, seems to have vanished.

At present there are 17 Councill rs, 3 of whom are Europeans.

The Council has had a mediocre success in the field of Public Works to date, due to the difficulty of obtaining skilled technical staff, however its success in the Political Field is marked, all residents of the area recognise the Council as having power and prestige, and they all (with the possible exception of some Dagi Settlers) look toward the Council for assistance in their local problems of health, welfare and works. The Council is also gaining confidence in the legitimacy of its opinions, and over recent months has not been laggard in taking Administration Departments to task for what it sees as ineffectual implementation, or lack of effective policies. When the Ward Development Plans are finally formulated, it is hoped that the Council will commence to take the initiative in aspects of local planning of particular importance to the area.

The standard of debate, and range of opinion expressed within the Talasea Council has steadily been improving, and it was notable that of all the Councils represented at the West New Britain Council Conference, the Talasea Council showed the least Parochial outlook, and a greater ability to express its opinions, no matter how unpopular some of those opinions might have been to the general consensus of opinion. The Council no longer seems to be bound by the idea that unanimity in opinion must be sought on every issue, an idea that often mage limits the effectiveness of local Government.

Generally I would say, that whatever its shortcomings on the works side (shortcomings which it is now beginning to control), the Talasea Council has the makings of a valuable Political Force. It is to be hoped that this frend will continue.

The exception quoted - that of the Dagi Settlement, is apparent when in contrast to other villages the Dagi Settlers - who are of Tolai stock in the main - take their grivances, and imagined grievances in the first instance to the Gazelle Council, despite the fact that the Gazelle Council has situm neglected to reply to them. A number of these settlers also refuse to pay Tax to the Talasea Council. This may be mither a refusal of the settlers to give up their roots and connections with the Gazelle Peninsular, or due to lack of communication between the Settlers and their Councillor (there have been many complaints from the settlers on this score as well), or a combination of both.

At the Ward level, there is varying degree of acceptance of the principal that a number of separate village are represented by a single councillor - some hamlets have been ignored for years by their incumbent councillors, and there is in such instances a sense of graivance. Where councillors are active, there may be resentment, in that he is interfering with the affairs of villages other than his own, but this tends to be more valuable to those effected, in that it is an active thing, involving people in the political process, rather than the passive apathy and greivance of those who are ignored.

Apart from a number of more sophisticated individuals, there is little or no interest in politics outside the Council Area. The activities of the Local MHA go largely without report or comment, in this area.

The Bola Census Division consists of the volcanic Willaumez Peninsular, and the swampy base of the peninsular from the Dagi River as far west as KANDOKA.

Transport from Talasea, which is situated in a sheleterd hargour 1/3rd of the way up the Peninsular on the Eastern Side, is by road to the Dagi River. There are also two roads crossing the Peninsular, one across the narrowest part (which contains the Airstrip) to Volupai Plantation, and another in the hilks serving the majority of the population, from Talasea to Buluwara. There are wharves at Talasea, and Volupai Plantation. Timber tracks, or roughly cleared roads, following the routes of proposed roads segve Pangalu, Newlands & Pugau Lotumgau Plantations & Settlement Blocks & Woganakai village (Talasea Peninsular Road); across the top of the peninsular from Wanzgu-Wangu Sawmill to Buludava; in the vicinity of Bagum Sawmill (near Garu & Kambili Villages); and from Narunegeru to Ganemboku. (Please refer to attached map.)

The Eastern side of the peninsular has been partially developed, and a connecting road to the Dagi River constructed.

A number of coconut and mixed coconut & cocoa plantations have been developed. In addition to Volupai, Lotumgau, Pugau & Newlands Plantaions previously mentioned, Garua Island is almost entirely planted to coconuts, Lagenda, Numondo, San Remo operate successfully; Walindi has been resumed by the ex-service credit board; Wandoro is under absentee management - a trade store & PMV LandRover operate from this plantation.

Navarai (previously a Timber Lease) is not yet developed, pending a decision by the owners whether to plant mixed copra, cacao or oil palm.

Cocoa Die Back serjously affected Numondo Cocoa some years ago, with lesser effects in other plantations. Some die back resistant strains have been found at Walindi, and DASF, who are managing on behalf of the ex-service credit board, hope to breed some resistant clones from these.

Timber rights have been purchased over most of the Penininsular area, and therexxxxxxxxxiiix is a sawmill at Garu, and logging at Wangu Wangu - both however suffering due to the present timber recession. At present Kwalakesi Sawmill, in the Hoskins Sub District, is the best sourge of milled and dressed timber.

Much land has been purchased by the Administration in the Peninsular area, which it is hoped to cut into small holder resettlem -ent blocks. The soil is generally well drained and highly fertile volcanic loams. There is a fair choice of crop from the traditional copra & cocao, to oil palm in those areas between Gigo, and the planned Harrisson & Crossfield Factory at Tamba. If Numondo Plantation decides on Oil Palm, Navarai, no doubt will follow suit. It I have been told that the high rainfall in this area would negative a suggestion that rubber be planted in the Peninsular. Existing Samall holder blocks are at Dagi, Panagalu and Buluwara.

There has been a great deal of local village effort in planting coconuts and cocoa along the existing road network, I am assured by the Talasea Council that additional planting will follow the extension of roads to unserviced areas - the Council, in fact is pressming strongly to upgrade existing tracks to all weather roads. With much of their land already alienated the Bakovi (or Bola) people are beginning to take positive action to improve their future prospects.

There has been an upsurge in village copra production, and all road side villages have at least one copra dryers following the recent rises in cocoa prices, it has been necessary to construct another fermentary for village cocoa at Bamba, in addition to the well set up fermentary and dryer at NAMOVA, on the Narunegeru Road.

The provision of road linkages and Transport services remains the greatest problem in the area. Already there are more requests for assistance on road projects than there is time and staff to give advice, and in the majority of cases, apart from the small amount that the Council cam afford to allocate, there are no funds.

(3) SOCIAL

The event of the construction of GIGO Township, has to date caused only minor impact on the social life of the Bola people.

However there are signs that the presence of the township which will be the new District Headquarters for West New Britain, will accellerate a process of destruction of traditional modes, values and ways of life, and while producing many undoubted benefits, create a number of new problems.

Some of these problems which appear to be incipient, would not to the casual observer appear to be logical developments. The first I will take is envy. The Bola people have traditionally been a friendly and somewhat indolent people, as a consequence they have often been imposed upon by foreign natives (and some Europeans), and have been a prey for cult leaders of all kinds. Lacking hard headed realism they have tended to become economically depressed in relation to more energetic neighbours and settlers. The vision of a township arising next door to their own depressed condition is already arousing envy. The sight of energetic settlers profitably working on blocks of what until recently was their own undeveloped land (the proceeds of which have already been "squandered" in traditional feasts, exchanges, ill founded business ventures, and heavy drinking) is arousing land hunger. The sight of unattached females practising prostitution in the labour quarters of the contractors for digo is causing envy of another kind - the women are almost invariably foreigners from the KOMBE (and are regularly chaesed out by the police if vagrancy can be proved).


Envy and land hunger should be faced head on, by endeavouring to involve the Bola people profitably in all development taking place. This is in fact being done, by all Departments, but the Bola's are still tending to lose out - for example in selection as small holders in the oil palm scheme, due mainly to better qualifications of applicants from other areas where the people have suffered land hunger for much longer, and are traditionally more industrious. As for business ventures, the lack of a business advisory service in this District is sorely felt, busy D.D.A. and D.A.S.F. Officers cannot give prospective entrepreneurs the time they need, with the result that many rush headlong into ventures without adequate advice, and lose whatever small capital they possessed. (On the other hand some owners of PMV's tend to rely unduly on helpful D.D.A. and Transport Officers to assist them out of all kinds of bother without any realisation of the costs involved, and are reluctant to settle debts incurred on their behalf).

On the Welfare side, there is such great discrepancy between villages merely a few road miles apart, and the learned skills of the aducated and the lack of skills of the village - centered person, that in order to raise the standard of living (in the social as opposed to the economic sphere), the sooner the plans to set up a District Welfare Centre, either at Gigo, or at Talasea, come to fruition, the better. It is astonishing, in a coastal area such as this to come in contact with people who have no concept of cooking, apart from burning food in the ashes, yet who have lost traditional skills of weaving, who depend on store-bought clothing that they are unable to repair etc., but it is nonetheless true for all that. For some reason there has been no spread of womens clubs, and little absorbtion of skills in living into the vallages - housing for the most part is poor and inadequate, village layout fragmented, standards of village cleanliness low, and only kept up by constant policing. Part of the deficiency can be remedied by patrolling IN rather than THROUGH villages (if sufficient staff and time is available), the remainder must be supplemented by Womens Clubs, Health Education, and other means of Community Development and Community Education. Development of Sporting Facilities should be encouraged in every village - perhaps Welfare or The Council could make available a football, or basket-ball to those villages who whave the energy to keep up a sportsfield - the cost would be relatively low in contrast to the social benefits that could be gained

The problem of apathy and grievance in small fragmented hamlets has already been touched upon under POLITICAL (at para 8, page 5.)











DEPARTMINT OF LANDS SU PROPOSE) ACCESS ROAD SETTLEMINT SCALE O CHAIN TO I








## TALASEA P/R 7-68/69 - PENINSULAR ROAD

The report of the above patrol submitted by Mr Geri and your covering memorandum 67-1-1 of 9 Decembr are acknowledged.

Your covering comments clarify several blanks in Mr Geri's report which is very sketchy in regard to the actual amount achieved during the period. I would expect more details of the type of terrain, drainage requirements, road clearance than given. Do I take the fact that as none of these were mentioned that there are in fact no drainage or culvert requirements?

Though the rodishoud be opened to a width commensurate with providing sunlight to assist drying, the actual width of pavesent will be dependent on the volume of traffic utilising it. This will also largely be determined by funds allocations. Your submission of this road as a Rural Development Project has been before the District Co-ordinating Committee and accorded a District Priority No. 3. (My 10-37-6 of 29.11.68 refers). Unless funds can be made available on the half yearly review, it is most unlikely that Administration financial assistance can be given before next financial year. Your initiative in having an access made to these areas utilizing facilities to hand is good. I assume, though not mentioned, either in the report or your comments, that the work through Tolupai Plantation and removal of small coconuts on the roadline was cleared with the management in advance.

Mr Geri appears to have achieved a useful 16 days but I believe his organization could have been improved. Returning some 7 miles to the station for lunch is time wasting and a pressure on transport which on your earlier submissions is hard pressed. Further, in the conditions mentioned in respect of water it would be far preferable to take daily a large container rather than have to proceed over a mile for a drink. (para 2 Labour, page 3). Mr Geri should be advised of these points, not as idle criticism, but in terms of basic organization which will lead to better and easier roults.

The work undertaken will do much to assist the morale of the Pangalu settlers and villagers in that their problems are appreciated and assistance is being given within our resources. There should also be a minor lesson that the Administration is more likely to help those who first help themselves.

## TALASEA PATROD No. 7/68-69/ .

Please find enclosed the report of a Special Patrol conducted by Mr. J. Geri for the purpose of opening the Panagalu - Volupai Road (Tlasea Penissular Road).

The work commenced on 28/10/68 and ceased on 16/11/68. There are 16 Patrol Days, not 15 as stated. The Report was first presented to me on 19/11/68 - I returned it to Mr. Geri for clarification on distances and measurements, for preparation of a Patrol Map, and a Report on the Police, it was again presented to me on 6/12/68. The Map is attractive, but both the Report and the Map are inaccurate with respect to size of the road and distances.

In fact there is a distance of 5 chains cleared to a width

of 100 links (shown black on the map).

A Distance of 8 chains cleared to a width of 50 links.

A distance of 3 chains cleared to a width of 15 links, this abuts onto the old plantation road, which in turn joins a narrow track cleared by Mr. H. Rothmeier, a few yards further on. Mr. Rothmeier's track, whilst sinding to avoid stumps and young coconuts, is within the boundary of the Surveyed Road.

A total of 69 coconuts were uprocted or destroyed in the course of road making. These will most likely be the subject of a claim for compensation by Volupai Plantation Ltd., Mr. Humphreys is the Manager.

The work done by Mr. Geri in supervising the detainees on this road work is quite satisfactory to me - he did as good a job as was possible under the circumstances, and with the time available. It was not possible for the detainees to camp out as there was not sufficient water available, nor a decent camp site. Transport shortages forced me to curtail the mark transport and a supply them. I would have wished. the work somewhat sooner than I would have wished.

You have my submissions on the Talasea Peninsular Road, of which this section is simply the beginning. As Mr. Geri points out in the final paragraph of his report, the road provides very rough access, and to complete it will require finance and a lot of labour, I might also add that mechanical equipment will be required to form an all weather road up the peninsular. The extent of voluntary work that has been done along the Peninsular Road cannot be minimised Pangalu Settlers, Pangalu Villagers, Mewlands, Pugau and Lotumgau Plantations, Volupai Plantation, and Woganakai Village people have all worked hard to provide temporary access roads. This however is a stop gap to provide temporary outlets for established needs, for th future development of the area permanent roads are required, and this will need Administration assistance.

#### FANGALU SETTLEMENT AND SETTLERS.

Unlike the Dagi Settlers, the Pangalu Settlers are very hard working people, and this illustrates the ammount of work done on their blocks during the writer's visit. Almost all of the individual block is covered with some sort of crops.

It was very pleasing to note that they build their own roads into their blocks after it was roughly marked by Mr, Rothmier. This The writer thought that the settlers out there really understand the meaning and importance of roads into their blocks.

#### COCONUTS FOR COMPENSATION.

The writer's daily detailed record showed that the total of 69 young coconuts were uprooted or destroyed in the course of road - making which will be claimed for compensation, by the plantation owner, Mr. Humphrys of Volupai. There are alot more young trees totalling a few hu hundred inside the entire length of and width of the road.

#### CONCLUSION.

The road is done two-thirds of the way only likely reached the old plantation road, othwise it will be incomplete because the word from the Assistant District Commissioner, Talasea that detainees will ceased to work on the road.

#### Introduction.

The purpose for this patrol was to locate the already serveyed cement pegs, clean, clear, form and open the Volupai - Pangalu Road. This road was opened very rapidly without refinements which provides a direct access along the serveyed road to the Pangalu Blocks.

The total field days out on this road is fifteen days. Detainees from Talasea Corrective Tuntti Institution were put on this road with Warders and Policemen of Talasea Detachment.

The initial clearings are done with removal of logs and tree stump stumps, only final finish awaiting grading. This road is expected to be a very important one when its in completion, to help with developments in the

With lack of funds avaiability, to employ labourers, detainees from Talasea Corrective Institution was used. The task of opening this road was a difficuat one because every few feet there is either a log or stump to be uprocted. Apart from stumps and roots, there are alos general overgrowth vegetation including vines.

A daily rate of 25 to 30 detainees were observed working on this road. Lunch for detainees were brought out from Talasea by the Administration vehicle which on its return trip brings the writer to Talasea for lunch and back on road at 1 p.m. Water is obtained at from the tank at the airstrip, a distance of one mile, by three detainees each time the water is rationed out.

There's a change of police and warders to take charge of the detainees twice a days. The part they played was received by the writer with appreciation. Constable 1st Class SINAI was very outstanding.

#### TOOLS .

Tools used in this patrol were axes, spades, shovels, picks, crowbars and grass- knives, all obtained from the Government Store at Talasea. Axes were so blant, the progress was slow due to big stumps and logs but the result was satisfactory.

#### SIZE OF ROAD.

The size of the road is 100 zkains links wide and approximately two miles long. The work done on this road now is only a narrow strip which provides access right throught and is not the actual size. The width now is about nine feet or more.

This Volupai road is now open as far as the old plantation road which connects the rough road used by Mr. Rothmier to reach his plantation at Newlands. Its a rough road and to build this road it needs a lot of effort.

The Council Tractor is hired to take detainees and warders and police out on to the road every morning at 7.00 am and back to Talasea in the afternoon at 4.30 p.m . daily.





#### TALASEA PATROL REPORT No 8/68-69 KOMBE CENSUS DIVISION

Receipt of the reports submitted by P.O Leaf and CPO Bassett covering their patrol of the Kombe C.D and your comments per memo 67-1-1 of 3rd instant, are acknowledged.

Your comments are pertinent and cover the reports well. Bot reports are well presented, but there is a lack of factual information which firm decisions may be based. Viz copra central store. How much copra can be expected to be produced and pass through the store? At what rate per month; how shipping arrangements can be organized collect and at what intervals. I am interested as to whether the idea came from the middle Kombe or whether it has come from the patrol. I believe that the approach is sound if from the people, and advice of copra to be shipped could be advised vessels probably through courtesy of Lingalinga pltn. Neither Officer notes as to whether the store is to built on a co-operative basis, and what some planned action is to be taken within a specified time.

I believe this could be a big step in accelerating copra production the area, but planned action is needed.

A Fisheries survey of the Kombe re crayfish, was undertaken during late 1967 but no definite results were obtained.

In respect of Council development, I agree with your covering comments. However the staff situation within the Department will not allow for expansions at the present time. #### TALASEA PATROL NO. 8/1968-69 KOMBE CENSUS DIVISION

Herewith please find the report of the above patrol to the Kombe Census Division, together with copies of the patrol instructions and camping allowance claims for Messrs. Leaf and Bassett for approval, please.

- 2. The patrol is regarded as being relatively successful though the results arising from it cannot be described as being really productive.
- Various matters arising from the report have been covered under separate correspondence. Some general comments are respectfully submitted hereunder:-

#### Political

Mope of Vessi Village was brought before the Local Court at Talasea, charged and found guilty under Regulation 125 of the N.A.R's and given a short term of imprisonment. He will be watched in the future but further trouble of any consequence is not anticipated.

#### Local Government

Mr. Leaf has repeated the theme reported by a mumber of officers after their visits to the Kombe. I would have liked to have seed some concrete proposals submitted. The general attitude towards the establishment of a council appears to be unchanged, though it is slightly disheartening to read that some of the pro-council villages seem to be losing interest. Personally I favour the establishment of a separate Kombe Council just as soon as staff is available. This council would not be a strong financial unit and its ultimate future would lie in amalgamation with the Talasea future would lie in amalgamation with the Talasea Council. At present I find it difficult to determine just what is the District policy towards this area and seek your considered opinion on the subject.

#### Economic Development

The problem of the poor shipping service in the middle Kombe area has been acknowledged for quite some time. Mr. Leaf has failed to produce any facts or figures as to the volume of copra likely to be held at the proposed bulk store at Nukakau Village. Until something definite is known it is difficult to interest or encourage vessels to move into the area. The matter of a frozen fish industry has long been under discussion. I would like to have the area visited by a Rural Development Officer to assess the potential of the Kombe in actual facts and figures.

#### Reef Markers

This is a very sound request. Would you please advise the approach that should be made in an endeavour to have reef markers positioned.

#### Guhi Fire

The people have rebuilt their village on the original site and there is no further need for Administration assistance.

4. Mr. Leaf's report is neat and clear, and soundly prepared. The delay in submission, due to Mr. Leaf's involvement in cash office work, is regretted. You are again assured that there will be no further delays in the preparation and despatch of patrol reports from this office.

5. Mr. M. Bassett, C.P.O., accompanied Mr. Leaf throughout the patrol and submitted a report as a training exercise. His report is a very sound first effort, though it tends to follow too closely the matters raised by Mr. Leaf. This report is forwarded herewith for your information.

- 6. Linga Linga airstrip. You have read the District Commissioner's letter 4-4-2 of 6th December, 1968 on this subject. Approach the Kombe people and seek their voluntary participation in the building of this airstrip which will ultimately be of great benefit
- 7. Discuss with the people the matter of Local Government, and find out their attitudes. Tell them that they have not been forgotter, but that no target dates can be set at this stage.
- 8. Law and Order. I have given you a copy of the N.A.R.'s, investigate and complaints, and bring any court Cases back to Talasea.
- 9. Village Housing & hygiere. Ensure that all previous orders on these matters have been carried out, and issue fresh instructions as necessary, recording same in the village books.
- 10. Investigate the economy of the Kombe, and see if any arrangements can be made to increase copra production by picking up copra at ports bach as Iboki, Poi, Silavuti, and Linga Linga.
- 11. If possible carry out the patrol targets in each village, and be at Lings Lings on the 22nd in order to be picked up by the The on its last run from Gloucester belove Christmas.

#### TALASEA PATROL REPORT No. 8-68/69. KOMBE C/D.

The Kombe Census Division is located on the North Coast of West New Britain District to the West of the Willumez Penninsula. All villages within the Census Division are within one days sailing, from Volupai, by Administration Workboat.

All but three of the Kombe villages are on offshore islands, two, Muliagani and Makati being little more than sand bars.

The Kombe is now the only area on the Nth.

Coast of West new Britain that is not under Local Government.

It was one of the main aims of the patrol to continue the work of earlier patrols in Political Education, particularly to point out the advantages of Councils.

The Kombe clans were the first in the Talasea
Sub-District to come in contact with the Germans. The first
German traders operated from a base on Talasea Island which
is owned by the Talasea clan who live mainly in Kalapiai village.

The Talasea clan people consider themselves as being the main helpers to the Germans and later to the Australians in bringing the Bakovi people and the Nakani people out of the inland and settling them on the coast. They still consider the Bakovi people to be inferior and more primitive than themselves.

The Kombe is an excellent sailor using his large sea-canoes to sail to the Kilengi people of Gloucester and also making trading trips as far afield as Bali. The trading trips to Bali were undertaken even before sails were trading trips to Bali were undertaken even before sails were used. Sails only coming into popular usage after the coming of Europeans.

The Kombe also has a fine record of service with the police and army.

POLITICAL.

As stated in the Introduction one of the main aims of the patrol was to find out as much as possible about the recent activities of MOPE from VESSI village.

Mope has been known to Government officers for many years. Me is able to recall meetings with Army and Angau officers just after the war. During these meetings he says he received assurances that radical changes would be made within a short time to bring the natives standard of living up with that of the Europeans.

The mechanics of such a change were not explained or were misunderstood by MOFE who insists that the native people have been cheated out of their share by the greedy Europeans.

In common with many cargo cultists MOPE has cast around for a reason why the European has acquired much of the material wealth whilst the Native has remained materially poor.

Mope has travelled widely to Rabaul and other centres and has been present at meetings where attempts have been made, by Government officers, to explain the material advantages of a law-abiding society. MOPE has deduced that, seeing as Europeans are so concerned with LAW, therefore the read of the cargo must run through the Crown Law Office.

Misinterpreting the attention, and reason why, so much importance is placed by the European on obeying the "Law" MOPE considers that, if the Grown Law Office could be pursuaded to relent, by means of a bribe, then the material benefits, now enjoyed mainly by the Europeans, will flow into the Kombe as promised.

MOPE

NEWE was in the precess of obtaining the bribe, in the form of a head tax, when the patrol arrived in the Kombe. A check was made in every village as to the amount collected. Totals from village to village varied considerably and it was apparant that few had the same faith in the Grown law Office as did MOPE. However, more tax was collected from those villages considered to be anti-council than from those considered to be pro. \$18 was collected from huliagani, this being the highest amount taken from one village, the next highest total being \$8 from Guhi village. Both the above villages are considered to be very anti-council. Both the above villages are considered to be very anti-council. Of the six villages we that gave MOPE tax only one-NUKAKAU is procouncil. When found at his own village MOPE had in his possetsion only \$17-00 and could account for only \$5-00 more that had gone to various people for help rendered during the tax patrol. MOPE to various people for help rendered during the tax patrol mope accompanied the patrol back to Talasea to explain his actions to the A.D.C.

Most of the Kombe villages had refused to pay tax to MOPE realizing that (a) the head tax collected by the Government has been discontinued and (b) Only Government officers are empowered to collect tax. MOPE had mentioned that he had the District Commissioners consent to collect tax but this was at no village ever believed.

#### LOCAL GOVERNMENT.

The Kombe is now the only Census Division on the North Coast of West New Britain that is without Local Government Councils.

Delay has been caused because of the outspoken opposition of a few reactionary villages in the middle Kombe. These are:
GUHI, WOGEWOGE, RANGAHI, SUMULANI, TARAVA, NUKUHU. The last two mentioned villages are divided on the question of councils and would probably not actively hinder a new council.

Talks on Local Government with the people centred around the advantages that the Kombe would gain from joining together in a Council. The idea of a unified Kombe, speaking with one voice which would be given a fair hearing, was stressed and was well received.

All of the Kombe villages, including the anti-coucil faction, welcomed the idea of a D.D.A. officer satting up a base camp in the C/D. An officer would have to be in residence for at least part of the year as communications from Talasea are unreliable and the new council will require "on the spot" attention for the first few years. In the anti-council villages the advantages of having an Officer being stationed, even only part time, in the C/D were stressed, more than the virtues of a council, as it was thought that a great amount of opposition to the idea of councils would be evercome if the villages could be made to realise the other advantages that would accrue from closer overall supervision.

In the anti-council villages it was found that the majority of people were more interested in copra production or the making of Tambu than in opposing the council. Enquires regarding D.A.S!F. assistance in the purchase of materials for copra dryers, co-operative ventures and assistance with shipping were just as frequent in the anti-council villages as in the pro-council villages. It seems that much of the opposition to councils comes from a minority of vecal clan spokesmen who are reluctant to see their traditional powers wane. The majority of people in the anti-council villages are passive and a secret ballot in these villages, IXIAAI would probably show a greater pro-council vote than the seemingly solid 100% anti vote now suggested.

Pro-viilages are also confused and disappointed that the Government has seemingly backed down because of the opposition of the dissidents. In Nutanavua it has resulted in a marked deterioration in the peoples enthusiasm for councils. The people are unwilling to listen to explainations about the delays, considering the D.D.A. officers over the last two years to be "Maus wara tasel" (all talk no action). This expression was teld to me by the Luluai of Nutanavua, Rava, long considered to be one of the most pro-council of the leaders in the Kombe.

The Kombe expression "Mi laik lukim na holdim" attitude towards councils at this stage. This sums up the Kombe can be expected in increasing the % of the "Yes" vote until the proposed council is started. Only an increase in apathy will result from overlong delays in commencing the council.

#### HOUSE OF ASSEMBLY

The new House had been sitting for six months or more when the patrol visited the Kombe. The general attitude towards the House is one of apathy.

The Kombe people consider that they are forgotten by their members, both Open and Regional glastafter, who, they say do not visit them enough. Promises by the Regional member to place freezer units in the Kombe to stimulate frezen fish production are still widely remembered and there non-arrival is considered to be proof of lack of attention to the wants of the Kombe constituents. The Kombes consider that only a Kombe could properly look after their interests. Therefore there should be no lack of candidates from this area for the next elections.

Explainations that the members had other areas to laok after as well as the Kombe, other duties eg Ministerial respesibilities and that the elected members had a responsibility to the whole of Papua and New Guinea as well as their own axax electorates, produced only little response. The Kombe outlook is still extremely porocial.

#### LAND MATTERS.

The patrol read out one Final Order (Talasea file 34-3-11 refers) at Ke village on the twenty third of Dec.

At Kalapiai the Patrol also investigated the suspected existance of an area of Government Land known as BULE that was suposed to have been purchased by the Germand but later abandoned in favour of LingaLinga(Talasea file 34-3-14 refers)

Although ownership was admitted to by two witnesses at a Native Lands Commission Hearing in 1961, refer Talasea file 35-22-5, before Mr. J. Reid, the Talasea clan of Kalapici village now deny all knowledge of payment of attempted purchase. A full report has been made on the above file.

#### LAND DISPUTES.

During the patrol the three main land disputes, supposedly settled by Mr. Reid during his 1961 hearings, were again brought up for review. These are namely:-

#### KAPO V MULIAGANI

The Kape and Kavukavu clan of Pape and muliagani villages repectively are again at leggerheads over the boundaries of their clan lands. The most recent clash occured when the Kavukavu clan (S.D.A.) built a mission school on what the Kape clan considers to be its side of the clan boundary. The kape clan says that the KELUPU creek is the actual boundary whilst the Kavukavu clan considers that the LIAPAPA creek is the actual boundary.

The matter is further complicated by the fact that Muliagani Island is owned by the Kape clan and the EAVUKAVU clan only enjoy permissive occupancy.

Both sides attention was drawn to the Native Lands Commission Findings N.L.C. 5/2/6 of 28/8/62 Mr. J.Reid. which placed the Kape boundaries at the PUA river in the East and the Aria river in the west.

#### SUMULANI V NUKAKAU

At Sumulani the people brought a complaint to the patrol to the effect that the Nakakau people had been stealing coconuts from stands belonging to the Sumulanis. On further investigation the ground refered to was found to be that called MILIMATI. Mr.Reid adjudged this land to belong that called MILIMATI. Mr.Reid adjudged this land to belong to the NUKAKAU people, although the coconuts were eriginally planted by the Sumulanies at the insistance of a D.D.A. officer called Mr. Ellis in 1930. According to Mr. Reid officer called Mr. Ellis in 1930. According to Mr. Reid the Sumulani people were to have use of the coconuts for ten years after planting, after which, the coconuts were to become the outright property of the SAPULO clan of NUKAKAU. As the outright property of the SAPULO clan and no case of the coconuts rightly belong to the SAPULO clan and no case of stealing can be brought against them.

LAND DISPUTES CONTD.

#### TALANGONI V KALAPIAI

At KALAPIAI I was informed that the SAPULO clan on TALANGONI Island had planted a number of coconuts over the boundary onto TALASEA clan land. TALANGONI Island was divided into two, a cement peg and a blazed tree being the markers, by Mr. Reid in 1961.

One half to belong to the SAPULO clan resident on the island at TALANGONI village. The Eastern half was retained by the TALASEA clan resident at KALAPIAI.

On inspection it was found that over 1,000 new palms had been planted by the SAPULO clan on TALASEA ground. Both the cement peg and the blazed tree were found and the boundary line walked with clan leaders from both villages. The SAPULO people were informed of the waste of planting palms on other peoples ground as such palms are considered to become the property of the land owner.

It seemsex that the findings of Mr. Reid are either being forgotten or convieniently ignored.

#### DEMARCATION.

Demarcation was discussed in most villages during the patrol with particular emphasis being given to it in the three areas mentioned above. The people of KAPO, MULIAGANI, and NUKAKAUand KALAPIAI are the most interested in dividing up clan land into more managable blocks. The remaining villages, perhaps because their boundaries are not at the moment in dispute, do not feel the need for change and say they prefer to follow the eld ways of communal ownership. Advantages, such as security of tenure and better chance of obtaining Development bank leans, were felt to be of little importance to the majority. However, a few young men expressed a desire to see land that they had planted themselves demarcated so that they could be assured of continued occupancy. Demarcation is necessary to settle, once and for all, the land disputes that currently divide the clans and cause a barrier to unity which is vital for the proposed council.

ECONOMIC DEVELOPMENT.

The new coconut cosus is not yet at hand. Therefore the ald figures of roughly 88,000 mature and immature trees still stands. New plantings are going ahead at a steady pace.

Several factors hold back the Kombe from benifiting fully from its copra. One is the traditional land tenure system which refuses to allow one man the right to plant and harvest copra without interference. The patrol received several complaints from young men who stated that their coconuts were periodically invaded by their relations who considered the coconuts stands to be communally owned even though they had no hand in the actual planting.

four hours outlets for the copia produced are Lingalinga plantation at the Eastern End of the Census Division accounting for approx. 4 tens of native produced copra a month and Iboki plantation at the extreme western end experting slightly were each menth. Cepra is also shipped out through the Catholic Mission at Sasavura which has a six weekly visit by ceastal beat. The main problem is in the middle Kombe around Sumulani, Megewoge Guhi and Rangahi. These villages are the most poorly served of any by shipping. Although their copra production is improving and they are extending their stands of new plantings there will not be any real upsurge in enthusiasm until a regular outlet for their copra can be arranged. Subsidized shipping such as suggested by the U.N.D.P. survey would help in solving this problem. A bulk store is to be erected at Nukakau island in which the combined production of the above villages is to be stored. It is hoped that the total number of bage willbe sufficient inducement for a coastal vessel to make a regular stop at Nukakau.

It has long be hoped that a frozen fish industry might be started in the Kombe to foster a cash economy. Due to lack of finance to buy the expensive freezer equipment necessary the project has never become a reality. One alternative to freezing the fish may be only to salt them, thereby circumventing the need for expensive equipment. It has been suggested that a expensive equipment, It has been suggested that a market is to be found amongst the Chinese community in Rabaul.

# AIRSTRIPS. - LINGALINGA.

Within the Census Division there is only one airstrip. This is on Lingalinga plantation. 2900 feet in length 150 feet wide. The mirstrip was partly constructed during 1965 and requires only clearing of secondary growth and a small amount of leveling before it becomes operational. The present manager of Lingalinga would prefer to complete the strip using purely plantation labour or by using schoolbeys from Silavati Missien in preference to using lecal Kembe Labeur.

The construction of the airstrip was discussed th with the SAPULO, TALASEA and Poi clans eg these villages with approx. four hours cance sailing from Linga Linga. They are unwilling to work on a voluntary basis. Their reasons are these.

(a) When the airstrip was first startedby by the

company the Kombe were asked to work on it, which thet did. On this occasion they received pay.

(b) They are trying to establish a cach economy and have little time for working gratis for the Government.

(c) They realize the advantages of an airstrip to them but consider it primarily for Government and plantation use and not for them,

### REEF MAPKERS. - KOMBE AREA.

Whilst at Silavuti Seven Day Adventist Mission the Pastor Pascee approached me re:a request for marine assistance in the placing of permanent markers on some of the mere dangerous reefs around the Kombe islands. Some reefs have already been marked by the mission but these are often sweapt away during heavy seas and are difficult to replace.

The request is reasonable asspermanent markers would aid, not only mission boats, but also encourage coastal vessels to venture into the islands to bring out native copra.

### THE TAMBU SYSTEM

Kembe people had in circulation a mode of exchange that worked sufficiently well for it not to have been replaced to this day.

Tambu money and the elaborate gift exchange system that accompany it still form a large part of the way of life in the Kombe. Where money is in short supply the traditional money, (Unit - one fathem tambu =\$1), is readily exchangable for either goods or services. All items of exchange have their equivilent value in money and tambu.

The tambu shell, semetimes called LEMLEM, is usually found in the mouths of the large rivers and is gathered by the women who dive for it off cances. After a basket or two has been gathered and the edible meat consumed the shell is cut into rough half inch diameter circles. Then a hole is punched into the centre with a screw-driver which has been suitably sharpened to a needle like point. The rough circle is then further pared with pliars until the circle of shell is no more than a ring of quarter inch diameter. So far allth the work has been done by the women who are very proficient at wielding the pliars. (One enterprising European, a enetime resident of the Kombe, was known to manufacture his own Tambu using an electric drill to punch the holes in the centre of the circles).

The rale participation occures when the next stage is reached. A length off fishline, three to four feet long, is strung between two nails embeded in a piece plank. The shell circles are threaded onto the fish line and packed fairly tightly. A small section at a time is then scrubed with sandstone to remove the last rough edges and to give the shell its distinctive smeeth feel.

A days labour, with all the family and relations helping, may manufacture up to five fathoms of tambu. Such a consentrated effort would only occur in case of special need eg. The need to accumulate bride price.

Red tambu, sometimes called MISH, is only used during the traditional secret exchanges of Tambu before marriages. This cannot be found locally but is purchased from around Rabaul. Red tambu is \*\*REMETER\* reported to cost as much as \$10 a fathom which the Kombes complain is \*\*EEX\* exorbitant. Five to six fathoms of Red tambu are given to the parents of the intended bride as the traditional preliminary to negotiations of the actual marriage agreement.

Brides are bought with the payment of both tambu and money although, at a pinch, money on its own will do. Prices vary with the husbands relations ability to pay. The record reputedly being held by a Sepik who paid \$600 cash for his wife. Payments are also made to the brides relations at the birth of each child.

Exchanges of tambu also occur during feasts where, when a man makes a feast, he invites all the people that he owes tambu to and during the feast he acquites all his debts. however in typical Kombe fashion he goes one further by doubling the amount that he had originally borrowed thereby transfering the obligation back on to the recipient to hold a feast. This partly explains why the Kombes travel so much from feast to feast. A man who is not in attendence at one of these feasts to collect his debt stands a good chance of forfiting his tambu. In some cases a Kombe just cannot afford to miss a party.

Problems arise when debts are allowed to stand for long periods before any action is taken to recover them. However the Tambu system is in the blood of the Kombes in the same way as the Hire purchase schemes are in the blood of many Australians.

The material comes from two types of tree known locally as SHU and MANGAS. The former is used in the actual construction of nets whilst the latter is used to make a plaited rope. The bark material is separated into thin strands which are then relied together with the palm of the hand against the thigh. A very strong twine is produced that is resistent to salt water. The net is made by the use of two simple instruments. A piece of tertose shell made into a comb about six inchs long and one inch wide, very highly pelished. The other is a wooden shuttle, forked at both ends, around which the twine is wraped.

The comb is held in one hand. Several lenghts of rope are attached to the comb( called MATA). At the other end the ropes are attached to a nail driven into a convienient house post. The shuttle(SIONI) is used to thread the rope through the strands attached to the comb to complete the net.

The comb has a great deal of significance for the Kombe. Besides the comb that he has made for himself the Kombe also has the comb that belonged to his dead father. which he keeps in momerial of him. When he himself dies his son will break the komb that belonged to the grandfather and keep the comb belonging to his father.

The shuttles (SIONI) also have significance.
Young boys have the habit of sitting close to their fathers or
Uncles during conversations when they may be working at net making.
If, by accident, or intent, the shuttle should touch the boy then
he is considered not able to marry. The reason is unclear but it is
considered great shame to be touched by a SIONI during net making.

The person so touched is called OSIOSI or ORI and cannot marry into the Kombe tribe. This custom is enforced by the women who insist that they would have nothing to do with an OSOOSI. It is interesting to note that Mope of Vessi village (see Political Situation) is an OSIOSI being accidentally struck with a SIONI during his youth. Mope has never married.

# Accidental Drowning -Taraua.

On the 12-12-68 the small sen of the S.D.A. teacher at Taraus accidentally drowned whilst playing in the sea. T revisited the village on 19.12.60 from Talangeni. An investigation into the drowning showed no suspicious circumstances.

# Guhi-Fire Report.

At Guhi a fire that spread from a Haus Kuk destroyed twenty five houses before a change of wind blew the fire back on itself.

Guhi is situated in the middle Kembe. The village occupies the whole of the small island with houses extremly ast close together.

These who lest their houses and possessions in the fire are new housed with relatives in the remaining houses. This is causing great evercrewding and the people wish to start rebuilding as seen as pessible. Although building on the mainland was advised by the patrol as a way of ensuring no further repartition of the fire hazardy the people are insisting on rebuilding on the island.

The Land is came to me with a request for assistance in retailing. I replied that deverament assistance was usually restricted to cases of great need where it is accessary for the Government to step in and step famine etc. Although a large number of houses and step famine etc. Although a large number of houses were destroyed they were all native materials houses that were destroyed they were all native materials houses that were destroyed quickly and cheaply. Also, as the people can be replaced quickly and cheaply. Also, as the people insist on rebuilding on the same site, the possibility of another fire is ever present.

I consider that a Government grant should not be given without the provise that the houses be reconstructed on the mainland where they cam be better spaced.



TALASEA PATROL REPORT NO. 8 68/69 KOMBE CENSUS DIVISION

The Kombe Census Division is located on the North Ceast of West New Britain, between the Bela and Kaliai Census Divisions. The population numbered 3,619 at last census, and of the 15 villages, all but 3 are on offshore islands.

The Kembe gardens and plantations are found mostly on the mainland adjacent to the respective islands. Although clan boundaries were drawn up and marked in 1961, there is still much friction between groups over land usage.

The Kombe are traditionally excellent seamen, and travel videly by sea-cance. Large numbers of them have found work and settled in other areas, and trading trips are still undertaken as far as Bali and Gloucester.

This Census Division is new the only one on the North Coast without a Local Government Council. Thus one of the important aims of the patrel was the furthering of Political Education with respect to the advantages a council would bring to the area.

Other aims of the patrol were to enquire into the activities of MOPE, an old cargo cult prepagator from VESSI, and to report on the advisability of using Kombe voluntary labour to complete the airstrip at Lingalinga Plantation.

The patrol was accompanied as far as NUTANAVUA by a medical patrol, conducted by Peter Bolamark who visited the villages per N.V. "Toa".

# SITUATION REPORT

### A. POLITICAL

## Local Government

The Kembe is the only Census Division on the North Coast of West New Britain not yet under Local Government. This lagging behind is due to lack of staff, and the epposition of a few conservative villages in the middle Kombe. From discussions, it appears that village leaders at GUHI, WOGEWOGE, RANGIHI and SUMULANI are still definitely anti-council, and that this eppesition is due mainly to the association of councils with head tax. These villages, although coconut planting is increasing, still rely heavily on working tambu for a living, and claim they can't afford to pay council tax on top of church taxes and school fees.

Throughout the patrel, in discussions with the people, two points were stressed. One, that an officer experienced in council work would come to the Kembe to help them organize their council, and two, that the council would unify the Kembe, and work for their own interests.

Both these arguments seemed acceptable in all the villages.

The pro-council villages are not interested in talk any more. They want a council new, and are disappointed, some even anneyed at the delay.

A possible site for the Council House could be a large island adjacent to NUKAKAU, which the patrol inspected with this in mind. It is strategically placed close to the anti-council villages and fairly well in the middle of the Kombe area.

One of the aims of the patrol was to report on the recent activities of HOPE, an old cargo cultist from VESSI village.

Mope claims to have attended meetings with many important officials in the early post-war years, who promised radical material changes for his people. He says that instead of his people receiving these benefits, the Europeans have been cheating them of their rightful possessions.

Mope has no conception of where European goods come from, er how they are manufactured. Somehow, he came to the conclusion that everything the white man does is controlled by law, therefore this must be the basis for getting his "cargo". Mope then set about to "buy" the Crown Law Office, by means of a tax collected from the Kombe.

When the patrol arrived at VESSI, Mope had collected a total of \$45.20, according to a check made at each village, but could account for only \$22, \$5 of which he had spent.

Although Mope claimed authority from the District Commissioner to collect his tax, he was not believed by the Kombe, who know that only Government officers can collect tax, and that the Government head tax has been discontinued.

Generally, Mope is considered by his people as a harmless, simple minded old man.

Mouse of Assembly The attitude of the Kombe tewards the House of Assembly is generally apathetic. They are disappointed, considering themselves forgotten by Hembers who seldem visit them, and they have little idea as to what goes on in the House. The Kombe are a little idea as to what goes on in the House. The kombe are a people who judge the usefulness of a thing by the tangible benefits that result - to date they consider it has done nothing for them.

In a number of villages, we were asked why there should not be In a number of villages, we were asked why there should not be more broadcasts on the House of Assembly over Radio Rabaul.



Copra is the main source of cash income for the Kombe. At last census, total trees numbered approximately 88,000.

On either end of the Kembe Census Division, outlets via Lingalinga and Ibeki Plantations take about 8 tons (total) of copra per wonth from the village copra driers. (All villages have at least one drier.) Copra is also shipped out through the Sassavuru Catholic Mission. ( on the mainland opposite Poi).

The middle Kembe region has virtually no shipping, and copra sust be transported long distances by canee. Coconut planting is continuing in this area, but until regular shipping can be provided, ne real enthusiasm can be expected.

If the proposed construction of a bulk store on NUKAKAU should be realized, the copra industry should benefit greatly, for as yet there is no good dry-storage available.

The traditional land tenure system appears to be a major drawback to development in the Kombe. There are quite a number of energetic young men throughout the villages desirous of "getting en" who have worked hard on their plantations, only to have them The patrol raided by relations and traditional creditors. received many such complaints, but Kenbe land is communally owned, and nothing can be done except to wait for demarcation.

The prospects of a frezen fish industry seem poor at the moment, due to lack of finance for equipment, but a far less expensive and more easily established alternative could be found in salting and drying the fish, if a market could be found.

### Lingalinga Airstrip

The airstrip on Lingalinga Plantation (2900° x 150°) was partly built by paid Kombe labour in 1955, and is the only one in the area. It needs only a little work before completion and this work was discussed both with the plantation manager and the Kembe people in the vicinity.

The Kombe, typically, dislike the idea of voluntary labour, and feel that the airstrip would be of little benefit to them anyway.

The plantation manager would rather use his own labour, alos, so there was no need to ask for volunteers.

# Crecedile Protection Ordinance

Crocodile shooting is still a profitable industry in the Kombe area, at the moment carried out partly by locals and partly by migrant Sepiks. The Ordinance was explained in every village, although many had already heard of its requirements over the radio.

### Land

The patrol was instructed to investigate a section of land known as BULE, situated east of Lingalinga Plantation on Wilson Peninsula. This land was thought to have been bought pre World War I, but the KALAPIAI villagers deny ever hearing of any such transaction.



## Land (cont.)

The patrol read the Final Order on the Catholic Mission site at Kor (on the mainland) to the Ken villagers.

### Pemarcation

This subject was part of the regular discussions throughout the patrol. The majority does not wish to change from the traditional system of sommunal holdings to individual ownership of land

Those villagers that were involved in disputes over land seemed more receptive to the idea of demarcation due to their desire to have some sort of permanent settlement.

Some of the more industrious young men would be happy to have demarcation, to ensure their individual work would benefit them personally.

### Lend Disputes

### 1. Kape v Muliagani

The latest dispute between these villages came about when the Muliagani people (S.D.A.) built a mission school on land the Kapo Clan (Catholic) considers its own. The Native Lands Commission Finding (N.L.C. 5/2/6 of 28/8/62) was read to them, which states the boundary of the Kapo Clan is at the Pua River and not, as they claimed, at the Kelspu Creek.

### 2. Sumulani v Nukakau

This dispute arose over a piece of land (known as "Milimati") which, originally, had been planted with coconuts by Sumulani. They claimed that Nukakau people had been stealing coconuts from these trees. Upon studying the N.L.C. Finding it was evident that the land, and therefore the coconuts, belonged to the Nukakau people. Although the Sumulani villagers did plant the coconuts, they had only 10 year's use of them, ending during the Second World War.

### 3. Talangoni v Kalapiai

The island of Talangoni was divided roughly in half by the f.L.C. Finding, 1961, one section being designated to the Sapulo Clan (resident on Talangoni), the other to the Kalapiai Fillagers. The dispute resulted from the Sapulo people planting coconuts (about 1,200) and gardens on Kalapiai ground. They were reminded of the Finding, and the boundary line marking the division was walked with both posties. These coconuts and gardens, legally, belong to Kalapiai.

### C. SOCIAL

### Health and Housing

Throughout the Kombe, the standard of housing was very good. Only two houses were ordered rebuilt. Villages were clean, and very few pigs were seen in housing areas.

Health is also of a high standard. One child with badly infected scabies was ordered to Talasea for treatment.

There is one aid post in the area, at Maputu (on the mainland) just off Kalapiai.

Schooling up to Standard 4 is available at Sassavuru (Cathelic) and Silavuti (S.D.A.) Missions. An increasing number of boys are attending High School in Rabaul, many of whom intend joining the Folice Force and D.D.A. It is the hombe custom for girls to remain within the clan group until marriageable age, thus no girls have

### Tambu

Tambu or sheel money is the traditional means of exclange still used by the Kombe, with origins back far beyond living memory. Tambu is readily exchangeable with Australian currency, as well as for goods and services. A large sea-canee, for example, might cost 10 prahins of tambu (1 prahin = 6ft.)

During the patrol, we watched the making of black tambu. It is made from a shell called "Lemlem" which is broken into small pieces, each piece then being pierced with a metal spike, and threaded on fishing line. These small pieces are then trimmed with pliers into rough %" rings, packed tightly and secured by knotting either end of the line. This much is done by the women.

The string is then ground with sandstone, until the finished product is polished and even. One prahin is worth \$1.00.

Red tambu is exchanged only in very important marriages, and is seen only by the groom and his prespective bride's parents. It is imported from the Gazelle Peninsula, reputedly costing up to \$10 a prabin, so only the wealthy can afford it.

### Tubuna System

It is the Kombe custom to hold large feasts and accompanying singsings, during which exchanges of tambu and other goods take place. All debts are expected to be settled at these exchanges, and new ones incurred with the giving of more tambu, and so on. Each man has a number of traditional exchange partners, and if he misses a feast, he risks forfeiting his rights to repayment. Thus much time is spent at organizing and attending feasts that could otherwise be spent at work. This custom is called "Tubuna".

The non-payment of debts was one of the biggest causes of complaints: the patrol listened to dozens of them.

A number of the better educated young men are dissatisfied with the way of tubuna. They want to leave the system and get to work on their plantations, but have met extremely hostile opposition from the influential men in the villages.

One young man from Nukakau, Vincent Lunga, is trying to persuade the young men to stay away from the feasts and work. He owns a large number of account trees, a hot-air copra drier and a trade store. He feals that the sooner the council comes, the sooner the chance to break down this time-consuming custom.

### D. MISCELLANEOUS



I visited Mr. Voase while he was working in the Dagi and am pleased with the work done. His report contains a number of thoughtful comments, but I do consider that he tends to be somewhat too critical of Administration efforts to make a success of the scheme. Mr. Voase must try and view things in their proper perspective He must endeavour to evaluate each settlement scheme on its merits in relation to other schemes within the District, and give full consideration to their economic potential and relative importance. Certainly there are a number of unsatisfactory features in the Dagi Possibly the biggest problem, and one that cannot be solved, is the poor location and its tendency to become flooded during the wet season. However, efforts are being made to improve the overall situation - the settlement is not being forgotten. settlement. I have attached a copy of memorandum 30-1/61 of 28/7/69, from the District Rural Development Officer, covering a number of the points raised by Mr. Voase. With D.A.S.F. District Headquarters now located at Kimbe there should be greater opportunity for checks to be made on the settlement. With regard to the school, I will endeavour to press for the completion of the building, and I will keep you informed of the progress made. I will approach the District Health Officer regarding the staffing of the Aid Post. As you will see in the District Rura Development Officer's memorandum, there is already a proposal that the local Pastor's wife undertake medical work. I want you to re-examine the Dagi settlement with the view to submitting a request for Rural Development funds. The above report has been read with interest. The conclusions and recommendations are in the main supported.

Below is comment of various parts of the report -

Page 4 para 4 (2) Councillors - The councillors has never attended meetings organised by D.A.S.F. or been on his block when inspected by D.A.S.F. staff.

Page 4 para 7 (4) Hopes and Aspirations. Contary to the report the Dagi settlement has not been neglected by D.A.S.F. and staff have been made available through neglect by other departments may be true.

Page 4 para 8. Urgent action should be taken to do something for the school. I understand that there was an aid post orderly but he was withdrawn by PHD Talasea.

Page 6 para 3. The area planted is some what less than 80% an accurate figure will be available shortly but it is estimated to be 65-70%.

Page 6 pars 9. It is understood that the Pastors wife is being considered to undertake aid post duties.

Page 6 para 10. Accurate census figure will be available shortly and will be made available for any submission for funds.

Page 7 para 3. D.A.S.F. will be encouraging the settlers to support and market to supply the new township of Kimbe.

Page 7 para 4. There is no D.A.S.F. station at Dagi, only a rest house which requires virtually no maintenance. Therefore D.A.S.F. staff at Dagi are available for full time work on the blocks.

Page 7 para 6. The organisation referred is certably not a cooperatives but a club or group of settlers formed for their mutual benefit. It is very doubtful that the settlers wish to form a cooperative.

Page 7 para 7 & 8 Driers are now being constructed on several blocks with D.A.S.F. assistance.

Page 8 para 1. It is reported that the children of Tande Daniel portion 60 are not at all well.

Page 8 para 3. Housing standards are generally higher than their areas as these settlers with loans have \$120 allocated for their houses.

Page 8 para 7. 8. & 9
The house was originally built on Pakuk's xxx
with his permission. If he has objections it would be best to ground
move the house,

It is recommended that -

- a special effort should be done to complete the roads within the settlement.
- (11) efforts be made to complete the school as proposed.
- (111) Satisfactory arrangements be made for an aid post orderly.

Please note that following the move to Kimbe close supervision of D.A.S.F. at Dagi should be possible.

The Dagi Settlement is located on the perimeter of the area controlled by the Talasea Multi Racial Local Government Council. Therefore being some distance (27 miles) from the centre of local government at Talasea it is unfortunately rather neglected by the council.

This state of affairs is not helped by the attitude of the settlers. Mostly Tolais, they look towards the Gazelle Council for guidance, despite the fact that the Gazelle Council ignores their pleas.

Perhaps with the growth of Talasea council more unison could be expected between the settlers and their council. As coconut palms in the settlement begin to bear and the settlers realize the need for improving their existing access roads etc.; a sound scheme could be initiated using council equipment financed by their newly established club or co-operative, mentioned later in this report.

# 2) COUNCILLORS

The councillor for the Dagi Settlement Ward (ward 1) WILLIAM PUKURA is chronically unsuited to the position. In my initial labour recruiting attempts I sought his assistance, assuming that as a councillor he would understand the need for self help in the settlement and as such would be able to guide the settlers thoughts towards self help. It is dificult for a field officer, a Government representative, to stress national self sufficiency and its relationship to the development of primary industry, to people in the position of the magi Settlers who feel when they have been let down so badly by the Government.

I would therefore recomend that some effort be made in the near future to show these people that their work is appreciated by the Administration and is helping to draw the Territory towards self determination. This could best be done along the lines proposed under the sub-heading GENERAL RURAL DEVELOPMENT in the ECONOMICS section of this situation report.

# GENERAL RURAL DEVELOPMENT

The Dagi Settlement is a sud-division on the eastern border of the Talasea Sub-District. It consists of 65 blocks we each having an average by roads and Government and public facilities the settlement has an area of somewhat over 2000 acres.

The economic objective of the settlement is to create individual self supporting native owned coconut plantations by the early 1970's.

The majority of the settlers are from the Gazelle Peninsula area of New Britain. Some settlers have been on these blocks since late 1961 and 1962. Therefore some of the blocks are now supporting mature bearing coconut palms. It is estimated that 80% of the settlement is now planted, with coconuts in all stages of development. However some of the plots remain virgin rainforest.

Most blocks appear to be suffering from some degree of neglect, especially those whose owners are in the habit of spending extended periods in Rabaul. Indeed some blocks are virtually unreconiseable as plantations until cleaving with a bushknife reveals immature palms choked and light starved by faster growing under growth.

As stated elswhere in this report absentee owners and resulting neglect and stagnation of plots is not entirely the fault of the watthe settlers. In some ways even the site chosen is unsuitable for such a project. For instance during the north west wet season, much of the settlement is either very swampy or even submerged in some sections after excessively heavy rain. However by the greatest contributing cause of the settlers dwindling interest, is lack of Administration interest and assistance. Atthe moment the future of the Dagi Settlement looks rather bleak.

If the interest and moral of the settlers is to regained, in order to restore the settlement to the level where it will prosper, some urgent action would appear nescesary. This would best take the form of an upsurge in Administration activity and assistance in the settlement.

Perhaps the proposals enumerated hereunder could be considered :-

- a)According to the head teacher at the Dagi School, materials allocated for the construction of new classrooms are at present stored at Kapa Rapa educational centre in the Hoskins Sub-District. These materials were reportedly awaiting the onset of the 1969 dry season for transport to the Dagi. The dry season has now been in progress for some two months but as yet no materials have arrived at the settlement. If there delivery, materials have arrived at the teachers residence and a together with materials for the teachers residence and a carpenter to erect them, could be expediated it would be a firm step in the right direction.
- b) The settlers have long been awaiting an orderly to man the aid post on the settlement. Due to the nature and the volume of work involved in clearing blocks and roads injuries are common. When we want from this the latest census reveals the settlement has a settlement of 203 men, women and children. Surely this alone population of 203 men, women and children settlement.
- d)Instead of using the remaining 9642-80 of the original roadbuilding vote solely to pay for labour lines, it could at

this stage be more economically spent on earthmoving equipment and materials with which to manufacture culverts and bridges. This completed to tractor access standard, it would be only common sense to build culverts and bridges so that a vehicle could actually reach the roads. Ferhaps towards the end of the current dry season the hax bulldoner and grader now operated out of kinbe by the Public Works Department could be spared to do approximately three days in the Dagi Settlement.

This patrol went into the settlement believing that the Dagi Settler was a hard man to recruit into a labour line, even though he would be working on his own roads. This was to be found basically incorrect. Due to the spread out mature of the settlement and the fact that the settlers seem to keep within their own family groups, the "talk" concerning faxaxa attendance at future labour recruiting meetings is rather slow making the rounds. If a little persaverance and patience is practiced and one walks around the mattiana settlement speaking to each family group individually, it is not difficult to recruit almost all the available settlers. However the settlers do not like to work for more than a fortnight in concurrance, arguing that some time office required for block and garden maintenance. Therefore if a staggared roster is used and half the manpower works the first fortnight and the remainder the following fortnight the settlers seem happy to play along.

Apart from activities concerning the EXEXNER Maintenance of coconut palms the settlers also practice subsistence agriculture. The crops planted would be typical those grown in such gardens anywhere on the New Guinea coast. The main aim of these cultivations is of course to supply the cultivator with a fresh and varied food supply, any surplus however is sold to less fotunate settlers and the nearby construction camps housing personel involved in the Kimbe Township project.

### ACTIVITIES OF DEVELOPMENT DEPARTMENTS

The Department of Agriculture Stock and Fisheries has an agricultural assistant stationed paramanaki permenantly at the Dagi Settlement, who from the appearance of the blocks is either not doing a competetant or the settlers are not paying heed to his advice. I suspect the volume of field work on the station is to great for him to cope with.

Both the District Rural Development Officer Mr. Mark Jones and the Hoskins Project Manager Mr. Peter Holmes visited the settlement during the patrols stay.

Recently the settlers have established to a perative on the settlement.

Attempts were made, when the settlers received their pay, to stress the

advantages of directing some of this money towards building up this

co-operative. It is not known by me whether the Department of Trade and Industry

is showing any interest in this project.

### Processing and Marketing

As yet the great majority of palms on the settlement are not bearing and in most cases it will be several years before they do so. As each settlers palms mature he will probably erect his own permanent material hot air copra drier.

At the moment the most likely market for Dagi Settlement copra, would be the nearby township of Kimbe, where a large volume of shipping is expected in the future. However, depending on the progress of the above mentioned co-operative this could grow into a likely on the spot market.

# Health

Apart from injuries received whilst clearing blocks etc., the health of the settlers appears satisfactory. There is no evidence of malnutrition; the children are free from pot bellies and spindley legs, often a symptom of incorrect diet. Grili and other skin afflictions were rarely seen.

The adult Dagi Settler was capable of working strenuously, on the patrols labour line, from Sam until 4pm, in itself a fair indication of soundness of body.

### Housing

The settlers are principally housed in indigenous styled dwellings of hand hewn planks and bamboo floors built on a frame of bush poles, with the added refinements of corrogated iron rooves, doors and window shutters that lock and galvanised iron, roof fed water tanks.

Dwellings and surrounding living spaces were generally best in a clean and hygenic condition. Toilets, mainly the deep pit latrine type, are screened by plated comonut fronds and located some distance from the houses.

### Missions

The only two religious organisations on the settlement are the Roman Catholic and Methodist onominations. Catholic services are conducted by a catechist, in a small bush material church and Methodist observances are presided over by a pastor at the settlement school.

### Law and Order

There were no complaints brought to the patrols notice, and no infringements were noted.

### Queries

One settler, Pakuk of plot 39, raised a querie in regard to the rest house located on his plot. Pakuk complained that this dwelling was preventing him from planting further coconuts and that he is not in receipt of any rent for the space the rest house is occupying.

After examining cement survey marks, it appears that this rest house is in fact on Pakuks plot. However the issue is clouded by this settlers past convictions for altering the position of surveyors this own advantage. Since a surveyor will km wint plot have to marks to his own advantage. Since a surveyor will km wint plot have to re-align cements (result of Pakuks past Tamperings), visit plot 39 to re-align cements (result of Pakuks past Tamperings), I suggest that he be requested to check the position of the surveyors marks surrounding the rest house.

If it is found that the rest house is actually on Pakuks plot, it would seem in order to either advance Pakuk some rent, or re-locate the rest house in the area reserved for D.A.S.F. buildings and personel.
