Regarding an increase in our present supply and storage, at points now developed, it will be well, perhaps, to state a few facts: From seven to nine months in the year we have, as you well know, an abundance of water flowing in the San Diego River at our Diverting dam, and of this water, which is of the best quality, we divert what we want during that time into out system, which is at present only a small portion of the running water.

A very important and practically unlimited source of water supply; at our command is the tunneling of the mountains above our head works, as is done at Passadena and vicinity, a plan much favored by experts as being modern, certain and inexpensive. Furnishing the largest summer flow for the smallest outlay.

We have from surveys determined that the drainage area of the San Diego River and its tributaries above the Diverting dam is 105 sq. miles.

In addition to this the South Fork of the San Diego River with 40 sq. miles, and Sand Creek with 16 sq. miles drainage area, can be, and are, easily diverted into our system by auxilliary flumes, both of these

Our Cuyamaca Reservoir Catchment can be increased by running a ditch around the high mountain, north west of dam, for two miles; increasing the drainage area and supply 18 per cent. This has been carefully surveyed and the ditch can be extended easily three miles further, when desired, thus largely increasing the supply.

The Cuyamaca Reservoir can readily be raised to 45 feet if desired, as the foundations were laid for that elevation, but even by raising the waste weir four feet, to the 35 feet contour, it capacity would be increased 1,150,000,000 gallons. This increase will undoubtedly soon be made.

Our La Mesa Reservoir, while not intended especially as a source of supply for irregation purposes, will be a valuable adjunct to the system and add greatly to the capacity of our irregation supply, by reason of the night flow in the flume being used to fill this reservoir, and the supply for the City of San Diego being drawn from it in the day time, thus allowing all the day-time flow in the flume, to be used for irregation.
