P.S.

The Board of Trade have reported to the Privy Council that they conceived the latter shd. move his Majesty to recall Mr. Knowles immediately from Jam<sup>a</sup>. and I believe an Order will be made by the King for that purpose on the 20 Inst.

Mr. Knowles's behav<sup>r</sup> in Jam<sup>a</sup> is taken up by the House of Commons  
vide the Notes herewith sent

to-morrow afternoons

Resolved

That an humble Address be presented to his Majesty that he will be graciously pleased to give directions to the proper Officers to lay before this House (copy) Of his Majtys Comiss: appointing Charles Knowles Esq: Gov: of Jam: a copy of his Majtys Comiss: Instruc: given to the s: d: Q: along with the s: d: Comiss: Of his Majtys Addit: instruc: to the s: d: Gov: relative to any suspending Clauses to be inserted in Acts of them to be passed by him.

Of the Petet. of Jam. Seale Esq: for and on behalf of S: Dellaist Esq: presented to his Majtys informed on the 1<sup>st</sup> day of Jan: 1755 with the Order of Reference Report & his Majtys Order in Council upon the same.

Of the Minutes of the 1<sup>st</sup> Assm: of Jam: held under the s: d: Charles Knowles after his Arrival in the s: d: Government and the dissolution of the s: d: Assm: on 20<sup>th</sup> August 1751.

Of the Min: of the 2<sup>nd</sup> Assm: of Jam: called & held by the said Charles Knowles, and the dissolution of such second Assm: upon the 20<sup>th</sup> Nov: 1751.

Of the Min: of the 3<sup>rd</sup> Assm: of Jam: called & held by the said Gov: Knowles, and the dissolut: of such third Assm: upon the 20<sup>th</sup> Jan: 1755. Of the Min: of the 4<sup>th</sup> Assm: of Jam: called & held by the said Gov: Knowles, and the said Gov: prorogation of the same upon the 23<sup>rd</sup> Oct: 1755, for an hour.

Of all such representations or Narratives as the s: d: Charles Knowles hath transmitted to his Majtys, or to the Lords of his Majtys most honourable privy Council, or to the Commiss: for Trade & Plantations relating to the same Gov: proceedings ag: the s: d: S: Dellaist late Proov: Mars: of the Isl: of Jam: — Of all Orders, Warr: & Committim: of the s: d: Dellaist, and of all proceedings and Judgm: had ag: him in the s: d: Isl: of Jam: upon the 1<sup>st</sup> Oct: 1734, or at any time since.

Of the s: d: Gov: Order for altering the Return of Records from the Inferior Courts of Jam:.

Of a Bill or Act assented to by the s: d: Charles Knowles for removing the sev: laws Records Book, Pap: & Writing, belong: to the sev: Office in the said Isl: of Jam: from the town of St. Jago de la Vega to the Town of Kingston & for holding the supreme Court of Judicature in Kingston.

Ordered

That the s: d: Address be presented to his Majtys by such Members of this House as are of his Majtys most hon: Privy Council.
