In this connection, and while referring to the subject of health, it may here be profitably observed that, owing to the salutary effects and gentle daily motion of the northwest winds, without extremes of heat or cold, disease cannot live, and hay fever is altogether unknown at Coronado. As a Table Water it will be put up in pints and quarts carbonated. Still water will be put up in five-gallon carboys for families. Ten-gallon tanks will be furnished for soda fountains, thus enabling dispensers to sell absolutely pure water at the same cost as ordinary water.

The tanks are lined with pure, sheet, block tin (not copper tin-lined), and are such as are approved by the State Medical Boards, which dispensers are compelled by law to use in the States of Massachusetts and New York.

Especially constructed apparatus is used in preparing carbonic acid gas, and we guarantee its purity. We invite inspection of the process employed in carbonating the Coronado Mineral Water for these tanks. People drinking this water at soda fountains can be assured that they are receiving a beverage absolutely free from all impurities and metallic contamination.

How the Coronado Natural Mineral Water was Discovered Long Ago.

IN 1769, Father Junipero Serra, the President of the Missions about to be established in the extensive territory then known as Alta California, arrived in the Bay of San Diego, accompanied by other Franciscans and a few soldiers. Sometime after their arrival several of the soldiers had a severe illness, caused by their indulging too freely in the use of a liquor, made by the Indians, which they called "agua de fuego" or *fire-water*.
