Dean told me about your proposal for the development of Cedar Creek on the Cleveland National Forest. As I believe I have told you before, we are currently without funds for undertaking any work of this sort and it is extremely doubtful that we will receive much in the way of trout stream development funds in the years immediately following the termination of the war. Aside from the money situation, however, I am heartily in favor of any move to improve the trout fishing on the Cleveland Forest, and would be pleased to see the Fish and Game Commission working in that direction.

You may assure the Commission that the Forest Service would be glad to cooperate in every way possible, except for financing the project, to assist in the construction of check dams and any other phases of the development as well as the maintenance of good fishing in Cedar Creek.

Dear Colonel Ed:

I have your letter regarding the relocation of a low standard existing road from Barona Indian Reservation to the floor of the San Diego River at or near the diversion dam, that is, the proposal we looked over on the ground recently with Supervisor Fischer. Part of the road is across the Federal land within the Cleveland National Forest.

I understand that both the City and County of San Diego are interested; and, of course, the property owners have a legal right to a reasonable outlet for their properties above the dam. I understand that the present low standard road does not, in your view, constitute a reasonable outlet.

I have been told that the County has made a preliminary map location for a road of higher standard than the existing road; and I should certainly like to see the specifications of standard and the estimates of costs which the County has in mind as desirable.

Is it reasonable to assume that, having made their preliminary investigations, the County government would expect to prosecute the construction in the near future? If so, we would, of course, grant a right-of-way on authoritative request, with whatever stipulations might be required to protect Federal lands and interests.

If, as seems proper, the County is prepared to undertake the project of providing an outlet for its taxpayers and voters, then I will leave the way open for some participation by us in the construction costs. This suggestion is solely in the interests of friendly cooperative relations, and not because we badly need the road for our own uses. I would like to go further, but competing demands are so numerous and heavy for whatever road construction money we may get that I must restrict any participation to a limited amount.
