Dear Colonel:

I want to again call your attention to the Wood Ranch in San Pasqual Valley, containing some two hundred fifty odd acres. This land is in the very best part of the valley and every bit of it subject to cultivation and irrigation.

You, with your many irons in the fire, might just as well put another one in and get cleaned up this fall, by subdividing and selling off in small acreage which is now in demand in that vicinity. Within the last sixty days several small tracts have sold there, I am informed, from two hundred and fifty dollars to three hundred and fifty per acre.

The Wood Ranch can be bought for \$47,500.00 one-third down and the balance to run at your pleasure at six per cent interest payable semi annually.

You can place the whole tract in the trust company after subdividing and sell the same out, and as each individual tract is sold Mrs. Wood can make releases of the same.

Of course I can teach you nothing in this game or tell you anything that you do not already know, but I am merely calling your attention to this good opportunity.

By doing this you could obtain all the riparian rights and make arrangements with the purchasers of the individual tracts so that when you finally desire to build the Pamo Dam you will have no trouble in that section.

This is a plan which Mrs. Wood is going to carry out for herself in the event that she cannot find a purchaser for the whole of it.

Please let me hear from you as to whether or not you are interested.
