Gentlemen:

Your letter of December 26th, received and I am enclosing herewith a schedule of our water rates at this time. These rates went into effect April 1st, 1922.

In regard to the charges for services, we do not make any charge for installing services but we do have each new consumer sign an application to agree to use the water and pay the minimum rate per month for at least one year from the date of installation. When the application is signed, we make the tap and run the service to the curb and install meter and meter box.

Each service installed by us is charged to our capital account and we are entitled to receive a revenue from the time of the installation.

Dear Sir:-

Replying to your letter of recent date relative to water rights belonging to a piece of land located at Lakeside, San Diego County, California:

Reg to say that you do not state just what parcel of land you have in mind, the former owner or the acreage. Having this information would facilitate us in giving you the exact facts relative to the water. However, from April 1st, 1917 rates were authorized by the State Railroad Commission, which went into effect at that time and are at the present time in force. It is set out on page three of our book of Rates and Rules as follows:

For irrigation water the first 1000 cu. ft would be at 25 ¢ per hundred cubic feet, or \$2.50. For the next 1000 feet the rate would be 15 ¢ per hundred cubic feet, or \$1.50. This would make the first 2000 cu. ft. cost \$4.00, and all over this amount would be at rate of 2½ ¢ per hundred cubic feet, where the water is taken from our main flume or pipe line.

If the property is known as "Lakeside Farms" I believe they have their own pumping plant and in that event we would have nothing whatever to do with the water as they get their supply from the San Diego River and deal directly with their patrons.

My dear Colonel:

The Forward Club of Lemon Grove is engaged in a civic enterprise in which we desire your interest and cooperation. As you were a former resident of this place, and your company having been closely associated with our community for a number of years, we feel privileged to address you.

The Forward Club, as you perhaps know, is the Woman's Club at Lemon Grove. It is federated with the County and State organizations, and is also incorporated under the laws of California. We own our club house, upon which there is a mortgage indebtedness of \$3500.00. The building cost approximately \$8500.00, and with grounds and equipment, constitutes an asset of about \$10,000.00. This Club House was erected about four and one-half years ago, and was made possible through contributions of citizens of the community, who nearly all gave generously in accordance with their means. While technically the title is in our club, we regard it as a community club house and use it as such. It is the only auditorium in the place, and is a valuable community asset.

Since the erection of the building our club has paid \$500.00 or more of original indebtedness, not included in the mortgage, and has kept up the interest at 7% on the \$3500.00 mortgage note. Interest, taxes, insurance, federation dues and general current expenses have taxed the financial capacity of our small organization of some seventy women. Our only income is that received from membership dues, entertainments and occasional rentals.

The immediate problem confronting us is this: The \$3500.00 mortgage note is past due, though tentatively extended pending our consideration of ways and means. Notwithstanding this situation, it is not possible to raise more than \$500.00 at Lemon Grove at this time. We are therefore appealing to you, knowing your generosity to Grossmont Union High School District, and in other instances, but more particularly because of the close business relations

of your company with this community for a number of years. We recall that we have met all our obligations, and in addition gave you our support and cooperation throughout the proceedings pertaining to the water situation, and now, when the water question seems to be nearing a final solution, we are giving you this opportunity to reciprocate.

In closing, may we hope to enlist your favorable consideration of the matter herein presented?
