IMPLEMENTATION PLAN IMMIGRATION REFORM AND CONTROL ACT

CAVEAT


Information in this hand-out represents a preliminary plan of the Immigration and Naturalization Service (INS) for implementing major provisions of immigration reform legislation now under consideration in the 98th Congress.

The INS plan will continue to evolve, and these planning materials will continue to undergo changes/ revisions accordingly, consistent with the provisions of enacted law and the agency's defined role and responsibilities for implementation.

PURPOSES

TITLE I

Control of Illegal Immigration
Penalize employers who hire Illegal
aliens



Coordinated,
Comprehensive Program
to Regain Control of
U.S. Borders

Results

- Is a disincentive for employers to hire illegal aliens
- Encourages illegal aliens to return home
- Gives aliens less incentive to cross
 U.S. borders illegally

TITLE III

Legalization

Legalize residence of illegal allens who have been in U.S. for considerable time and are productive members of society

Results

- Brings these aliens into mainstream of U.S. life
- Gives them protection of U.S. law

GENERAL PROVISIONS

Legalization

- Assigns responsibility to Attorney General
- Sets up eligibility requirements
- Grants permanent or temporary resident status to certain classes of illegal aliens
- Provides for adjustment from temporary to permanent resident status after three years
- Establishes 18-month application period
- Prohibits public assistance for three years
- Includes VOLAGS in screening applications

GENERAL PROVISIONS

Employer Sanctions

- Makes it illegal knowingly to hire, recruit, or refer for employment an illegal alien
- Requires employers to attest they have verified eligibility -- an INS controlled record system
- Requires employer to retain form for 5 years or until 1 year after employee's termination
- Requires President to establish a secure system of employee identification within 3 years
- Sets up penalties and remedies: civil, criminal and injunctive (notification: first six months; warning: second six months)

GENERAL PROVISIONS

Other Provisions

- Establishes U.S. Immigration Board to hear appeals
- Limits or eliminates other Judicial review
- Tightens asylum requirements and procedures
- Revises immigrant admissions system

ASSUMPTION: 2.3 MILLION WILL APPLY

6 million illegal aliens are now in U.S.

1.6 million will apply for temporary residence730,000 will apply for permanent residence

OTHER ASSUMPTIONS

• Impact of legalization on INS structure and workload should be minin

INS will act as decision-maker and monitor

Applicants should bear most of the expenses of the program

Each applicant will be charged a filing fee

Initial processing should be assigned to qualified voluntary agencies

VOLAGS will handle majority of screening functions

The application and review process should be well managed

Central Processing Facility will be efficient and automated


LOCATION/STAFFING





APPEALS PROCESS

- All denials will be reviewed by supervisory Examiner
- Aliens given specified period within which to appeal
- Appeals decided by Senior Immigration Examiner and signed by supervisory Appeals Officer
- Appeals are independent of initial decision-making process
- Notice of denied appeal sent to alien and case referred to INS District Office for appropriate enforcement action


