#### 1. We want unity and true Chicano representation which will come from La Raza Unida Party and not from traditional political parties like the Democratic and Republican Parties, that only relate to the community during election time. a. There are approximately 3 million Chicanos in the L. A.

area and yet we have no representation in the city or county

and only 2 in the state government.

b. We must create a Political Party that will adress itself to the needs of the community and not necessarily simply to the partisan needs. We must elect individuals that were born and live in the barrios and who sacrifice and suffer in the barrios.

2. An end to the use and abuse of the Chicano vote by the Democratic and Republican parties.

a. 1951 - the Republican party gerrymandered the barrios. b. 1961 - the Democratic party repeated this partitioning of our barrios.

c. The Democrats have never nominated a candidate that it did not already control at the expense of our community.

3. Adequate housing for our people; (an end to urban renewal which usually means removal of our people from their homes and the destruction of our barrios.

a. The Monterey Hills Redevelopment Project, that is being pushed by the Democrats, will destroy thousands of homes in Lincoln Heights.

b. The new Pasadena Freeway will destroy much of El Sereno as it goes through Huntington Drive.

4. An end to racist police and police brutality.
a. Ruben Salazar was "tragically" killed by Sheriff's Depu-

b. The Sanchez cousins were brutally murdered in their own homes.

5. An end to consumer fraud.

a. Merchants sell lower quality merchandize at higher

6. Drugs are endangering the lives of our youth. The drug makers and rich pushers should also be arrested, and not only our barrio youth.

a. The drug corporations are profiting from dope pushing in the barrios. Stop the source and you need not worry

about the children.

7. The community shall control the schools through community committees.

a. Bilingual and bi-cultural programs.

b. More competent teachers and administrators.c. An end totthe "drop-out" problem (50% in ELA).

8. End racist employment practices. There is a 25% unemployment rate for our people in L.A. Our people receive the lowest wages and have the most hazardous jobs.

9. Non-Chicanos - All people that live within the 48th district regardless of race, color or creed will benefit from the Partido because the party addresses itself to the problems of the Chicanos, who are at the bottom of the social scale, all other peoples will necessarily benefit.

I do not pretend to think that all of these problems will be eradicated by my election to the Assembly, but certainly through this office and through the united front of our people through the Partido de La Raza Unida we will be better able to voice our grievances, to wield power and to influence
