Dear Senator:-

I was much interested in reading the copy of your letter to Manager Flack. The contents were carefully noted.

I am not so sure that the people will vote for the exercise of the Hodges option. That remains to be seen. Neither am I in accord with the idea that it is necessary to exercise this option in order to be in a position to complete the Sutherland Dam. It is a very debatable question.

Regarding the construction of a dam at Mission Gorge, Mr. Savage and present engineers are all wet as to the cost of the dam at this site. Trusting to my memory, it appears that you have "upped" your estimates, also. Somewhere in my attic I have a blue print of what is known as a radial cone dam, designed by the late Mr. John S. Eastwood. Mr. Eastwood drew these plans to fit Mission Gorge No. 3 site. As near as I remember, he put the cost figures around \$750,000. Of course, the type of a dam and the height govern the cost. It would be impracticable and unwise to figure a dam for Mission Gorge #3 to a height that would exceed level flowing materially beyond the Old Padres Dam.

If Sutherland and San Vicente are not initiated at once, then Gorge No. 3 should be put to the top of the list to take care of the overflow from El Capitan which is bound to come next year.

We are getting a good organization together here and we do not intend to let Super Hodges or Mission Gorge #2 go through. One great trouble around San Diego has been that personalities have always entered into these water fights. I will say this for you that, even though you were on anything but good terms with the Henshaw people at the time of the Hodges purchase, nevertheless you did get out to recommend and work for its purchase.

We will never get anywhere here until we get rid of this man Pyle. This is what I am writing you this letter for, principally, to start the underground work. Get in touch with Engineer Lars Jorgensen, Berkeley, California, and find if he is in a position to accept the job in San Diego. I have been told that he would accept. It would not do for me to recommend Jorgensen any more than for you to recommend the purchase of Gorge No. 3 site. You, no doubt, have much influence with the City Manager or with people who gave him his job.

My dear Don:

Thanks kindly for yours of the 20th. I think it would be a grave mistake if they did not vote to take up the Hodges proposition.

I have the cost of building Mission Gorge #5 to the 340 ft. contour for the reason that I believe our friend Hyatt will want a single arch type. I have written to Jorgensen for a new plan with an estimate of cost. It would not cost over \$750,000 to a million to build a dam that would not exceed the level of the old Padre Dam, but to carry it up to the 530 or 340 ft. contour, is another matter and will be more expensive. I am glad to know that you are interested in Mission Gorge #5 more than I can say.

After I am dead I hope you will put it over and name it for me for it is the most controversial project of all, and Lord knows I have made enough controversy in the last twenty-five years on water matters. I played the game with the Henshaw people, even in spite of Trainor's jealously and unfair dealing, but he is dead now and I have nothing further to say on that score.

Iou will hear from me further. I am writing to Jorgensen, and am absolutely in sympathy with your point of view in that matter, but neither you nor I could ever get anywhere. I will be home in six or eight weeks, I hope.

My dear Don.

Thanks for yours of the 28th. I am going to keep quiet regarding the Hodges' proposition, but I think it ought to be carried and refinanced. The first dam to be built should be Sutherland, then Pomo - that is an ideal site with an elevation of 900 to 1000 ft. and will flow by gravity from Linda Vista wesa into the City. That same pipe line from Pomo Pam will go the length of San Pasqual Valley across Linda Vista Wesa into the City. This will enable the City to pump 10 or 12 million gallons a day during a six or eight months period into that same pipe line from our City owned water bearing gravels.

My advice would be just to build the pipe line from the City to the Pomo lam site, put in a little diverting dam and divert all the water in the winter that may be flowing there, and not build the dam until later. You can get three or four million gallons a day from Pomo by gravity from the stream flow, and there is always some water there. In other words, that 12 million dollar pipe line with the pumping out of San Pasqual, will give you a net safe yield of ten million gallons a day, plus the normal flow, and you can divert the water by gravity from Pomo to Otay if the storage is there.

I am sorry you are going to oppose the Hodges' Bond issue. I feel that we have a champagne appetitie and a beer pocket book. Complete Sutherland first, take it over to San Vicente or #5; second, B wild the pipeline to Pomo later on; third, Build Pomo; fourth, Raise Hodges Dam sufficient to practically control the river. I do not think that will be over 20 or 50 ft. higher at the most.
