O P I N I O N

A public hearing was conducted by Myron Westover, Examiner, at San Diego, March 1, 1917, on above application to issue note for \$5000 at 7% to San Diego Consolidated Gas & Electric Company to be dated February 1, 1917, and payable six months after its date, in renewal of a 30 day note for \$5000 in favor of the same payee, dated December 26, 1916.

At the time the latter note was issued applicant was indebted to the payee on a note dated December 21, 1915, for \$5493.23 given for electric energy previously purchased for operating applicant's pumps. On December 26, 1916, applicant paid on said note the sum of \$493.23 and issued the note for \$5000 to cover the balance.

O R D E R

JAMES A. MURRAY and ED FLETCHER,

co-partners, doing business under the name of Cuyamaca Water Company, having applied to the Railroad Commission for authority to issue the note hereinafter described, and a public hearing having been held thereon,

IT IS HEREBY ORDERED by the Railroad Commission of the State of California that said James A. Murray and Ed Fletcher, co-partners doing business under the name of Cuyamaca Water Company be and they are hereby authorized and empowered to issue to San Diego Consolidated Gas & Electric Company a promissory note in the sum of \$5000 to be dated February 1, 1917, payable 6 months after date with interest at a rate not exceeding 7% per annum, payable semi-annually, and also to issue renewals of said note provided the combined terms of all the renewals thereof do not exceed the total period of two years. The proceeds of said note or any renewal or extension thereof are to be used only for the purpose of refunding the note for \$5000 payable to San Diego Consolidated Gas & Electric

Company and dated December 26, 1916.

The authority herein granted is upon the following conditions:

1. Within 10 days after issuing or reissuing said note, applicant shall make ~~verified~~ report in writing to the Railroad Commission stating the fact and date of issue thereof and the disposition of the proceeds as required by General Order No. 24, which order in so far as applicable is made part hereof.

2. The authority herein granted to issue said note to be dated February 1, 1917, shall apply only to such note as may be issued on or before 30 days from the date hereof.

3. This order shall not become effective until applicants have paid the fee specified in Section 57 of the Public Utilities Act.
