JOHN C. VEYSEY IS A PROPAGANDIST FOR THE ABSENTEE LANDOWNERS

In the March 27, 1986 issue of the local newspapers is a Voice letter by John C. Veysey, who is listed as Vice-President of the 45th Agricultural District of the State of California.

In paragraphs one, two and nine, he raves about the 4-H and FFA especially as to the livestock being so wonderful. So you should know the history of the Veysey family to not believe the hogwash that Veysey gives out. VictorVeysey, his father married a rich woman who gave the family the 800 acres it has. The father of John Benson whom I attack also for being a propagandist, built up his ranch from nothing.

Now the absentee landowners who own ninety percent (90%) of the farmland as tax shelters, DO NOT WANT THE LITTLE PEOPLE OF IMPERIAL COUNTY TO GET THE EAST MESA LAND FOR FARMING. THE LITTLE PEOPLE COULD GET THIS LAND FOR \$320 FOR 160 ACRES.
