My dear Mr. Hughes:

I have read with much interest the letters of Mr. Potter, and your reply.

I did not know the Southern National Highway Association existed. For several years we tried to hold an annual meeting and failed, however, the more highway associations the better, for it all means publicity for the good of the cause.

I do not know to what Col. Potter refers when he talks about a pledge. Certainly any pledge that may have been made by Mr. Fred Jackson, or the Chamber of Commerce, or anyone is not binding when the Southern National Highway Association has failed to function for the last five years.

Unfortunately until very recently, Phoenix has not cooperated much with San Diego in the early construction of a road to Yuma. Colonel Potter is probably unaware of the fact that the road from Phoenix to Yuma has just been made a primary road, and thru the initiative of San Diego in assisting Yuma County to sell the bonds, the road is now financed jointly with federal aid and county money to build the road from Yuma to the Maricopa line, and will be completed within 18 months from date.

I do not know what more we could have done to help out the Southern National Highway Association than this, if the Southern National Highway Association was still in existence. When \$50,000 of all the funds of Yuma County have been allocated to build a dirt road to Ajo, and it is at the request and demand of the Yuma County voters themselves, who voted the bonds for that purpose, they have a perfect right to desire a connection with Ajo, and Ajo has a perfect right to desire a connection with Tucson, and it is unfortunate, perhaps,
