NISSAN ISLAND

1. I visited NISSAN per M.V. 'NIVANI' on the 11th and 13th October 1970 on route the FEAD Islands. I have the following remarks on the present situation.

2. POLITICAL

The subject of a local government council is in abeyance and there is little discussion on the matter. I did not raise it. This is as planned, following on from our visits in May and June of this year.

5. DONATUS MOLA visited the island during the week commencing 5th October, 1970. He spoke generally about his journey to Asia and Africa and about debates in the House of Assembly. The people brought the following matters to his notice:

- (a) the difficulty in shipping copra;
- (b) funds for up-grading the road from TUNGOL to YOTCHIBOL;
- (c) construction of a shelter at the airport.

4. There does not seem to be much interest in NAVITU NAPIDAKOE or the Bougainville referendum, neither is there much interest in P.N.G. unity. The NISSAN people are an isolated, island community, and will remain so for the foreseeable future.

5. ECONOMY

The NINSA II was taken over by the agents, TONGS Rabaul, on the 10th August, 1970. Since then the vessel has not picked up copra from anu co-operative society in this sub-district let alone NISSAN. It concentrates on expatriate plantations. There is a new captain on board, Capt. L. Atkinson is now working for Mr J.Thurston, RABAUL.

6. There were about 800 bags of copra waiting at NISSAN at the time of my visit. Fortunately, the M.V. 'MUKUMANU' called a few days later and uplifted all of it. It also brought supplies for the mission and native trade stores.

7. So our plans for a regular 6 weekly pick-up seem to have been sabotaged. For the present, we will have to wait until there is a build up of say 800/1000 bags, whereupon the mission at TUNGOL, or Sub District Headquarters HUTJENA, or Co-operatives KAMERAU can radio various coastal ships on the Bougainville run. In effect, this is the system that has operated most of the time in the past.

8. H.KEMITO, in his letter to you, your 1-3-13 of 20th October, 1970 is suggesting a Development Bank or government loan for a large initial order of trade goods to stock a bulk store at NISSAN. The goods would then be re-sold to smaller

stores, the loan paid back and a fresh order made with the profit. The idea, of course, being to have forward cargo from RABAUL to entice shipping.

9. This looks too pat to be practical! The average cargo shipment to the two co-operative stores each six weeks from BUKA is 20 tons. Include the Mission and the private stores and there could be a demand for 50 tons. The mission, of course, ships on its own vessels. Further, a bulk store project as suggested is exactly what C.W.S.L. is in the business for.

10. I have passed Kemito's suggestion on th Co-operatives for an analysis. When I receive his reply, we can make a decision whether to approach the Development Bank. Experience on Buka has been that the Bank is only interested in stocking stores to a small extent, maximum of \$600. In the meantime, I suggest you write to Komito and say his suggestion is under consideration, also that we shall endeavour to divert a ship whenever there is a full load at the island.

11. Whilst at Nissan, I noticed many new coconut plantations in the MABIRI/TANAMALIT area, all with new stone fences around them to keep out the pigs. Cur exhortation to plant up new areas, then, did not fall completely on deaf ears.

After an inspection in August, the airport inspector requested that the following work be done:

- (a) clear fly-over areas, measuring 50' back from the markers on each side;
- (b) clear splayed approaches;(c) clear windsock areas.

This work has to be done every year and normally en-tails sending an officer to the island for about a month. The work will cost \$200 which should be made available on a cash fund certificate for payment of labour. A P.W.D. team re-constructed the airport waiting romm during this trip of the 'NTVANT'.

13. WHARF YOTCHIBOL AREA

I have not as yet been able to send an officer to survey the YOTCHIBOL side of the lagoon and as ist the people in building a second wharf. With the BUKA Council elections, for which three teams will be required commencing on the 16th November, this will probably have to wait until the New Year.

14. HEALTH.

The medical officer at SOHANO requested that 'NIVANI' bring some 60 suspected T.B. patients with families, to SOHANO hospital for X-Ray. I demurred for the following reasons:

- (a) The people do not wish to come;
- (b) if brought to SOMANO, they would be X-Rayed, after which they would all gradually find their way to HAHELA catholic mission who would have to feed them until such time as a ship returned them to the island. This has happened several times in the past; The Medical Officer at SOHANO is leaving on transfer (c)
- this week.

15. This idea of moving large numbers of people long distances is impractical and inconvenient. I recommend, instead that the RABAUL mobile T.B. unit visit NISSAN by trawler and carry out a thorough survey, and I request that you take this up with the District Medical Officer, please.



PATROL REPORT NO.2 1970/71 HUTJENA M.BOS ASSISTANT PATROL OFFICER.

The Patrol was of 12 days duration and Mr Bos was accompanied by A.Vinoko (Local Government Assistant).

Copy of Patrol Instructions does not accompany Report although it is assumed they were the same as issued to Mr Kelliher - Report No.4 70/71 Hutjena.

Whilst no actual pre-election patrol was carried out, coverage by Circulars and Radio Bougainville seems adequate in this fairly sophisticated area.

The elections themselves seem to have been carried out effectively though a talk by the old councillor immediately before the poll and after the returning Officer's talk might be classed as favouring one candidate though I assume the talk was procedural rather than canvassing.

With a voting attendance of 50% total and with a 60% female vote it appears the women have quite a voice.

The observation of poor polling on Fridays and Saturdays due to the proximity of the market is a good one and should be remembered next election.


I am not in favour of using Council transport to bring voters to the polling places as this could involve a good deal of money should such a precedent be set. It is after all a responsibility and a right to vote but to bring the voters to the polling point is I feel taking things a little far.

The comment on Pidgin on the Ballot papers is a good one.

The report is a good informative one where interest has been shown by Mr Bos in the elections. A situation report as per the Departmental Head's 67-1-0 of 21st June, 1968 on Patrol Reports would have further improved the report.

Perhaps camping at night in villages in lieu of returning to Hutjena and Hanahan Base Camp could have improved contact there may be reasons precluding this of which I am unaware.

BUTA LOCAL GOVERNMENT COUNCIL -ELECTIONS

The following narrative and statistical report covers the 1970 General Elections for the Buka Local Government Council.This Report covers the East Coast and Solus Areas. The team conducting the polling consisted of A.Vinoko Local Government Assistant and M.Bos Assistant Patrol Officer.

Type and Duration of Pre-election Campaign. (1)

Since the institution of the Council in 1961 and following the first Elections, five General Elections have been carried out. There is no ward that has not participated in at least three General Elections. This combined with the House of Assembly Elections has bought the people to a stage where it is considered they are well versed in electoral matters. No specific election campaign was carried out. A general

circular setting out the three teams itinerary was distributed throughout the Council area around the 4th. of November. Wide coverage was given by broadcasts through "Radio Bougainville" of the itineraries over a period of three weeks before the Electons. Individual wards were again announced on the

verbal notification of impending Elections was of course given at every opportunity.

Although some nominations were received beforehand most were taken at the start of proceedings.

Manner of Elections. (2)

In order to give the people of the Council area every opportunity to present themselves for voting on the appropriate day 28 polling booths were allocated to the East Coast and Solus

day 20 polling booths were allocated to the hast constrained contained areas. Three teams conducted the polling. Team One consisted of M.Bos and A.Vinoko and patrolled the East Coast and Solus area. Team Two consisted of J.Tierney and F.Kakinoru (1st week) and T.Callagher and F.Kakinoru (2nd week) and patrolled the West Coast Buka and Selau area. Team Three consisted of D.Showell and S.Tousala and worked in the Hahon and Kunua areas. The Elections commenced on the 16th November 1070 and concluded onthe 27th November .All wards were completed within the prescribed time. Approximately 90% of voters , predominantly in the over 30 age bracket, required assistance in marking their ballot paper. Rate of Infomal voting was low and resulted almost exclusively from those who marked their own ballot papers. Polling was conducted in an open part of the village with Mr Vinoko and myself alternating the tasks of calling the electoral roll and assisting with the marking of ballot papers. Procedure alopted at each polling place was as follows (a) Address by returning officer (b) Talk given by old Councillor (c) Polling

The Whisper Ballot was each yed where waters were incapable or unprepared to mark their own ballot paper. Candid tes did not elect to appoint scrutineers, tevertheless many took a keen interest in the counting which was done immediately after polling finished. ceen interest

Most Wards were decided by the first count. A total of 7 were decided in the first count,2 by the second count,1 by the third and one closely contested election at Gogohei carried on to the fifth count.

Feminine Interest in the Elections. (3)

No female candidates stood for Election although female interest was almost as great as that of the men. Women had no hesitation in coming up and many ware decided in

their choice. It was encouraging to see many young educated girls marking their own ballot papers. Approximately 60% of possible women voters attended the Elections.

During the Elections only one incident occurred. The voters of Karoola and Diwau Plantations wanted to align themselves to the Hitou/Pororan Ward rather than vote with the Hananan Ward. The Hitou and Pororan people also wanted the change. Whilst doing the Elections we canvassed the Karoola and Diwau voters and found an overwhelming majority in favour of the motion. This will necessitate an altering of the Council's Constitution. It is anticipated that this ratification will take place within a four months.

(5) Absenteeism and Analysis of Statistics.

The second states of the

The sumtotal of people on our Electoral Roll was 2536. A total of 508 wre unavoidably absent of those unavoidably absent, most were within the District and absent on a short term basis.C.R.A., Schools and Missions removed quite a few young men from the Electoral Roll.

No refusals to vote were noted. 3% of ballot papers were informal. An average of 4 candidates stood for each ward. 7 new councillors were elected. 9 councillors were re-elected. Attendance was approximately 50%.

(6) Summary of Elections.

Generally speaking the Elections can be classified a success. Interest varied from intense in some wards to apparent apathy in others.

In many electorates there were landslide victories. This seems to indicate some villages hold meetings before the Elections start, select a candidate and then all vote for him.

It was found Friday and Saturday were bad lays for polling. Both are Market days and ascanth absenteeism hotably increased eventhough prior notification of Elections was received. It is falt councillors should be made more aware of their

It is felt councillors should be made more aware of their responsibilities at Election time. On a few occasions councillors, eventhough told Elections were to be held the following day , made no effort to "bung" the people and they themselves were nowhere to be seen.

In the East Coast and Solus areas the coucil possesses 2 tractors. It is felt more vigorous use could be made of these at Election time, especially in bringing villages to polling booths. There were some

Explanation of the Preferential System of Voting is difficult in English, even more so in Pidgin. Some Visual Aids or Pre-Typed Examples on "How TO" and "How Not To Vote" might aleviate this problem to some degree.

More and more people are learning to read Pidgin. It is felt ballot papers with instructions in both Pidgin and English will reduce the high degree of assistance required in marking ballot papers and aid in understanding the mechanics of the Preferential System.



GENERAL ELECTIONS 1970 BUKA LOCAL GOVERNMENT COUNCIL.

HUTJENA PATROL No. 3 - 1970/71

Attached please find electoral forms 9, 10 & 11 covering the Buka Local Government Council elections conducted over a period of two weeks between 16th November and 27th November, 1970.

The Writ was returned to the Regional Local Government Officer, Rabaul, under cover of my memorandum 42-1-2 of 3rd Pecember, 1970.

The first meeting of the Council after the elections was held on 11th December, 1970. Oaths in accordance with section 24(6) of the Orainance were taken at this meeting.

(1) <u>Type and Duration of Election Camapign</u>

No formal pre-election camapign was conducted as the staff situation did not permit full patrol coverage of the council area. All electors had had previous experience with council elections, and, with additional experience gained at House of Assembly elections, were well versed in electoral procedure.

The elections were well publicised by circular two months prior to commencement and polling dates were also made known at this time. Extensive publicity was given over Radio Bougainville during the fortnight prior to commencement and polling dates, times and places were broadcast each evening during the election period.

(ii) <u>Manner of Elections</u>

Polling was conducted by three teams during a period of two weeks. Team i conducted polling in the north and east coast **Buke areas** and the Solus area; team 2 in the west coast Buka and Selau areas; and team 3 in the Kunua, Hahon area.

60 polling places were used. Initially it was expected the polling would be conducted at 64 polling places, but as voters elected to vote at nearby places instead, 4 polling places were not used.

The degree of assistance given to voters varied from area to area from about 99% to 40%, The overall average assistance given was approximately 87%. I feel sure that about 60% of voters would be capable of voting unassisted, but many ask for assistance because they are unsure of themselves.

No scruitinoers were nominated by candidates. However polling and counting of votes was conducted in the open where the assembled electors were able to view procedures.

Frior to commencement of polling at each polling place a short talk on the local government system, the duties of councillors and electoral procedure was given by polling officials.

34 councillors were elected to the 33 wards. In 9 wards the election was not contested and 9 councillors were elected unopposed.

(111)Feminine Interest in the Elections

No female candidates stood for election although special mention was made of their eligibility during the pre-election campaign and they were encouraged to participate. The interest shown by women in voting was equal to the interest shown by the male voters.

2.

(1v) Incidents

The voters of Karoola and Diwau plantations - approximat-ely 30 - expressed their dissatisfaction of being included in ward 5 by refusing to vote. Prior to the elections their desire to be removed from Ward 5 and included in Ward 19 was made known, but there was insufficient time to effect a change of the Constitution.

The electors of Ward 19 - Pororan and Hitau Islands -showed apathy towards the elections as they too wanted Karoola and Diwau included in their Ward so that they would be able to nominate and vote in Mr. J.K. George, Manager of Karoola Plant-ation. (Mr. George was previously a member of the Council and his re-election in 1968 was disallowed because of voting irreg-ularities.) To show their displeasure at being unable to vote for Mr. George only one nomination was received and the previous councillor was re-elected uncpposed.

Geographically Karoola and Diwau are better situated for inclusion in Ward 19. Ward 5 extends from HANAHAN on the east coast of Buka through to the west coast where the two Plantations are situated. There is little communication between Hahahan and the plantations whereas there is a good deal between the latter and Pororan/Hitau.

The people of Pororan, Hitau, Karoola and Diwau were can-vassed during the election and are unanimous that Karoola/Diwau should be included in Ward 19. The people of Hanahan were also canvassed and have no objections to the removal of the two plantations from Ward 5.

Proposals for a constitutional change to enable this transfer will be submitted in the near future.

There were no other incidents.

(v) Absenteeism

66% of electors available to vote did vote leaving 34% who absented themselves when, perhaps with a little effort in some cases, they could have presented themselves to vote.

Lowest attendances at polling were obtained on Fridays and Saturdays when many people go to Buka Passage to the market and stores. Polling in the near micinity of Buka Passage should not be scheduled on a Saturday if it can be avoided in the future.

(vi) Analysis of Statistics

Of the 7414 voters enrolled 1089 were unavoidably absent and a further 2519 did not vote because condidates were elected unopposed in their wards. This leaves a total of 3906 who could have voted in contested Wards, of whom 2561 did in fact vote. Thus 66% of voters who were available to rote attended the polls.

3.9% of the votes cast were informal.

Approximately 50% of voters ballot papers did not in-dicate all preference and would have been classified informal without our modified system of preferential voting.

Allocation of preferences did not effect the election of candidates and the results would remain unchanged if the first past the post system had been used.

21 of the 34 councillors were re-elected to office. 1 of the 13 new councillors has held office in the past.

The fact that the seats in 9 wards were not contested indicates a certain amount of apathy on the part of voters, but in most cases pre-selection of candidates was the reason for lack of nominations. In only two of these 9 Wards was definite disinterest shown and the reason for disinterest in Ward 19 has already been explained.

(vii) <u>Summary</u>

0

The elections were successful and incident free. Interest shown was a little better than at the 1968 elections - 66% of available electors voting as against 64% in 1968.

Mr. Donatus Mola, M.H.A., did not stand for re-election in his ward because of pressure of commitments. However, I feel sure that he will continue to actively support the council and take a lively interest in its affairs as he has done in the past as a councillor.

Three non-indigenous candidates stood for election. Two of these - Messrs J.C. Lee, and W. Cheungy both of whom previously held office, were re-elected. The only other nonindigenous member of the last council, Mr. Wong You, did not stand for re-election. The seat vacated by Mr. Wong You was contested unsuccessfully by Mr. Justin Hang Szeto and won by Mr. Bealik Sawa, an employee of the Posts & Telegraphs Department at Buka Passage Post Office.

Mr. Sawa sought approval from the Public Service Board to contest the Council elections, but approval was not received prior to commencement of polling. A further approach was made to the Board on 3rd December, after Mr. Sawa's electior, but a reply has still not been received.

Pre-selection palloting was evident in a number of Wards, but in most cases where there was pre-selection, the election was not contested.

Elected Office Bearers

Mr. Paul Holi (Ringin) of Hangan Village was elected President of the Council on 11th December. He has not previously been a member of the Council. The presidency was hotly contested by two ex-Presidents - Messrs James Billy and Anton Keare - and Mr Holi, the latter narrowly winning.

Mr. J.C. Lee of Madehas Plantation was re-elected vice-President unopposed.

Details of new members elected to the Council are shown in appendix 'A'. Also attached are copies of the polling schedule and instructions to polling officials.

Some nominations have been received and it is probable that others will be received prior to the three teams' departure to the field. These will be given to Presiding Officer prior to 16th November.

- 5. Nominations may be received up to one hour prior to the comm-encement of polling for each Ward Regulation 31(c)(ii). REMEMBER that polling for a particular ward commences when the poll is opened at the <u>first polling place</u> for that ward. It is essential therefore that all intending candidates nominate at the <u>first polling place</u> where more than one polling place is to be set up for a particular ward; e.g. ward 14 where polling will be conducted at IETA and at KUBU and all nominations must be accepted before polling commences at IETA.
- 6. To ensure that all candidates are aware of the above, word should be sent out a day in advance advising all intending candidates for a particular ward that they should be present at the first polling place for that ward prior to the time nominated for commen a sait of polling.

7. ELEGIBILITY FOR CANDIDATURE

To be eligible to nominate for election an intending candidate must:

- (a) be resident in the ward for which he intends standing;
- (b) be eighteen years old or more,
- (e) accept nomination

- 8. A person is not eligible to nominate if:
 - (a) he is an officer or employee of the Council
 - (b) he is an undischarged bankrupt or insolvent, or
 - (c) he is undergoing imprisonment after having been convicted of an offence punishable by death or imprisonment for one year or longer.

- 9. Any person employed in the Public Service must have the approval of the Public Service Board to stand for election.
- 10. ACCEPTANCE OF NOMINATION

A candidate must <u>accept</u> nomination for the nomination to be valid - Regulation 31(3). <u>Ensure that each person nominated</u> <u>consents to become a candidate</u>.

11. WITHDRAWL OF NOMINATION

A candidate may withdraw his nomination <u>prior</u> to the close of nominations - Regulation 32.

12. INSTRUCTIONS TO VOTERS

A short talk should be given by the Presiding Officer prior to the close of nominations. The points to be brought out are:

- (a) A brief general talk on the local government system as part of the democratic process;
- (b) A reminder that a Councillor's job is a responsible one and that the voters are the only ones that can determine good representation by ensuring a good man is elected to the position for the ensuing two years;
- (c) Mention the responsibilities of a Councillor. He is a representative of the people and should maintain liaision between the people and the council and vice versa;
- (d) a brief run-through of voting procedure.
- 13. Ensure that nominations are finalised and close nominations.
- 14. Collect badges from the current Councillor. These will be presented to winning candidates at a Council General meeting scheduled for 11th December.

PREPARATION OF BALLOT PAPERS

15. The order in which candidates names will appear on the ballot papers is determined by draw - Regulation 35.

CONDUCT OF POLL

- 16. Refer to Regulations 38 to 45.
- 17. At the first polling place for each ward the empty ballot box must be displayed - Regulation 42(2).
- 18. Note Regulation 42(5) which requires that a tick be placed against a voter's name after he has been handed a ballot paper. It will also be necessary to mark on the roll those unavoidably absent as this information is required on Form 10 - Voting Statistics.
- 19. Ballot papers must be initialled on the reverse side by the Presiding Officer Regulation 42(3) . before handing to the voters.

20. THE COUNT

Refer to Regulations 46 to 57.

- 21. The winning candidate is the first candidate to receive an absolute majority of votes. An <u>ABSOLUTE MAJORITY means a</u> greater number than one half of live votes, i.e. ballot papers which are <u>not</u> informal or excluded at the second or subsequent counts.
- 22. The winning candidate is declared by the Presiding Officer.
- 23. Voting statistics are required as per Forms 10 and 11. These should be compiled as the election proceeds ward by. ward.
- 24. If it should arise that two or more candidates have an equal number of votes at any stage during the count and one has to be excluded or <u>elected</u> the Presiding Officer shall decide, by drawing lots, which one is to be excluded or elected - Regulation 56.

REPORT ON ELECTIONS

25. Each Presiding Officer will be required to submit a report on the conduct of the elections. This will comprise Statistical Returns in accordance with electoral forms 10 and 11 and a narrative report in accordance with Local Government circular No. 16 of 1970 at pages 7 and 8. Copies of this circular have previously been distributed to all staff.

GENERAL

- 26. Each officer is to ensure that he is conversant with the composition of wards. A list of ward numbers and localities is appended for easy reference.
- 27. In all wards, except for ward 1, LONOHAN, one councillor cnly will be elected. Two councillors will be elected for ward 1 - see Regulation 57 for procedure.
- 28. The attached polling schedule is to be strictly adhered to and may be varied only if it becomes impractical to adhere to it - Regulation 37.
- 29. A briefing session will be held for all officers participative in the elections on a date to be fixed dependant upon Mr. Showell's return from Port Moresby.
- 30. Remind all winning candidates that the first Council meeting after the elections will be held on Friday 11th December.







BUKA COUNCIL ELECTIONS - 1970.

- Attached are copies of the polling schedule for the Buka Council elections, to be conducted between 16th November and 27th November, and the Local Government (Electoral Provisions) Regulations 1970. 1.
- 2. The Local Government (Electoral Provisions) Regulations 1970 are to be studied carefully and each officer is to make himself fully conversant with all aspects of electoral procedure prior to commencement of the elections. If you are uncertain of any points, please discuss them with me. The main points concern-ing the conduct of the elections are dealt with below.
- 3. Three teams will conduct the polling:

Team No. 1 - B. Reynolds and A. Vinoko will work in the East Coast Buka and Solus area;

Team No. 2 - J. Tierney and M. Bos (1st week), M. Bos and F. Kakinoru (2nd week) - will work in the West Coast Buka and Selau area;

Team No. 3 - D. Showell and S. Tousala - will work in the Hahon and Kunua area.

4. NOMINATIONS

Some nominations have been received and it is probable that others will be received prior to the three teams' departure to the field. These will be given to Presiding Officer prior to 16th November.

- Nominations may be received up to one hour prior to the comm-encement of polling for each Ward Regulation 31(c)(ii). REMEMBER that polling for a particular ward commences when the poll is opened at the <u>first polling place</u> for that ward. It is essential therefore that all intending candidates nom-inate at the <u>first polling place</u> where more than one polling place is to be set up for a particular ward; e.g. ward 14 where polling will be conducted at IETA and at KUBU and all nominations must be accepted before polling commences at 5. nominations must be accepted before polling commences at IETA.
- To ensure that all candidates are aware of the above, wori should be sent out a day in advance advising all intending candidates for a particular ward that they should be present at the first polling place for that ward prior to the time nominated for commencement of polling. 6.

ELEGIBILITY FOR CANDIDATURE 7.

To be eligible to nominate for election an intending candidate must:

- be resident in the ward for which he intends standing; (a)
- (b) be eighteen years old or more, and
- (a) accept nomination

- 2.
- 8. A person is not eligible to nominate if:
 - (a) he is an officer or employee of the Council
 - (b) he is an undischarged bankrupt or insolvent, or
 - (c) he is undergoing imprisonment after having been convicted of an offence punishable by death or imprisonment for one year or longer.
- 9. Any person employed in the Public Service must have the approval of the Public Service Board to stand for election.
- 10. ACCEPTANCE OF NOMINATION

A candidate must <u>accept</u> nomination for the nomination to be valid - Regulation 31(3). <u>Ensure that each person nominated</u> <u>consents to become a candidate</u>.

11. WITHDRAWL OF NOMINATION

A candidate may withdraw his nomination prior to the close of nominations - Regulation 32.

12. INSTRUCTIONS TO VOTERS

A short talk should be given by the Presiding Officer prito the close of nominations. The points to be brought out are:

- (a) A brief general talk on the local government system as part of the democratic process;
- (b) A reminder that a Councillor's job is a responsible car and that the voters are the only ones that can determine good representation by ensuring a good man is elected to the position for the ensuing two years;
- (c) Mention the responsibilities of a Councillor. He is representative of the people and should maintain liaision between the people and the council and vice versa;
- (d) a brief run-through of voting procedure.
- 13. Ensure that nominations are finalised and close nominations.
- 14. Collect badges from the current Councillor. These will be presented to winning candidates at a Council General meeting scheduled for 11th December.

PREPARATION OF BALLOT PAPERS

15. The order in which candidates names will appear on the ballot papers is determined by draw - Regulation 35.

CONDUCT OF POLL

- 16. Refer to Regulations 38 to 45.
- 17. At the first polling place for each ward the empty ballot box must be displayed - Regulation 42(2).
- 18. Note Regulation 42(5) which requires that a tick be placed against a voter's name after he has been handed a ballot paper. It will also be necessary to mark on the roll those unavoidably absent as this information is required on Form 10 - Voting Statistics.
- 19. Ballot papers must be initialled on the reverse side by the Presiding Officer Regulation 42(3) before handing to the voters.

20. THE COUNT

Refer to Regulations 46 to 57.

- 21. The winning candidate is the first candidate to receive an absolute majority of votes. An <u>ABSOLUTE MAJORITY</u> means a greater number than one half of live votes, i.e. ballot papers which are not informal or excluded at the second or subsequent counts.
- 22. The winning candidate is declared by the Presiding Officer.
- 23. Voting statistics are required as per Forms 10 and 11. These should be compiled as the election proceeds ward by. ward.
- 24. If it should arise that two or more candidates have an equal number of votes at any stage during the count and one has to be excluded or <u>elected</u> the Presiding Officer shall decide, by drawing lots, which one is to be excluded or elected - Regulation 56.

REPORT ON ELECTIONS

25. Each Presiding Officer will be required to submit a report on the conduct of the elections. This will comprise Statistical Returns in accordance with electoral forms 10 and 11 and a narrative report in accordance with Local Government circular No. 16 of 1970 at pages 7 and 8. Copies of this circular have previously been distributed to all staff.

GENERAL

- 26. Each officer is to ensure that he is conversant with the composition of wards. A list of ward numbers and localities is appended for easy reference.
- 27. In all wards, except for ward 1, LONOHAN, one councillor only will be elected. Two councillors will be elected for ward 1 - see Regulation 57 for procedure.
- 28. The attached polling schedule is to be strictly adhered to and may be varied only if it becomes impractical to adhere to it - Regulation 37.
- 29. A briefing session will be held for all officers participating in the elections on a date to be fixed dependant upon Mr. Showell's return from Port Moresby.
- 30. Remind all winning candidates that the first Council meeting after the elections will be held on Friday 11th December.

Mr Kelliher's Special Purpose Report on the patrol is rather vague and lacking in basic statistical data on his part of the elections. Most of the figures could have been recorded at the end of each day in a note book on a Ward by Ward basis.

The Situation Report is again vague and really needs basic information. The stage of tourist resort development referred to is an important point. Is it stagnant or progressive? My brief personal knowledge is that little is happening.

Possibly if Mr Kelliher read the 67-1-0 Circular of 21st June, 1968 to all Field Staff from the Departmental Head "Patrol Reports - Patrol Reports Generally" it would assist him in compilation of information.

It appears that Mr Kelliher's part of the elections were conducted satisfactorily.

As this was a Council Election patrol, all areas visited in the two Census Divisions were in the BUKA Council. The Council appeared to be very active in the area. A number of water storage tanks and catchment areas were observed as well as an extremely good feeder road system. Councillors appeared to have authority in their areas and were given respect by the people. As pointed out in the Election Report, the electoral system was well understood. Political Education on this patrol consisted of an explanation of the democratic system of government as it operates in Papua and New Guinea prior to voting. Owing to the type of patrol and its brevity no other Political Education was possible.

ECONOMIC

The area appeared to base its economy primarily upon copra production with a small amount of cocca in evidence. Processing would appear to be done in the village and marketing would be no problem with the good road system and port facilities available. It is assumed that, as there is an agricultural officer based at KUBU, extension departments are active in the area.

There is plenty of non indigenous development in the area patrolled with seven plantations four missions and the tourist resort development next to BONIS Plantation.

SOCIAL

Only one Aid Post was observed during the patrol but easy access to SOHANO hospital precludes the need of any further facilities. All persons appeared very healthy.

The area appeared orderly and no couplaints were brought to the patrol. There was no evidence of all or unrest but a slightly less friendly attitude towards the patrol was observed in TARBUT and in the small settlements near CHARAI blosion and PORTON Flantation. Whether the fact that these areas border the error under Hahalis Welfare influence has any bearing on this attitude could not be certainly ascortained.

All Missions are Roman Catholic and gave their full essistance and co-operation to the patrol.

NISCELLANEOU/

The only matter raised on this patrol was the question of ex-gratia payment of Loluais and Tultuls. The matter was explained and the people informed that payment would be made at HULJENA.

SPECIAL PURPOSE REPORT

PUEA LOCAL GOVERNMENT COUNCIL LECTION PART SELAU AND PART HAHON AND ISLANDS CENSUS DIVISION

A. MANMER OF EASCTIONS

Polling was carried out by day trips from SOHANC using the M.V. "Hazel" and hiring vehicles as required. There were a total of fifteen polling places set down in the election programme but only at nine of these places did polling actually occur owing to the two unopposed wards and the fact that the people of ANAREI village elected to vote at TOROTEI.

Generally interest created by the election was high and the patrol was well received by all villages. The exception to this was at ANALI and TOROTEI where the people, although present in large numbers, were most uncommunicative for some time. There had been only one nomination for the ward from the retiling Councillor KOBON but, as he stated, he only nominated because it would appear that no one else was willing to stand. After an herr or so of inquiries to electors it WCS obvious that they were not satisfied with KOBON and KOBON was not particularly interested in standing. However, just prior to my deciding to clore nominations one KAVERL arrived by bicycle and nominated. Interest after this revived and KAVERE was elected on the first count.

During the course of polling approximately one fifth of the voters marked their own ballot papers. Those who did were mainly of the younger generation. When one considers the small number of informal votes cast, it is apparent that most of these people have a good idea of voting procedure.

B. FEMININE INTEREST

No women nominated for the election. Female interest in voting was just as high as male interest and all were quite clear on how and for whom to vote. The number of aged women who exercised their ballot was higker than in other elections in which I have participated, which is more than can be said for the aged males of the ages. The numerous female members of religious orders in the Fea were all extremely interested in participating in the election.

C. INCIDENTS

There were no incidents.

D. ABSENTERISM & ANALYSIS OF STATISTICS

As this report is being written in FRETA, and the electoral rolls and voting statistics are held at HUTJEMA it is not possible to go into details concerning these Matters. There were very few people absent for no reason, and orly about one third of the total absentees were outside the District. Most absentees inside the District were working in KIETA or on plantations some distance from the polling places.

E. SUMMARY

The election was successful. The people were very interested in the results although of the five wards

covered by this patrol only two new Councillors were elected.

All villages were aware of the dates set down for polling in their words and were all assembled and awaiting polling officials on those dates.

Of the three wards which were contested I would say only SA OSA was not pre-selected. It was obvious the AMAKEI-TOROTEI-TARLENA Mard & pre-selected and it is suspected that, owing to the way electors voted in Mr. B. Cheung's ward, if a definite pre-selection had not occurred, at lease an intensive "how to vote" campaign was carried out.





The following information has been extracted from Patrol Report No. 5 of 1970/71, covering West Coast Buks, Buka Passage Sub-District, Bougainville District. Patrolling Officer : Mr. P. Baram. The period of patrol : 14th March, 1971 to 25th March, 1971.

Extract.

"The value of the Hapan to Bei road would depend on the serviceability of the Gagan River bridge. P.W.D. have stipulated that funds will be made available er! in the 1971/72 year for reconstruction of this bridge".

Reports received here indicate that the Gagan River bridge has been unserviceable since mid 1970, and that, as a result, a heavily producing indigenous cocoa area has been denied road access to markets and shipping.

I would appreciate it greatly if you would ask your Bougainville staff to give the reconstruction of this bridge some priority. Mr. D. Mola, Member of the House of Assembly, also inquired of this matter during his recent visit to Port Moresby. I don't know if he saw you.

Your reference is 67-1-3 of 29th June, 1971.

I acknowledge with thanks receipt of Annual Census, Area Study and Situation Report by Mr. P. Baram of West Coast Buka Census Division.

It is interesting to note the attitude that the West Coast Buka people do not want Bougainville to secede from the rest of the Territory, and that self-government should not come too quickly. This indicates a conservative, pragmatic approach which, to my mind, is to be commended.

Your comments on political education and those of the Assistant District Commissioner, Hutjena, have been forwarded to the Political Education Section. With the Hahalis group, the NAVITU NAPIDAKOE, Local Government activity, the development of the huge copper project and the secession movement, the Bougainville people can become "politically educated" simply by observing issues close at hand.

Mr. Baram states (P.3, Area Study) that all jetties require repairs but that he feels expenditure for extensions and repairs would be better applied to the Tung/Buka Passage road. These are island villages and, as such, will always be dependent on sea transport, and hence reliable jetties. The Buka Council might well consider subsidizing the island villages in part for replacement of all jetties to accommodate vessels up to 100 tons. To my mind, this would be a practical and worthwhile project, one worthy of the attention of the Council Adviser. It might also help to dissipate the dissatisfaction with the Buka Council expressed by the west coast people. (P.1, Situation Report).

It is noted that Rural Development Funds will be injected into the Hapan/Bei and Nova/Hutjena road projects. The completion of these roads will necessarily be a long process. The report recommends a road from Tung to Buka Passage. If you wish to have this admitted to the Territory Needs/Design Lists, a convincing submission will be required.

The section of the Area Study on the economy is somewhat vague and unprecise. For instance in (j) the reporting officer states - "I think it doubtful that the mean average income per annum would exceed \$200". Whilst this is no doubt true as far as it goes, it is still pure guesswork. Sufficient facts and figures should be available locally from Co-operatives, local traders etc. to enable an accurate estimate of per-capita income.

Would you please advise the present position regarding the establishment of a Copra Marketing Board Sub-Depot at Buka Passage.

Report of the above-specified patrol conducted by Mr P.Baram, Assistant Patrol Officer is forwarded herewith together with a copy of covering memorandum 67-2-1 of 9th June from the Assistant District Commissioner, Buka Passage Sub-District. These are quite comprehensive.

2. Rural development planning for 1970/71 envisages extension of the Bei road towards Tung. This extension, and work on the Hapan - Bei road this year has been held up pending Department of Public Works' re-construction of the Gagan Bridge. The real effect is not that the people have been passed over by the C-abcil but that they feel they have been. One roadworks recommence in the area I should imagine there will be a reawakening of Council interest.

3. I agree with the Assistant District Commissioner's remarks concerning political education. In fact a large proportion of political education in Bougainville is topical and good results are being obtained. The essential point is that other methods of communication are not recognised as forming part of the overall political education programme. The more formal approaches e.g. talks on the structure of government and responsibilities in a democratic scelety, unity theme etc., are somewhat remote in concept and therefore arouse little interest in the adult section of a community whose traditional political life is rigidly organised by custom.

Attached please find, in triplicate, report of the abovementioned patrol. The report consists of a situation report, area study and census statistics.

- 2. This was Mr. Baram's first solo patrol and he has conducted it in a competent manner. His report is well written and gives a good picture of the area covered.
- 3. Also attached are census figures for the rest of the Buke Census Division = 1.e. census areas SOLUS = 3(11), SOUTH EAST COAST BUKA = 3(111), and NORTH EAST COAST BUKA = 3(1v). Census of these areas was conducted by various officers who did not submit reports. Most of the work was done by M. BOS, A.P.O. and E.B. Reynolds, P.O., both of whom have since resigned from the Department. Mr. Baram's figures for the West Coast area balance, but the figures for the other three areas do not. A complete recompilation of the figures would have to be carried out if an effort was made to reach a balance. Random checks of some villagetotal population figures have been made and the current figures found to be correct. It is therefore assumed that the previous census statistics are incorrect. As it would be too time consuming to check each village register for errors and/or an explanation for discrepancies the Village Population Registers are now submitted in accordance with para 4 of Adsec memorandum 14-2-0 of 14th October, 1969.
 - Complaints that the Buka Council has done little for the West Coast area compared with the East Coast are not correct when expenditure in relation to population distribution are compared. It is true that some 10,000 gallon water tanks supplied by the Council have not been installed, but this is mostly the fault of the villagers who are expected to prepare for installation of the tanks by gathering materials and constructing concrete stands, which they have not done.

5. Mr. Baram reports that little interest was shown in his political education programme. This is typical of sub-district wide reaction. Most political education is regarded as 'old-bat' and unless a current topical subject is discussed little enthusiasm is met with. Generally speaking the peoples' understanding of political matters is good, and I feel that they are unwilling to listen to subjects rehashed time after time. Far more interest is shown in other media for disseminating political information, such as radio, and I feel that more emphasis should be given to political education through this medium and less importance placed on the role of field officers in this field. It is difficult for the average field officer to present a topic in which little interest is shown, whereas there is far more scope for making the same topic attractive to a radio audience when it can be interspersed with news items, music and etc. I feel that the role of the field officer in the political education programme should be more that of, (a) concentrationg on very recent and political developements and 26

ib) ancouraging the people to put forward their views and report on same.

6. Mr. Baram's comments on the need for read acess to the West Coast Buka area are sound. Speps are being taken by the Buka Council through the Rural Developement Fund to alleviate the present situation. Two roads are planned for the 1971/72 year - one from HAPAN to BEI and the second from HUTJENA to NOVA. As Mr. Baram points out, the value of the HAPAN- BEI road Would depend on the serviceability of the GAGAN river bridge. P.W.D. have stipulated that funds will be made available early in the 1971/72 year for reconstruction of this bridge. The natural progression of the proposed HUTJENA - NOVA road will take it beyond NOVA towards the TUNG area and eventually to meet up with the HAPAN - BEI road at BEI in subsequent years.

7. With the increasing reliance of the people on a cash economy based mainly on plantation agriculture, the shortage of land in the West Coast area is becoming more appatent. The Island residents of HITAU, PORORAN, PETATS and MATSUNGAN are most affected. These people do own land on Buka Island proper, but much of the land claimed is in dispute. One application over a large area known as 'TUHUS' has been submitted to the Land Titles Commission Office. The people of PETATS and MATSUNGAN dispute the ownership of this area with the NOVA people. The P.N.G. Development Bank is at present investigationg the feasibilt of a loan to the BEL/PETATS/MATSUNGAN groups to purchase BEI, JAME and SAL plantations, which cover a total area of about 700 acres, most of it planted to cocnuts and a good portion interplanted with cace.

8. Late submission of this report has been due to the amount of time put in on compiling_y and checking census figures for the three census areas covered by Messrs. Reynolds and Bos so that all figures for the Buka Census Division could be submitted t together.

SITUATION REPORT.

A. POLITICAL: - Local Government Council.

Although local government taxes are collected without problem in the area, dissatisfaction with the council was voiced often, especially in the northern sector. Firstly, the people feels that the council panders to the East Coast villages the West Coast gets nothing, they say. Secondly, the islands are facing a food production problem because of land shortages, and its felt that the council could, somehow, help the alleviate this problem. The people arm't necessarily asking for large council support, but would be satisfied with smaller things, to let them know that they are not forgotten.

B. HOUSE OF ASSEMBLY and CENTRAL GOVERNMENT.

Generally speaking, little interest in politics was displayed throughout the area. The greatest interest shown was when I explained why a political party was formed and how it operated. Only occasional interest was shown in discussing the recent United Nations Visiting Mission (despite the meeting in the Buka Local Council chambers.) and the work of the Select Committee on Constitutional Development - the main worry was that Bougainville should not seceed from the rest of the Territory, and that self-government should not be quickly assumed. Dissapointment that their Member, Mr. D. Mola, had not visited them for years, was expressed by the people. Mr. Mola says he shall shortly rectify this matter. C. ECONOMIC.

Cash production is probably more vital to the offcoast island people, then to those of Buka-proper, because of the land shortage problem and its resultant problem of limited local food production. With more cash, the people would be able to purchase supplementary dietry needs. The most obvious cash source is copra, but this is limited by a severe marketing problem, and in some cases, by land shortage. I feel that a road from Tung to link up with existing east-coast road at the Buka Passage airport would help to aleviate both of these problems. D. SOCIAL 20

Literacy is high in t e area, especially at Petats. because of the early influence of Skotolan Mission. Many European style houses have been built ,plenty of European cooking utensils are in evidence and European clothing is common, but teamed with bare feet or thongs. There are many radios, Pororan, for example has twenty-two and most villages have more than two sewing machines, especially if a women's club is functioning. The area possesses sixteen large, motorised canoes. Many bank accounts are current, but few are being used correctly. Some books of seven to nine years vintage have not been forwarded for interest in that period. Because of the dollar change-over, some people did not have any idea how much money was in their account, or even if the account was valid. It seems to me that some officer could tour the villages and rectify any banking problems and so provide a good public service. Probably the worst problem in this respect, is that school-leavers do hot know how to transfer their school account to any ordinary savings account. Schools acting as banking agents should tutor their pupils in the handling of savings/cheque accounts. The ex-pupils could then help the older villagers with their banking problems. E. CONCLUSION.

Generally, the people are healthy, despite the low amount of stocks hel? in the four aid-posts that serve the area. I feel that another aid-post should be built at Kahule, which now has a new four-teacher primary "T"school.Kahule aid-post could serve Matsungan to the west, Tung and Poka to the north and the sister village of Sipani to the east. The people seem vigorous and willing to move ahead. A high premium is set on education - but unfortunately it is largely"education nowhere". Young people who have completed primary school or some secondary school, return to the village not equiped to be totally satisfied in the village environment, yet not possessing sufficient skills to leave and make a good life elsewhere. This gis particularly se with girls, and is, I feel, partly to blame for the high marriage-break-up incidence in the area.

The brighter side of this determiniation to acquire learning, is that many people have become tradesmen, professional people, have joined the police force or armed services and do make a living away from the villages. This reduction of people in the village helps with the food shortage problem and also brings finance into the area.

A number of young people are attending tertiary

institutions, such as teachers' colleges, university, seminaries, or are at officer training schools. There are three people from the area studying in Australia.

In this area, the Hahalis Cargo Cult has no power; the last ardent member in Petats, I was told, "Doesn't talk that rubb\$sh anymore", and has gone to work for C.R.A. - he's obviously seen the light. When the people in the above-mentione d institutions graduate and assume resposible positions and receive the material benefits from these positions, I think that cargo teachings will have limited impact.



Forwarded herewith is the original and copy report of the above specified patrol conducted by Mr P.Baram, Assistant Patrol Officer. Copy of the Assistant District Commissioner's covering memorandum 67-2-1 of 21st July is also attached.

2. Both reports adequately describe conditions at Nissan, and should be read in conjunction with my detailed memoranda 1-3-13 of 12th May, 1970 and 18th June, 1970. The political situation has not radically altered since then although some communications and economic problems are being overcome.

3. A D.I.E.S. film unit with political education material will visit Nissan commencing on 9th August, 1971.

4. The District Political Education Officer will further his interest in Nissan and pay another visit in the near future.

5. Unfortunately the staff situation does not permit the manning of the base camp there (Mr Baram in fact has transferred to another department since his patrol) however there is a continuing interest and effort to bring the people more into the sphere of political life in 1971. The inbuilt lethargy, compounded by isolation presents difficulty in this regard. The most obvious factor in breaking down these persistent attitudes lies with the younger educated men who now seek to expand and improve their ideas.

Buka Passage Patrol No. 6-1970/71 Missan and Pinipel Census Division - P. Baram, A.P.O.

- 1. Attached please find 3 copies of Mr. Baram's report of the above-mentioned pa trol. The report consists of a Situation Report, Area Study and census sta tistics.
- 2. Mr. Baram has conducted this patrol in a competent manner and has submitted an interesting report.
- 3. It is of interest to note that Missan is probably mis-named Green Island on current maps. Fr. Muller of the Marist Mission, a resident of the Bougainville District since the early 1930's, contends that the Green Islands are in fact the Carteret group and that pre-war maps showed them as such. Current maps how the Carterets as also being named KILIMATIAU. Fr. Muller further contends that this is a corruption of Green Islands. This may be of inte rest to the Place Names Committee.
- 4. Resistance to Local Government persists. Remoteness poor communications and differing attitudes of the people puclude inclusion of the Missan/Pinipel groups in the Buka L.G.C. If these people are to be introduced into the local government system at some future date a new council would need to be established. However, the small population (2932), disinterest of the people and difficulties of super vision provide and unsound
- of the people and difficulties of supe. Asion provide and unsound basis for effecting such a move at this stage. In view of this the subject of Missan/Pinipel inclusion in the local government system should be left in abeyance for the time being.
- 5. Since Mr. Baram's patrol the rest house at Missan Base Camp was fairly extensively damaged by the earth tremor of 13th July. The house still stands, but roof and floor joints have parted and repairs will be necessary to make it safe before it can be again occupied.

6. Despite numerous serious injuries, some deaths, and repeated warnings of the illegality of their actions, the Nissan people persist in using war-time explosives for 'bombing' fish. It would appear that the practice will endure whilst war-time explosives are readily available. Perhaps the only solution to this problem would be for a demolition team to attempt to make a clean sweep of the area and destroy all explosives. Other preventative measures have no effect. In the last reported incident, a cripple (who can only get around unaided by dragging himself along the ground) attempted to use a home-made bomb resulting in serious injury to himself and two others - one of wh or lost a hand. Twelve months ago a young man committed suicide by exploding a home-made bomb clutched to his chest. There are unconfirmed reports that explosives

- and taken back to Missan. This may be true, but I think the main source of supply of explosives would be from the wartime stocks at Missan.
- 7. Lack of attention to duties by Aid Post Orderlies has been reported to the Medical Officer, Schano.
- 8. I suggest that an approach be made to D.I.E.S. Kieta and arrangements made for a film unit to visit Missan/ Pinipel when movements of the Administration trawler permit. As mentioned by Mr. Baram in his report, films with political education content should be included in the programme.
- 9. The Missan/Pinipel people remain a lethargic, disinterested group whose only wish appears that they should be left to their own devices. Their attitude is fro-Administration in as much that they realise the Administration is providing services for which they do not have to pay and they are quite content with this arrangement. Previous reports on the area and advice from missionaries stationed there indicate that the people are very reluctant to pay for any service and are more apt not to use the service if payment is required. Last year the people would not make use of the Tungal Mission hospital because a charge of ten cents per treatment was being levied. Even seriously ill patients were being denied medical treatment as relatives would not take them to the hospital. The fister-in-Charge of the hospital reports that this situation has resolved itself somewhat now, although the peoples' attitude to the service fee is still not very satisfactory.

Please prepare to depart on patrol to Nissan on Monday, 19th April. The M.V. 'NIVANI' will be available to move you and your family and is expected to depart Buka at approximately 9 p.m. on that date. Two police constables will accompany you. You will be at Nissan for approximately two months and the M.V. 'NIVANI' will return you to Buka at the end of that period. There is a Base Camp established on Nissan at MAPIRI where you will live in a good native material house.

The Transport Officer, KIETA has approved an allocation to enable you to hire a vehicle whilst travelling on Nissan. Henry Kemito of Mapiri has a Landrover which is available for hire. You are to limit your usage of this vehicle to essential travel only. You may commit up to \$200 for this purpose and this amount should not be exceeded.

It is eighteen months since the last patrol to this area and during the interim only brief patrols have been made by various officers. The Nissan/Pinipel people are a fairly lethargic group and in the past have not shown much enthusiasm towards the Administration or the efforts of officers who have tried to assist them. The general attitude appears to be one of wanting to be let alone, whilst there are a few vocal individuals highly critical of the Administration for not 'doing more' to help the people. I expect that you will find this attitude persists.

The following matters are to be attended to during the course of your patrol:

Situation Report

A. Polatical - Local Government Council

The people of Nissan & Pinipel are not in the local Government Council. None of them are really keen to join, but about half the population, that is those south of Tanamalit and the people of Balil would be willing enough to join. The memainder are anti local government as they know they are onto a good thing, receiving benefits, but not paying taxes. They say they cann't afford taxes.

B. House of Assembly & Central Government.

The older people openly state that politics etc. concerns people of other areas, not them. As long as Bougainville doesn't eccede they will be happy. Young adults showed some interest in new developements & were very keen to hear about the formation and function of political parties and the meaning of Self-Government, and of Independence. The new flag was shown round the villages and posters put up. There was none but a curiosity reaction to it.

C. Economic

Copra is the economy of Nissan, but marketing is difficult. Gardens are sufficient to supply the needs of the people, but some places have limited their gardens, and one has no garden to enable greater coconut plantings.

D. Social

Most young people and some middle-aged people are litrate in Pidgin. Only the younger people read and write in English. Scrap materials are still heavily used in some villages, such as Mapiri, for building. Such edifices make a depressing sight. I doubt if those houses are more functional than maintained nativematerial houses, but as these places are not maintained there is less work attached to them. Basic European cooking utensils are in common use. Shirts, shorts, dresses are common apparel. Most villages have at least one radio and sewing machine, bikes are very common bbecause of the road system. and the people arehot keen on water travel. A local C.S.B. Agent, Patrick Samuel of Yochibol does an excellent job and most people of the southern half of Nissan have accounts with him. The remainder run savings accounts through Rabaul.

JONCLUSION

None of the people are greatly interested in change, especially if it involves work. Generally the people are lethargic and are waiting for the next American "invasion" that will repair the roads and provide more building materials and supply other wants.

Attached please find three copies of a report of the abovementioned patrol dubmitted by Mr. Tanu Tanu, Assistant Field Officer.

Mr. Tanu was sent to the Selau census division specifically to update the census preparatory to recompilation of the electoral roll. I did not instruct Mr. Tanu to submit a patrol report, nor did I expect one from him. The fact that he has compiled and submitted this report reflects the Leen attitude that Mr. Tanu has always shown towards field work and any other duty allocated to him.

I am not familiar with any plans along the lines outlined at para. B of the 'Political' section of the report and the matter is being further investigated. I am sure that this cannot refer to a large section of the Carteret population as they have always opposed any plans to resettle them. There is nearly always a small group of Carteret people resident in the Buka Passage area, working, attending school and awaiting sea transport back to the Carterets, and I should think that KERROL'S plans would invoive this itinerant group only. The matter will be further reported when more details are known.

The people of the northern portion of the Selau are quite staunch Council supporters. As mentioned by Mr. Tanu the Buka Council has carried out a lot of work in this area and in particular has provided an excellent feeder road system. The villages in the southern Selay come under the influence of KERROL of SIARA and the Hahalis Welfare Society. These people are currently upgrading the road through their area to link up at TARBUT with the road constructed by the Council. An amount of \$3000 is being expended on this project to hire a bulldozer.

INTRODUCTION .

The patrol in engaged espercially updating census in Selau census division. The area has fiftheen villages. Which of eight villages are in Buka Local Government council. The rest are non-council villages and are predominates of Hahalis Welfare Society.

Political A. The Buka Local Government Council is very active in the area and its member appear to be reasonbly satisfyed with the progress. Council members are convinced that idea of Local Government itself is quite concrete. The people seem to appreciate that progress can be made by using council and supporting it as much as possible. In the case of council activities, a number of water storeage are put up and has good feeder road system. Councillors are repected by the people, and have authority in the area.

The non-council villages in the area once again are Hahalis Welfare Society predominates, Kepo as a hadman. There is rumour that some of Catrets people are to be migrated to the area. A place has been half mile away south of Poton plantation. Meanwhile the matter is under consideration. I suggest that this is the extention of Hahalis welfare pociety в. as well as multiple its population.

Economic. The area based its economy upon copra production and with a amall amount of λ_{0} of cocoa in evidence. There are about thirty persons have copra marketing board T numbers. Those who do not have T number send their production through above thirty persons. Minority of them sell their product to Local tradema Local traders.

Social.

There is only one orderly base at Gohi. The people attend the aid post daily , and appeared that all the people are healthy . There was no complain upon orderly.
