Your letter of the 3rd inst. together with your report on the California Historic Landmarks Project came to my attention upon my return from Washington. From the discussions we have had you are aware that I am generally in accord with your views on the desirability of proper publicity and additional efforts to disseminate knowledge and information of our state parks and other natural resources. The projected series of monographs, on which you have done such fine work and which is now on the press, of course, is a step in that direction.

So the question now is: Shall these corrections be made, in spite of the extra expense involved, which will be the reply of the printers. It seems to me that it will be a great mistake to print anyone's name as a member of the Commission, when he is no longer there.

Since I am no longer handling this job, it occurred to me that a work from you will be enough. Especially as you have asked to see the volume in your letter of yesterday to the Supervisor of Documents.

Prehaps in time some one person can have the job of seeing that these books are completed right. Whoever it is, he must have the authority to see that the plans as Oked, are put through.
