2 hereby mutually agree, and in consideration of our mutual pro-
3 mises herein contained, and for other considerations, do each
4 severally promise to pay to Julius Wangenheim, as Treasurer of
5 the Marine Biological Association of San Diego, or his suc-
6 cessor, as such Treasurer, for the benefit of said Association,
7 the sum of Nine Thousand Dollars (\$9,000.00), as follows:

8 Ellen Scripps agrees to pay Three Thousand Dollars
9 (\$3,000.00) in nine equal installments,- one of said install-
10 ments on the first day of May, one on the first day of July,
11 and one on the first day of September of each year, beginning
12 with the first day of May, 1904, and continuing until said
13 Three Thousand Dollars (3,000.00) shall be paid.

14 Homer H. Peters agrees to pay Three Thousand Dollars
15 (\$3,000.00) in nine equal installments,- one of said install-
16 ments on the first day of May, one on the first day of July,
17 and one on the first day of September of each year, beginning
18 with the first day of May, 1904, and continuing until said
19 Three Thousand Dollars (\$3,000.00) shall be paid.

20 E. W. Scripps agrees to pay Three Thousand Dollars
21 (\$3,000.00) in nine equal installments,- one of said install-
22 ments on the first day of May, one on the first day of July,
23 and one on the first day of September of each year beginning
24 with the first day of May, 1904, and continuing until said One
25 Three Thousand Dollars (\$3,000.00) shall be paid.

16 Homer H. Peters agrees to pay One Thousand Five Hundred
17 Dollars (\$1,500.00) in nine equal installments,- one of said
18 installments on the first day of May, one on the first day of
19 July, and one on the first day of September of each year, be-
20 ginning with the first day of May, 1904, and continuing until
21 said One Thousand Five Hundred Dollars (\$1,500.00) shall be
22 paid.

23 E. W. Scripps agrees to pay One Thousand Five Hundred
24 Dollars (\$1,500.00) in nine equal installments,- one of said
25 installments on the first day of May, one on the first day of
26 July, and one on the first day of September of each year be-
27 ginning with the first day of May, 1904, and continuing until
28 said One Thousand Five Hundred Dollars (\$1,500.00) shall be
29 paid.

30 The sum above agreed to be paid is in addition to the
31 Nine Thousand Dollars (\$9,000.00) agreed this day to be paid
32 by the parties hereto, and it is understood and agreed that if
33 said Association should, during the period covered by this
