Mrs. Terese Karmel, the Peace & Freedom Party candidate for Congress had 5 articles on her statements in the Enterprise but the San Diego Union and the Schurz's papers have a CURTAIN OF SILENCE on her statements.

The radio stations in Imperial and Riverside Counties have no

reporters. For local news, they just read excerpts from all 3 news-paper groups. Since no statement of Dr. Yellen or his political activities in his election campaign are printed in the papers, there is a COMPLETE BLACKOUT OF THE NEWS ABOUT DR. YELLEN ON RADIO BROADCASTS.

Yet all these newspapers will assume the halo of Civic Virtue and give political advice to their readers and exhort the voters to be sure to go and vote. How can the voters know the issues in this election if a CURTAIN OF SILENCE IS KEPT ON THE STATEMENTS OF DR. YELLEN? THIS IS THE HEIGHT OF IRRESPONSIBLE JOURNALISM:::: ARE WE IN RUSSIA??

Dr. Yellen for 8 years has been putting out a Newsletter in which he tells the facts as he sees them. He walks the streets with a sack on his shoulder containing his Newsletters and distributes them to homes, stores, autos, persons, etc. He asks all those receiving them to give them to others after reading them. He has to do this himself for those who have jobs fear the loss of jobs by the pressure of the big ranchers who have been accused of escaping at least 50% of the taxes in Imperial and Riverside Counties because the corrupt Assessors put fake low assessments on the farmland and the rest of the people have to pay more taxes to make up for the big ranchers.

In all Imperial County and in the Coachella Valley County Water District of River. 1s County which have 110,000 of the 200,000 people in the Assembly district, the people are being swindled for the benefit of the big ranchers by being forced to pay 3 times more in electricity bills so that the big ranchers can get irrigation water for 1/4 the correct price. The little people by the provisions of the U.S. Reclamation Law of 1902 are supposed to do the farming in the Imperial Irrigation District of Imperial County and the Palo Verde Irrigation District and Coachella Valley County Water District, both in Riverside Counties. Absentee landowners own 70% of the farmland in the Imperial Irrigation Dist., 80% of the farmland in the Palo Verde Irrig. Dist. and 50% of the farmland in the Coachella Valley County Water Dist.

SC AT LEAST 70% OF THE FARMING PROFITS LEAVE THESE AREAS WITHOUT BEING SPENT ONCE WITH THE LOCAL MERCHANTS AND BUSINESSMEN. BECAUSE THESE ABSENTAE FARM OWNERS ESCAPE AT LEAST 50% OF THEIR TAXES
AND ESPECIALLY THE SCHOOL TAXES THERE IS A CONSTANT SHORTAGE OF MONEY
FOR THE SCHOOLS. Your tax bill will show that 2 out of every 3 dollars
you pay in property taxes, went to the schools.

THE SECRET WEAPON OF DR. BEN YELLEN IS THE TRUE FACTS AS REVEALED IN THESE NEWSLETTERS ABOUT TAXES, ELECTRICITY BILLS, WHO IS ENTITLED TO FARM(NOT ABSENTEE LANDOWNERS), AND THE BIG HANDOUTS TO BIG RANCHERS.
