| <p>Details: <i>In the last two weeks the harassment by Border Patrol officer [REDACTED] has gone progressively worse. He flashes his badge and forces his way into my house. He intimidates us and tells me my kids better have "papers". My kids were born in Chula Vista. He and his wife yell at me and call me "whore" and "slut" for no reason at all. They yell at a neighbors kids and my kids and call them filthy names. and his wife live in the apartment next door, separated only by a wall, they pound on the wall constantly and complain to the manager. They even call the police and child abuse department on me for no reason. The wife and lady below us (both are white) continually harass me even when I leave the house for church, saying, "look at that slut going to church she thinks she's to good for us".</i></p> <p><i>[REDACTED] and his wife both go around the neighborhood spreading malicious lies and questioning the neighbors about us. They also went to the manager and complained about us. Now, the manager has asked us to move. We dont think it's fair.</i></p> <p><i>Before it was a verbal abuse problem now they are getting physical and threatening. What is difficult to understand is why both [REDACTED] and his wife call us "dirty Mexicans" and "Wetback". We are citizens of the United States and so are the neighbors they harass.</i></p> <p><i>We want to protest this harassment before it becomes a physical confrontation. Especially since [REDACTED] has his hand on his gun when he comes to my door and tries to force his way in - on and off duty.</i></p> <p><i>No border patrol officer should be allowed to use his badge to terrorize people.</i></p> | | |
