Dear Sir (Copy)

On the otherside is copy of my two last letters to you since I have not heard from you. I find that all the Plank & some of the Boards charg'd in Torwin Accounts last year were used about the Dam & Gutters, which gave way as a time when plank could not be sawed to repair it I have already writ you that I have bought 23 Negroes for your Estates which are divided in the following manner viz^t

& Duty for the Men £53 & duty for the Women & 40 & Duty for the boys all which do very well. On the 6th Inst. I gave Thomas Hamilton Bills of Exch^{ce} on Robert Gordon Esq^r for £500 & of the 8th Inst. I gave Erskine & Mottusett Bills of Exchange on Robert Gordon for £250 & towards payment of the above negroes in your account to which you'll please desire him to give due Honour. He shall pay here these are the first Bills & I hope will be the last I shall draw on your Account payable out of this for I shall endeavour to get 15 or 20 more Negroes for your new Estate before Christmas which I think will make them pretty strong & enable them to go on with small supplies afterwards. Mr. Stone says he will pay your son Thomas's Legacy next year - would it be agreeable to lend it to Dulix's Ferring for a couple of Years upon very good Security he is a most industrious man & wants to build a Water Work but cannot do it & make his other payments let me know your mind on this matter.

I am not at all satisfied with the present made of letting out your Wharf, since I have been over you have lost three Negroes some by accident & some by being neglected when sick & the Repairs above £100 so that it doth not appear to me you get any thing by it. I have therefore let Mr. Celand know that I will rent it for the time to come without Negroes & given him a Month to consider of it he lives mostly in the Mountains where

where he is setting a Sugar Work, so that the Wharf is chiefly
under the care of his Brother John & another Boy, I am afraid
this new Settlement and Mr. Murr's Debt will hurt that Family
& I am more regard to his own opinion than any other,
I have been round your Estates, The new Estates look very
well The old ones have suffered by the dry weather, If the
Seasons that have been for a fortnight past continued I hope
the farms will entirely recover, & make more than last Crop as
there are good plants in the Ground, but really if the dry
weather had continued 2 or 3 weeks longer most of the Plants
would have been entirely dead. There are 3 bunches of Rum
from Tryall Estate marked I II shipped on board the Sally
Capt. Curtis for which he gave not bill loading the Wharfinger
has a Receipt for them dated 9th Sept last signed John Brown
I hope Capt. Curtis has delivered them to your order as he
must be sensible it was a neglect in his not landing them
at Montego Bay, I expect to send you a Box of Shaddocks
by the King George to the care of Mr. Gordon give him
directions about them I am with regard
