


FINSCHHAFEN PATROL 1 of 1971/72.

TERRITORY CENSUS  
SPECIAL REPORT.

1. While waiting at Tigidu 80/100 men arrived from Lae, after working for four weeks unloading ships for Burns Philp.

The home villages of these men were Tigidu, Busega, Butola and Bukausip. The census of these villages was completed and they were not counted in Lae.

Because of being in transit these men were not included in the census.

2. M.V.Boroko. The M.V.Boroko departed 0800 hours 10th July from Buki wharf en route for Tuam Island, in the Siassi

It made its way north in heavy seas changing to a no -easterly course at Fortification Point to cross the Vitiaz Straits. Here the seas became higher - and during this period the M.V.Boroko became noticeably more difficult to steer, the seas breaking over all decks. We eventually arrived at Tuam Island at 1400 hours.

On inspection it was found that the Port Rudder was missing, being washed away in the rough seas.

This is the second time this ship has lost a Rudder since it arrived in the Finschhafen Sub-District.

It is in my opinion that this vessel is not suited for the seas in this area and consideration should be given to replacing the M.V.Boroko with a larger or more sea worthy ship.

This is the second patrol by Mr. Arabata. The patrol diary shows a keen attitude in his application to patrolling. With training and experience he will become a very useful man in the Department.

The report is adequate. However, I agree that patrol officers are to be astute and must record their observations and not what they image a situation to be. The suggestion that M.H.As might prepare a brief, either yearly or half-yearly, for distribution through their council is sound. It is a pity that the most experienced members are losing touch with their electorate because of frequent absence from their district on tours and attending to parliamentary matters.

Attached are three copies of the above report submitted by Mr. S. Arabata T.O.O.

This patrol, together with Finschhafen No.4 of 1971/72 (Mr. T. Trumbull - and APO) was mounted to complete the electoral roll in the Kotte Division. To do this, the census, which had not been revised since 1967 had to be revised. The collated census figures were submitted with P/R 4-71/72.

Because of the urgency in getting the electoral roll completed, the patrol did not deal with other routine census matters, except to enquire into whether or not the agents for the 'Fongungbalong' land purchase had received the \$10 purchase price - refer your file 35-121-6; and to endeavour to get more signatures on the Declaration of Custom.

The patrol achieved its main objects, specific comments are as follows:-

Patrol Diary

Because the Mape river bridge was cut by flood water, it was necessary to ship the patrol per MV Boroko around the mouth of the river to Nugidu where private vehicles were arranged to get the patrol to its starting point.

Pangu Pati

It will be interesting to see how this party approaches the forthcoming elections - so far 3 members of it have expressed their desire to stand.

Social - Activities

Mr. Arabata would do better to use his observation rather than imagination in describing the activities of the Women's Clubs.

'Fongungbalong' Land Inquiry

Though the seven agents say that they received the \$10 from 'the said Kiap', Mr. Taengoc Sanangkeec T.O., we have still been unable to locate a voucher at the Finschhafen cash office. Work on getting the required number of signatures on the Declaration of Custom will continue, it will be a long job, I fear.

SATTLEBERG/WAREO AREA OF THE PART OF THE KOTTE CENSUS DIVISION

INTRODUCTION

Two patrols were made for the same Census division, Mr. Trumbull-Ward - A.P.O., patrolled around the Mape area of the part of the Kotte Census division. I S. Arabata, T.P.O., did the Sattleberg / Wareo area of the same Census division.

The patrol was organised to revise the Census and compile the Common Electoral Roll for the next House of Assembly election.

One constable accompanying with each patrol. At the completion of the patrol both of us will be submitting a special patrol report.

PATROL DAIRY

9-8-71

0745 hours I was ready to go out on patrol but I was delayed because of the Mape river overflowing the bridge.

1000 hours I was accompanied by constable Horanbopa ex-Gagidu by truck to Buki at 1015 hours. Spent five minutes unloading the patrol gear. 1020 hours ex-Buki by M.V. Boroko. 1100 hours arrived Nugidu wharf and ten minutes later ex-Nugidu by truck to Poiya plantation. Hired one P.M.V. landrover truck to Jivenang at 1230 hours.

From this point the carriers carried the patrol gear and the party advanced on foot. Arrived Balanko village at 1420 hours.

Villagers lined and the Census was revised. Common Electoral roll amended. The work completed at 1830 hours and I walked to Fior village at 1900 hours. I spent the night there.

10-8-71

0800 hours I lined the villagers and the Census revised. Common roll amended afterwards. The work completed at 1200 hours and ex-Fior on foot.

1300 hours I arrived Masangko village. Held the Census revision and amended the Common roll. 1700 hours I completed and departed.

1900 hours I arrived Sililio village and I spent the night there.

11-8-71

0800 hours as usual I did the Census and compiled the Electoral roll for this village. 1035 hours completed and ex-Sililio on foot.

1145 hours I reached Sosoninko village. Work was delayed for a couple of hours because the people received the wrong message. Gradually the people gathered and the Census was revised and the Common roll amended the work was then completed and ex-Sosoninko at 1400 hours.

I arrived Bolingbongen at 1600 hours and spent the night there.

12-8-71

The work here was very much delayed by the heavy rain, so so I called the people in the Councillors house and the Census was revised. Electoral roll amended and ex-Bolinglongen at 1220 hours on foot while it was still raining.

1

1400 hours I arrived at Nanduo village. The village lined and Census revised. Common roll amended. Completed work at 1700 hours.

I spent overnight with the people. I asked the people for more signatures on the Declaration of customs for the piece of land known as Fongunbalong leased to Namasu Company.

13-8-71

0800 hours ex-Nanduo on foot while it was raining I arrived Yanzein Village still with the rain at 1230 hours.

Villagers lined inside the village school classroom and the census was revised. The Common roll amended afterwards. I spent the night there.

14-8-71

0800 hours I ex-Yanzein village on foot through a bush track to Zafilio at 1200 hours.

Villagers lined and Census revised. Later Common roll amended. Completed and spent the night there.

15-8-71

0800 hours ex-Zafilio on foot to Merikeo village at 0930 hours. The villagers lined and Census revised, later Common roll ~~XXXXXX~~ amended. 1200 hours completed and ex-Merikeo.

1300 hours I arrived at Kwimliki village. Villagers lined and Census revised as usual. Electoral roll was amended and completed at 1500 hours. Ex-Kwimliki at 1510 hours.

1700 hours I arrived Uluor village and spent the night there.

16-8-71

0800 hours the villagers lined and the census revised. Common roll amended afterwards. Completed and ex-Uluor village at 1000 hours.

1130 hours I arrived at Gwinlanko village. The people lined and the Census revised as usual. The Electoral roll was amended afterwards. Finished off at 1230 and ex-Gwinlanko village.

1400 hours I arrived at Kawngko village. Census revised and Common roll amended. 1630 hours I finished the work and ex-Kaungko.

1730 hours I arrived Badzuluo village and spent the night there.

17-8-71

0800 hours the people lined. Census revised and Electoral roll amended. I finished off at 0945 hours abd ex-Badzuluo.

It took me about  $2\frac{1}{2}$  hours to walk to Aimolau at 1200 hours. The villagers lined up and the Census revised. Common roll amended and ex-Aimolau village at 1500 hours.

I arrived Lakona village at 1600 hours and spent the night there.

18-8-71

0800 hours the people gathered and the Census revised. The Common roll was amended afterwards. Finished off at 1000 hours and ex-Lakona by Council tractor.

I arrived Bonga at 1030 hours. The villagers lined and the Census revised. Later Common roll was amended. I finished off the work at 1200 hours.

I was waiting for the truck til 1800 hours I had a lift from Council truck back to Gagidu at 1600 hours.

19-8-71

0800 hours I departed Gagidu by toyota truck still the constable was accompanying me. 0850 hours I arrived at Katika and the people from Lekc village assembled at Katika.

Census revised and Common roll amended, completed both villages at 1200 hours and departed.

1250 hours I arrived back to Gagidu. The rest of the afternoon I revised the Census figures. Stopped work at 1606 hours.

20-8-71

0800 hours as usual ex-Gagidu by toyota truck to Poiya plantation at 0840 hours and the people of Kiwisuna and Tareko villages assembled at the said plantation.

Census and Electoral roll was revised for both villages. This is the last patrol completed at 1445 hours and ex-Poiya plantation.

I arrived Gagidu at 1520 hours. The few minutes I spent on checking over the Census figures. I stopped work at 1606 hours.

#### ROADS

The main road between Gagidu and Jivenang is good and it is maintained by the Finschhafen Local Government Council. From Jivenang and there onwards is a bush track which is kept clean in most cases. The area I patrolled is mountainous and the road is slippery. On occasion the road between Yunzein and Zafilio is not cleaned and not used for a long time.

#### VILLAGES

The places I visited, they were kept quite clean.

It would be very difficult for the members to visit their relatives but they would surely use the road for the visit and send it through the Local Government or other organization leaders in the village so that they would understand why their members could not visit.

In the rural areas the main cash crop is coffee. I have noted with cocaine (cocain), coffee, cacao and the cotton plant which is mainly introduced to the area purely to benefit the indigenous.

#### DRINKS

Much of the native or imported cocaine trees are used mainly in the coastal areas and so the coffee drying is concentrated in the coastal villages.

Some of the native trees were planted by Germans while the area was under the German Government. Now the trees are dried mainly by中国人 (Chinese) and they add some salt.

#### FOODS

Mostly coffee is grown in the village areas so mainly coffee. It is not eaten in the village areas except for all ages.

## THE STAGE OF POLITICS

5

In the early stage of the establishment of the Finschhafen Local Government Council in 1957, the people have been voting in every council election. They also participated in the last two House of Assembly elections. There should be no trouble in the next House election.

While on my patrol on revision of census and amendment of Electoral roll, the people understood what I was doing.

### THE PEOPLES ATTITUDE.

The attitudes towards the Administration and its Officials visiting is reasonable good. The people participated with the work of the Administration in these. The law and order was brought in on the first contact of the people until the present day so they seem to distinguish the policies in other activities.

### PANGU PATI.

This party has set up branches around the Finschhafen area. The minority of the men in each village have showed great curiosity in politics and some of these men have been practicing their ability in thinking in the council meetings. Although their ability in politics have not been mobilised yet.

The most of the political education in this area is done by the associates of the above mentioned party and the Administration. The Administration at this stage has not staffed one political education officer to the Finschhafen district yet. I think much of this should be done by the Pangu Pati and its associates.

### HOUSE OF ASSEMBLY MEMBERS.

In most cases, the people have been longing to see their honourable members of the House and some men have already lost confidence in their members.

It would be very difficult for the members to visit their electorate but they should summarise their work for the year and send it through the Local Government or Administration Officers to the people so that they would understand what their members job is like.

### THE ECONOMIC

In the rural areas the main ~~main~~ cash crops I have noted were coconut (copra), coffee, cocoa and the cattle project which is newly introduced to the area purely to benefit the indigenous.

#### COPRA.

Much of the mature and immature coconut trees are most noticeable in the coastal areas and so the copra drying is concentrated in the coastal villages.

Some of the mature trees were planted by Germans while the area was under the German Government. Now the big plantations are mostly owned by the Lutheran Mission and they make copra.

#### COFFEE.

This cash crop is planted by the village people in small holders. It is most noticeable in Yunzein, Zafilio and Uluor villages.

COCOA.

The cocoa has been introduced in this area a couple of years ago and it seems to be going very well although the minority of people only own small holdings. Introduction of this crop was bought in by AKUA society.

THE CATTLE PROJECT.

It is newly introduced to the natives of this area. The Lutheran Mission has been here for many years so they have a great number of herds of cattle in Heldsbach and elsewhere. The natives have shown a much greater interest in this project so the DASF extension officers are now advising the people.

BUYING AND SELLING.

This is done in few business associations. The FMDC buys copra and some coffee beans from the people who are non-members of the other associations.

The AKUA gets the cocoa from its members and non-members too.

CANTEEN.

Practically in every village the people have owned canteens in family groups. Only on few places you see Namasu Stores established for the people there.

I would say the people are very reluctant to run their own businesses as they have not gained the business making ability and experience.

SOCIAL

HEALTH.

The Local Government Council have built Aid Posts in several places for the people. Each Aid Post is staffed with one Aid Post Orderly. The Lutheran Mission have been running clinic centres in the places where there is a good road available for a truck.

The main hospital is at Buangi which is staffed by the Lutheran Mission and they get their supplies from the Administration. The T.B. Chest Hospital is at Butaweng in the Yabim census division. It accepts its patients from every corner of the Finschhafen District.

EDUCATION.

Since the Lutheran Mission was established here, the education of the people was done in Kotte language and Yabim was taught in Yabim areas. There is still village schools in existence, and a couple of places for mission primary schools, taught in pidgin and probably English.

The Administration has set up primary schools at Nanduo, Siki, and other primary schools in the Yabim area which accepts the children from either areas. It is most obvious that they learn English and pidgin in schools.

Most of the people who are in the villages can now read and write in pidgin or their own dialects.

MISSION.

The Lutheran Mission is the only one here which functions in religious matters and it also provides a good service in hospitals schools and plantations. Most of the people around here are very

respectful to their church and they know what their duties are in regard to the mission.

LANGUAGE.

The most outstanding language in this area is Kotte besides pidgin or their own dialects.

ACTIVITIES.

In the village level the women have formed womens clubs and hold basket ball competitions in the villages.

I imagine that they do simple things like making baskets, sewing, cooking, etc... The leaders of these clubs attend womens courses at Gagidu every end of the month.

TRANSPORT SYSTEM.

In the case of coastal villages the means of transport is very easy because of good truck roads to their places. The inland villages are the ones who do most walking to get their produce out to the market.

'FONGUNGBALONG' LAND INQUIRY.

While on this routine patrol I inquired from the Nanduo people about the piece of land known as 'Fongungbalong' which contains approximately 0.032 hectares which was leased to Namasu Company.

Refer to File No. 35-2-13 Application for Business Lease Mamasu of Nanduo for further information.

I ascertained that the said seven men who are the agents of this particular land had actually received \$10.00 in cash in the presence of them and the said kiap.

The declaration of Customs forms containing the names of the relations, needed majority signatures were unsuccessful. Most of these people are working in towns and in the case of females, they have been married and migrated out to their husbands places.

After the inquiry no queries were made.


FINSCHHAFEN PATROL REPORT NO. 4 - 1971/72

Herewith please find two copies of the above-mentioned report.

Comments by the Assistant District Commissioner adequately cover this patrol.

The attitude towards the Pangu Pati appears to contain the seeds of deflated expectations (i.e. things promised and benefits not received) and it implies the nostalgic sentiments of a Melanesian cult. I again wish to draw your attention to the proportion of absentees from the area; in this case it is 50% of the adult male work force.

Please note that the next patrol to the area will be dealing with council tax prosecutions and political education.

FINSCHHAFFEN PATROL No. 4 of 1971/72

Part KOTTE C/DIV.

Enclosed are three copies of a report on the above patrol submitted by R.T.J. Trumbull and A.G.C.

As the Census of the Kotte Division had not been revised since before the last House of Assembly elections, it was necessary to revise the census to enable the electoral roll for the 1972 election to be compiled.

The completion date for the electoral roll was moved forward and it became necessary to mount two patrols, taking half of the division each and concentrate on census revision and roll compilation to enable the task to be completed on time. The second patrol was undertaken by Mr. S. Arabata M.O (refer Finsch. 1/r 3/71-72). Information for area studies was not collected and other routine matters were left owing to the shortage of time.

The patrol achieved its objects, the roll has been revised and despatched to the Chief Electoral Officer; the census is now up to date.

I intended mounting a patrol through the entire Kotte Division as soon as the Council Tax team has finished its collection. This will deal with political education, tax prosecutions and routine administration. The interest shown by the people at Kawaining is encouraging and will be followed up.

It is hoped that the extension of the road network in the area will lead to increased marketing of vegetables from the mountain areas.

Illegitimate births are a feature of the Finschhafen area. Concern has been expressed in the Finschhafen Council and this body is considering ways and means of remedying the situation.

The discrepancy in the balance of census figures with the 1967 census is large, however, the present figure corresponds with the number of names in the register (Mr. Trumbull-ward should have commented on the results of his census more fully in his report). The natural increase of 1.5% (average over four years) is small. Some 50% of the male adult work force is absent from the area, mostly within the District.

Claim for camping allowance is attached. Claim for the accompanying policeman and report has been passed to the Off. -in-Charge Police at Finschhafen.

#### ECOLOGY

The majority of the areas are based on Arabica Coffees.

Strangely enough, no mention was given to coffee prices. However the people hope that the problem of transportation for their coffee will soon be solved as an airstrip is being constructed by the government near Hawaring and Samantiki villages.

It was noted in some villages that very small plots of vegetables had been planted, the owners said that they were trying out to see if it would be worthwhile to go into vegetable business.

It seems a pity that the fresh vegetables (tomatoes, onions, beans, cucumbers etc) that grow in the higher regions cannot be readily bought down to the markets when ripe, as I feel that if a market garden set up and some method of quick transportation was on hand an extremely lucrative business could be set into operation for an enterprising individual. Owing to the inability to readily obtain a good supply of fresh foods on the coast, fresh vegetables would improve the diet and probably the health of villagers living on the coast and there would be a ready market amongst the expatriates.

#### SOCIAL

A high incidence of illegitimate births was noted at Hawaring village. No comment was made by myself about this, but later I found out that house, the village committee suppressed their concern over this matter. It was suggested that the names of the offenders be taken down alongside the names of the founders and brought to the PROTECTION OFFICE with the view of holding a public hearing date to decide on punishment payable or other circumstances for the offenders.

At Hawaring was the first village visited. I wished to note the incidence of illegitimate births. All the village I visited displayed however, over exaggerated concern to the point of alarm. One man only laughed about it, said it was like a natural thing.

3

FINSCHHAFEN PATROL 4 OF 1971/72

Two patrols were mounted in the Kotte Census Division to expedite the compilation of a revised Electoral Roll in preparation for the House of Assembly elections in 1972. And to do a long overdue village census.

No difficulties were encountered on the patrol.

SITUATION REPORT

POLITICAL

At Mawaning village an expression of discontent with the "Pangu Pati" was passed to me. They felt that the Party was not doing all the things that have been promised by the Party and that they were not receiving any benefits from supporting Pangu. After the villagers talked amongst themselves for some time, they asked if a political education program or discussion could be delivered to them so that they could gain a better idea of how their Government operates, and what policies of the various political parties are and how they (the policies) are operated.

When asked the reason for their desires to have such a program they stated that with Self-Government and Independence not too far off they felt it was high time they educated themselves in the workings of the government and its constituent parties instead of blindly following the great majority of the Kotte people and voting "Pangu Pati" without really knowing why.

I assured the people that a program would be delivered on the next patrol through the area.

ECONOMIC

The economy of the area is based on Arabica Coffee.

Strangely enough, no mention was given to coffee prices. However the people hope that the problem of transportation for their coffee will soon be solved as an airstrip is being constructed (by the villagers) near Mawaning and Samantiki villages.


It was noted in some villages that very small plots of coconuts had been planted, the owners said that they were trying-out to see if it would be worthwhile to go into the copra business.

It seems a pity that the fresh vegetables (tomatoes, onions, leeks, cucumbers etc) that grow in the higher regions cannot be readily bought down to the markets when ripe, as I felt that if a market garden set up and some method of quick transportation was on hand an extremely lucrative business could be set into operation for an enterprising individual. Owing to the inability to readily obtain a good supply of fresh foods on the coast, fresh vegetables would improve the diet and probably the health of villagers living on the coast and there would be a ready market amongst the europeans.

SOCIAL

A high incidence of illegitimate births was noted at Hapahondong village. No comment was made by myself about this, but later, in the rest house, the village committee expressed their concern over this matter. It was suggested that the names of the unmarried mothers be written down alongside the names of the fathers and brought to the Sub-District Office with the view of holding Court on a later date to decide on maintenance payable or other alternatives for the children.

As Hapahondong was the first village visited I decided to note the incidents of illegitimate births in all the villages I intended visiting. However, when I expressed concern to the village committees they invariably laughed about it, said it was "samting nating".



The patrol was conducted by the Finschhafen Local Government Council Adviser to supervise one project - a classroom at Gunazaking village - from the council Capital Works programme. Mr. Elder notes the high percentage of absentees from the area - 63%. There is no record on where the people have moved or if that movement is permanent. I presume that many have moved to the coastal areas or to LAE.

In view of the lack of co-operation and the remoteness of the area it will be recognized that the council adviser has done a good job.

Mr. Elder fulfilled the objects of his patrol efficiently and successfully; I am sure his visit to this area and the display of interest in the people there will assist in maintaining good relations between the Council and the people.

FINSCHHAFEN PATROL No.5 1970/71

SPECIAL PATROL REPORT.

The object of the Patrol was to organise labour to carry building material from the Sattleberg Road head to Gunazaking village, where the Finschhafen Local Government Council is endeavouring to build a double class room and a teachers house.

1. HISTORY.

A class room and a teachers house was planned in the Finschhafen Local Governments 1969/70 works programme. Material for the above projects were trucked to the Sattleberg Road head at Mararuo village. The people from Gunazaking were told to come down and pick up the material, however this was not done and the material was bought back to the Council at Finschhafen.

This was the only project not completed in the 1969/70 works programme. This work has now been transferred to the 1970/71 Council Works programme.

2. REASONS OF FAILURE TO PICK UP MATERIALS.

- A. On reaching Gunazaking I found that the Councillor had not been in the area for three months. Although he was instructed to do so at Council General Meetings.
- B. The distance from Gunazaking village to Sattleberg is a three day walk through difficult mountainous country made more exacting by the wet season.
- C. Like other villages in the area there is evidence of absenteeism. The latest census figures (August 1971) showed 38 male and Females present between 16 and 45 years and 60 males and females absent in this same age group, 63% absenteeism.

3. ACTION TAKEN.

It was decided to involve all villages in the Mawaring circuit, as they have children attending the school at Gunazaking.

A relay system was employed as follows.

4. RESULT

By Friday 27th August all material had been taken from Mamanuo. The cement was difficult to carry and some of this was passed into bamboo tubes and carried in this manner, on the original plan the walls of both buildings were to be constructed in fibro sheeting.

Because of the difficulty of the journey I have changed this to flat iron which will be much more easy to transport.

#### CONSTRUCTION

At Gunazaking I found a local carpenter who worked previously in Madang. He came back to Finschhafen with me and has signed a contract to construct the classroom in a three month period. If he proves to be satisfactory the Council will offer him a further contract to complete the teachers house. The material for this is now at Gunazaking.

#### POLITICAL

#### LOCAL GOVERNMENT

The Finschhafen Local Government Council has constructed a school and a teachers house at Gunazaking in 1965, both with tanks.

The school is attended by both children in the Finschhafen Council area and the Pindiu Council area, Gunazaking being on the ~~border~~ border of both Council boundarys.

There is an Aid Post at Embawaning one hours walk from Gunazaking which is in the Pindiu Council area.

There is little else both Councils can do as far as Social Services are concerned. As mentioned previously it is situated in rugged country, three days walk from Sattleberg and a days walk from Pindiu Patrol Post. An ~~Access~~ road would not be practical from either side at this stage.



##### SANTABA



1345. Arrived Nanduo village after stopping for short times at Bolingbongen village and Nanduo Primary School.

6/10/71

Entire day spent at Nanduo village awaiting signatories to arrive to complete the signing of the Lease by NAMASU of a piece of land known as "Fongunbalong". Two signatures only were obtained.

7/10/71

0900. Departed Nanduo village for Sattleberg Mission Station.  
1200. Arrived Sattleberg. Landowners of the land adjacent to the Sattleberg Mission land not arriving until Friday.  
1300. Departed for Gagidu owing to ill-health.

The remainder of the patrol was completed by Mr. B. Henoa A.F.O., and Mr. S. Arabata T.P.O., due to my contacting a bad case of influenza which put me in bed for a few days.

FINSCHHAFEN PATROL NO. 6 OF 1971/72.

INTRODUCTION

The patrol was undertaken for two (2) purposes, firstly to endeavour to complete the papers on the lease of a piece of land known as 'Fongonbalong'. The 50 year lease was taken out by the NAMASU organization for the purpose of building a trade store in the village of Nanduo. The second was to contact the landowners of the land adjacent to the Sattleberg Mission land and arrange to walk the newly surveyed boundaries of the Mission land with them.

DETAILS

Business Lease, Namasu of Nanduo.

Land File: LA 8793 (NG).

DDA File : 35-10-6 (Finschhafen Sub-District Office File  
35-2-13)

Name : FONGUNGBALONG.

In January of 1971 the purchase of the land was made at Nanduo village, but unfortunately there was not sufficient signatures in the Declaration of Custom - the document was therefore returned for completion.

As stated in the introduction to this report, the object of the patrol was to obtain further signatures for the Declaration of Custom. A total of nine (9) further signatures were obtained, one (1) at Nanduo village, two (2) at the hospital and the rest (6) six at nearby villages. These nine signatures added to the ones obtained earlier are deemed to be sufficient for the Declaration of Custom to be declared complete.

An attempt was also made to obtain the signatures of the seven lessors on a receipt i.e. it appears that no receipt was written in respect of the ten dollars (\$10) paid for the lease of land when the transaction originally took place in January 1971. The form of the receipt is as follows:-

Only two (2) signatures were obtained from the lessors as the remaining five were away from the village at the time.

The Declaration of Custom is now complete, all the necessary paper work as required in the relevant file will be completed by Mr. B. Henao A.F.O.

Lands Titles Restoration: SATTELBERG.

Finschhafen Sub-District Office File: 34-1-7.

As I was taken ill at the time arranged to walk the newly surveyed boundaries I am not able to give an account of the actual walk which was completed by Mr. B. Henao A.F.O. and Mr. S Arabata T.P.O. (refer patrol report No.7 of 1971/72). The following is a resume of facts surrounding the situation at Sattelberg.

The final order dated 30/10/70 stated that the 550 hectares of land, as surveyed, is held Estate, ~~known as Sattelberg~~, in fee simple by the Lutheran Mission - Finschhafen. The native people felt that this was too much land for the mission to hold and that some of it should be restored to the people for the purpose of

extending their existing gardens. Consequently a new boundary was cut and surveyed with the resulting area being 162.9 hectares as compared with the 550 hectares as mentioned in the Final Order. This 162.9 does not include roads and the Posts and Telegraphs Repeater Station - the gross acreage including the roads etc is 168.3 hectares.

Mr. B. Henao A.F.O. and Mr. S. Arabata T.P.O. walked the newly surveyed boundary on the 11th, 12th and 13th days of October 1971. No disputes were voiced by the people at any stage. The final official function to be undertaken is an Appeal. The Appeal should be settled by a Consent Order adopting the boundaries as per the Mission survey provided that the native claimants agree to the boundaries. It appears that this will eventuate as the representatives of Clans concerned did agree with the boundaries as per the Mission survey.

Please refer to attached plans of "FONGUMBALONG" and "SATTELBERG" for a clearer picture of the pieces of land mentioned in this report.

The houses stand on rocky ground and all houses have a thickness of three to four feet. The walls are made of mud and stones and the roof is made of dried palm leaves. Some houses have a thatched roof made of dried palm fronds or dried grass and branches. Most of the houses are built to be permanent but some are temporary and are built over the old foundations of former houses. The roofs are made of dried palm fronds and the walls are made of mud and stones. The facilities of the village are very poor except for the church.

#### School

The Standard Primary School is in a very poor state of repair but despite the poor conditions the school is well attended. Parents are apathetic towards the school but they do send their children to the school so long as no one is sent to the school related to old but the parents want their children to go to the missionaries instead of the school. I feel that the parents should be encouraged and urged to take interest in the school so that the children would definitely not benefit from the school. The teacher in this will be addressed separately.

SITUATION REPORT

POLITICAL:

While at Nanduo village I informed the village committee that the House of Assembly elections would occur during February 1972 and that it was about time for each individual to decide or give consideration as to how they would be voting. I backed this up by saying that with self-government and independence only a matter of a few years away it is very important that the most suitable man as the elected member is the man who takes an interest in his country and its people, because within the term of the next House this country could probably see self-government which is a very important aspect of a young country's growth. Judging by the astounded looks and quietness of the village committee I doubt whether they had given any thought to that particular aspect of politics. I feel that an intense political education program should be drawn up and delivered to the people before the elections for the next House take place - possibly even before nominations for candidates are called. Naturally the program would have to be delivered to the entire Finschhafen area and not just isolated groups and villages if anything worthwhile is to be gained from the Finschhafen electorate.

ECONOMIC:

The Namacu store at Nanduo services the villages that are within a ~~two~~ three to four hour walk from Nanduo. The main items are tinned fish and meat, sugar, rice, biscuits, some tobacco and some other sundry items such as soap and salt. These items complement an already balanced diet of fresh fruit and vegetables. Weekly takings were unable to be obtained because the storekeeper was absent from the village and was not expected back for some time. If the meals served to ~~Meneq~~ and myself are any indication then it must follow that the people use the facilities of the store to its fullest extent for their own use.

SOCIAL:

The Nanduo Primary School is in a very poor structural condition, but despite the poor conditions the attendance is very good. The parents are apathetic towards the school but they will not hesitate to enroll their children - a strange set-up to say the least. No solution has been found for this problem and the Headteacher of the school related to me that he is at his wits end in trying to instil some enthusiasm into the people. I feel that the Education Department should be informed and asked to look into this matter as any friction between the teachers and the parents and/or between the teachers themselves would definitely not benefit the pupils in their academic career or in their will to achieve something worthwhile through hard work.


SITTELBERG MISSION LAND

Enclosed are three copies of a report on the above patrol submitted by Mr. T. Trumbull-Ward APO following his visit to the Sattelberg/Nanduo area of the Kotte Division.

The patrol was a special purpose one concerned with outstanding land matters. Mr. B. Henao APO accompanied the patrol and one objective was for him to give Mr. Trumbull-Ward some experience in land work.

Unfortunately Mr. Trumbull-Ward fell ill and was unable to complete his objectives. These were however, completed by Mr. Henao and Mr. S. Arabata IPO (refer P/R Finschhafen 7/71-72).

The papers relating to the Restoration of title to Sattelberg have been forwarded to Lae, I understand the appeal was to have been heard about 21st October 1971.

The papers relating to the Fongunbalong lease have also been forwarded to the District Commissioner.

I had hoped to patrol the Kotte area before this on a Tax Prosecution-Political Education patrol, however, the Council has not yet completed its tax patrols in the area. Mr. P. Elder, the Council Adviser intends patrolling the entire Kotte Division with the Council Tax team in November, he will continue the Political Education campaign it is then planned to follow this up with the tax prosecution patrol.

In my experience, assistance by the local people to schools in their area depends mainly upon the ability of the Head Teacher to arouse enthusiasm for their school- some teachers have 'got it' others haven't. Patrolling Officers will endeavour to support the Nanduo teachers in their efforts to improve the school.

Assistant Field Officer, Badira Tali Henao and I, Sturges Arabata - a Trainee Patrol Officer, accompanied him to ascertain the Sattelberg mission land boundary.

The patrol commenced on 11-10-71 to 13-10-71. We had done only a days trip out and back by truck.

PATROL DIARY

11-10-71

0745 hours I resumed duties at the office. 0830 hours I departed Sub-District office by Toyota truck accompanied by Badira Henao. 1000 hours we arrived at Sattelberg Mission Station.

Left the truck on the station and we began our task. We began from Maruruo/Sisi common boundary accompanied by Sisi representatives. Finished off at Sisi/Balanko common boundary. We left uncompleted.

1400 hours we departed Sattelberg and we arrived Gagidu at 1600 hours.

12-10-71

0745 hours I was at the office.

0860 hours we departed from the office by truck.

0930 hours we arrived at Sattelberg Mission Station. We left the truck on the station and we continued on from the previous task Sisi/Balanko, common boundary accompanied by the people from Balanko.

We reached the mark for Balanko/Masangko and this time the Masangko people accompanied us until we reached the mark for Masangko/Maruruo. We left uncompleted.

1430 hours we departed Setelberg by truck and arrived Gagidu at 1600 hours.

13-10-71

0745 hours I resumed duty at the office.

0830 hours we departed Gagidu by truck.

1000 hours we arrived at Sattelberg. Left the truck at the station. We continued on from previous Masangko/Maruruo common boundary. This time accompanied by the people from Maruruo and we ended up at the start again i.e. Maruruo/Sisi common boundary.



Then we followed the zig zag road on the side of the mountain to Gunabozing village at 0900 hours. 1030 hours we came up to Faseo old village and passed through to Faseo new village site at 1100 hours.

Enquired about the man named Ebu-Sinu and then we spent the night there.

### 22-10-71

0800 hours we departed Faseo village on foot. We followed the same track back to Yunzein at 1200 hours. Paid off the carriers and we spent the night here.

'FONGUNBALONG' LAND

This patrol was purely done to complete the Finschhafen Patrol Report No.6 of 1971/72 for the above mentioned piece of land. To gain more information refer to S/No 35-2-13 - Application for Business Lease Namasu of Nanduo.

The person named Ebu-Sinu who is the agent for the said piece of land is stationed at Faseu Village in the Dedua Census Division of Sialum. He has put his signature on the required forms for the agreement of Fongunbalong land held on lease for 50 years by the Namasu Company. He was not there at the time the Patrol Officer handed the money \$10.00 in cash to the people for the leasehold of the said piece of land.

The other person named Siali (Sali)- Desiang of Nanduo is at present working as a carpenter at Kainantu employed by Watkins Overseas company. The people do not know the definite address of this person yet.

The Hewani clan complained that they should have equal share in the amount paid for the said piece of land. The Havani clan received only \$2.00 out of \$10 and the Bililung clan received \$8 which the Hewani clan thinks is unfair.

Ebu-Sinu thinks that he should have some money. After all his name is included in the agents list who supposed to get the money on behalf of the clan group.

The attached report and comments refer.

1. The council adviser is an energetic builder. His proposals for development have been frustrated by a non-reacting society, not by the councillor. If the people wanted a new school complex with ancillary buildings, etc., they would take the initiative with construction and carry the building materials to the site. They have not done so and nothing is to be gained by putting the blame singularly on the councillor. The role of the councillor is, after all, expected only to reflect the activity and wishes of the people.
2. The attitude towards road building is, however, encouraging. Steps have been taken to assist the council for the supply of tools on the job. Competent staff will be available to advise on construction.
3. It appears that the estimates had already taken into account a substantial number of absentees (30% - 40% of the work force).
4. Two tax patrols have been mounted to obtain tax monies to date. If none had been arranged, I doubt if revenue would be anywhere near the estimates.

1. Councillor Sankara - Ward 11

This Councillor's lack of interest in the Gunazaking area has caused considerable ill-feeling in the area this year. It is apparent that he has no intention of carrying out his duties in his ward.

Mr. Elder appears to be requesting his removal under the provisions of Section 27 Local Government Ordinance. I would imaging that some resolution from the Council specifying the particular sins of omission supporting its allegation that he has:-

abused his powers;  
 is incapable of exercising his powers justly; or  
 for some reason is not a fit and proper person to  
 continue to be a member,  
 is necessary to support a request to the Commissioner for his removal.

2. Council effect on development of the area

The Council works program is well in hand. The people's volunteering to build a road from Sattelberg to Gunazaking is encouraging. Preliminary survey and the marking of gradients and alignment is absolutely essential before any work is actually done to prevent wasted effort and consequent ill-feeling.

3. 1971/72 Tax

The tax collection has been excellent, with no defaulter to date. The discrepancy caused by absenteeism will most probably not be made up, anyone who has not paid by now will be safely ensconced in the Lae town Council tax haven.

1. Suggest the Council takes action under Sect. 27 LGO and start proceedings for removal of Councillor Sankara.
2. DDA staff from Sub-District may be able to assist in route survey.

Information on Local Government Councillor Sankara of  
Finschhafen Local Government Council (Ward No. 11).

(1) The above Council decided to build a double classroom and a new teachers house at Gunazaking on the 1971/72 Works Programme.

Gunazaking village is situated in mountainous country three days walk from the Sattleberg road head on the border between the Pindiu and Finschhafen Local Government Councils.

In August 1971 (Finschhafen Patrol No. 5) I walked to Gunazaking to see why materials for the project were not being carried from the Sattleberg road head to Gunazaking. As reported in the Patrol Report Councillor Sankara had not visited the area to organise the people to carry the material although told to do so at previous General Meetings.

While there I organised labour in the area, hired a local carpenter on a contract basis and work commenced on the both projects.

On the Tax Patrol which I have just completed of the complete Council Area Kotte and Yabim Census Divisions, Gunazaking was again visited.

Cement and iron structures were completed in the double class room and the posts and floor of the teachers house finished. However work again had come to a standstill because material had not been carried from the Sattleberg road head. The carpenter had begun to cut bush timber for the job. Although the Council had sent the cut timber to the road head.

At Gunazaking I found that Councillor Sankara had not yet visited the site, although work has been carried out since August, and was told specifically by me when I returned from the Patrol 4 months ago and again during this 4 month period.

Unfortunately it is not only people who are sending children to school at Gunazaking, but also people in the Mape area, who get no benefit from the school at Gunazaking who are involved in the transportation of the building material. Again this time I organised people to carry material.

As pointed out in Patrol No. 5 (August 71) this Councillor has a business at Tigidu on the Coast where he spends most of his time.

In my opinion this Councillor is both a liability to his Ward (Number 11) and to the Finschhafen Council as a whole and I would like permission to hold a bi Election and have him replaced in the near future.

(2) Overall Council Effect on the Developement of the Area.

The 1971/72 Works Programme is continuing as planned. Some people in the Mape Area, (the interior) thought that too much money was being spent on the Coast. However it was explained that the Wareo Road was completed last year; this month the first car was able to drive to Nanduo Village; and that coronus would be put on this road in the New Year. It was suggested that a road should be put into the interior from Sattleberg to Gunazaking by the people of this area. I explained that the Council didnot have the money to do this at this time.


They then volunteered to try and build this road without pay if the Council would supply the tools. e.g. picks shovels, crow bars etc. It was encouraging to get a response such as this so we will endevour to supply the necessary tools and I will try and get a surveyor out before they start work on this road. Even if such a road could only be used in the Dry Season, it would be of enormous help to get coffee out of the arca; the main cash crop.

In conclusion the people are happy with the Council and I feel have a reasonable knowledge of its function and the benifits it offers them;  
by (1) The individual Councillors themselves,  
(2) The Council Newspaper "Kaya News",  
(3) Radio Morobe.

(3) 1971/72 Tax.

The 1971/72 tax estimate is \$15,500. We have to date collected \$14,000, all people having paid in the area, both Kotte and Yaobim Census Divisions.

The \$1550 discrepancy is due to absenteeism in the Area. People living in Lae and other large centres.



1. The council adviser is an energetic builder. His proposals for development have been frustrated by a non-reacting society, not by the councillor. If the people wanted a new school complex with ancillary buildings, etc., they would take the initiative with construction and carry the building materials to the site. They have not done so and nothing is to be gained by putting the blame singularly on the councillor. The role of the councillor is, after all, expected only to reflect the activity and wishes of the people.
2. The attitude towards road building is, however, encouraging. Steps have been taken to assist the council for the supply of tools on the job. Competent staff will be available to advise on construction.
3. It appears that the estimates had already taken into account a substantial number of absentees (30% - 40% of the work force).
4. Two tax patrols have been mounted to obtain tax monies to date. If none had been arranged, I doubt if revenue would be anywhere near the estimates.

Information on Local Government Councillor Sankara of  
Finschhafen Local Government Council (Ward No. 11).

- (1) The above Council decided to build a double classroom and a new teachers house at Gunazaking on the 1971/72 Works Programme.

Gunazaking village is situated in mountainous country three days walk from the Sattleberg road head on the border between the Pindiu and Finschhafen Local Government Councils.

In August 1971 (Finschhafen Patrol No. 5) I walked to Gunazaking to see why materials for the project were not being carried from the Sattleberg road head to Gunazaking. As reported in the Patrol Report Councillor Sankara had not visited the area to organise the people to carry the material although told to do so at previous General Meetings.

While there I organised labour in the area, hired a local carpenter on a contract basis and work commenced on the both projects.

On the Tax Patrol which I have just completed of the complete Council Area Kotte and Yabim Census Divisions, Gunazaking was again visited.

Cement and iron structures were completed in the double class room and the posts and floor of the teachers house finished. However work again had come to a standstill because material had not been carried from the Sattleberg road head. The carpenter had begun to cut bush timber for the job. Although the Council had sent the cut timber to the road head.

At Gunazaking I found that Councillor Sankara had not yet visited the site, although work has been carried out since August, and was told specifically by me when I returned from the Patrol 4 months ago and again during this 4 month period.

Unfortunately it is not only people who are sending children to school at Gunazaking, but also people in the Mape area, who get no benefit from the school at Gunazaking who are involved in the transportation of the building material. Again this time I organised people to carry material.

As pointed out in Patrol No. 5 (August 71) this Councillor has a business at Tigidu on the Coast where he spends most of his time.

In my opinion this Councillor is both a liability to his Ward (Number 11) and to the Finschhafen Council as a whole and I would like permission to hold a bi Election and have him replaced in the near future.

(2) Overall Council Effect on the Developement of the Area.

The 1971/72 Works Programme is continuing as planned. Some people in the Mape Area, (the interior) thought that too much money was being spent on the Coast. However it was explained that the Wareo Road was completed last year; this month the first car was able to drive to Nanduo Village; and that coronus would be put on this road in the New Year. It was suggested that a road should be put into the interior from Sattleberg to Cunazaking by the people of this area. I explained that the Council didnot have the money to do this at this time.


They then volunteered to try and build this road without pay if the Council would supply the tools. e.g. picks shovels, crow bars etc. It was encouraging to get a response such as this so we will endevour to supply the necessary tools and I will try and get a surveyor out before they start work on this road. Even if such a road could only be used in the Dry Season, it would be of enormous help to get coffee out of the area; the main cash crop.

In conclusion the people are happy with the Council and I feel have a reasonable knowledge of its function and the benifits it offers them;

(2) The Council Newspaper "Kaya News",  
(3) Radio Morobe.

(3) 1971/72 Tax.

The 1971/72 tax estimate is \$15,500. We have to date collected \$14,000, all people having paid in the area, both Kotte and Yabim Census Divisions.

The \$1550 discrepancy is due to absenteeism in the Area. People living in Lae and other large centres.



He performed quite satisfactorily and has the potential to be a good field officer - as he gets older and more experienced in exercising authority.





"The PANGU PATI, reported to the patrol as having in excess of 5000 members and supporters throughout the Finschhafen area, appears to be the only organisation concerned with Election Candidates, which has taken the trouble to solicit votes in the area visited."

"At GUNAZAKING, EMBENGWANING and MAWANING, the activities of PANGU Committee men from the Pindiu area, were reported to the patrol. In brief, these Committee men are reported to have advised the people from the above area, that the PANGU PATI, should it become the Government of this country, will provide the above villagers with the following:-

The objects of the patrol are:-

1. House of Assembly Elections

This patrol is in fact a continuation of Finschhafen Patrol No.11/71-72 which has had to stand down owing to the illness of Mr. T. Trumbull-Ward.

Obtain from Mr. Trumbull-Ward his itinerary, list of candidates and Polling program for the 1972 elections. In each village, advise the people of the names of the eleven candidates for the Finschhafen Open Electorate, and the two candidates for the Wroke Regional Electorate. Care should be taken to avoid any discussion on the relative merits of the various candidates political parties, or doing anything that could be interpreted as supporting or opposing any candidate.

Advise the people of the polling program and ensure that they know where the polling places will be and on what days they will be open. Warn the people that carriers will be required and that rest houses should be repaired if necessary.

Identify the various ward committee members and advise them that they will be required to attend the election patrol while it is in their respective wards and sit as Voter Identification tribunals.

2. General Administration

Check all firearms in each village and compile a list of all shotgun owners and permit numbers for Police station records. Any unregistered shotguns should be reported to the police.

Endeavour to locate any Medical Tultuls still alive in the area and compile a list of their names and years of service.

Hear and settle any disputes brought to notice.

On completion of the patrol submit as soon as possible a report in accordance with the Secretary's 67-1-0 of 25th November, 1971.

1. House of Assembly Elections:

Finschhafen Patrol No. 13 of 1971/72 was mounted as a continuation of Patrol No. 11/71/72, which had to stand down owing to the illness of Mr. T. Trumbull-Ward, Assistant Patrol Officer.

The generally good reception afforded the patrol was marred slightly by the fact that advice in respect of the itinerary of the discontinued patrol had unfortunately not reached many of the villages visited and several of these villages received the patrol after little or no advance warning of its arrival. Notwithstanding, the great majority of the people normally resident in their home area were contacted, although in order to achieve this, an extra day was spent at the MAMBA Aid Post/Census Unit site, awaiting the arrival of various adjacent groups.

Care was taken to ensure that all groups visited were fully advised of the eleven Candidates for the Finschhafen Open Electorate and the two Candidates for the Morobe Regional Electorate. There was no discussion on the relative merits of the various Candidates, political parties and nothing was said in support of, or opposition to, any Candidate or political party.

The people were advised of the Electoral Polling programme as it concerned their area and location of the Polling Booths was fully explained. Advice was given as to the Polling dates at the various Polling Booths. Those groups who will be asked to provide carriers to support the Election patrol were so informed.

Rest Houses generally, are not impressive throughout the area visited and in a number of villages, the people were asked to effect necessary repairs prior to the Election Patrol. Whilst most Census Units have Police Barracks in evidence, their average condition was one of decay. Much work will be required to restore these Barracks buildings to an acceptable state and in as much as the Election Patrol will require the use of these buildings, the people were asked to proceed to this task with some urgency. The above requests were met with approval by the people concerned. The lack of real warning of the arrival of this patrol in many of the villages gave this Officer the opportunity of seeing the villages in their normal state and as a result, it will be recommended that the Rules Inspector of the Finschhafen Local Government Council proceed to inspect the area at the earliest possible time in pursuance of the requirements of the Hygiene and Sanitation and other relevant Rules of that Council.

All Ward Committeemen in the area were contacted and advice was given as to the requirements that they sit as a Voter Identification Tribunals in their respective wards during the Election Patrol. All were happy to perform these duties.

have been drawn between the pro and anti PANGU blocs. No PANGU Committeemen from the Finschhafen area came to the notice of the patrol and it was observed that opposition political parties appear to be unrepresented in the area visited.

Towards the end of the patrol, specimen ballot papers for both the Open and Regional Electorates concerned, complete with photographs of all Candidates became available and the identification of Candidates to the voters was greatly facilitated. The people generally regarded this innovation, along with the reduction of the voting age to 18 years with much approval. It appears that use of the whisper ballot will again be in great demand.

Within the Morobe Regional Electorate, only one of the two Candidates, BOYAMO SALI, a PANGU representative and local to the Finschhafen area, was recognised by the voters. Within the Finschhafen Open, some confusion has been caused by the fact that the list of Candidates contains the names of several men known to be sympathetic to the PANUU cause, which I must believe result in preferential voting on a favourite son rather than on a party basis.

2. General Administration:

All firearms in the area visited were asked to be presented for inspection. Appendices "A" and "B" attached contain the necessary details. Unavoidably, some firearms were not seen due to the Owners absence from the area. In two cases, it was necessary to direct owners of unregistered firearms to report with the said shotguns to the Finschhafen Police Station. The Officer-in-Charge of the Police Station has been advised fully of these cases.

A total of ten retired Melville Tulu's from nine villages were located and information in respect of their names and years of service has been received by Sub-District Office staff for processing.

No disputes or complaints of a serious nature were brought to the attention of the patrol and in three cases only was it necessary for me to mediate on matters of minor consequence. Each village was advised that the services of a Magistrate were available should they require same.

It was my practice in a number of villages to hold informal meetings at night for a couple of hours with Committeemen, village leaders and any interested persons. The matter of political development towards Self Government, generally regarded as being just around the corner, was the topic most often raised by these people. I found a great deal of confusion in evidence about the significance of the terms Self Government and Independence. My explanations on these and other queries of political nature were greatly facilitated by reference to the excellent Administration produced booklet, "Towards A United Country".

responsibilities. These Committee men are often in attendance at Council Meetings.

I strongly recommend the ~~redrawing~~ <sup>redrawing</sup> of the ward boundaries to include a separate Council encompassing GUNAZAKING, MAWANING and BOKASU villages in order to combat their present sense of neglect and isolation. This ward could also include the village of EMENGWANING within the Pindiu Council area, but administrated from Finschhafen. These people have a close affinity with GUNAZAKING. SAFIFI village, within the Pindiu Council area but administrated from Finschhafen has recently transferred its location to a site nearer Pindiu and could be administrated wholly from that Patrol Post.

An airstrip located at YOLLINOC near the MAWANING hamlet of QUQUQC, was inspected and found to be favourable. The ward Committee men of MAWANING, claims this airstrip project came about as a result of encouragement from a previous ADD and RDC. Two previous trial locations have been rejected as unsuitable. Although to date, only the MAWANING people have worked on the project, promises of assistance have come from BOKASU, GUNAZAKING and EMENGWANING villages. The strip has dimensions of at least 1700 by 100 feet and the approaches are clear across a valley. The strip would be one way operations only. I advised the people to carry out certain clearing work and the strip will be re-inspected during the Election Patrol. If the work as advised, is completed by the next inspection, the road will be open to fully report on the matter and request a DCA evaluation of the airstrip's potential. As the Councillor for that ward has expressed little interest in the project and the people intend to request the Finschhafen Council to allocate funds for the project in 1972/73, considerable animosity has been directed towards the Councillor for his lack of interest and concern. The airstrip upon completion, should greatly decrease the isolation of the area.

With proper local government representation along the lines suggested, political stability should return to the area. Both GUNAZAKING and MAWANING groups are determined that whatever happens their incumbent Councillor will not be returned at the next elections. It seems that failing implementation of the change in ward boundaries recommended above, the above two groups will only be satisfied, once the Councillor is elected from their respective villages.

Camping Allowance claims in respect of Trainee Patrol Officer, Mana HAWAWE, who accompanied Patrols, 11 and 13, have already been submitted.

In addition, Trading Licences in respect of all Trade Stores were checked, where the owner could be located and no irregularities were discovered.

Politically, the area visited appears stable and I believe much of the credit must be directed towards the influence of the Lutheran Mission which is unchallenged in the area. The comprehensive road network is another contributing factor, as is the apparent progressive nature of the Finschhafen Local Government body.

Encroachment by other Mission organisations on this Lutheran preserve is an unlikely eventuality and it is interesting to note the complete lack of success garnered by the Seventh Day Adventists, who, through the agency of a KEN PATI, of TIRIMARA Village, have been for the past two years, engaged in wooing the local people to their cause. KEN PATI has met a solid wall of opposition and in one case near violence, and that organisation is withdrawing to greener pastures. Not with standing, there is an undercurrent of resentment directed at the extensive land holdings of the monopoly mission organisation, of which I believe that body is aware and is taking steps to combat the problem.

The one crack in the political stability of the region occurs at the boundary of the Finschhafen and Pindi Council areas and I refer specifically to Wards 11 and 12 of the Finschhafen Council area. There is unrest in the villages of GUNAZAKING and MARANING, but the cause is primarily one of lack of Local Government representation. Ward 11 <sup>population</sup> encompasses c. 682. The Councillor is a BEING man and whilst the BOKASU people are moderate on the issue, the people of GUNAZAKING complain bitterly that their Councillor neither visits them nor evinces any interest in their local government problems. This is particularly unfortunate as the Finschhafen Council has invested large sums of money towards the construction of a permanent material double classroom and a permanent material Teacher's house on the GUNAZAKING Primary School project in this financial year. The contract carpenter, a GUNAZAKING man, is currently struggling with the inconvenience of under-supply of needed materials to complete the projects, although he states he has furnished the Council Clerk with a list of the materials he urgently requires. The BEING Councillor is reported to be showing no interest in that project. Infact, only the GUNAZAKING and MARANING people have in the past, carried materials overland from the MARARUA Roadhead to the project site.

At Ward 12, encompassing MARANING, SAMANTIKI and FONDENGKO villages, a similar lack of representation is apparent, in as much as the MARANING people claim that their Councillor, resident at SAMANTIKI, neither visits them nor properly represents them within the framework of the Finschhafen Council. At both GUNAZAKING and MARANING, there is a noticeable atmosphere of isolationism from Council activities, compounded by the fact that these two villages are the farthest distance from Finschhafen. The Ward Committee men of GUNAZAKING and MARANING are the practicing political representatives of the people at the local government level and each actively and overtly criticizes his respective Councillor for failing in his

The people generally greeted with dismay, the realisation that eleven Candidates were contesting the Finschhafen Open Election, proclaiming at the same time, their collective inability to mark their preferences in respect of all Candidates. Infact, a number of the Candidates were unknown to the average villager. It will, I expect be a rare instance, where all contestants receive preference votes.

Copies of the Polling Programme were left at all proposed Polling Booth locations, normally with the Ward or Village Committeemen. These gentlemen promised to inform any people not seen by the patrol, about information contained in the Programme.

The PANGU PATI, reported to the patrol as having in excess of 5000 members and supporters throughout the Finschhafen area, appears to be the only organisation ~~with~~ concerned with Election Candidates, which has taken the trouble to solicit votes in the area visited. In fact, on a general basis and more particularly in the area of BOKASU, EMBENGWANING, GUNAZAKING, MAWANING and SAMANTIKI villages, it was not hard to detect a tenous, yet significant division of the people along pro and anti PANGU PATI lines. Many people appear to have withstood the exhortations of PANGU Committeemen to become financial supporters of that political party and those withstandees have I believe, adopted a hardened attitude towards present members of that party.

At GUNAZAKING, EMBENGWANING and MAWANING, the activities of PANGU Committeemen from the Pindiu area, were reported to the patrol. In brief, these Committeemen are reported to have advised the people from the above area, that the PANGU PATI, should it become the Government of this country, will provide the above villagers with the following:

1. Free materials for the construction of permanent houses in all three above villages.
2. A significant reduction in current Local Government Tax Rate.
3. An immediate airstrip and road network in the area.
4. A significant reduction in the price of store goods in the local Trade Stores.

Non members of the said party regard the above with disbelief; a contributory factor in their observed anti PANGU stance. In reply, it was pointed out, that these claims were not in accordance with the PANGU Electoral Platform and the people should seek out and determine the truth about what in fact, that political party actually stands for and decide on the merits of that party accordingly. I understand that the Assistant District Commissioner is fully informed of the above and has the matter in hand. In the light of the situation described above, it is difficult to foresee the PANGU PATI increasing its membership in the area as the lines



HOUSE OF ASSEMBLY ELECTIONS- YABIM DIVISION

YABIM CENSUS DIVISION

The Yabim Census Division is made up of the coastal strip from Heldsbach Mission Station fifteen miles north of Gagidu to Tigidu village some twenty-two miles to the south of Gagidu.

Polling started at 8am on the 19th February, 1972, at the Finschhafen Council Chambers all villages were covered in the Yabim area as per Field Officers Journal (attached), the team returned to Finschhafen Council Chambers on 7-3-72 where it remained open until 1800 hours on the 11th February thus giving people who were unable to vote during the patrol an opportunity to do so.

POLLING

The new type of ballot papers with photographs were an improvement, identification of candidates being made more simple.

It will be an interesting exercise to see if the percentage of informal votes had risen compared to previous years. I believe the photographs encouraged people to fill in their own ballot papers, how successful they were, remains to be seen.

On the whisper vote I noticed very few people went beyond first or second choice. Finschhafen Open having eleven candidates.

On the Regional Vote I would estimate 70% (Whisper Vote) of voters did not attempt to mark the ballot paper. The reason being neither candidate had campaigned in the area and consequently were virtually unknown.

VOTER IDENTIFICATION TRIBUNALS

These were used throughout the election at village level in a rural area, it was found that the people voted as a village, consequently they had little work to do in identification. Where I found them to be useful was in establishing the correct age of the younger voters. With the voting age reduced to eighteen this year quite a number of people voting for the first time were not included in the Common Roll.

(Information not of a situation report nature)

Reduction in the voting age was well accepted. It was  
thought that if a person had to pay council tax then they had the  
right to vote.

VISITORS

On the 22nd February 1972 at Buangi Hospital Polling Station we were visited by members of the Australian Press. Polling was observed for about forty-five minutes.

On the 2nd March 1972 at Malasiga Village we were visited by the United Nations team. Polling was observed for 60 minutes. They appeared to be satisfied as to how the election was being conducted.

There were no incidents of any nature during the patrol. I would estimate that 95% of the people eligible to vote did so in the Yabim Census Division.


3. I anticipate now a factual report on the potential development and potential use of the airstrip site at KONEDGBU. This report should include an estimate of all costs of construction.

Situation Report (Extracts) - Elections

"Ballot Papers: It now remains to head up the instructions in Pidgin rather than the English language. The instructions should be bold, simple and comprehensible to the average voter, which is not the case at present. Very few voters can understand the instructions on the ballot paper as they now stand and few bother to read same."

Common Roll: Where demand for Section 130 (1) voting procedures reached a peak it was found that the names of a number of elderly folk, who had voted in 1964 and 1968, were not on the Roll.

Voter Identification Tribunal: Again, many young people of both sexes who, as a general group, showed much interest in voting had to be referred to the Tribunal for a decision on their eligibility to receive a ballot paper.

"Because the Electoral Roll was an incomplete document containing many omissions, there was a great need for the Tribunal which proved an effective and necessary body."

Assessment - Assistant District Commissioner

It is high time a critical examination was made of all electoral forms and notices and an imaginative redrafting of them made.

2. It is clear that after eight years the electoral rolls create more problems than they solve, particularly with the insistence on having them compiled in alphabetical instead of the normal family order as is done for census and Council elections, although the same register is used as a basis for both Electoral Rolls.

Assessment - District Commissioner

After years of census revision, maintaining council registers and various other village records of birth, etc., we have not overcome a problem of personal name identification. Less sophisticated people have customs of name changing; or, alternatively, they cannot understand our attempts to interpret and pronounce correctly, the names previously recorded.

This problem is highlighted in the Common Roll. Attempts have been made to explain this as 'typographical errors' or 'printer's errors'. (No doubt this occurs sometimes.) However, local people do appear to forget, or to change their given names.

It is questionable that the Common Roll will be universally maintained in the future. Projected urban migration figures suggest that the number of eligible voters in the town will increase dramatically. The cost of maintaining an efficient registry is probably beyond the resources of a developing country.

A hard look should be taken now to examine the present efficiency and cost of the existing register, its defects, duplicity and its future.

Three alternatives to the Common Roll have been suggested:

- (a) Identification Card
- (b) Council Tax Ticket
- (c) Indelible marking of the Voter.

In fact electoral teams for years have been using the system unofficially to verify the credentials of voters - in one way or another.

Again it is clear that even after eight years the electoral rolls ~~are~~ create more problems than they solve, particularly with the insistence on having them compiled in alphabetical order instead of the normal family order as is done for census and Council elections - little trouble is found in running Council elections, although the same register is used as a basis for both electoral rolls.

SUBJECT : VOTER IDENTIFICATION TRIBUNALS:

Twenty-three Ward Committeemen sat as Tribunal members in fifteen Polling Places. Each one presided within his respective Council ward and all were recompensed.

This is hardly a new conception. It has been usual for years to refer matters relating to Voter age and identification, Census problems and myriad other queries to Ward Committeemen for confirmation and elucidation, and this practice would have been naturally followed in these elections.

It is sufficient to say that reference where necessary to the Tribunal on matters of voter identification facilitated due process and enabling reasonable decisions to be made, particularly in relation to Regulation voting.

The Tribunal was invaluable in sorting out the exhaustive yet incomplete electoral roll. At MANGA Aid Post and LANITZERA Polling Places, where demand for Section 130 (1) voting procedures reached a peak it was found that the names of a number of elderly folk, who had voted in 1964 and 1968, were not on the roll. Again, many young people of both sexes who, as a general group, showed much interest in voting, had to be referred to the tribunal for a decision on their eligibility to receive a ballot paper. A number were rejected on grounds of immaturity.

Because the Electoral Roll was an incomplete document containing many omissions, there was a great need for the Tribunal, which proved an effective and necessary body.

SITUATION REPORT - FINSCHHAFEN LOCAL GOVERNMENT COUNCIL

The Council has been operating for almost 16 years.

According to my view, some Councillors, mainly those elected for the first time, do not really know the aims why they were elected to the office. Apparently they become reluctant to offer anything at Council meetings. Others were even criticised for failing to attend to their duties as Councillors - they do not even know much about their own Wards.

It is understood that this problem cannot be solved unless Councillors are made fully aware as leaders of the group and that it is their responsibility to approach their people in order to settle their worries.

Some complaints made about Councils included:

1. Water Tanks. The Council was asked to put up new water tanks or replace those in poor condition.
2. Education. Teachers complained that payments/ rents for the houses built by the Council - they indicated that rents cannot be settled due to poor accommodation provided.

It has been felt by the Patrol that rules passed by the Council are not properly enforced.

It is felt that the people in this area have a strong political awareness, due to the numerous visits made by Administration officers, Members of the House of Assembly and some Members of the visiting Missions of the United Nations; also others from mission and business sectors.

However, with regard to their Member representation of Finschhafen Open Electorate, there has been some criticism. It was explained to them that at the moment nothing can be done and they would have to wait until the next General Election is held.

It has been noticed that most people are associated with the Pangu Party.

I gave an explanation for all questions concerning the present Coalition Government and an explanation of Self Government and Independence. The Assistant District Commissioner has been consulted on promoting political awareness through the Local Government Council. He has agreed that seminars be arranged in liaison with officers of the Administrators Department.

COMMENTS: District Commissioner

There were eleven candidates who nominated for the ~~FINSCHHAFEN OPEN ELECTORATE IN THE~~ last House of Assembly Elections. As there were no ~~patrols~~ successful candidates from this area, it can be anticipated that some dissatisfaction would arise.
