Mr. McNeil evidently has used one fourth inch of water during the month of May, and at the same time, he has no rights whatever, and has not bought the Weatherbie Ranch that has a water right. Under the circumstances, it would be impossible for us to furnish Mr. MoNeil with water for irrigation purposes, and if such is the case, the water to Mr. McNeil should be immediately shut off.

Also we are enclosing a bill for the water used in May which we would ask you to present to Mr. McNeil and have him give you his check.

If we had the water in our reservoirs, we would be only too glad to accommodate Mr. McNeil, but as it is, from the 15th of May, we put every consumer on one half supply, and unless we get rains before this year closes, it will be necessary to make a further cut in the supply.

Herewith please find Book of Rules and Regulations approved by the Railroad Commission lust year. Kindly read Rules 5, 8.1/2 and 9. In order that your delinquent consumers do not work a hurdship on those who pay their water rentals, I suggest that we arrive immediately at some understanding as to turning off these delinquents on the 21st of the month rather than make the ones in good standing suffer as a consequence of the nonpayment of the others as you will see by the rules may result.

Is it my understanding that your Mr. Berry is authorized to make turn offs for non-payment of bills each month and keep said water off until the consumer shows a receipt in full for bills since Juke 30th last year or a receipt for the preceding month in case he is delinquent as mentioned in Rule 5. I suggest that you write us a letter along these lines so that we can deal directly with such agent and endeavor to keep such accounts in good standing, starting say with the 20th of June.


