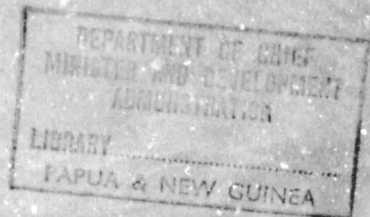

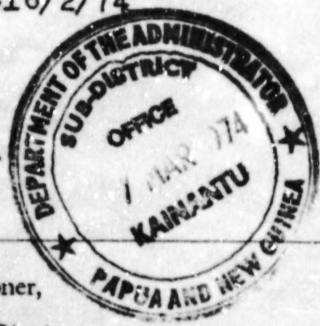

OBURA PATROL NO. 5/73-74 - WAFFA VILLAGES AND LAMARI COUNCIL

Receipt is acknowledged with thanks of the above situation report, submitted by Mr. Patrol Officer, A.P. Friend and your covering comments.

I am inclined to support your suggestion, that only the TUBUNA and SIAGA group of villages should be tested out for a trial period of 12 months, in joining the Obura administrative area, because other villages in the Waffa Censu Division did not show great interest on the proposal.

After the trial period, the situation could then be reviewed to ascertain whether or not the Obura people and the Waffa people reach any agreement for the latter to be administered by the Obura Patrol Post.

You are already aware that there has been suggestion of a probable inclusion of all, or part of the Piara Censu Division in the Lamari Council area in the near future and the problems the Council will face, owing to the almost lack of economic development in this area, I would consider that neither the Council, nor the Waffa people will benefit anything if the latter is also included at or about the same time.

The District Commissioner, Morobe District, will be approached to give his considerations and advice on our proposal. At this stage, no action will be taken until advice is received.

It is, however, anticipated that if the proposal is adopted to have the two groups administered from Obura, assistance for the construction of the road link through AHEA could probably be obtained from the Rural Improvement Funds with the Patrol Officer in charge, Obura as sponsor. Although this would add to the already overous burden on the officer in charge, I foresee no other alternative if the proposal is adopted.
