The future of child care in California largely depends upon SB 863, the Sieroty Bill, currently before the State Senate Finance Committee, having passed through the education Committee.

This bill would implement recommendations of the Report of The Riles Commission to Formulate a State Plan for Child Care and Development Services in California, 1979. It would provide new funding for infant care and for those most in need (migrant laborers, teenage mothers, etc.). It is the only bill providing new funding for child care. (Of the 400,000 children in need of some form of child care, only 15,000 are now served.)

Because of Prop. 13, and the likely depletion of the state surplus in the next year or so, it is critical that this legislation be enacted now. It will need to pass the Senate Finance Committee and the full Senate (by a two-thirds majority.)

Please write your own State Senator and Assemblyperson, as well as key members of the Senate Finance Committee. Address all letters or telegrams to the State Capitol, Sacramento, CA 95814. Key members of the Senate Finance are: Albert Rodda, William Campbell, David Roberti, Jerry Smith, Walter Stiern, Nicholas Petris, and William Greene.

Stress the importance of the bill in keeping families with marginal incomes working. And remember, legislators do consider their mail; even one letter will have an impact.

REGARDING: Closing of Rathskellar Editorial

On October 10, 1979, the Associated Students of UCSD approved the following editorial, to be submitted as a letter to the editor of The Daily Guardian and distributed to the College Councils for support:

The Rathskellar Taco Shop was the focus of an \$85,000 overhaul of the Muir Rathskellar (formerly the Muir Five & Dime). The overhaul was completed Winter Quarter of 1979, and the facility opened for business Spring Quarter. In the six months of it's operation, the Taco Shop served students, faculty, staff, conventioneers and summer campers, and developed quite a following of regular customers. The reasons for it's popularity were apparent: the food was delicious, nutritious, plentiful and well within even the poorest of students' budgets. The Taco Shop served chicken, beef and cheese tacos, tostadas and enchiladas (examples of the pricing are: one item for \$.70 or two items with rice and beans for \$1.60).

Why would such a place be closed? According to Larry Barrett, director of Housing and Food Services, the Shop was closed due to operational and financial problems. He explained that the quality was inconsistent and that to alleviate the problem, a full time cook would have to be hired, making the operation too expensive. For that reason, the Shop had been closed to explore other options; namely, the new Teriyaki Shop (according to Barrett, the new shop is a temporary measure).

We find these arguments to be hardly persuasive. The operation of the Taco Shop was a very straight forward and profitable operation. The shop flourished. As far as quality

consistence is concerned, among the Taco Shop's regular customers there was not a complaint to be heard. A petition placed in the Rathskeller for two days collected over fifty names of customers wanting the return of the Taco Shop.

The campus food facilities are here to serve a very specific clientele; namely, students, faculty and staff. It is the job, and should be the intention of food facility management to cater to this specific clientele. The closing of the Taco shop displayed a lack of such an intention in the new management of the Rathskellar, and showed that personal interests are the criterion for operational decision making. It is the hope of the A.S. Council that before the "temporary" status of the new Teriyaki Shop becomes "permanent," popular student, faculty and staff opinion will be solicited, possibly through the Housing and Foods Service Advisory Committee, and that all decisions will be based on that information.

The Rathskeller is not the Coffee Hut - it has it's own personality, and likewise it's own features. If Holly Holmes wishes to add something, that is positive and welcome, but to take away the Taco Shop which has taken so much time and money to develop (and pleased to many customers) - that lacks our accord.

Purpose:

- 1) To evaluate the student need for an Activity Fee increase.

- 3) Having evaluated a need for an analysis of the Activity Fee increase, the Task Force will submit findings, recommendations and petitions to the ASUCSD Council for consideration of recommendations.
- 4) The Task Force will report back to the ASUCSD Council no later than the seventh week of Winter Quarter.

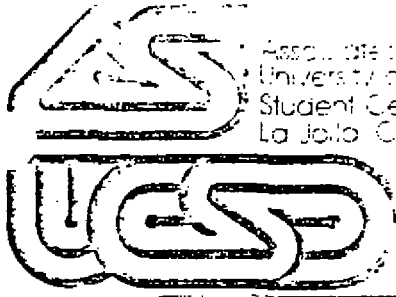

Speech given by Carlos Montalvo to the City

SUBJECT: CASE NO. TM 79-464 (La Jolla Village)

On behalf of the Associated Students of the University of California, San Diego and our concern for the students, staff and faculty, I am requesting the Planning Commission to demonstrate foresight regarding the importance of UCSD to the community by acting to halt the rapidly accelerating trend of condo conversions that places community living conditions beyond the reach of the students, faculty and staff it was originally intended to serve.

I strongly protest the planned conversion of the La Jolla Village Apartments on the grounds that this proposal is in violation of the 1971 University Community Plan; a plan which was unanimously approved by the San Diego City Planning Commission. As stated in the Master Plan:

"A complete range of housing types must be provided recognizing the importance of the University oriented population and others working in the Plan area. The University community should not become a bedroom community for the City of San Diego.

Housing of a variety of price ranges must be interspersed throughout the community to insure adequate housing availability and balanced distribution for students, employees and others with low and moderate incomes (p. 22).

The environment is of great importance in the development of the University Community. Every effort must be made to see that the best environment possible is created.

The city should develop and adopt a specific policy that would require all major residential developments to include a significant portion of their units for low and moderate income housing. The amount of these units to be provided should be based on objective studies of the need for such housing. These units must be integrated into the total development and not clustered in isolated areas." (p. 28)


Of the approximately 1,017 rental apartment units left in the area, 657 (two-thirds) are now being considered for reconversion. Even this figure of available units is way below the 3,231 housing units recommended for student dwellings by the 1980 outline in the University Community Plan. Of the 500 units at La Jolla Village, 100 units are housed by students. Reconversion, therefore, is directly affecting the pursuit of academic excellence and wellbeing of 200-300 students.

The reconversion will also affect a comparable amount of staff and faculty in these units. In many ways, the reconversion reflects economic realities of the times. The University of California has moved to meet these pressures by pursuing a rapid on-campus building program. UCSD already has the largest percentage of on-campus housing of any UC campus in the system. Nevertheless, the lack of adequate on-campus housing has a waiting list that extends into the hundreds. The injustices and hardships that are being imposed on our community can only be solved by a equal commitment on the part of San Diego. A commitment which has, in the past few years, been negated.

With no current plans to build low-cost housing in the area, elimination of these apartments pushes the housing shortage in this community at a crisis level. Presently, La Jolla realtors have already placed the selling price at \$125,000 for a 710 sq. ft., one bedroom to \$132,000 for a 1112 sq. ft. two bedroom unit. Even though some of the units will be reserved as rental units, the proposed reconversion will no doubt inflate the existing rental price of \$335 for a one bedroom and \$425 for a two bedroom to levels that will be well out of reach of the community they serve.

In closing, it is apparent that the subdivision board has not taken into account the full merits of the University Plan in recommending the La Jolla Village Apartments conversion. I ask the commissioner to reject this proposed condominium conversion and work along side the University in its effort to preserve the uniqueness and mandates of the University Plan.

REGARDING: Daily Guardian Account Policy

The following guidelines shall constitute the ASUCSD Council policy between the ASUCSD Council and the Daily Guardian, which may be amended at any time by approval of the Council according to its Bylaws, and which shall terminate June 30, 1980. The \$10,000 account with the Daily Guardian shall be effective immediately upon passage of this policy:

- A. All advertising for the 1979-80 Activity Fee shall be purchased at the agreed upon lower rate, retro and proactively.
- B. Josie Hollinger and Harry Tolen shall maintain ledgers to keep current track of pages used by each user; no user shall, therefore, receive more ad space than has been issued to them.
- C. Josie Hollinger shall give the written approval to the user who shall then submit that to Harry Tolen with their advertisement. Josie Hollinger must have 24 hours minimum notice of the ad. Harry Tolen shall not accept an advertisement until this written approval is submitted.
- D. No program shall receive more than one-quarter page per event and/or per week; supplemental allocations must receive recommendation from the Finance Committee, and from ASUCSD Council only when a consensus in committee cannot be reached.
- E. No unit (of the three listed below) shall allocate more than one-third of its total allocation per quarter. A mandated reserve must be maintained within each of the three units.
- F. The user's Ad Allocation shall be formulated in conjunction with their budget allocation, and determined on a programmatic basis.

G. The Daily Guardian shall be used for fundraising programs and underwrites, whereas the Bulletin Board shall be used for free events, meetings and announcements, and Appointments and Evaluations recruitment. A concerted effort between the Commissioner of Public Relations and the user must be made to coordinate advertising prior to the event.

H. The following base allocations shall be given to each of these units, pages are to be distributed in the following ratios:

Student Organizations	=	25 pages
ASUCSD Bulletin	=	25 pages
ASUCSD Council	=	<u>17 pages</u>
		67 pages

I. The Activity Fee Board will have the responsibility of allocating the Student Organizations share of the Daily Guardian allocation.

A. Limit of 1/2 page on underwritten ads

B. All proposals must be made to the Activity Fee Board one (1) week in advance of the requested publication.

J. All unused Guardian pages at the end of the 79-80 fiscal year shall be carried over to the next fiscal year pending either agreement by the Daily Guardian or change in Guardian account policy Item E.

2. No candidate shall man the polls.
3. No organization who endorses a candidate shall provide workers for the polls.
4. There shall be no loitering at the polls.
5. The locations of the polls shall be publicized before and during the elections. Poll locations must not change after they are announced. Polls shall be located to avoid congestion and provide easy access to the voter. The location of the polls shall be determined by the Election Board. The opening and closing times of the polls shall be decided before the election and no changes can be made.

D. Ballot Tabulating

1. The ballot tabulating shall be supervised by the Election Commissioner, the Policy Overseer or his/her representative, the Associated Students/Organizations Advisor.
2. It shall be a violation of the Election Codes and direct grounds for invalidation of the election for any member of the Election Board, group or independent candidate who has access to the counting room to release the result while the ballots are being counted before the polls are closed.
3. The results of the Election shall be released by the Elections Commissioner following the completion of their tabulation or at his discretion.
4. The Election results, as certified by the Elections Board, shall become effective by their being read into the minutes at the next Council meeting following their certification by the Council.

E. Procedures and Protest of an Election

1. All ballots, key punchcards, computer print-out and programs will be held by the Board until the First Day of the Quarter a year after the election.

2. Protest: within (10) ten days following an election any member of the ASUCSD may file a protest of that election with the ASUCSD Judicial Board on grounds of official mismanagement of a violation.

a. a public hearing must be held within 48 hours of a protest being filed.

b. the Judicial Board must issue a written opinion on the protest.

3. New Elections: ASUCSD Judicial Board shall review the case and submit its findings to the A.S. Council. If the Board rules that there are mismanagement of the elections, or that there was a unpunished violation therein, the ASUCSD Judicial Board may void the elections on the grounds that the mismanagement of, or the unpunished violation substantially effected the election. The ASUCSD Judicial Board may not void an election on any other grounds or by any other procedure. The Council may not void an Election.

4. The ASUCSD Council may not change the dates of an election after the first poll has opened.

F. Safeguards

1. The Policy Overseer shall have the privilege of attending all polling places where ballots are kept and tabulated.

2. When not being officially handled or tabulated the ballots must be kept in a neutral safe location at all times.

G. The Elections Board shall be authorized to include on the ballot all initiatives which have

collected a minimum of 5% of the Student Body signatures with ID#s on a petition supplied by the Elections Board, and all propositions which have passed by a 2/3's consent vote of the ASUCSD Council. Such propositions and initiatives must qualify for consideration by Wednesday of the Second Week of Spring Quarter.

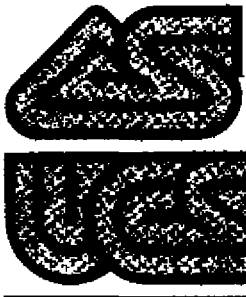

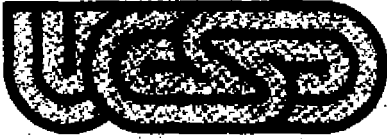

STABLES LAND PROPOSAL

Associated Students of UCSD

Introduction

In the April 1979 Presidential Report regarding University of California land review, Saxon's office notes University needs and forewarnings consistent with this proposed plan. Systemwide states that "large campuses (such as UCSD) were secured to avoid extensive on campus expansion, (to prevent) a sacrifice of open space," and "to allow room for controlled development of related housing and other ancillary uses." The report also cites "that almost no student or University employee can find affordable housing near the Los Angeles campus," due to lack of the regions foresight and planning.

Though the report is in answer to the supplemental budgetary language of the 1978 (Legislative) Budget Conference Committee that requested a March 1979 "plan for sale of all land held by UC which is not needed for academic purposes or because of endowment restrictions," the consequent plan documents that "the University has adopted a guideline that no property contiguous to an existing campus should be considered as surplus."

The Regents have thus adopted a policy for campus "inclusion areas," "intended for facilities and uses which are University-related, but which are not appropriate for location on regular campus property; examples being student housing cooperatives, fraternities and sororities, and independent research institutes."

Though the report closes with the mention that "the President intends to submit a policy for adoption by the Regents which will direct the properties not required for current academic purposes be investigated for other uses," and that

"ground leases will be considered as the first alternative for such properties because they provide income to the University without foresight into the use for academic purposes," the sentence continues to note the condition that (because such properties supposedly do not 'foreclose future use') when the University's mission and programs expand or change, surplus status will ensue."

The Preface of the current University Community Plan states:

"...that a great academic complex can succeed and become fertile only in an environment which welcomes it and complements it. Such a community should be essentially self-sustaining. It must provide not only for the daily living and working needs of its residents, but also for their civic, cultural, recreational and commercial needs. It must acknowledge in its very being the controlling influence of the University on its residents and the community's own impact upon students, faculty and staff whose lives and welfare it touches directly."

Site selection for UCSD was chosen for some of the following criteria: Civic interests and support, accessibility to existing and projected transit routes, availability of utility services, proximity of existing and potential housing, shopping, cultural and recreational facilities, relationship to center of population to be served, and lastly, availability.

The report could further quote existing University documents regarding planning parameters, such as the fact that by 1980, UCSD was to have 4,000 rental units within a two-mile radius whereas in 1979, we have only 1,000, and even these are being threatened with conversion, but we feel you know the contretemps and directives we now face.

We have introduced specific excerpts to show the importance of the stables land, since its proximity is separate but close to the nucleus of the University. The following proposal is in concert with the housing need for all elements of the campus, academically important in meeting the future needs of the University, and represents a model for the community as a whole.

We assert that academics and basic needs of the UCSD community may integrate, as is stated in one of our cover letters to an earlier rough proposal draft:

"The UCSD Student Township is a study/exercise in alternative lifestyles. As Appropriate Technology becomes a more viable concept (and thereby reality) in our society, the need for creative uses of that technology becomes paramount. Through the establishment of a model community and a series of studies designed to measure the effectiveness of the model, the concepts behind the creative use of Appropriate Technology will be disseminated to the San Diego community, and hopefully a more self-reliant society can emerge.

The following proposal meets the criteria of the University Community Plan, especially in the aforementioned requirement of "self-sustaining," and of the Presidential Report for "inclusion areas" as University-related but inappropriate for location on regular campus property, (though two or three sites in the proposed five-part plan would be located on the main campus property).

We hope the committee will recommend this proposal as a priority of the University to be pursued in a comprehensive effort within the University Plan.

Preliminary Proposal

We, the Associated Students of UCSD, propose that the University set a precedent with the stables land by initiating Step One of the University Township, with the intention of creating similar developments in nearby areas, and suggest that these proposals be integrated in order to initiate the development of the UCSD University Community.

We support Chancellor McElroy's plan for the development of an additional 250 units for students and faculty in the Group A Housing Plan, of which 100 units would be included in the development of the Stables property, but object to his suggestions for small shops and restaurants on the property.

Originally this community was planned for University City, but the plan did not materialize on that site. Consequently, we lack a unified, visible student, faculty and staff community.

The University of California Site Selection study of 1957 states that a "great University" cannot be realized without the development of a University community. The present problems are being compounded by the energy crisis, which, within the next five to ten years, will make student housing in communities outside of a five-mile radius of the campus inappropriate.

Regarding the proposed location of the community, the California Coastal Act addresses several concerns about land use of this site:

- 1) Visitor-serving uses, such as bike paths and recreational facilities would be a fairly high priority.

- 2) The Act requires that opportunities for moderate and low-income housing in the coastal zone be protected. Students are generally considered to be a low-income group.

The ASUCSD Stables Task Force would like to add the following stipulations to Chancellor McElroy's general suggestions:

3) That development on the stables land integrate the needs of a University Community (housing, recreational and other living needs) with the La Jolla community's interest for open space and concerns for coastal parks, bike and walk ways.

4) The overall purpose of the community should be the building of a better psychosocial environment for UCSD students, faculty and staff.

a. Architecture should be planned to:

i. permit for large open space areas for recreation and food production

ii. encourage more community large and small events, i.e., a central commons and several smaller parks should be included

b. The plan should encourage the development of the "new extended family," (group cooperation and sharing) which is impossible in housing complexes presently on or near the University campus.

c. No motor-driven vehicles or storage of such vehicles should be allowed within the Township interior grounds.

5) The community should be built in accordance with the knowledge of long term availability of water, energy and open space. Taking into consideration the coming scarcity of these resources, we suggest the following:

a. The architecture should enable passive solar heating and cooling.

i. Therefore, subterranean with light wells are encouraged.

b. There should be a self-contained sewage system having the following characteristics:

i. nonpolluting

ii. methane fuel producing

iii. fertilizer endpoint

iv. not necessitating substantial water use

c. technology enabling substantial water conversion should be a high priority through the following measures.

- i. grey water recycling for watering gardens
 - ii. landscaping with rare indigenous plants and other local chaparral intermixed with food-producing plants requiring little supplemental watering, rather than grass and other ornamental plants.
- d. Water conserving sewage techniques (see 5 b)
- e. Drip irrigation
- f. The community should be, to as large a degree as possible, self-reliant in energy production. It should utilize the following forms of energy production as well as other nonpolluting renewable resources for its utilities:
- i. solar
 - ii. wind
 - iii. methane
 - iv. alcohol
- g. It should be, to as large a degree as possible, self-reliant in food production, using the following techniques:
- i. french intensive gardens for each housing unit.
 - ii. community cooperative intercropped gardening
 - iii. aquaculture
 - iv. fish farming
 - v. fruit trees
- h. The community should be of an experimental nature, acting as an important model for other communities, and producing research directed toward the following future community concerns.
- i. Appropriate Technology
 - ii. New psychosocial environments
 - iii. Experimental integration of needs for open space with middle density housing.

We hope this proposal will serve as a prioritized basis for future growth at UCSD, and carefully reflected to inspire a sense of urgency and positive diligence on the part of the University community as a whole. Realizing that higher education represents the fundamental progress of society, we hope that the University of California at San Diego will continue and actively promote this effort in the best interests of its community and as a model for society as well. Thank you.

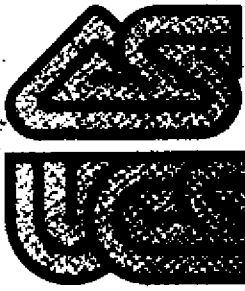

ASUCSD ELECTION CODES

SECTION I. PURPOSE

A. The purpose of these Election Codes is to provide for the conduct and control of all elections, referenda and initiatives held under the jurisdiction of the ASUCSD.

B. These Codes insure that each candidate is afforded an opportunity for election equal to that of any other candidate for that office.

SECTION II. ELECTION BOARD

A. Description

The Election Board will be responsible for the conduct of election and enforcement of Election Codes.

B. Membership

1. Commissioner of Elections
 - a. the Commissioner will serve as Chair
2. Assistant to Commissioner of Elections
3. Poll Person
4. Assistant Poll Person
5. Publicity Person
6. Secretary
7. Policy Overseer

C. Rules

1. Board members, other than the Commissioner, shall be nominated by the Commissioner of Elections and Appointments/Evaluations Commissioner, and approved by a two-thirds (2/3) vote of the ASUCSD Council.
2. Board members' appointments shall expire upon their removal from office or at the end of the Commissioners term of office.

3. Members of the Election Board shall not participate in any public, or private support of any announced candidate, slate or proposition while serving on the Board. Failure to comply herewith shall be sufficient grounds for removal from the Board by the Election Commissioner or by a two-thirds (2/3) vote of the ASUCSD Council.
4. No Board member, shall be eligible to run for elective office during the term in office of the ASUCSD Council which approved their nomination to the Board.
5. All Board members shall be responsible to the Commissioner of Elections and shall assist in the performances of the Commissioner's duties.
6. The Election Commissioner may not run for office during his term.

D. Duties of the Board Members

1. Commissioner of Elections
 - a. to take complete administrative charge for all details of all ASUCSD elections, referendas and initiatives.
 - b. to nominate the members of the Election Board subject to the approval of the ASUCSD Council.
 - c. to appoint such additional members of the Board as may be necessary for the efficient administration of the elections subject to the approval of the ASUCSD Council, with the exception of attendants at the Polls, who do not require AS confirmation.
 - d. to serve as Advisor to the Colleges and to other campus organizations which request assistance in conduction of their elections.
 - e. to provide an interpretation of any of the elections and of the campaign; such interpretation shall be subject to review by the ASUCSD Judicial Board.

- f. to design and arrange for the printing of the ballot.
 - g. to design and arrange for any other details involving the ballot.
 - h. to issue warnings for violations of the Election Codes.
 - i. to receive all election application forms.
2. Assistant to the Commissioner of Elections
- a. along with the AS/Orgs. Advisor conduct the compulsory candidate's meeting before the beginning of the campaign period.
 - b. to provide and prepare all election application forms.
 - c. to provide, prepare and receive all candidates' expense forms.
 - d. to maintain a file of all Board records, papers, forms and reports or statements filed by candidates.
 - e. in the event of the removal or resignation of the Election Commissioner, to replace the Commissioner, as acting Chairperson until such time as the ASUCSD Council by a 2/3 vote consent replaces the acting Chairperson with another Commissioner.
3. Poll Person
- a. to provide sufficient workers and materials for all polls.
 - b. to arrange for transportation of the ballots and ballot boxes.
 - c. to arrange for the setting up and removal of the polls and to arrange for a sufficient number of polling booths at each location.
 - d. to arrange for all other details related to polls not included in these Codes.
4. Assistant Poll Person
- a. to assist and be responsible to the Poll Person.

- b. to provide for a number of alternative poll workers in case a poll worker is not able to appear or if a poll worker has an observable partisan connection to any candidate.
5. Publicity Person
- a. to work with the Commissioner of Public Relations to insure the availability of adequate Election information.
 - b. to provide extensive publicity to the candidate filing period, and job description of the positions open, in such a manner to insure that all elements of the campus community will receive equal notice.
 - c. to provide extensive publicity prior to the election day of all polling places and times that each will be open.
 - d. to publicize fully the elections.
 - e. to clearly mark all polling places so that they will be easily identifiable.
 - f. to insure that a sample ballot be available to all voters, either by distribution or by printing in available campus media at least one week prior to the opening of the polls.
6. Secretary
- a. to aid any member of the Elections Board.
 - b. to insure that the Election Board's candidates files remain closed. Total expenditures of individual candidates and slates are open for public examination.
 - c. to post a list of warnings and citations for violation of these Election Codes, at a location decided by the Election Board, and make known to candidates at the Compulsory Candidates Meeting.
 - d. to insure that statements submitted by the candidates are distributed or printed in available media at least one week prior to the opening of the polls.

7. Policy Overseer

- a. to oversee the voting proceedings of the election.
- b. to investigate alleged violations of these Codes and to bring them before the Election Board.
- c. to oversee the collection and processing of the ballots.
- d. to act as the representative of the Election Board before the ASUCSD Judicial Board.

SECTION III. COMPLAINT PROCEDURES

A. All cases arising under these Codes shall be brought before the Elections Board.

B. Prompt Hearing: If a case arising under these Codes is filed with the Commissioner during an Election period, the case shall be heard within forty-eight (48) hours at a time to be decided by the Commissioner and convenient for the parties involved.

C. Sanctions: The Election Board shall be empowered to impose the following sanctions upon candidates for violations of these Codes:

1. Disqualifications and ineligibility to run in any further campus elections.
 - a. for interfering with proper and accurate tallying of votes.
2. Disqualifications from current elections.
 - a. for willful violation of a lawful order consistent with the Codes, from the Election Board or Commissioner of Elections.
 - b. for exceeding campaign spending limits.
 - c. for the following violations, at the Board's discretion.

- i. for repetition of violation after warning or censure.
 - ii. for repeated violation of any section of the Codes.
 3. Suspension of campaign privileges for a stated period of time.
 - a. for illegally interfering with the campaign of another candidate.
 - b. for illegal campaign practices.
 - c. for slanderous charges against another candidate with the Committee.
 - d. for libalous charges against another candidate with the media.
 - e. for printing, posting or distributing slanderous campaign material.
 4. Censure
 - a. official notice ordering the cessation of repeated violation of these Codes.
 5. Warning
 - a. notice to candidate of violation of these Codes.
- D. Appeal Process
1. If a candidate, after his case has been heard, finds evidence not introduced in the original hearing which could effect the decision of the Board, the candidate will have the opportunity to appeal to the ASUCSD Judicial Board.
 2. If the candidate feels the Flection Board was unfairly prejudiced, the candidate will have the opportunity to appeal to the ASUCSD Judicial Board.
- E. The ASUCSD Judicial Board is advised to follow the sanctions stipulated in these Codes.

SECTION IV. CANDIDATES

A. All Candidates

1. Must be a member of the ASUCSD.
2. Must have at least a 2.0 overall GPA at time of candidacy, as indicated on an official UCSD Transcript.
3. Must meet the requirements of eligibility for the office for which they are running as stated in the ASUCSD Constitution.
4. Must attend an instructional meeting called by the Elections Commissioner. No person may represent another candidate.
5. Must file an intention of candidacy with the Board and submit a petition of candidacy with 25 signatures accompanied by Student I.D. #. Presidential candidates will be requested to submit 40 signatures accompanied by Student I.D.#. Filing must be done within the stated filing period.
6. Must submit a list of their campaign workers prior to the compulsory candidates meeting.
 - a. names may be added by the candidates, in writing, but must be added prior to the agent's participation in the campaign.

B. Filing

1. The filing period for candidates shall be from 8:00 a.m. on Monday of the First Week, to 4:00 p.m. on Monday of the Second Week of Spring Quarter.
 - a. candidates for all positions must indicate their desire to run by completing an official candidates application along with the petition with signatures which shall be provided by the Election Board.
2. Official candidate application forms must be filed with a representative of the Elections Board, to be received by the Commissioner of

Elections. Each Election Board Member's office hours will be posted on the Commissioner of Election's Office door.

3. All candidates declared ineligible to run shall be notified by the Election Board.

4. A candidate may withdraw from the election at anytime. In the event that a candidate decides to withdraw, or is disqualified, after his name has been placed on the ballot, none of the votes that he received will be counted toward him. After a candidate withdraws or is disqualified from the election, no additional campaign materials bearing his/her name shall be produced.

5. No changes in the slate affiliation or candidate's order shall be made after the close of the candidate's meeting and no candidates shall be added to any slate.

C. Compulsory Candidate's Meeting

1. All candidates are required to attend the Candidate's Compulsory Meeting. Special provisions will be made for those candidates who are unable to attend at the designated time, and have notified the Commissioner of Elections before hand.

2. The meeting shall be conducted by the Assistant Election Board Person in conjunction with the AS/ Student Organizations Advisor, and shall be held before the beginning of the campaign period. All Candidates are responsible for all information that is distributed or gained at this meeting.

3. All candidates must submit a list of their campaign workers prior to the start of this meeting.

4. Functions:

a. to acquaint all candidates with the basic structure, functions and authority of the ASUCSD and of the Election Codes and to discuss any questions relating to these topics.

- b. to delete from the list of candidates all persons who do not appear at the meeting, except those candidates who are unable to attend and have made special provisions with the Commissioner of Elections.
- c. to determine the ballot order of candidates names through lottery, by office. The process shall be witnessed and recorded by the Commissioner of Elections.

D. Campaign Workers

- 1. Only the candidates and their campaign workers may:
 - a. tamper with their respective campaign material.
 - b. post campaign materials.
 - c. canvass
- 2. All campaign workers must identify themselves, when asked to by an Elections Board member, with their current UCSD Registration Card or Valid Drivers License. Any person who is asked to identify, and fails to do so, must surrender all campaign materials they have in their possession at the time to the Election Board member inquiring.
- 3. Any campaign material confiscated by the Election Board, under this section will be released by the Election Board the following day and any day thereafter to the candidate that the material belongs to, if said candidate is not guilty of a violation which requires further action by the Elections Board.

E. Write In Candidates

- 1. Write in Candidates with the greatest number of votes shall win unless any declared candidates receive a greater number of votes.
- 2. Write in candidates are subject to campaign regulations.

SECTION V. CAMPAIGN REGULATIONS

A. Campaign Period

1. The campaign period shall begin at 12 NOON on Tuesday of the Second week of Spring Quarter.
2. It shall be a violation of these Codes:
 - a. for any candidate or their campaign workers to take part in any form of public activity designed to further the election of any particular candidate(s) before the campaign period.
 - b. for any candidate or campaign workers to make personal appearances for the candidate(s) before an organized group for the purpose of soliciting support before the campaign period.
 - c. campaigning shall be limited to UCSD campus.

B. Conduct of Campaign

1. It shall be a violation of these Codes for any candidate or group or campaign worker thereof to:
 - a. willfully destroy, deface, cover, move or remove from their places posters, signs, banners or campaign literature of any other candidates.
 - b. put campaign literature in the following places:
 - i. on trees and folliages
 - ii. defacing University property
 - iii. on windows, unless approved
 - c. appear as a candidate on a radio broadcast, unless all candidates for the same position or their representatives shall have the same opportunity to appear, except for unsolicited news coverage.
 - d. commit, according to established legal standards libel or slander against another candidate.
 - e. place more than one (1) piece of the same campaign literature on any bulletin board.

f. falsify information of official Election Board forms.

g. to refuse to appear before the Election Board when so requested to do so.

h. to fail to file any of the Election Board forms specified by these Codes on time.

i. to distribute official ASUCSD Ballots.

2. All leaflets or similar campaign material must be submitted to a member of the Election Board before they may be distributed. Two(2) copies must be submitted along with the number of copies printed, the receipt of the printing and where the literature was, or will be printed.

3. No campaign literature, except banner shall be posted or distributed that exceeds 8 1/2"X14". Posting shall follow general University Policies.

4. Individual candidates, or slates, shall be limited to one large banner per University building as specified by general University Policies.

C. Campaign Material and Procedures

1. Candidates or their campaign workers may make unlimited personal appearances for the purpose of campaigning.

2. Campaign Procedures

a. all campaign material must be removed by candidate(s) or campaign workers and properly disposed of one week after the polls have closed.

D. Finances

1. Individual candidates for University-wide offices may use physical materials having a total cost not to exceed \$50.00. Slates with two or more candidates shall receive an increment of \$25.00 for each additional candidate, (i.e. 2-\$75.00; 3-\$100.00) College Representatives who are running receive \$25.00

a. Slate is defined as an attempt by two or more candidates to coordinate their campaign (placing names on same campaign material in such a way as to...continued next page....

indicate their cooperation or affiliation or use their funds or written endorsements to aid another candidate.

b. The status of a candidate is subject to determination by the Election Board.

c. Total run-off costs shall not exceed \$25.00 per candidate.

2. Any other financial quotas which need to be set shall be set by the Elections Commissioner.

3. Final campaign financial reports for all candidates and slates must be presented to the Commissioner, or his representative in the Election Board, on the last day of voting by 2 p.m.

a. two (2) copies of all campaign expenses on the candidate and slate financial report form which shall be made available by the Election Board in the Commissioners' Office.

4. Assessments for campaign materials:

a. all campaign materials and printing costs will be assessed at fair market prices.

b. the same materials used in previous campaigns shall be charged against a candidate or slate.

c. the use of apartments, phones, staples and staple guns will not be assessed against a candidate or slate.

5. No individual(s), group, or organized group may spend any amount of money toward the election of a candidate or slate independently of the prescribed limitations established in these Codes and not included in the campaign expenditures of a Candidate or slate. This section shall not apply to an endorsement of a candidate carried in a campus media.

6. No ASUCSD funded organization may use its ASUCSD funds, facilities or materials for the purpose of supporting an ASUCSD candidate for

for office whether the funds be used for utilizing University facilities, including, but not limited to: typesetter, ASUCSD personnel and staff, purchasing material, or purchasing space in a regular publication for endorsement or advertisement.

7. Candidates may request the Elections Board for an assessment of campaign materials.

8. Candidates must disclose the sources of the funding they receive for campaigning in their fiscal financial statement.

E. During the campaign, there shall be one (1) debate between Presidential candidates organized by the Election Board.

1. to be at a time convenient to the majority of candidates.

2. to be at a time conducive to attendance by the electorate.

3. to be well publicized in available campus media and by other available means.

SECTION VI. QUALIFICATIONS AND CONDUCT OF VOTERS

A. Eligibility of Voters

1. All members of the Associated Students of the University of California who can present the current quarter registration card and one other signed piece of bona fide identification are eligible to vote.

B. Voting Procedures

1. The voter must sign his name, print his name and write his ID # on a voter registration form.

a. the voter's registration card must contain his signature in ink.

b. the signature on the voter registration form must correspond to the signature on the registration card. If there is a question concerning the authenticity of the signature,

the poll workers may refuse the voter his ballot. The burden of proof is on the voter.

c. each voter's registration card shall be marked in such a way as to indicate that he has voter.

2. No voter shall cast morethan (1) one ballot.

3. No student shall under any circumstances vote or attempt to vote using a registration card other than his own registration card issued for the correct quarter.

C. A circular containing the information in Section VI must be prominently displayed at each polling place.

SECTION VII. MECHANICS OF ELECTION

A. Date of Election

1. the polls will be open during the times set by the Election Board on Wednesday and Thursday of the fourth week of Spring Quarter.

2. Campus wide offices will be decided by a majority (50% + 1) of those voting for that office being obtained by a single candidate.

3. In the case of no majority being received in the race for a campus wide office, those two with the most votes will have a run-off on Tuesday of the Sixth Week. The individual with the most votes in the run-off wins.

B. Campaign Period

1. The campaigning shall begin at 12 NOON on Tuesday of the second week of Spring Quarter and continue until the closing of the polls. Run-off campaign times shall be determined by the Elections Commissioner.

C. Polls

1. There shall be no campaigning, signs, posters, or other literature, nor any vocal campaigning

ASUCSD PROGRAM BOARD BYLAWS

ARTICLE I - NAME

SECTION 1

The name of this organization shall be the ASSOCIATED STUDENTS PROGRAM BOARD, hereinafter referred to as the ASUCSD PROGRAM BOARD.

SECTION 2

The ASUCSD PROGRAM BOARD shall consist of six (6) programming subcommittees. Their names shall be:

- A) Pub Subcommittee
- B) Student Center Subcommittee
- C) Special Events Subcommittee
- D) Films/Dances Subcommittee
- E) T.G.I.F. Subcommittee

SECTION 3

The ASUCSD PROGRAM BOARD shall work out of the office of the A.S. Commissioner of Programming, Associated Students Office, Student Center, University of California, San Diego.

SECTION 4

Programming Subcommittees may be created or abolished by a majority vote of the Associated Student Council subject to a majority vote of the ASUCSD PROGRAM BOARD STEERING COMMITTEE or by a simple 2/3 vote of the Associated Students Council.

ARTICLE II - PURPOSE

SECTION 1

The ASUCSD PROGRAM BOARD shall function as the coordinating, calendaring and promoting body of the following areas:

- A. ASUCSD
- B. Student Center Board

The Primary interest of the ASUCSD PROGRAM BOARD is to coordinate and promote effective, efficient and diverse student programming in the Student Center and campus-wide.

SECTION 2

The programming subcommittees shall be used to breakdown the broad programming spectrum into easily identifiable areas of responsibility. This structure will enable each subcommittee to function as an individual entity, concentrating all efforts towards the established goal of each subcommittee.

ARTICLE III - STEERING COMMITTEE

SECTION 1

The ASUCSD PROGRAM BOARD shall be the official programming advisory group for the Associated Students through its Steering Committee.

SECTION 2

The Steering Committee shall consist of the following voting members:

- A. ASUCSD Commissioner of Programming,
Chair
- B. Subcommittee Chairs

SECTION 3

The ASUCSD Commissioner of Programming shall chair the Steering Committee, and shall call and preside at the meetings and shall be the official spokesperson for the ASUCSD PROGRAM BOARD.

SECTION 4

The Steering Committee shall include the following ex-officio, nonvoting members:

- A. ASUCSD Advisor
- B. Activity Fee Board Chair
- C. Four College Program Board Chairs

SECTION 5

The following are the duties and powers of the Steering Committee:

- A. It shall oversee the programming subcommittees. To this end it shall meet at least once every two weeks.
- B. Approve, calendar and evaluate all ongoing board programming. All programming must be submitted to the ASUCSD Advisor, who is responsible for coordinating A.S. programming with the master calendar at the University Events Office.
- C. Compile and administer the Program Board budget, subject to approval of the A.S. Council.
- D. Set the objectives and priorities of the ASUCSD PROGRAM BOARD.
- E. It shall review and comply with systemwide programming policy in conjunction with the Student Center Director at least once per quarter.
- F. Approve Appointments and Evaluations nominations before they are introduced to the Council.
- G. Subject to a majority vote of the A.S. Council, establish or abolish programming subcommittees.

SECTION 6

The Steering Committee may sponsor an event, where the ASUCSD funds and promotes the event and takes financial and administrative responsibility.

- A. The Steering Committee may co-sponsor an event, in which it assumes shared responsibility for the presentation of a program or entertainment event with the department or organization within the university community. This includes academic departments and programs, colleges and student organizations. The Steering Committee may fund co-sponsored events totally, or in part.
- B. The Steering Committee may sponsor a professional promoter or outside agency subject to approval by the Student Center Director.

SECTION 7

The Steering Committee shall submit a complete annual budget to the A.S. Council by the end of the third week of Spring Quarter.

ARTICLE IV - SUBCOMMITTEES

SECTION 1

The areas of programming responsibility of each of the subcommittees shall be as follows:

- A. The Pub Subcommittee: The Pub Subcommittee shall be responsible for advising on all programs taking place within the Student Pub.
- B. The Student Center Committee: The Student Center Committee shall be responsible for advising and presenting programming designed to attract students to partake in the many services of the Student Center.
- C. Films/Dances Committee: The Films/Dances Committee shall be responsible for programming campus-wide A.S. films and dances.
- D. Pop Concerts: The Pop Concerts Committee shall be responsible for scheduling large spectator events (typically music, dance, etc.) which must be calendared outside the Student Center.
- E. Special Events: The Special Events Committee shall be responsible for advising and presenting lectures and lecture-demonstrations.

ARTICLE V - MEMBERSHIPS

SECTION 1

Each programming Subcommittee shall consist of the following members:

- A) Chair
- B) No more than five undergraduates

SECTION 2

All Subcommittee members will be nominated by the A.S. Commissioner of Programming and approved by the A.S. Council.

SECTION 3

The Pub Subcommittee must be chaired by a voting member of the Student Center Board.

SECTION 4

Nonvoting members shall consist of any interested student.

SECTION 5

The number of voting members on a committee may be increased only upon recommendation of the Steering Committee and approval by the A.S. Council.

SECTION 6

All appointments made shall be for one year and can be renewable. Appointments are due by the end of Winter Quarter and membership shall begin on July 1. All appointees are nonvoting members for Spring Quarter. College and Student Organizations should submit recommendations to the Associated Students for consideration of appointments.

SECTION 7

Vacancies on any of the campuswide Programming Committees shall be submitted to the A.S. Council. It shall be the responsibility of the A.S. Council to fill the position for the duration of membership.

SECTION 8

In the event that a member must terminate his or her membership, written notice must be given to the chair of the committee and to the Commissioner of Programming.

SECTION 9

In the event that a member fails reasonably to fulfill his or her obligation(s) as a member, a recommendation that he or she be replaced shall be made to the A.S. Commissioner of Programming by any member(s) of the same committee as the member in question. A member can be removed by:

1. Majority vote of the Steering Committee plus a majority vote of the A.S. Council.
2. A two-thirds vote of the Steering Committee or the A.S. Council.

ARTICLE VI - OFFICERS

SECTION 1

The officers of each campuswide Programming Committee shall be a chairperson, a secretary, and other such officers as each committee may from time to time create.

SECTION 2

The officers shall be elected in accordance to the following:

- A. The seven committee chairs shall be selected at a joint meeting of all seven committees on the ninth week of Winter Quarter. A person is eligible to be nominated for committee chair if he/she has been a voting member of a Program Subcommittee for a minimum of two weeks.
- B. Students without previous or sufficient experience can be considered for chairpersonship upon nomination by a Steering Committee member.
- C. Nominees must receive a majority of all votes cast to gain chairpersonship.
- D. The winners shall serve as chairs elect of their respective committees for Spring Quarter, and shall take office July 1, serving for a one-year term.
- E. Each campuswide Programming Committee shall elect a secretary from among its members at the first meeting of the Committee after July 1.

SECTION 3

The duties of the officers shall be as follows:

- A. The Committee chairs shall preside at all meetings of their respective Campuswide Programming Committees. They shall attend Steering Committee meetings. Each shall be responsible for advising on all facets of planning and carrying out of events within the committees programming area, including booking, publicizing, staging and financial reporting. Committee chairs shall perform the usual duties of that office and shall have such other powers and perform such other duties as the Steering Committee may from time to time determine.
- B. The secretaries of each campuswide Programming Committee shall be responsible for the minutes and records of the meetings of that Committee. The secretary shall also be responsible for publicizing committee meetings to the general campus community.

B. Cont.

Each shall serve as Committee chair in absence of the elected chair, or in case of the inability of the elected chair to serve. In that case, the secretary shall serve as chair for the remainder of the term of office, and a new secretary shall have such other powers and perform such other duties as the committee may from time to time determine.

ARTICLE VII - MEETINGS

SECTION 1

The campuswide Programming Committees shall meet at least once a quarter. Meetings shall be called by the committee chair. It shall be the responsibility of the chair to make sure that all members are notified of meetings sufficiently in advance.

ARTICLE VIII - AMENDMENTS

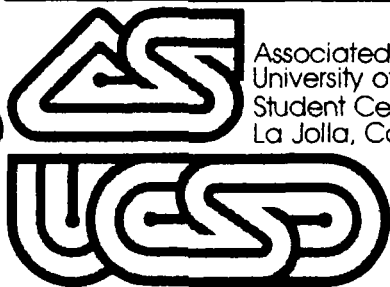

ASUCSD Student Store Proposal

- I. Statement of Purpose

To provide a diverse convenience and supply store to the UCSD community, promoting the lowest possible prices.

 - A. Students with UCSD Student Identification shall benefit a lower price than non-fee paying individuals.
 - B. It is the Board's charge to insure an inventory spectrum that is reflective of student needs.
 - C. The store will remain open for the longest, economically feasible hours possible.
 - D. The store will be the first of the ASUCSD business services, each of which will reflect the same low-price, high accessibility purpose.
- II. Board of Directors (hereinafter referred to as "Board")
 - A. Membership:
 1. The following shall be full voting members:
 - a. ASUCSD President, or designee
 - i. shall Chair the first Board meeting annually to facilitate the Chair's election.
 - b. Four ASUCSD at large appointments
 - i. to be appointed by the ASUCSD Council from Appointment & Evaluations Commission nominations.
 - c. Four Store core members, one each from the following divisions:
 - i. cashier and personnel
 - ii. ordering and stocking
 - iii. accounting
 - iv. educationCore members shall be elected by the personnel within each division; education member shall be through ordering and stocking.
 2. The following shall be ex-officio, non-voting members:
 - a. All Store employees
 - b. Student Center Board Coops & Enterprises Subcommittee Rep
 - i. to be appointed at the discretion of the subcommittee
 - c. ASUCSD Advisor
 - d. Student Center Director
 - B. The Chair shall be elected during the first annual Board meeting, with any member eligible for nomination, and shall be rotating.
 - C. The Board's membership shall be determined by the ASUCSD electoral process timeline and the Council-elect's subsequent convenience by no later than the last Council meeting of Spring Quarter.
 1. The duration of a member's term shall not exceed one

year.

2. Members may apply for re-appointment as long as they remain registered UCSD students.

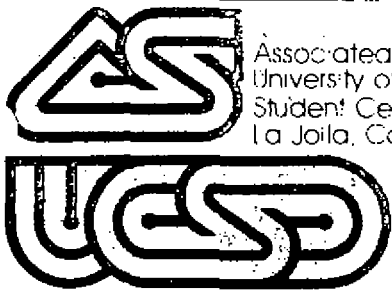
III. Purview of the Board

- A. Formulate and determine all inventory.
- B. Design the annual Base Budget and major allocations, including but not limited to:
 1. operating costs
 2. mark-up
 3. projected growth of inventory and services
 4. major physical alterations
 - a. subject to approval by the Student Center Board,

And these shall be subject to approval by the ASUCSD Council by no later than the last Council meeting of Spring Quarter.
- C. Insure that all Store initial and generated funds shall remain within the ASUCSD Business Account to allow low prices and expansion of services.
- D. Shall meet at least once a week
 1. These meetings shall be open to the public
 2. Employees attending shall be paid for that time accordingly
- E. Shall hire and fire all employees
 1. The first Board shall be appointed by the ASUCSD Council as nominated by the Appointments & Evaluations Commission.
 2. Employee salaries shall be determined by the appropriate employment office of UCSD job descriptions, and employees shall not work more than 19 hours per week.
- F. Shall insure that the initial Council underwrite in the Business Account be paid back to that account within the most feasible timeline it can follow; this account shall remain under the auspices of the Board, and, as previously stated, shall be subject to approval by the ASUCSD Council.
 1. Funds may only be budgeted for business services as determined by the Board, and approved by the ASUCSD Council.
- G. All Board actions shall be subject to veto by the ASUCSD Council, and its minutes shall be submitted to the ASUCSD Vice President as its report to the ASUCSD Council.
- H. No ASUCSD Businesses shall be formed unless generated by the Board, subject to approval by the ASUCSD Council.
 1. Businesses are also subject to approval by the Student Center Board Coops & Enterprises Subcommittee.

- b. Failure to comply with this procedure shall result in the relinquishment of the organization's right to further funding during the remainder of the quarter and the quarter after that.

ORGANIZATIONAL PROPOSAL
of the COFFEE HUT COLLECTIVE

INTRODUCTION

It seems ironic that at an institution of higher learning such as UCSD, where a large percentage of the undergraduates are premed, there is little or no concern amongst many as to the quality of food ingested. A majority of the food available is highly processed, dubiously nutritious, energy intensive, and relatively expensive. It is full of refined sugars, additives, preservatives and/or greasy animal proteins.

Since the inception of the Food Coop, there has been a viable alternative, and judging by its success (January '80 daily sales averaging \$800.00), we feel justified in initiating another like service. The Food Coop has brought together a community of workers concerned with promoting good nutrition through a structure that is cooperatively owned and managed. The joys and awareness that result from participation in such a coop are the ends to which we strive. It is with these ends in mind that we propose the establishment of a cooperative kitchen and restaurant located in the Coffee Hut. The name of this organization will be the Coffee Hut Collective.

PURPOSE

The general purposes of this organization are as follows:

To make available to the University community inexpensive, and nutritious food of a type that produces good health, is produced non-destructively, and is a joy to eat.

The collective will function as a system to teach cooperative behavior rather than be hierarchical. It will encourage group interaction in all its functions and will act as an example to the University community of the benefits of cooperative work. It will make available information on its structure and policies to all those interested.

The collective shall not make a surplus profit from its selling of food. Instead the price of food sold shall be just adequate to cover the cost of food, labor to prepare and sell it, and operating expenses of the Coffee Hut. This rule of operation is unchangeable by any means, and failure to abide by it shall result in disbandment of the collective.

The collective shall, by pursuing the purposes stated in the above, attempt to improve the state of the University community. The Coffee Hut will provide a multi-cultural gathering place for students. A stage will be available to all students wishing to provide music, theatre, readings, etc. It will also be available to groups for evening gatherings with the option of prepared banquets by appointment for groups of 20 or more.

RULES OF DEMOCRATIC MANAGEMENT

1. Meetings shall be held weekly at a convenient time, or as called by a consensus of the workers.
2. Management resides in the collective as a group.
3. The collective consists of all of the workers, one A.S. representative, one S.C.B. representative, one S.A.A.C. representative. Each member has one vote.
4. The Student Center Director shall act as advisor.
5. The chair will be rotated among the collective members each meeting.
6. The duty of taking notes shall also be rotated each meeting and the minutes will be posted until the following week.
7. Hiring and firing shall be done by consensus of the collective.

STRUCTURE

The workers will be organized into six categories of activity:

Accountant/Purchaser: 1/ 19 hours per week

Records daily sales and expenditures
Provides business office with monthly income/expense report
Acts as liaison with business office.
Reports financial status to collective.

Prep food for daily operation
Maintain salad bar
Provide general assistance for cooks

Wash dishes

Cooks: 4/ 76 hours per week

prepares all cooked foods
makes sandwiches
posts weekly specials
coordinates banquets

Cashiers: 4/ 76 hours per week

takes and rings up orders
serves beverages
assists prepers when free

Maintenance: 1/ 19 hours per week

wash dishes
daily clean up of kitchen
clean tables
takes out garbage and compost

Volunteers: unlimited

publicity
grounds work
coordinate entertainment
manages art displays

Volunteer positions will enable those who cannot commit large amounts of time and energy to help create and participate as workers of the collective. Volunteers will receive assignments at the weekly meetings and will be entitled to a vote for two hours of work per week.

HOURS AND MENU

The initial operation of the Coffee Hut Collective will be 8:30 to 2:30. Preparation work only will be done from 7:00 to 8:30. Breakfast will be served all day, while a salad bar, soup, sandwiches and specials will be offered from 11:00 on.

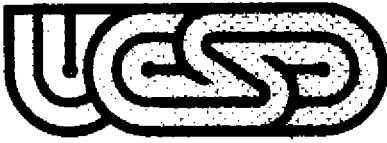

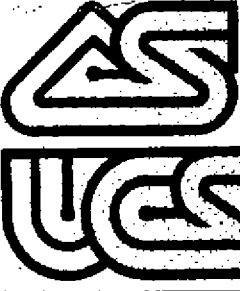

ASUCSD STUDENT STORE PROPOSAL

Robb Strom

On Wednesday, January 23, 1980, the A.S. Council passed tentative approval of a proposal calling for the operation of some sort of new and used record store. The following proposal is hereby submitted in a more complete form in hopes of solidifying that initial commitment. There are three main areas with which this overall proposal must deal:

1. Initial and Continuing Expenditures
2. Income and Overall Co-op Structure
3. Management Structure

I. INITIAL EXPENDITURES

The initial investment in the store will require about \$7,500 of student monies to be distributed in the following manner:

\$1,000 will provide an inventory of 750 used records. This is based upon a cash payout of \$1.50 for a record in good condition by a popular artist, and a \$1.00 cash payout for a sellable record in fair condition. The final decision with regard to what type of records this person will choose will of course be extremely subjective. The more efficient this person is in his/her job, the more available cash the store will have to deal with. The \$1,000 cash payout assumes 500 records were purchased at \$1.50 and 250 records at \$1.00.

The price of a new record is \$4.55 for a \$7.98 list record and \$5.15 for an \$8.98 list record. Therefore, we can initially purchase approximately 850 new records. Many record companies will sell records on consignment and many records cost well below \$4.55, so 850 new records is the minimum that can be purchased. The actual number of new records will vary between 850-1000.

Blank cassette tapes (Maxell 90-minute UDxLII) cost \$3.90 each. We can therefore purchase about 125 of these for \$500. We will also stock 60-minute cassettes which cost less than a 90-minute tape. As in the case of new records, the number of tapes purchasable reflects an absolute minimum.

Video cassettes cost \$14.09 for a 3M-VC-20 minute and \$22.08 for a 3M-VC 60-minute tape. If we buy a box of each type of tape (10 per box), this should be sufficient to start a videotape inventory.

Record racks have been designed, and will be built by Phill Lowe. These will be completed by spring break. A copy of the tentative store design is enclosed along with this proposal.

If we are to be professional both with the companies that supply us and the general public who buy from us, we should have a telephone in the store to assist us. The cost for installation and 6 months rent is \$154.00. We have added an additional \$46 for long distance.

Cash register, counter and calculator have all been tentatively secured from the Student Center Board from the Coffee Hut and existing equipment.

For the first two weeks of operation salaries (paid on an hourly basis), will come to \$385.60. This is calculated by having three cashiers work a total of 40 hours per week at \$4.82 per hour (standard university payscale). Core members will be paid a salary once the store operation gets underway.

There will be an understanding between those involved in the beginning stages of development that little or no salary will be drawn. We may be able to secure work-study positions and there is the possibility of wages in the form of discounts on records in stock.

Any music store needs a good, dependable stereo system. We have a tentative agreement with Pacific Stereo to purchase a Caliber 225 receiver (25 watts), a Dual turntable and TransAudio 1011 speakers for \$425.00. This price is comparatively low and will give us a good quality system. Cheaper systems could be purchased, but these usually reflect poor sound quality and poor mechanical dependability.

Plants will be purchased from Spero Yiamilos, who will also deliver these to the store. Prices range from 50¢ to \$10.00 and the selection includes Creeping Charlies, Ivy, Coleus and Ferns.

II. INCOME AND OVERALL CO-OP STRUCTURE

The question of how much profit should be made translates into charging a markup per item of either 50¢, 75¢ or \$1.00. This means that a \$7.99 list record which costs us \$4.55 would have a selling price of \$5.05, \$5.30 or \$5.75 respectively. Probably a 75¢ markup would cover overhead costs and allow a small margin for increasing inventory.

As the store will be working with a "break-even" or low-profit structure, its financial situation should be evaluated quarterly. One core member (to be defined in Section 3), must make a financial report to the ASUCSD Council no later than the second week of each quarter.

Initially, any profits should be used to expand the store's inventory. Once the financial situation has stabilized, we will set up a special account for profits. Half of the total profit will go towards expanding the store inventory and the other half will go into this special "agency account." An agency account may not be set up with student activity fee money. It may, therefore, only contain money that is profit from the store. A good time to determine when this account should be set up is at the quarterly report. It should be stressed that it is not the intention of this proposal to allow excess revenues to be removed from the store's business accounts. Excess funds are used, as mentioned, to build up inventory or to generate another student enterprise or co-op. In this way all money is tied up in some form of student enterprise. This will be contingent, of course, on Council approval.

Business hours are still tentative but Monday through Friday we should be open from 11 a.m. to 7 p.m. Saturdays and Sundays we will open on a trial basis. Accurate records of sales will be kept at all times. All monies will be turned in each day to the A.S. secretary who will be keeping the official books for the store.

III. MANAGEMENT STRUCTURE

As the record store will be run on a co-op format, the members of this co-op can be subdivided into three categories.

A. The co-op will have a core group consisting of five members. These people will have extensive musical and business knowledge. Their duties will be categorized as follows:

1. General overseer - makes employee work schedules
2. New records - ordering and returns, etc.
3. Used records
4. Accessories and plants
5. Accounting

These people will eventually develop a level of expertise in each of these areas and will pass on information to the volunteers so that an effective exchange of information takes place between core members and others working in the co-op. Some decisions will be made by the core regarding store policy but in general most decisions will be made by the co-op as a whole. It may be advisable to have one of the Council members as a core member.

B. Volunteers will make up the major body of the co-op. Approximately 10-20 persons will work closely with core members in an effort to learn the different aspects involved in running a record store. These persons will have as their common base a desire to learn and some musical interest before the store opens. Their duties may include such things as security, stock work or just helping out where needed. Volunteers who have put in some minimum number of hours (to be determined), will be entitled to a vote if they have worked two consecutive weeks in the store and attend the co-op meetings.

C. Cashiers must have prior experience and be musically inclined. Three cashiers will be hired part time and will fill the hours the store is open according to class schedule, etc. They will also each have a vote at the co-op meetings.

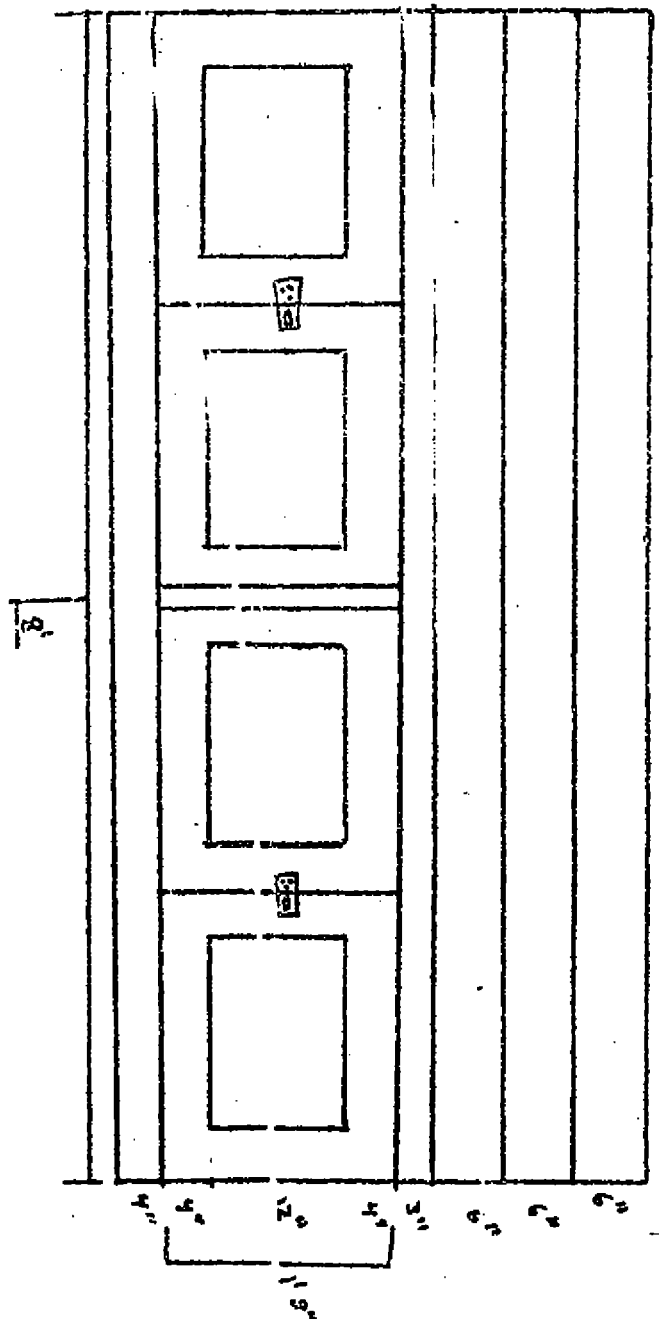
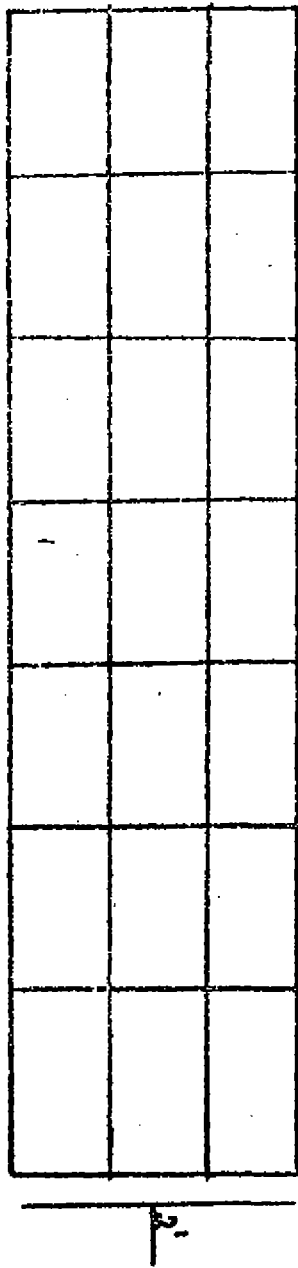
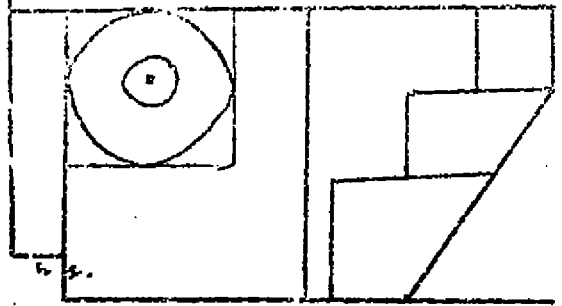
The co-op shall hold weekly meetings to determine store policy and exchange information. The five core members and all eligible volunteers and cashiers will be entitled to one vote each in this General Assembly. Should a core member drop out, the remaining core members will nominate a new core member and the General Assembly will approve him/her by a 2/3 majority.

The core members and other volunteers will generally recognize the potential of a volunteer to move up into the core.

To remove a core member, three out of five core members must make this recommendation to the General Assembly. The Assembly may then, by a 2/3 vote, remove that core member.

We sincerely hope this proposal will be wholeheartedly accepted by the A.S. Council. It is only logical to assume that some ideas stated in this proposal will change with time. Many new ideas will develop as the store itself develops. To coin a phrase, "only time will tell." As long as those involved are willing to put the time and energy into making this new store a success, then it shall become one. The ASUCSD reserves the right to further amend this proposal at a future date.
