Dear Sir!

My absence from our Riverside office has resulted in a delay in answering your letter of October 4th, having reference to the purchase of lands from the Southern Pacific Railway necessary for the carrying through of the Snow Creek Development.

This whole matter has lately received the attention of our Board of Directors and after careful consideration a decision was reached that the Company will not be justified at this time in making any advance to the Albright Estate for the purpose of purchasing the land in question.

It was a part of our agreement with Mr. Albright, under which the development was to be made, that he at his own expense should furnish all necessary rights of ways and releases necessary to permit the development.

On account of the financial condition of the estate it was proposed that we advance the necessary moneys to cover the purchase outright of the land involved, charging Mr. Albright with one-half of the amount advanced, we to permanently assume the cost of the remaining half of the purchase price, in consideration of securing the fee title to the sections of land involved, instead of an easement for the portions of such lands as will be copupied by our structures.

Notwithstanding our desire to do everything in reason to assist Mr. Albright, it was decided that we could not accede to this proposal in justice to our own stockholders. One reason leading to this decision is the fact that in the present condition of our load we have no immediate need for the bringing in of this development at the present time.

Under the circumstances we would not be justified in making a large investment for the purpose of expediting a power development, the output of which will not be needed for a year or so.

We are, of course, ready to go shead with the development at any time the Estate fulfills its part of the contract, but this is as much as we can premise today. It is possible that conditions may change next year so as to warrant us in medifying our present decision to the extent of helping Mrs. Albright carry through her end of the agreement. However, we feel that the price asked by the Railroad Company is very excessive and should be substantially reduced.

By abandoning the idea of purchasing the land outright and buying simply the necessary rights of ways with a release of riparian rights you may be able to get a more reasonable figure from the Southern Pacific Company.





My dear Colonel:

I have your letter of August 4 and am frankly somewhat surprised at the tenor thereof. You and Mr. Cowan are seeking to sell a property valued in excess of thirty millions and seem to be under the impression that it can be sold largely sight unseen and with the same methods that one might dispose of a corner lot.

The answer to your questions one and three is "no". As to question two, I am not in a position to state definitely, although on the basis of a satisfactory deal I believe our Company would be able to finance the proposed purchase. We are definitely interested in the possibility of the purchase of the San Diego Company but do not wish to go further with negotiations with you and Mr. Cowan until we know first, that you are authorized to deal on behalf of the owners, and second, that the owners will permit our engineers to examine the physical properties involved and our accountants to examine the books of the Company. Without such engineering and accounting examinations we would not be in a position to make a firm proposal to the owners nor to arrange through our bankers for the necessary funds with which to pay for the stock of the Company.

The proposal that we advance \$100,000 in order to be allowed to make such examination is not acceptable to us.

I frankly feel that you are wasting your time, as well as our own in the matter in pursuing the deal along the lines that have been followed to date. However, if you could show some definite authority from the owners of the property to deal with us for its purchase and could secure authority for the necessary engineering and accounting examination, we would be interested in vigorously following up the matter in the hopes of consummating a deal.





As you stated there are two franchises - a Constitutional Franchise for illuminating (either electricity or gas) and the other Franchise representing heat and power which I am informed by City officials can be cancelled by a majority vote of the people.

The Power Company have been dodging their responsibility, Mr. Cooper has been employed, and the City is right after the Gas Company for dodging their 2% Franchise tax on heat and power. The authorities at the City Hall claim that legally they can only collect four years back tax according to #539 Code of Civil Procedure. However, there is a credit to be taken into consideration in favor of the Gas Company where the Utility Company owns outright a percentage of the right-of-ways. To illustrate: If the City owns 1/2 and the Utility Company owns 1/2, there would be a 50/50 credit.

The City claims that the power average per unit is 35 kilo watts per hour. Oakland compromised with the Power Company on 40. However, the City does not want to go to Court in the matter, and undoubtedly a compromise will be made shortly. As stated above, the total amount that the City can claim against the Gas Company is only for four years legally, but morally, the Company owes for the entire period. There will be a compromise somewhere of \$20,000 or \$30,000 paid by the Gas Company, and hereafter they will agree to pay.

It would be very expensive to have a survey made by the City and they say they do not want to do that if they can help it. For this coming year there is only \$6,000 or \$7,000 involved as coming to the City.

In strictest confidence, showing it only to Mr. Phipps, I am sending you Harold's original letter which please return.

Los Angeles voted yesterday more than two to one to buy the Edison distribution lines of Southern California, and I am looking for competition from that bunch if we do not get busy and soon. I am expecting a letter any day from Mr. Lynch. Harold is very close to Lynch, and, as you know, is in the organization. It would be a terrible thing if this information got out, and I know you will keep it confidential.

Cowan has not answered my last letter. I have a sneaking idea that he is flirting strongly with the Miller crowd, believes he can sell to them and leave us out on the end of the limb or in open competition in Court - that, of course, we do not want.

I have had a telephone talk with Mr. Black, President of the PG&E in San Francisco. He wants to see me on a couple of legislative matters, and I am going to find out from him the low-down as far as Cowan is concerned.

In the meantime, don't you think it would be fair, \$100,000 from each side in the matter of commission, and will you extend the time as Harold suggests, if necessary? I feel that psychologically the time is ripe to do business. I am enclosing copy of Cowan's last letter to me and my answer in reply. I answered this for two reasons:

- (1) It would indicate he was trying to sell to an outsider and had not told me, and wanted to hold him in line and get half of what is coming to me if he sold to someone else.
- (2) I would be able to keep in touch with the situation and keep you informed.

Mr. A.B. West:

A good deal depends upon Lynch's answer as to what our next move is, but do you think I had better take the risk and write a letter to Cowan calling everything off with him, or, accept my 4400 or \$500 that I advanced him and keep him in the picture. Cowan made the side remark in San Francisco when I saw him the other day on my return home from Denver that -*\$100,000 did not mean anything, if he did not make several hundred thousand dollars out of it, he would be greatly disappointed. How he is going to do it, I do not know, but it will not be done with my consent except with your approval and knowledge ahead of time.

When are you returning to Riverside? I suppose you are aware that the San Diego Gas & Electric Co. are planning to increase their capacity, things are picking up with them tremendously and there will be bigger business this year than last by far and larger profits.

This will acknowledge receipt of your letters of December 9 and 12. I was quite interested in reading the letter you enclosed, which I am herewith returning.

First, as to the suggestion that we agree to a double commission being paid: Even though the additional amount should come from the other side, yet, as I have previously stated, you can usually count on the purchase price including all commissions paid, so that the purchaser pays the entire bill. Under the circumstances, I am sure our people will oppose any further modification of the commission arrangement. You will recall that I have already secured their consent to one important modification - that being that our Company will pay your commission, if a deal satisfactory to us is consummated along the lines as stated in my letter.

You, however, need not worry over fear that you might lose your commission through the deal not being closed within the exact time named in my letter. If there appeared to be a reasonable chance of the deal going through, I feel sure our people would approve a thirty and possibly a sixty day extension.

With reference to Mr. Cowan, as I have previously intimated, I have no confidence in him whatsoever and my personal feeling is that you stand a better chance of putting over the deal if he is out of the picture.

On the subject of purchase price, I feel that the figures we have discussed are as high as we or anyone else can justify in paying. In this connection, you may be interested in knowing that less than two years ago, the price under discussion with the Edison Company was \$85 a share.

While our losses in Imperial Valley have been held to a smaller figure than we anticipated, approximately 30% of our Valley revenue, yet it will take us a year or so to overcome this loss, which makes new financing very difficult.

I have just learned that the S.E.C. have declared H.M.Byllesby & Company to be a holding company and in violation of the Public Utility Act of 1935, and hence were refused the use of the mails and other facilities of doing business. This would make it imperative for certain changes to be made in the Standard Gas & Electric Company situation since H.M.Byllesby & Company owns a very large block of stock in Standard Power & Light Company, which, in turn, owns a very heavey control of the Standard Gas & Electric Company.

I have assurances that very much better figures will acquire the property now, and I can put you in touch with responsible people if you care to open negotiations at all at the present time. Thanks for the information concerning the position that the S. E. C. is taking with reference to the Standard Gas and Electric Company.

I am sorry that I cannot give any encouragement at this time as to the ability of our Company to finance the acquisition of the San Diego stock. Not only our own earnings, which have been adversely affected by the Imperial Valley competition, stand in the way, but the general financial situation resulting from the war would, I believe, preclude us from raising the necessary money.

I am glad to say that while our earnings have been declining over the last year or so, they are promising to take a turn for the better. Competition in Imperial Valley is becoming more or less stabilized, while our business is picking up at other points. This, taken in conjunction with a very drastic economy campaign which we have been carrying through, will we expect, give us better earnings for the coming year than for 1959.

This improvement in earnings will, however, have to be actually realized before any large financing on the part of the Company would be practical.

The official record so far shows Fletcher 43,388 as against 28,853 for Izac, with a number of precincts still out, and without the absentee ballot and Townsend, Progressive, Prohibition and Socialist having been counted.

Congressman Joe Martin, from Washington, over the radio last night gave me a great send-off and congratulated me over the national hook-up. Imperial Valley gave me both the Democratic and Republican nominations.

I take it you are not interested in getting control of the common stock. They had set the price of fifteen million and got fooled. I am satisfied that a deal around eleven million could be consummated, but with these unsettled conditions, I do not plame you for not taking on anything new. I am just finding myself again after as hectic a campaign as one could imagine. They pulled a blitzkreig on me. Roosevelt wired his support and good luck to my opponent and turned over everything needful, so that Roosevelt carried the District by over 25,000 and I was defeated by something like 3000. We will not know definitely until the final absentee ballots are counted. Washington gave five or six million dollars for San Diego in the last six weeks for different projects; \$317,000 for our San Diego Zoo the day before Election; increased the WPA worker's salary \$1.00 a day all over the State; gave those on relief a double contribution of surplus commodities, and the school teachers were given carte blanche to order what they wanted for the children. In the pay envelop of each was a note asking their support of the Administration. and all over the District were large posters of Roosevelt and my opponent as running-mates.
