Answering yours 26 th I will say that I took this matter of donation of \$50.00 which Mr Franklin sent me, and he tells me that it should be credited to San Diego, as per his letter attached hereto, and I have this day transferred to the San Diego sheet. With this your total to date is \$1,565.00

I have before me copy of your letter to County Engineer Smith of the 27 th, and I will be only to give you what information I can on this that may help you out. You say what about this man Hunt? Thats just what I would like to know, and I will tell you vary frankly that in my opinion he is a good started, but a darn poor finisher, In my conversation with him, his talk to the Yuma Chamber of Commerce meeting, which I happened to have the pleasure of attending he told us that San Diego would come through with at least \$1,500 which has been true, 21 Centre with a thousand Brawley with a thousand, Calexico, and imperial about the same, and he also told us, both Swith and I that Yuma would come with at least \$1,500, but after attending the Yuma meeting, I could see that Hunt did not know what he was talking about, and that if every place was on a par with the feeling in Yuma, we were all blowed up, for there was a sentiment in Yuma, that they were scared to death of Phoenix, and I told them the sooner they mustered up the guts to tell Phoenix where they "Yuma" stood on this matter the better they would be off, for so long as Phoenix had them scared just so long would thay roll tham.

So far as I know Hunt has not attempted to raise a dollar in Tucson, Casa Grande, Gila, or Yuma, only in the beginning getting some one warmed up to do it, which was a mighty good thing to do, and I think we will, all be well paid for our efforts before long. I do not know anything about what Hunt has been doing for some time, as he has been over East of Tucson some where, went through here a few days ago, but from what I heard that he said, I think he needs a real good talking too, and have him settle down and finish up what he has started.

We have collected in our little town a trifle over a \$1,000, and without the aid of Mr Hunt, he is not responsible for the collection of one cent of the money, a committee of the local Chamber of Commerce and Citizens took a list and solicited the money in two half days.

So far the only money make to my personal knowledge is the \$1,565.00 from San Diego, and the \$1,000 from here, not one cent has some into my hands from any other source, or place.

It does seem to me that Mr Hunt should be impressed with the fact that he is the man that should make the collections in Imperial Valley, but I personally, doubt if it would be the wise thing to do, for I am afraid he does not always represent things just as they are, and that is just what a man has to do to do anything and not have a come back from some where, in any event we should try and arrange to have this matter looked after in the Imperial valley for they are interested in this just the same as we are.

I have not seen Hunt since the next day after he was in San Diego when you were going east, and am really not acquainted with his movements, only by hear say, he is like a flee, when you think you have him, you havent.

I will try and get in touch with him and see what I can learn from him, as to what money he got, where he got, and from whom, also what he did with it.

So far Smith has had nothing to do with the raising of funds, only to talk to the heads of some Organizations, or some road building heads, mostly to men who are interested in building roads, He is a very buisy man, and I surely appreciate the time and work he has given on this Casa Crande Gila road, and I want to cooperate in every way that I can with him and others to see that this road is pushed right through.

You no doubt know that Mr. Smith was working on this road between here and Maricopa long before Hunt ever showed up, so that Hunt cannot claim that he is responsible for this work, on the other hand Hunt came along and seen what this road when opened up really meant to the Southern Route, and he immediately fell in line, and no double, done some good work, but there is such a thing of spoiling some of it, so I think as you suggest we should check Mr Hunt very closely.

So far I have heard nothing from Tombstone, but will try and check him over there as I know people over there through whom I can check him, and I will do this right away.

Mr Smith as you know is working for the County and has a mans job on his hands, and I dont think we should call on him to go to imperial Valley to solicit funds, though I am sure he would be very willing indeed to go down there at most any time and meet with representative men and go over the matter with them, and then leave the collection matter with them.
