FRAMEUP BY DISTRICT ATTORNEY HAMILTON

PINKLEY'S PROSTITUTED PRESS and the radio stations of Imperial County have brainwashed you inhabitants as to what happened Nov. 15, 1965 when Joseph Sharp, an Assistant Superintendent of Schools in Brawley, attacked Dr. Yellen to stop him from distributing his Newsletters. Under the Constitution of the United States and the Federal Laws, the Doctor has the legal right to distribute these Newsletters. District Attorney Hamilton who is a corrupt official, seized the Sharp incident to vent his personal spite against the physician.

ON NOV. 5, 1965, EXACTLY 10 DAYS BEFORE THE SHARP INCIDENT, DR. YELLEN SENT A LETTER TO THE IMPERIAL COUNTY BAR ASSOCIATION WHICH SAID: " I ALSO WANT AN OFFICIAL INVESTIGATION OF JAMES HAMILTON, THE DISTRICT ATTORNEY, WHO IS A MEMBER OF YOUR BAR ASSOCIATION". Copies of this letter were sent to the Calif. State Bar, Thomas Lynch, Attorney General of Calif., Nicholas Katzenbach, Attorney General of the U.S., and Assemblymen Leon Ryan and Nicholas Petris, Chairmen of Assembly Committees which are interested in property tax swindles which are now being revealed all over the state. District Attorney Hamilton has been accused by Dr. Yellen for failing to do his duty in that he had not investigated the local \$8 millions tax swindle whereas the District Attorneys in other counties have conducted such investigations. Dr. Yellen has been presenting evidence of such a swindle in Imperial County for the last 5 years BUT DISTRICT ATTORNEY HAMILTON DOES NOTHING.

Dr. Yellen came to Imperial County in 1942. He had been a First Lieutenant in the Medical Corps, U.S. Army Reserves for 8 years. But he was refused active duty because of an attack of Rheumatic Heart Disease. He came to Imperial Co. to escape further attacks. Since being here, he has developed asthma which makes it difficult to breathe.

On the evening of Nov. 14, 1965, Dr. Yellen had to take an Adrenalin shot because of an attack of asthma. When he awoke on the morning of Nov. 15th, his chest felt heavy and he did not have good breathing. The Doctor was going out that morning to deliver his Newsletters. So he took another Adrenalin Shot at 8:45 a.m. so he would be able to distribute his papers. The Doctor drove to various schools and delivered the Newsletters to autos around the school. He then drove to A St. and North Imperial Ave. where he parked his car.

With his sack of Newsletters weighing about 15 pounds slung on his left shoulder like a mailman, he began to distribute his Newsletters to autos parked on the West side of North Imperial Ave. until he reached D St. Then he turned to the right and delivered walking on the North side of D St. until he reached 2nd St. Then the Doctor crossed to the South side of the street and began to walk East while distributing the papers. There were 2 autos at the curb at 264 D St. which is the office of the BRAWLEY ELEMENTARY SCHOOL DISTRICT. Newsletters were put here,

Dr. Yellen proceeded with his deliveries until he came to an empty dirt lot between North Imperial Ave. and 3rd St. This lot had about 5 school buses on it and further East on the lot were autos and pickup trucks. Dr. Yellen had seen autos and pickups on this lot on Sundays and this lot was not posted as to whom it belonged. He began dropping 3 Newsletters for the bus driver through the open window next to the

bus driver's seat. He was doing this when he heard shouting. The physician turned and saw a man who he later found out was Joseph Sharp. Sharp yelled, "Do not put your papers on the buses or on the private autos. This is school property".

Dr. Yellen then said to the man, " You are the one who shoved me when I was offering Newsletters to the teachers at the Teachers Institute at Palmer Auditorium in November 1962!" The Doctor continued, "I have the legal right to distribute these papers here". Then Sharp shoved Dr. Yellen and kept shouting, " Don't you put Newsletters on the private autos". Sharp is 5 ft. 9 inches and Dr. Yellen is 5 ft. 4 inches & because of the doctor's asthma, he had to retreat.

LJT SHARP KEPT ON FOLLOWING DR. YELLEN. HE BEGAN TO LUNGE AT HIM TO TEAR THE PAPERS OUT OF DR. YELLEN'S HANDS. HE BEGAN TO THROW PUNCHES AT DR. YELLEN. The physician whose left shoulder was loaded with the sack and whose left hand was full of Newsletters tried to fend off Sharp with his right hand and kicking at him with his right foot. But Sharp was determined to beat up the Doctor. He lunged in close enough to grab the sack and tear it from Dr. Yellen's shoulder and at the same time punching the Doctor with his left hand.

At this point, Dr. Yellen began to get short of breath from the exertion and made a grab for a small screwdriver which was in his shirt-pocket. Sharp at this time knocked Dr. Yellen to the ground and was on top of him with his right hand on the chest near the neck of Dr. Yellen. The Doctor was getting extremely short of breath so that with the screw driver in his right hand, he began to hit Sharp in the only place he could--the left chest of Sharp. Sharp finally felt this and grabbed the right hand of Dr. Yellen. The doctor was so out of breath he was unable to fight anymore. If people had not run up to stop the fight at that moment, it seemed as if Sharp would kill Dr. Yellen.

The physician then got up and gathered his torn sack and torn Newsletters and left. About 2 hours later, Brawley Police came and arrested the Doctor and told him he was going to be kept in jail for 48 hours pending investigation. Dr. Yellen protested he wanted to see District Attorney Hamilton and sign a complaint of assault and battery against Sharp. He was refused permission to see Hamilton. The doctor also protested keeping him in jail for 2 days claiming the investigation could be done just as well without the Doctor being in jail.

About 3 p.m., Joseph Sharp in the company of Hoxie Smith and William Dillard whose families escape \$55,000 yearly in farmland property taxes(as described in the Newsletters Dr. Yellen was distributing-- ERNEST O. STEIMLE DISGRACE OF THE WEEK, SUPT. E.O. STEIMLE & SUPT. R. GOODRICH ARE BETRAYERS, and THE TRUTH ABOUT T.B. SHANK) arrived at the Brawley Justice Court and signed the complaint. District Attorney Hamilton was waiting there all the time and made no attempt to find out from Dr. Yellen as to what happened. Since Hamilton was personally involved in a controversy about the tax swindle with Dr. Yellen, he should have put the entire matter up to the GRAND JURY to decide. But Hamilton in cahoots with Hoxie Smith and William Dillard pressuring him, evidently thinks that by means of PINKLEY'S PROSTITUTED PRESS and the radio stations, he can fool the people about this frameup.

Section #8454 of the Education Code states, "no bulletin ----- shall be distributed to the pupils on the school premises during the school hours or within one hour of opening of school to one hour of closing of school". So you see it does not forbid the putting of Newsletters on buses. This empty lot is not school premises since there is no school building on it. Finally, the Newsletters were not being given to pupils since there were no pupils on it.

THIS IS A BRAZEN ATTEMPT TO PREVENT THE DISTRIBUTION OF A FREE PRESS. Ernest Steimle and Joseph Sharp have their high jobs because they are bootlickers of Hoxie Smith and William Dillard. So they try TO PREVENT DR. YELLEN FROM REVEALING THE SCHOOL TAX SWINDLE.
