HE PROPOSED about six months after we had been going together, but when I try to pin him down to a specific date, he tells me he doesn't earn enough money to support a wife the way he would like to, though he makes almost $\$ 5,000$ a year.
"On numerous occasions I have told Fred that I would be willing to continue working after marriage but his reply is always that he doesn't want his wife to work. Do you have any suggestions on how I can bring matters to a head?"

Frankly, we're a bit skeptical about Fred's desire to marry you, his proposal notwith. standing.

The fact that you have been going steady with him for two years, that he earns an ample salary, and that he says he loves you, should have made him set a definite wedding date long before this, if his intentions were really sincere.

You say you're both very much in love. We don't doubt that you, yourself, are, but we're
very much inclined to doubt that Fred is-at least to the point where he wants to marry you.
