

We have at hand your letter of May 23rd in regard to cost of operating the Hawley Pipe Line during 1917, and arrangement to be made for future operation.

We note, with regret, that you still term the amount of payment per month at higher than the strictly irrigation rate as a domestic water payment. We have endeavored to explain this to consumers under the Cuyamaca Water System a number of times as an initial rate, intended to cover the separate cost, and in its effect in your case to provide approximately, at least, for the difference in returns properly to be given the company when it operates a distributary for service along which it would otherwise sell at the single rate to a company or association. Only in part is there a shade of reason for this higher initial charge in that it may be used for domestic purposes.

It has been explained before, if not to the president of the Hawley Pipe Line Company, to many others of the consumers that formal complaint may be brought at any time and will be given determination by this Commission upon this portion of the rates. If the higher initial charge is eliminated, the general irrigation rate will be increased.

In regard to the full time of a man when water is being delivered along Hawley Pipe Line heing unnecessary, can you help us to the extent of finding a competent person who will work under the Cuyamaca Water Company for part time only?

The Cuyamaca Water Company has stated to the Commission that it will not pay \$400 per year rental to the Hawley Pipe Line Company during 1918. We note your statement on behalf of the Hawley Pipe Line Company that it will accept nothing less. Under the circumstances, we presume that it will be necessary to have a stipulation from each party that a hearing may be conducted and the Commission determine this matter. There is no provision otherwise for the initiation of formal proceedings. Kindly let us know whether you are willing to so stipulate. If not, it appears to us that the Commission can only suggest to the Cuyamaca Water Company that it refuse delivery other than at the head of the lateral and to the Hawley Pipe Line

Company. It is within the power of the Commission to require the Cuyamaca Water Company to make its own installation. Under the present emergency conditions and in view of Federal instructions, it is probable the Commission would not render any decision that would require unnecessary expenditure for purchase and installation of pipe line.

For the 11 months from May 1, 1917 to March 31, 1918, we paid out as follows on the Hawley pipeline:

Labor - - - - - - - - - - 5 510.00
Rent - - - - - - - - - 333.50
Repairs - - - - - - 6.70
A total expense of 850.20

Our additional revenue from the sales of water were \$391.30, making a loss of \$458.90 for the 11 months or for the year approximately \$525.00.

You can readily understand that we cannot stand this financial loss in addition to the leakage from your system, and we cannot renew our lease the coming year.

The total revenue of the Cuyamaca Water Company for last year was \$54,952.00. The total operating expense was \$55,520.00; while the State Railroad Commission say that we are entitled to \$138,736. We have never been paid a dollar in dividends, and it has reached the point where we do not propose to stand any further losses.

Will you kindly take this matter up with all the stockholders of the Hawley pipeline, that the facts may be known?

You will please note in the decision that the Railroad Commission themselves say that a reasonable cost alone for operating the system is \$48,000.

For the 11 months from May 1, 1917 to March 31, 1918, we paid out as follows on the Hawley pipe-

Labor - - - - - - - - 510.00
Rent - - - - - - - - 333.50
Repairs - - - - - - 6.70
A total expense of \$850.20

Our additional revenue from the sales of water were \$391.30, making a loss of \$458.90 for the 11 months or for the year approximately \$525.00.

You can readily understand that we cannot stand this financial loss in addition to the leakage from your system, and we cannot renew our lease the coming year.

The total revenue of the Cuyamaca Water Company for last year was \$54,952.00. The total operating expense was \$55,520.00; while the State Railroad Commission say that we are entitled to \$138,736. We have never been paid a dollar in dividends, and it has reached the point where we do not propose to stand any further losses.

Will you kindly take this matter up with all the stockholders of the Hawley pipeline, that the facts may be known?

You will please note in the decision that the Railroad Commission themselves say that a reasonable cost alone for operating the system is \$48,000.

Gentlemen:

This is to notify you that on March first, 1930, we will discontinue our temporary arrangement to operate your line and furnish water at the Consumer's Meter.

Hereafter, we will only furnish water to the Master Meter at your connection with bur Main Flume. It will be necessary for you, in writing, to notify us the name of your Representative. This Representative must notify us, in writing, the amount of water to be turned in daily, with the distinct understanding that the water which is turned in will be paid for at the rates established by the Railroad Commission, in conformity with the Commission's orders. Until this arrangement is made, no water will be turned in.

We regret that we cannot continue the present service as an accomodation to you, owing to the fact that it has been at a loss to this Company, not alone financially, but a very large per cent of the loss of water on our flume line has been due to the leaky condition of the privately owned systems. We tried the experiment at the request of the Railroad Commission, but now find it necessary to cancel the arrangement, owing to the financial condition of the Company, and the necessity of husbanding our water, so that all may get 100% supply without this Company having to stand the tremendous leakage through your respective distributing systems.

This applies to all privately owned distributing systems connected with our system.
