Unity is the spirit and the soul of La Raza. It is unity which has enabled us to endure hundreds of years of oppression and empowered us to fight it for hundreds of years more.





In 1962, Reis Lopez Tijerina and the Alianza staged the famous court house raid in Tierra Amarilla. It was the first act of guerrilla warfare in the United States in this century.

This example of united action by the people of Tierra-Amarilla was again an inspiration which was to serve as a building block to a powerful movement.


In 1963 and 1964 the Farmworkers of San Joaquin Valley began to organize and in 1965 UFWOC (United Farm Workers Organizing Committee) gave birth to La Huelga in Delano and El Grito was heard throughout the Southwest.



In Logan Heights the first San Diego Brown Berets were formed and began a new militant push for the rights of the people. Pledged to "serve, observe and protect", they organized youth from all barrios and college campuses to become a single force in the defense of the community.

The Denver Liberation Conference was also held in 1968 and was one of the most significant examples of unity that we shall ever see. El Plan de Aztlan was introduced and a great deal of energy was directed into aiding in the formation of La Raza Unida Party.

The year 1969 saw the creation of the Chicano Federation of San Diego and a new voice for community representation was heard. The newspaper "La Verdad" also came to life that year and gave further strength to our growing struggle. Teatro Mestizo was also created that year and initiated part of an explosion of artistic creation throughout San Diego.

LIBERACION DE LA NEIGHBORHOOD HOUSE, OCTUBRE 1970

The year 1970 was one of the most significant. This was the year that the Neighborhood House was taken over by the community and the Berets. Many a sleepless night was spent here waiting for an attack by the pigs. But the people won and now the Chicano Free Clinic is located where before there was less than nothing.

Unity against the pigs gave us the Concilio Por Justicia, an organization formed to continue struggling against pig abuse.

This was also the year when Mario Solis informed students at San Diego City College that the Highway Patrol Was going to build a sub-station under the bridge in the middle of Logan.

Students, Berets, and the community organized with pickets, picks and shovels to take over the land and make a park for themselves. Chicano Park was born and became one of the greatest victories the people have ever known. The Brown Berets, MECHA and the Chicano Federation assumed occupancy of the former highway patrol station and began to establish social services from the building that would have been used for oppression.



The newspaper "El Barrio" official newspaper of the Berets also made its appearance and caused a great deal of interest in the community. So much interest that later the same year three Brown Berets who were involved with the paper faced charges of conspiracy and other accusations. Los Tres de San Diego were faced with up to 30 years in prison due to an attempted frame by an under cover agent of the San Diego Pig Dept., by the name of Jesus Manuel Lopez. Lopez Infiltrated the S.D. Berets in an attempt to stifle a movement for the betterment of "LA RAZA"... A raza that carries the same blood that his mother bares. Some of the laws they allegedly broke went back nearly 60 years.

The unity and support of La Raza was overwhelming and this alone made a victory out of what could have been a defeat.

The Ford building, being used by some artists temporarily, suddenly became a point of challenge to the system. The building was seized for a cultural center and the foundation of what later became the Centro Cultural de La Raza. Along with this the organization Toltecas en Aztlan whose hard work and dedication infused our movement with the power of culture.

Power through unity kept us strong, we continued to work hard to come together and fight for our people. Later that same year, this unity and power came together in a tremendous event that would create a milestone in the history of the Chicano Movement.

August 29, 1970 - The Chicano Moratorium in East Los Angeles 20,000 Chicanos marched against the war in Vietnam. Later, at the peaceful rally where families were gathered to hear speakers, the police attacked and beat our people into the streets.

And we fought back. And they tear gassed the crowds. Burning and rioting continued until the next day. And when it was over, Ruben Salazar was dead as well as many others.

All things were quiet for some time. No major changes occurred until 1971. So in 1971 we were marching again. Marching in San Ysidro with La Huelga at the Egger-Ghio farms.

We saw the first Mujeres Teatro and a (C) Che Conference at City College where the flag of Aztlan was raised.

Murals exploded all over La Logan and Toltecoyotl festivals brought the culture to every barrio. Our unity brought back the strength to carry on and we became even greater in our quest for justice.

And when 1972 came around we continued our march. There was the Amerindia conference, the take over of Catalina, the San Diego State Riots, the City College protests, and more high school walk-outs.

The lessons are here for today and for our children tomorrow. But they will remain only history and we will remain slaves if we do not put them into practice.

For oppression never stops, and unless we move now and resume our struggle we will be buried by the new avalanche of oppression which is building.

For while we sleep, the enemy schemes..

CHICANO PARK 1970-1977 ④

1970.....The cold Pillars of the Coronado Bridge stood on a piece of land that was cleared by the State in the Barrio of Logan Heights. A portion of land that was cleared of people's houses, gardens, trees, and their way of life. Cleared by the roar and pounding of heavy, cold, machinery. Cleared only to be replaced by the tall cold grey concrete pillars that support the Coronado Bay Bridge. For a long time the people of that community had been asking the city for a park. A park where their children could play in and not have to risk their lives playing in the busy streets of Logan Heights. A park where the Senior Citizens of the area could come and rest their bones. But little did they know, that this is not what the city had in mind. The red brick building that was constructed on the bare land was not to be harbored by the residents of that barrio, but rather, by the Highway Patrol. This was the discovery of a passing-by Chicano as he was walking by one day and asked a construction worker what it was they were building. The worker replied, "a Highway Patrol sub-station."



Stunned at the worker's reply, the passing-by Chicano quickly set off to spread the word to the Barrio residents. The community was soon informed on the matter and began to rebel.

LA CAUSA

It was on April 22nd, 1970 that the people of Logan Heights walked on to the land and took it over to construct it into a park for their community. Thus History was born in the City of San Diego.

For the first time in the history of the city a community walked on to the land and claimed it as a park, to meet the needs of their people. Men, Women and children, students, senior citizens, residents, non-residents, came on to the land with picks, shovels & rakes to start working the land. Women of the Barrio brought food and drink for the hard working people. The news of the take over spread like Wildfire throughout the county. The media was immediately called to the scene of action, to give their version of Chicano self determination.



Thus the BIRTH OF CHICANO PARK PREVAILED, for the residents of Logan Heights & La Raza of San Diego this was only the end of the beginning.

Hard work, organizing, negotiating and sacrifice lied in the future for the builders of Chicano Park. As the months began to pass by, La Raza began its utilization of the red brick building and the park land. The trees were planted and the grass began to sprout. It seemed as if the land was conducted.

PARQUE!

1970 Los sombrios Pilares del puente Coronado situados en un pedazo de terreno que fue arrebatado del Barrio Logan Heights.

Pero este no es lo que los representantes municipales tenian destinado para nuestro Barrio.

El Edificio de ladrillo que fue construido en este estrecho de terreno no era para el uso de los residentes, si no para el departamento de Patrulla.

Esto se descubrio cuando un Chicano que pasaba donde estaban construyendo y le pregunto a uno de los trabajadores que era lo que se estaba haciendo y le contesto que se finava una subestacion que seria ocupada por la Patrulla de caminos.

Ollendo esto el Chicano se dio priso a pasar la noticia y avisar a todos los residentes del Barrio lo que la ciudad se proponia aser.

Al enterarse de esto los residentes se rebelaron.

Fue en Abril 22 de 1970 que la gente del Barrio Logan Heights se apoderaron del terreno en que se construyo el Parque Chicano.

Asi es como paso a la Historia de San Diego. Por la primera ves en la historia de la ciudad de San Diego, la comunidad se unio y tomo posesion del terreno para un parque que era tan necesario para los residentes.

Hombres, Mujeres y ninos, estudiantes, personas mayores, residentes y no residentes trajieron sus palas, picos, asadones y empesaron a trabajar la tierra

Las mujeres del Barrio contribuian comida y refrescos a la gente que trabajaba con tanto afan.

La noticia pronto se extendio por toda la ciudad, y la prensa, periodicos y televisoras vinieron a presenciar y dar su version de la determinizacion Chicana. (5)

Asi fue como se formo y nacio El Parque Chicano.

Para los residentes de Logan Heights y La Raza de San Diego esto era solo un principio a un fin.

Trabajo, organizacion, negociaciones sacrificio, les esperaba en el futuro a los que construian el Parque Chicano.

Pasaba el tiempo y la Raza empesaba a usar el edificio de ladrillo y el terreno del parque se plantaron los arboles, y el sacate empeso a enverdeser.

Parecia que la tierra empesaba a revivir. La tierra debajo de los pilares sombrillos se lleno de musica, bailes, y una armonia que llenava los corazones de la gente que experimento el comienzo, y el sueno realizacto que fue el Parque Chicano.

Fue como se empeso a fundar la idea de celebrar el dia del parque, commemorando el Dia que se tomo posicion del terreno.

Con el paso del tiempo las celebraciones y la fama del Parque Chicano empesaron a ser mas grandes.

El Parque empeso a embellecer y a llenarse de color con los bonitos murales que fueron divujados por Artistas Chicanos de Aztlan, Artistas locales y de otras areas.

El primer equipo para el parque de recreo de los ninos fue instalado y con tiempo se aumento.

Agencias Chicanas ocuparon el edificio de ladrillo ofreciendo servicios sociales a los residentes de la comunidad.

Las escuelas empesaron a traer a los estudiantes en dias de campo para darles un ejemplo de la determinacion a que puede llegar la gente Chicana.

La lucha y el estrago para agrandar el Parque Chicano esta tan activo ahora como en Abril del 1970.

Un Kiosco de arquitectura Maya sera construido este año, de este modo no abra necesidad de pedir foros portables para los dias de fiesta.

For the first time the land under the bridge was filled with music, dancing, and a harmony in the hearts of the people that had experienced the birth of Chicano Park. Thus began the trend of the annual Park Day Celebrations, commemorating the takeover of the land. As the years went on the celebrations as well as the fame of Chicano Park began to grow. The park began to take color with the beautiful murals that were painted by local and non-local Chicano artists of Aztlan. The first childrens playground equipment was installed and later, more was to come. Chicano agencies housed the red brick building offering social services to the community residents.

The public schools soon began to bus students on field trips to the park to give them an example of Chicano self-determination. The struggle and expansion of Chicano Park is still as strong today as it was in April of 1970. A kiosco in the architectural form of a Mayan Temple is to begin construction this year. No longer must the celebration organizers ask the city for portable stages. After seven years of sacrifice and struggle, the City of San Diego is finally beginning to recognize and respect the history and the purpose of CHICANO PARK... A respect for history that did not begin in April of 1970, but hundreds of years ago with our Indigerous ancestors that also struggled on this land for the betterment of their PEOPLE....





En Logan Heights los primeros "San Diego Brown Berets" fueron organizados, y empezaron un nuevo grupo militante para exigir los derechos para la gente. Comprometidos a "servir, observa y proteger" organizaron a la juventud de todos los barrios y colegios para formarlos en una fuerza para la defensa de la comunidad.

La Conferencia de Liberacion de Denver se convino tambien en 1968, y fue un ejemplo sobresaliente de unidad que podriamos admirar. El Plan de Aztlan fue introducido, y se empleo mucho energia para la formacion de "La Raza Unida" (Raza Unida Party).

En 1969, se creo la Federacion Chicana de San Diego, aumentando una voz mas para la representacion de la comunidad. El periodico "La Verdad" tambien vio la luz del dia, contribuyendo con mas fuerza a la lucha entre manos. Tambien se formo el Teatro Mestizo ese año, lo cual inicio parte de la explosion de creaciones artisticas atravez de San Diego.

El año 1970 fue uno de los mas significativos. Ese fue el año en que el "Neighborhood House" fue adquirido la comunidad y los Berets. Muchas noches desveladas transcurrieron en guardia en espera de algun asalto inesperado de la policia. Pero la gente triunfo, y ahora la "Chicano Free Clinic" esta establecida y situada en donde anteriormente no existia nada.

La unidad contra la policia produjo la formacion del "Concilio de Justicia", una organizacion dedicada a continuar la lucha contra los abusos de la policia. Ese año tambien fue cuando Mario Solis informo a los estudiantes de San Diego City College que "Highway Patrol" construiria un recinto en medio de Logan, bajo el puente.

Estudiantes, el grupo Berets, y la comunidad se organizaron con piquetes de protesta armados con estacas y palas y decidieron tomar posesion del terreno para hacer un parque. Y asi el Parque Chicano vino hacer una realidad y al mismo tiempo fue una gran victoria para la comunidad la cual no habian experimentado.

Las Organizaciones Brown Berets, MECHA y la Federacion Chicana ocuparon la anteriormente estacion de patrulla policiaca, y principiaron a establecer servicios sociales en el edificio que habia sido intentado como un centro de opresion.

El Periodico "El Barrio" que es el diario oficial de los Berets hizo su aparicion y causo mucho interes en la Comunidad. A tal punto fue el interes que mas tarde en el mismo año tres Brown Berets que representaban el periodico fueron acusados de conspiracion y otras acusaciones. Los tres Brown Berets residentes de San Diego enfrentaban una sentencia de mas de treinta años de prision, debido a una trama de un agente del servicio secreto del Departamento de Policia de San Diego llamado Jesus Manuel Lopez. Lopez se habia infundido en el nucleo de los Berets de San Diego en un atento para suprimir la marcha por el mejoramiento de "La Raza". Una raza que lleva en sus venas la misma sangre que su madre.

Algunas de las leyes que ellos alegaban habian infringido estaban en efecto hace mas de 60 años. La unidad y apoyo de La Raza fue abrumador y esto contribuyo a alcanzar una victoria de lo que podria haber sido una derrota.

El edificio Ford ocupado por unos artistas temporalmente fue un punto de demanda para el sistema. El edificio fue apoderado para un centro cultural y tambien para la fundacion, lo que mas tarde llego a ser el Centro Cultural de la Raza. Ademas con esta organizacion, Toltecas en Aztlan

fundacion, lo que mas tarde llego a ser el Centro Cultural de la Raza. Ademas con esta organizacion, Toltecas en Aztlan cuyo intenso trabajo y dedicacion habia infundido nuestro movimiento con el poder de la enseñanza. Al traves del poder de la unidad nos conservamos fuerte y continuamos a trabajar con ahinco para juntarnos y pelear por nuestra gente. Mas tarde en ese año esa unidad y poder se juntaron en un tremendo acontecimiento que crearia un mejero en la historia del Movimiento Chicano.

El 29 de Agosto de 1970, 20,000 Chicanos marcharon en la Moratoria en el Este de Los Angeles en protesta contra la guerra en Vietnam. Mas tarde en una manifestacion pacifica donde familias se habian congregado para oir los oradores, la policia ataco y golpeo nuestra gente en las calles. Nosotros - nos defendimos pero ellos lazaron bombas lacrimogenas a la manifestacion. Incendio y motines continuaron hasta el siguiente dia Y cuando habia terminado todo Ruben Salazar estaba muerto, asi tambien muchos otros.

Todo estubo calmo por algun tiempo. No cambios grandes ocurrieron hasta en 1971. Y asi en 1971 de nuevo estabamos marchando. Marchando en San Ysidro con La Huelga en la Egger-Ghio Farms. Priemero vimos el Teatro de Mujeres y (C) Che Conferencia en City College donde la bandera de Aztlan se izo.

Murales aparecieron por todos lados en la Calle Logan y los festivales de Toltecoyotl trajeron la cultura a cada barrio. Nuestra unidad trajo de nuevo la fuerza para continuar nuestra lucha y nos sentimos mas poderosos en nuestra busca por la justicia.

Y cuando 1972 llego, nosotros continuamos nuestra marcha. Hubo la conferencia de Amerindia y la posesion de Catalina los motines de San Diego State College protestas y aun mas el abandonamiento de los estudiantes de las escuelas secundarias.

Las lecciones que aprendimos estan aqui para los ninos de manana. Pero permaneceran en las paginas de la historia y permaneceremos exclavos si no ponemos esas lecciones a la practica.

La opresion nunca para y a menos que nos activemos ahora y continuemos nuestra lucha seremos enterrados en un nuevo alud de opresion que so esta formando.

PRESS RELEASE FOR IMMEDIATE RELEASE

The Chicano Federation, since its inception, supported the CAUSE of the United Farmworkers. We firmly believe that the struggle for Union Representation, fair and equitable working conditions and equal protection under the law is just cause and one which is consistent with principles of a Democratic society. We further support the Farmworkers adherence to a non-violent course of action a cause which the Farmworkers have sustained in the face of violence-riddled opposition by its admiraries.

We believe that violence prone situations are often purposely or indirectly contrived by those public officials who by their action or inaction violate the public trust.

The Chicano Federation like other organizations and individuals expect public officials to be fully responsive to ALL of the people.

In regards to the presence of the UFW members and supporters at the agricultural labor relations Board offices, our belief is that the action would not have been taken at the ALRB through it's chief council been responsive to the concerns expressed by the United Farmworkers representatives.

We are appalled that the only public response by the chief counsel of the ALRB has been to unilaterally and arbitrarily order the United Farmworkers off its premises.

Local United Farm Workers and their supporters have been picketing and sitting in at the offices of the Agricultural Labor Relations Board here in San Diego since March 2, 1977. The demonstration arose from the arrests of 29 UFW members who were arrested in the El Centro ALRB office by 25 riot-equipped California State Police.

Cesar Chavez, UFW President began the statewide demonstration March 2 in San Diego accompanied by approximately 125 farm workers. All seven ALRB offices plus the ALRB's General Counsel's office have had 24 hour sit-ins, vigils and picketing since March 3.

Accusing Harry Delizonna, General Counsel for the ALRB, of gross distortions in carrying out his duties as General Counsel, Mr. Chavez demanded answers to the following questions:

1. Why did the ALRB allow a company union to be placed on a farm labor election ballot?
2. Why didn't the ALRB investigate the documentation that the UFW had concerning the company union which indeed showed that the ALRB should not allow the company union on the ballot?
3. Why were 29 UFW members arrested for entering the El Centro ALRB office to inform the ALRB Director of their great concern of the precedent setting action of sanctioning company unions by the ALRB.

Vowing that they will not retreat from their sit-in positions, the UFW members have ignored Mr. Delizonna's order that UFW cots, micro-oven, refrigerator and other possessions be removed from the San Diego office.

"We won't be starved out" stated UFW organizer Carlos LeGerrette, "We're here to stay until we get some action from the ALRB on the questions put forth by Cesar."

"If we allow the ALRB to sanction company unions, use riot equipped State Police to arrest UFW members for asking questions and if the ALRB refuses to hear valid and vital information which we possess then the whole intent of the ALRB law is prostituted."

The organizing efforts by the UFW will be hampered greatly if the ALRB chooses to remain on its present course. It would appear that the UFW finally was able to aggressively organize farm workers with the withdrawal of the Teamsters only to find that they now must confront Delizonna and the ALRB to insure that the administration of the law does what it's supposed to do.

"THE BARRIO RENOVATION PROJECT"

In the month of June, the Chicano Federation started a unique program.

The name of the program is "The Barrio Renovation Project". The purpose is to beautify houses in the barrio which belong to people (mostly senior citizens) that can not do the work themselves.

This program is unique because without any red tape it directly deals with two problems in the community, unemployment and Housing Improvement.

Thirteen Chicanos are currently employed by this project, ten formerly unemployed vatos from Logan, and three Chicanos from other barrios.

Employment of these Chicanos took them off the street and put them to work. Not for some ship building company or junk yard, but for our people.

These Chicanos are from the barrio, working in the barrio, for the barrio. No arguments over the best ideology to follow, no meetings with politicians, no studies on needs of the barrio, NO BULLSHIT!

The work that the renovation team does includes gardening, painting, fence building, roof repair, window repair, cement work, everything except major construction.

Senora Esperanza Valdez of Newton Ave., and Senora Dolores Martinez of Kearny Ave are two Senior Citizens that are extremely pleased with the work that was done on their homes.

Even though this program deals with the problems of unemployment and housing improvement on a very small scale, it deals with the problems, is successful, and has results that every one can see!

ALEX GONZALES


Alex Gonzales has been one of the longest members of the Chicano Park Steering Committee.

BARRIO LOGAN IMPROVEMENT

STUDY COMPLETED

The Barrio Logan Improvement Study was presented to the City Council on September 6, 1977. The study is the result of a \$100,000 contract given by the city of San Diego to consultants, appointed by the Chicano Federation, in conjunction with Simpson, Gerber & Bundy Associates. The consultants were to come up with recommendations for changes that would benefit all elements of the Barrio Logan community.

After a year of research, surveys, and community meetings the consultants completed the study which basically makes 12 recommendations dealing with re-zoning, housing, industry, pollution, beautification, traffic control, maintenance, educational facilities, etc., etc. At the completion of the study the Chicano Federation held two meetings for residents and other interested individuals in an effort to inform them as to the contents of the study.

Even though the study has received much criticism, some good points should be noted, such as its recommendation that an area be set aside for a senior citizens housing park and its recommendation that Chicano Park be extended all the way to the bay. It also recommended that any necessary re-zoning and re-location of industry should be implemented to allow for the development of additional housing sufficient to double the residential population. In addition to this it recognized the need for commercial businesses such as pharmacies and large grocery stores which would offer more reasonable prices than those of the present ones.



Criticism on the study is that it makes no stipulations for the quality of the proposed increased housing. Individuals are concerned over the possibility of having low quality, high-rise, and projects type of housing. Another criticism is that besides recommending that the Logan Heights area remain "mixed", that is, industry mixed homes, it also recommends that two Industrial Parks be developed - a Southern Industrial Park and a Dalbergia Industrial Park in the north. The development of these would increase the amount of heavy industry and would involve the displacement of hundreds of families in the Dalbergia area.

The strongest criticism on the study has been the apparent under-representation of the residents in the area. This is clearly seen in that the "community" that the study group recognized was heavy industry, light industry, commercial business, social service groups, city facilities, the U.S. Navy, and, the residents. Because of this it is felt that the residents, whose main concern is having a pleasant, healthy and safe environment in which to live and raise children were least involved in the study. In contrast to this, the industrial element, whose only concern is profit, was given total reign over the study.

Whatever the criticism or praise, it is obvious that all groups and individuals in Barrio Logan will be affected by the recommendations and subsequent decisions by the City Council. The continued industrial control of Logan Heights is imminent if we do not stay informed and involved in the redevelopment of this barrio.

LOS ESTUDIOS PARA MEJORAS DEL BARRIO LOGAN, COMPLETADOS.

(Spanish Transl. by: Ramon G.)

El resultado de los Estudios para Mejoras del Barrio Logan, fué sometido al Concilio de la Ciudad (City Council) el dia 6 de Septiembre (1977). Los Estudios fueron a resultas de un contrato de CIEN MIL (100,000) DOLLARES otorgados por la Ciudad de San Diego a consultantes nombrados por la Federacion Chicana juntamente con la firma Simpson, Gerber & Bundy Associates. Los consultantes debian decidir sobre cambios recomendables para mejoras y beneficios generales, de la Comunidad del Barrio Logan.

Despues de un año de estudios, mediciones, perspectivas y conferencias con la Comunidad, los consultantes completaron los estudios con 12 recomendaciones tocantes a nueva zonificacion, viviendas, industrias, polucion de la atmósfera, control del trafico, hermoseamiento, mantenimiento y conservacion, mayores facilidades para la educacion etc., etc. Despues de haberse completado los estudios, la Federacion Chicana llevo á cabo dos conferencias con los residentes y otras personas interesadas para informarles del resultado de dichos estudios.

Apesar de que los estudios han recibido muchas críticas, deben considerarse algunos buenos puntos, como la recomendacion de reservar un area para viviendas para los de la edad dorada, y la recomendación de que el Parque Chicano se extienda hasta la bahia. Tambien se recomendó una nueva zonificacion y cambio de local de las industrias si fueran necesarias para permitir el desarrollo de más viviendas para doblar la poblacion residencial. Y ademas de todo esto, reconoce la necesidad de más comercio,

como farmacias, y grandes super-mercados que podrian ofrecer precios mas ventajosos que los que actualmente existen.

Otra critica sobre los estudios es que no estipulan la calidad de las propuestas nuevas-viviendas. Tambien otra critica es que ademas de recomendar que Logan Heights continúe siendo una area "mixta", (viviendas intercaladas con industrias), tambien recomienda que dos "Parques Industriales" se realicen, un "Parque Industrial del Sur" y "Parque Industrial Dalbergia del Norte". El desarrollar ambos, causaria el aumento de "Industrias Grandes" (fabricas, fundiciones etc.) causando el trastorno y mudanzas de residentes del area de Dalbergia.

La critica mayor de los Estudios es que los residentes del area han tenido poca representacion. Esto se vé en que el "grupo de la Comunidad" que los Consultantes reconocen, son los de las "Industrias Grandes", "Industrias Ligeras" "Negocios Mercantiles", "Grupos de Servicios Sociales", "Representaciones de la Ciudad", La Marina de los EE.UU. y a lo ultimo - "los residentes". Debido a ésto, es aparente que los residentes, cuyos deseos son el de tener una vecindad tranquila, saludable y segura en donde vivir y criar a sus hijos, fueron los que menos representacion tuvieron en los estudios. Y en contraste, el elemento industrial cuyo único deseo son las ganancias, recibieron reinado sobre los estudios.

Cuales fuera hayan sido las criticas ó alabanzas, es obvio que todos los grupos é individuos del Barrio Logan seran afectados por las recomendaciones, y subsiguientes decisiones del Concilio de la Ciudad. Será inminente el

KIOSCO

The Kiosco is finally under construction!

In the last issue of our newsletter, I reported that the City had made a mistake on the amount of money for the Kiosco and that we needed an additional \$40,000.

A memo went out from the Parks & Recreation Dept. to the Councilman, stating that funds were available in Capital Outlay Unallocated Reserve Fund, and they recommended that the additional funds be approved for the Kiosco.

So it was up to the Council to approve the additional funds... But how could the council approve anything that wasn't even presented to them.

Councilman Jess Haro would not present it to the council because he did not like the design of the Kiosco. He felt the design should be Spanish (why not just build another Taco Bell). So the project was at a stand still for 2 1/2 months.

We tried to meet with Jess Haro for a long time, when he finally did meet with the Chicano Park Steering Committee, and residents of the barrio, the gente expressed to him that the design of the Kiosco as it is now, was what the people wanted!! If we want "Spanish" anything, we can go to Old Town!! (That is if we could relate to it)

On Wednesday, June 1, 1977, Jess Haro made the presentation to the Council, and believe it or not, it was a good presentation. The Council all voted in favor of the additional funds for the Kiosco.

On July 6, 1977. Patrick J. Timmins Construction Inc., started construction of the Kiosco. We have been in close communication with Patrick

Timmins, and he is doing a good job and he is keeping up to the time schedule he set up in June. If all goes well, completion of the of the Kiosco should be about the second week of October 1977.

Our own local artist will paint the Kiosco. We are planning a ceremony after completion of the Kiosco.

En el Mes de Junio, la Federacion Chicana inicio un proyecto singular.

Los trabajos que éste grupo de trabajadores ejecutan, incluyen el jardín, pintura, arreglo de cercos o instalación de ellos, arreglo de techos y ventanas, cemento (trabajos de albañil), y de todo, menos los de construcciones mayores.

La Señora Esperanza Valdez, de la Avenida Newton, y la Señora Dolores Martínez, de la Avenida Kearney son dos señoras ancianas que están extremadamente satisfechas con los trabajos hechos en sus casas.

Aunque éste programa se dedica a los problemas del desempleo y el mejoramiento de las viviendas en una escala reducida, sin embargo tiene éxito y muestra resultados que se pueden ver.


The Chicano Park Steering Committee is now struggling with a new project to expand Chicano Park by constructing a Plaza on the lot between National Ave and Newton ave (across the street from the Park).

This new project consists of constructing a Plaza around a water fountain complimenting the Kiosco that is now being constructed. A concrete floor, planter benches (around the pillars), drinking fountains and trees are also part of the proposed Plaza. Electrical outlets, lighting and flag stone will also be characteristics.

The meeting was cancelled due to lack of a quorum, but the consensus of the Board members present was to approve the Plaza. On September 6th the Southern Area Committee also approved the project.



And that the banks have loaned almost no monies for home repairs or home additions in that area. And did someone say that the residents of Logan Heights pay more taxes on their homes each year because of the way it's zoned (M-1), industrial, even more than Clairemont or La Jolla.

To say the least, someone in Logan Heights needs help as well as anyone else in San Diego at sometime. To consider the Senior Citizens of Logan Heights deserving of any help is the understatement of the year.


And so, our choice citizens (Seniors), are first to receive the help that the Chicano Federation Renovation Team is able to give. And don't think you can't help, you see we ourselves have to hustle the materials and donations to fix these houses.

Besides putting a conditioner (primer) on the house and then the paint, we replace broken windows and refit older ones. We also check out their electric system, put up and paint fences or replace old ones, clip trees, cut weeds, salvage dignity within the community. Oh, we check roofs for leaks and retile a roof where it needs it.

Don't forget that these people are of the lowest on the income scale (i.e. Social Security). So if you can donate money or materials please call and ask for the Renovation Team at 236-1228 ext.33.

**"FOR OUR DIGNITY AND HONOR",
IT'S BETTER IF YOU SAY NOTHING**

"Dedicated in Honor of Independence Day, July 4, 1977".

This banner headline ran across the front page of a newspaper which falsely claims itself as 'San Diego's Only Chicano Community Newspaper'.

Maybe Mr. Prensa needs to be reminded that Chicanos have nothing, if so very little, to celebrate on July 4th.....

...In a country that has tried to wipe out all our history and raped our culture and pride. A country where our people fill the jails with petty crimes while the rich gabachos get away with Watergate crimes and murder.

Since this newspaper, supposedly belongs to the people, it's about time the people became aware of the "hypocrisy" of the dignity and honor" which lies in between those words.

On January 27, Mr. Prensa served Gallo Wine (Carlo Rossi) during the Open House party despite staff members telling him to "get rid of it". Instead, the wine was poured into unlabeled containers and served to community people who whole-heartly support the UFW boycott of Gallo Wines.

(Note: This same wine- Carlo Rossi - created a semester of controversy at SDSU last year due to advertisements in the Daily Aztec. This chaos eventually led to the non-funding of the Farmworker Support Group and the abolishment of the UFW lettuce policy at SDSU).

Reliable sources also told "El Chingazo" that: An undocumented Mexican worker was paid slave wages of \$2.50 per hr. for type-setting the newspaper, a job that requires much skill and pays \$8.50 - \$9.50 an hour elsewhere.

When confronted by angered staff members, Mr. Prensa's justification was typical of any exploiter; "He's making more money here than he would be in Mexico".

Besides these facts, Mr. Prensa also turned down stories regarding: an out of town Chicana speaker at Las Hermanas Coffee Shop; articles concerning the Bakke Decision (the biggest blow to Chicanos in their fight for higher education); and news coverage of UFW-related issues. (Why weren't the ALRB sit-ins and picketlines at Nurseryland covered?)

These are the type of articles the community needs to know about! Not some stupid story on a Gauchopine Don Diego or a dumb, sexist contest on some blonde Mexican-American ruca. Son Pendejadas!


It's no wonder that ten original staff members have quit La Prensa! Who can blame them? Only a "tapado" would put up with this shit!

¿que es bakke?

racist attack on education!!!

WHAT IS THE BAKKE DECISION?... in 1974, Allan Bakke, a 34 yr. old gavacho, was refused admission to medical school at the University of Calif. at Davis. There were only 100 places available and 16 of these were filled under a special admissions program for disadvantaged minority students- Chicano, Indio, Black, and Asian. Bakke filed a law suit claiming that some of those 16 minority students were less qualified than him and that he was being discriminated against because of his race. The California Supreme Court ruled in his favor saying that the minority programs are unconstitutional because they violate the "equal protection" clause of the 14th Amendment of the U.S. Constitution. Thus declaring that special admissions were discriminating towards gavacho students. The system calls this "reverse racism", the Raza calls this "puro pedo".

In the 60's and early 70's our Carnales y Carnalas fought for a better education of our Raza. They had student walkouts, riots, militant demonstrations, marchas, and protests against unequal and racist education. Organizations like the Brown Berets, MEChA's and MAYO, took part in these actions. Many people were killed, hurt, and imprisoned. So many of their futures were destroyed and because of criminal charges brought against them, and today they can not hold a decent job. Because of the struggle and the pressure from our Raza- the system created special admission programs to increase the number of Chicano and other non-white students in colleges and universities. We must remember that it was through the struggle of

our Raza that these programs were created - - not because this chicken shit government wanted to help out minorities.

The two main reasons for the need of special admissions programs are (1) most minority students don't have the money to pay for tuition, for books, or for room and board while attending school (2) the shitty education we got in the barrio schools from racist teachers can't even take us through "welding school", much less a medical school. Even though minorities make up 35% of the population of California and we pay 35% of the taxes, taxes that go towards education, we make up only 2% of the student body in the colleges and universities!!!! The only place we are represented (over represented) is in the state prisons! We make up over 50% of the prison population. How come we never hear about reverse racism in Prisons?

The Bakke decision threatens the future of our Raza. We must unite and overturn the Bakke decision. We must use "any means necessary" to overturn this racist decision. Education is a right, not a privilege!

Here in San Diego Mecha Central (Mecha Central is made up of representatives from Mecha's in San Diego County- San Diego Evening College, Mesa College, U.C.S.D., San Diego S.U., Grossmont, San Diego City, and Southwestern College) has taken the initiative against the Bakke decision. Mecha Central has organized educational forums, a petition drive, a demonstration was held Feb. 23 in front of the Federal Courthouse Building in San Diego. On May 7, a marcha and rally was held by State-wide Mecha in Los Angeles- over 2,000 Mechistas participated in this march.


¿QUIENES ESTAN DETRAS DEL HARBORVIEW "COMMUNITY COUNCIL"

Pero hay que preguntarnos algo. ¿Como es posible que esta pareja de gringos baratos se crean tan importantes como para cambiar el nombre del parque y negar cualquier referencia a las palabras "Chicano" y "Barrio Logan" del parque en la bahia? Porque esperaron hasta despues de las negociaciones con el Puerto para atacar nuestro logro "de establecer un parque a base de negociaciones"? Finalmente, porque es que los Ducheny y su "Concilio", se han dedicado en atacar y ofender a la personas que han luchado por varios años para hacer mas fuerte al Barrio Logan?

Para comprender la motivacion de los Ducheny tenemos que considerar lo siguiente:

- 1) Los Ducheny tratan de dar la impresion de que son Chicanos y NO LO SON. Son unos izquierdistas fracasados que intentan hacer mas poderoso a su partido politico (Communist Party Marxist|Leninist). Le recomendamos a toda persona interesada que tengan cuidado con los planes de los Ducheny. Ellos no son nadien para intervenir en los asuntos del PARQUE CHICANO EN LA BAHIA .

LOS "METICHIS" QUE APOYAN AL TAL
HARBORVIEW "COMMUNITY" COUNCIL

ALVIN y DENISE DUCHENY se plantaron en los barrios de Sherman y Logan desde la primavera de 1982. Han dirigido sus actividades a la confusion y division de nuestras comunidades. Ambos son miembros y organizadores del partido Comunista Marxista-Leninista y su intencion es imponerse sobre los Chicanos de los barrios.

Recientemente se han concentrado en lo siguiente: 1) Infiltrar el periodico "La Pensa Muñoz" donde han hecho que se escriban historias exageradas y mentirosas sobre el Parque en La Bahia; 2) Establecer su organizacion llamada, "Harborview Community Council" - formada hace 5 1/2 meses. Este tal "Concilio" ha sido un instrumento para que ganen atencion. Por medio de este "Concilio" han hecho ataques verbales muy destructivos y han lanzado acusaciones de "vendidos" a personas que si trabajan a favor de la comunidad. El trabajo de los Ducheny se basa en mentiras. Es importante saber que el "Concilio" es controlado entre Alvin y Denise Ducheny. Esto es peligroso considerando que ni uno ni otro son Chicanos. Alvin apenas tiene rasgos de Puerto Riqueño--segun el-- y haci trata de pasarse como Chicano.

DENISE DUCHENY tambien es la abogada personal de DAN MUÑOZ, el periodista de La Prensa. Ella es la que le sugiere lo que debe escribir y el lo hace puesto que nunca se para el Señor en el barrio para saber que pasa.

ALFONSO "PELON" JOHNSTON es otro entre la bola de metichis. El es uno de los dueños de casa que mas explota a sus inquilinos. El es amante de formar comites innecesarios como deporte y esto lo hace sin falla por lo menos una vez cada dos años. Debido a el, cada uno do sus grupos se acaba sin lograr nada. Es mas, el fue el que formo el "Barrio Residents Association"--un grupo que se acabo tan facil como empezo, y, sin hacer casi nada. Alfonso tambien es un "corre y ve dile" para Daniel Muñoz de La Prensa.

En 1970, Alfonso fue nombrado por el Alcalde de la ciudad para administrar un fondo de \$9,000 dolares al año para ayudar ciertas comunidades. ¿Porque no ha mejorado mucho Barrio Logan desde entonces??

Luego, el incorporo el primer grupo oficial de Planeacion para nuestra area que no hizo nada. Es mas, se le pago a este grupo \$20,000 dolares por medio de la ciudad y de todos modos no hizo nada. La gente del Barrio se canso de el y de su falta de accion y conocimiento en asuntos de planeacion y mejoramiento del barrio.

"LOS METICHIS".....

De nuevo, fue nombrado Alfonso por Peter Chacon para que el participara en las negociaciones con el Gobierno de Puerto de San Diego sobre el parque Chicano en la Bahia. Aunque se le dio una oportunidad para que haga algo positivo, fue poco lo que hizo. Aunque no quiera reconocerlo, el fue parte del trato de que se divida el terreno del parque. Ahora el esta diciendo que fue "victimado", "confundido" e "inocente".

Como si no ha hecho bastante mal, Alfonso se ha unido con Alvin y Denise Ducheny para empezar otro grupo. El mismo grupo que se ha dedicado a mentir y hacer de chismes. El asunto del Parque Chicano en la Bahia.

JORGE PARRA es un joven que "va y viene" segun sus vacaciones escolares para solamente agitar las cosas en el barrio. En un tiempo fue el portavoz para el "Barrio Logan Residents Association". Solo trata de crear division entre la gente del barrio con sus ideas que inventa en la escuela sin consultar a gente del barrio. Jorge solo es dedica en atacar a la gente para que se sienta el gran lider. Tengamos cuidad con este "estudiante" ansioso de hacerse lider.



Ya trece años de existencia, este grupo ha cumplido con varios proyectos pra mejorar el parque. Estos son:


- El area de juego para niños

A parte de esto fuimos NOSOTROS los que prevenimos que se construya una fabrica de barcos que hubiera prevenido cualquier parque en la bahia. Es mas, fuimos nosotros los que promovimos que el concepto del parque sobre la bahia se incluyera en los PLANOS DEL PUERTO. Estos y muchas mas logros han sido los HECHOS que hemos logrado.

Nuestra organizacion, "CHICANO PARK STEERING COMMITTEE", siempre se ha basado en la accion y no las palabras. Con la reciente intervencion de estos oportunistas y agitadores politicos que pretenden hacerse mando de nuestro Barrio e interrumpir la expansion del PARQUE CHICANO HASTA LA BAHIA, nuestro comite se ve obligado en dar a conocer a todos sobre quien, en realidad, esta trabajando a favor del Parque Chicano y la comunidad. Es por esto que nos vemos obligados a informar a todos los Chicanos a nivel nacional, estatal y local sobre los sucesos y la historia




"LOS METICHIS".....

HERMAN BACA es el que dirige el "Comitee on Chicano Rights". Baca y su grupo han aplaudido y apoyado a La Prensa y al "Harborview Community Council". Esto es ironico porque a fines de 1978 Herman se quejaba de los "rojistas" que infiltraban los barrios. Durante este tiempo denuncio el partido extremista, "Socialist Workers Party" porque este grupo trato de manipular a la gente Chicano y sus movimientos. Ahora, 5 años despues, Herman esta demostrando sus verdaderos "colores".

A parte de unirse con los oportunistas Ducheny, Herman es un intimo amigo de Daniel Munoz. Al tiempo que varias personas han rechazado el periodico de Munoz, Herman Baca es un cobarde que aun le tiene miedo al periodista. Hace poco, muchas personas y organizaciones valientemente denunciaron a La Prensa. Sin embargo, Baca fue uno de los que prefiere apoyar a "DANIEL EL COCHINO". Mientras nosotros luchabamos a favor de los campesinos en sus huelgas y marchabamos en contra de la guerra en Vietnam, el tal Herman Baca se recuperaba del cansancio de las campañas de su candidato RICHARD NIXON. Desgraciadamente la respuesta esta en que esta gente solo se ve cuando hay oportunidad de mejorar su situacion politica personal.



La Comision Estatal Costera, durante su junta del Miercoles dia 27 de Julio, 1983, en Marina del Rey, re-afirmo su apoyo, que por dos anos a dado, y, de nuevo reconocio nuestro justo pedido de hacer una apertura en la Bahia. Nuestra comunidad con vista a la bahia, incluye el area entre la bahia hasta el "freeway" 94, que se extiende hacia el oeste a la calle 16 y que continua al este al boulevard Wabash--ahora el "freeway" 15. Nuestra comunidad no solo es "el area del Barrio" que esta al sur del "freeway" 5. Dentro de las fronteras de nuestra comunidad con vista a la bahia viven mas de 15,000 personas.

Al costado de nuestra comunidad esta Golden Hills al norte, el area de City College y San Diego High School junto con el centro de la ciudad y el area de Southcrest hasta National City donde hay muchas mas personas que trabajan y viven. 


4. We resent "outsiders" taking sides because they don't know the issues and the motivation of the players involved.


Who's Behind the Harborview

"Community" Council?

One of the critical points to understand in relation to the disgust and distrust felt towards them by the gente in Barrio Logan is that this couple and its council are seen as Johnny-come-lately carpetbaggers that were not around when the real "chingazos" were flying over the now popular issue of "All the Way to the Bay". OUTSIDE SUPPORTERS OF THE SO-CALLED

HARBORVIEW "COMMUNITY" COUNCIL

ALVIN and DENISE DUCHENY "planted" themselves in the Sherman and Logan Heights communities in approximately spring of 1982. They have directed their activities at dividing and confusing our communities. Alvin and Denise are members and organizers for the Communist-Party, Marxist-Leninist "click."

Recently they have concentrated their efforts on: 1) Infiltration of La Prensa Newspaper, carrying exaggerated stories about the bayfront park issue; 2) Creation of their so-called "Harborview Community Council", (formed ~~5~~ 1/2 months ago). In 1970 Al was appointed by the Mayor to CAB-Model Cities to control \$9,000,000 a year for target areas. How come Barrio Logan is still fighting deterioration? They sure pick them good!

Then he incorporated the first official planning association to "improve" Barrio Logan. Well, \$20,000 were paid to his group by the City and nothing good ever happened for Barrio Logan. The people got tired of his "trip" and took action.

Again, good old Al got an official appointment by Peter Chacon onto the Chicano Bayfront Park Negotiating Committee. He was a part of the "compromise" all along and again acted "innocent", "victimized", "confused", etc.

JORGE PARRA "pops" into Barrio Logan between "school breaks," agitating community efforts. While working at the Chicano Federation, Jorge disrupted the community planning efforts by "gossiping" about Barrio people to the White man and attempted to include a "Tourist" area on our proposed bay park land. Taco stands, pescado stands, etc. Money making pendejadas. It had been settled that the Bayfront land would be split between Chicano Park and a Longshoreman Union Hall when Jorge and his click interfered with their proposals for a "Mercado for the Turistas". It was at this point that the Port District gave up on community input and decided to build a shipyard on the entire 5.4. acres. Our bay-front efforts have been disrupted over and over again.

He made moves to turn Barrio people against each other. Where does this kind of energy and direction come from? We've had it with Mr. Parra and his kind.

The name of Jorges' game is "attacking" people to gain visibility and opportunity. Watch his pattern and beware of his presence.

JOHN GLEN - A black realtor has joined this group of agitators. He has been run-off planning associations in the past and has one of the filthiest residences in this barrio. At a recent City Council meeting Glen stated he didn't care about the bayfront park because "I'm not going to use it anyway." Yet he sits on the so-called Harbor-view Community Council.

The concept of a Chicano Park extending all the way to the waterfront was born with the takeover of the land under the East end of the Coronado Bridge. It was April 22, 1970 when residents of the Logan Heights Barrio decided not only on a community park but also on a park that would eventually extend to the waterfront of San Diego Bay. This small acreage of land occupied by community people at that time was not a large piece of land, but the symbolism, cultural and historical value of this act would generate local, state, and eventually national community awareness for this cause.

It was at this time, that involved and concerned residents and supporters saw need for the formulation of a committee to deal with any issues that would arise concerning the development and expansion of Chicano Park. These were the inceptional needs which gave birth to the Chicano Park Steering Committee.



In the thirteen years of its' existence, the Chicano Park Steering Committee has dealt with, and accomplished such projects as the Tiny Tot playground and the larger playground equipment area, the Mayan designed Kiosco Bandstand, the closing of Dewey Street to connect the North and Southern section of the park, the construction of the Plaza and water fountain area,

construction of the restroom facilities in the park, construction of the basketball court facilities, organizing and producing the annual Chicano Park Day Celebrations which have brought National and International support to the cause of Chicano Park, Annual community Christmas programs for underprivileged Barrio children, formulation of the Bayfront negotiations committee to deal with the issue of Bay access and extension of the existing Chicano Park to the waterfront, coordinating with local artists in the upkeep and production of the mural projects, dealing with legislation that has effected the future of the Chicano Park on the bay such as AB-47 in 1979 and AB-2280 in 1980, halted the construction of a ship repair yard that was to be constructed by Mauricio and Sons and pushed for the insertion of a Barrio Bayfront Park in the Port Master Plan. These and many more not mentioned have been the historical accomplishments in the expansion of Chicano Park.

The Chicano Park Steering Committee has always been based on action and not words. With the recent intervention into barrio affairs by carpetbaggers, agitators, political leeches, and barrio messiahs, that have stifled and disrupted the expansion of Chicano Park All The Way To The Bay, the committee has had to bring it to the attention of Local, State, and National concerned Chicanos




We suggest that John "clean up" his front yard, fix up, paint up his properties in Barrio Logan first!!

In September/October 1978, Herman was crying "red" all over the barrios, denouncing the Communist based, Socialist Workers Party for not respecting the right of Chicano self-determination and for attempting to manipulate issues which were already being addressed for years. So while most of us were striking with campesinos against grape growers, marching at the Chicano Moratorium and taking over Chicano Park, Herman was recuperating from the ills of the Nixon campaign and five years later he became a self declared leader.

It seems that the DUCHENY'S, LA PRENSA and BACA have formed a three ring circus, a left wing, right wing, nationalist(?) alliance in their attempt to manipulate the issue of "Chicano Park, All the Way to the Bay!"

The above individuals were not part of the takeover of Chicano Park in 1970 nor have they been involved in the development and extension of the park during the 13 1/2 years the park has existed. Along with Munoz, Herman has never attended a Chicano Park Day celebration, other than when he was invited as a guest speaker for two celebrations.

It has not been easy these last 13 1/2 years. We will continue to work towards that goal of bay-access. We have documentation of every meeting regarding this issue which dates back to 1970 to the present. We will expose every opportunist who tries to rape the progress of Chicano Park.

that have supported the cause of Chicano Park and those people who have worked and sacrificed for its' existence.

From day one, every accomplishment has been a small one, but a sure one. Thus was the case in the Bayfront negotiations. 2.7 acres was not a large amount of land, but neither was 5.4 acres. At a time like this when the State and the Nation are being governed by very conservative administrations, the 2.7 acres of land on the San Diego Bay waterfront would have been another battle won. Not just for Chicano Park, but for the lifelong war that goes on in every Barrio of this Country.

The intervention by outside agitators, carpetbaggers, and political leaches which again delayed all the work and efforts that brought us to this point in the negotiations will not be looked upon lightly. Where were these negative elements 13 years ago when the land was taken? Where were these negative elements in 1980 when community residents and supporters marched to the waterfront to declare the expansion of Chicano Park all the Way to the Bay?

For that matter, where were they prior and during the 13th anniversary celebration of Chicano Park when there was so much work to be done? The struggle of Chicano Park has never and will never rely on those negative elements that are only interested in their political aspirations. Those that have sacrificed and worked for this cause know and understand that this struggle cannot be prostituted as a free ride to "fame and glory" by a

handful of political hobos.

If the struggle for Chicano Park and the symbolic historical and cultural ideals for which it exists are a positive inspiration to Barrio youth everywhere, then it must be respected as that. The Chicano Park Steering Committee will continue its work in expanding the Park to the waterfront as well as their latest accomplishment of the new handball court facilities which will be under construction soon. Planning and ground work for the 14th anniversary of the park is also underway. We have been involved from day one and we will be here a lifetime. It is in the best interest of the Chicano community and supporters of the Chicano Park struggle that these agitators and political leaches refrain from interfering and disrupting the ground work that has been laid down over the past 13 years and all future work in progress dealing with the development and expansion of "Chicano Park All the Way To The Bay!"

Dear Mr. Bennett:

We, the steering committee of the HarborView Community Council, wish to thank you for your editorial of 7/29/83 in support of our bay park at the foot of Crosby Street.

The Coastal Commission, at their meeting on Wednesday, July 27, 1983 in Marina del Rey, reaffirmed their support, given two years ago, and recognized once again our justified request for an opening on the Bay. Our HarborView Community, which begins at the bay and extends north to R-94, goes west to 16th Street and east to Wabash Boulevard, now R-15, is not just the so-called "Barrio Area" south of the freeway R-5. Within these boundaries of our HarborView Community live over 15,000 people.

Adjoining our community to the north is Golden Hills, the City College and San Diego High School area along with the downtown area west of us and the SouthCrest area stretching all the way to National City east of us, where many more thousands of people live and work. All these communities will also benefit by our new HarborView Park.

We ask them to join with us in support for this opening on the bay - the last one for five miles down the road in National City. There is also good reason for support because of the continuing population surge that is occurring and will continue to happen as the Convention Center draws in many more thousands to San Diego for jobs and to live in America's "Finest City".

We therefore request that in the future you and others do not refer to us as a "Barrio Park" but as the HarborView Community Bayside Park.




