My dear Mr. Timken:

Attached hereto is a copy of the contract between the F. & W. Thum Company, and James A. Murray, Wm. G. Henshaw and Ed Fletcher, duly signed and recorded, whereby the consent of the F. & W. Thum Company is secured to build a certain tam, or dams on the North Fork and South Form of the San Diego River, one dam being ten miles above your property, and the other seventeen miles, and if there is any damage caused by the construction of these dams, then in that case, the Water Commission of the State of California determines the damage and we agree to pay.

This contract was in reality drawn by the State Water Commission of California, and has their approval, and they have agreed to serve.

I certainly hope that the same agreement can be immediately entered into between you and ourselves for the portion of the El Monte Ranch which you still own. I am not asking for any contract with you for any land which you have sold outright to others, or slready have under contract. Your interests are absolutely secure under this contract, in my opinion, as safely as they can be secured legally.

The City of San Diego are now making core drillings for bedrock just a mile above the east line of the El Monte ranch at the El Capitan damsite. It seems to me your interest is with us to have the dams built as far away as possible.

I shall certainly appreciate your cooperation and Messrs. Murray, Henshaw and Fletcher are willing to sign the identical contract that we have already signed with the F. & W. Thum Company. As a personal favor, will you please give this your immediate attention, for the best interests of San Diego County and the early development of the San Diego River by the construction of a dam to conserve the flood waters.

tention to the fact that the signed contract between the owners of the Cuyamaca Water Company and the F. & W. Thum Co. allows us to build dame on the San Diego River or any of its tributeries.

The above refere to the contract now on record, between F. & W. Thum Co. and the Cuyumaca Mater Company, owners. It is not our desire, however, to make such a sweeping reservation. The San Vincente River coming in by way of Fosters to Lobsside is a very large stream having. I believe, in emoses of 100 square miles of water-shed. We have no intention of building any dame on the Son Vincente River, and wan no dam sites or reservoir sites on that stream. Therefore, we are willing to limit the reservation in your contract to securing your consent to the building of a dam or dams on the Borth Fork and the South Fork or its tributaries, or the San Diego River. This limits us to building only on the San Diego River from 10 to 20 miles above Lamside.

In reality it is our intention to build only two dame: a small diverting dam on the South Fork about 12 or 14 miles from Lakeside, and a large dam about 20 miles from Lakeside, at or above the Diverting Dam. This leaves the riperian owners with the entire water-shed of the San Vincente River, together with the entire water-shed of Chocolate Canyon which comes in from Viejas and Alpine, together with all the water-shed below the Diverting Dam, 20 miles above Lakeside. If my recollection serves me right, it includes El Cajon Valley, which gives a water-shed of over 220 square miles below out dame and above Mission

Mr. Bridges was certainly an angel for Mrs. Ayres in the first place, but nevertheless, the Bridges investment is safe if it is handled right. I have read with interest the report of T. J. Allen, also the financial status by A. Haines, all referring to Whispering Pines and Mrs. Ayres.

The water supply comes from the springs and creek thru the property marked Circle A.

I never had any financial interest in Whispering Pines, my only interest being that I acquired a first mortgage on the residential subdivision property marked "I" in connection with the purchase of other properties from C. W. Potter, Mrs. Ayres having the equity to the property marked "I", subject to the \$5200 mortgage in Potters' favor, which was assigned to me by Potter when a deal was finally consummated.

of the \$51,000 paid out by Mr. Brigges thru an arrangement with Mrs. Ayres over \$40,000 was spent on the property marked "X" in grading roads, pipe lines, fire hydrants, concrete reservoirs, etc. This was all done without my knowledge until it was almost completed, but these improvements added, of course, to the value of my mortgage and made it gilt edge.

In my opinion, the only may to protect the Bridges Estate interest in this property was for you to acquire my mortgage, for the reason that you could then dictate the release clauses and make them high enough to protect the Bridges Estate in its advances.

On investigation, you will find that your security is very much greater now by acquiring the first mortgage than otherwise. Under present conditions Hrs. Ayres can hold out on you for a couple or three years before you can ever get title, and will take a year and a half to two years to foreclose in order that the Bridges Estate may get title.

I advocate the forming of a mutual water company. Your investment in relation thereto already amounts to around \$60,000, with interest. Your additional losses: in operating the water system until it takes care of itself, dill amount to \$15,000. You need some extra money to take care of riparian owners below, with a surplus for emergency. Therefore, I would say a \$100,000 mutual water company be organized, 500 shares at \$200 a share, or 1000 shares at \$100 a share. You are then in position to sell at \$200 or \$100 a share depending upon the amount issued as you see fit, and you can increase the cost of this mutual water company stock as the demand for water stock increases, one share to each lot.

The mutual water company to make a readiness-to-serve charge of \$1.50 per month in any event, and at least 35¢ per 1000 gallons for water. You will have surplus water stock that you can sell some day to the town of Julian or that vicinity, as you will have 500 shares to sell, where you have only 210 lots in the new and old subdivision, as I understand it. I am sure there will be enuglin water supply to take care of a mutual water company under this plan.

I will be glad to copperate with you in any way that I can in this matter.
