KONO PATROL REPORT NO. 1 OF 1964/65.

Thank you for the above mentioned Report which was received on the 19th October, 1964.

This is a most disappointing document and reflects adversely on the patrolling officer.

Mr. Greedy should study the Departmental Standing Instructions, Volume I and give particular attention to Chapter IV. I am aware that Mr. Greedy considers that Reports are not necessary for the Kono Area. His reasons are that the area has been de-restricted; this is not entirely correct, the area has been recommended for de-restriction but to date has not been gazetted as such. However, apart from this consideration there are two other salient points. (i) Reports are still required if a Patrol has been conducted in a markedly under-developed area - Kono in my opinion falls into this category (page 13, Vol. I Departmental Standing Instructions, supra.) (ii) One of the prime objects of writing a Report is to afford the writer an opportunity to marshall his thoughts and reduce them to a succinct and logically formed statement. This aspect Mr. Greedy fails to do and he obviously requires more practice in this field if his career is not to suffer.

Your remarks concerning the proposed medical patrol have been noted.



Tuesday ..7th July.

Departed KOMO after various station matters for MIGILI early afternoon - track well cleaned - preliminary talks - fresh foods for trade - routine administration.

Slept MIGILI R/H.

Wednesday, 8th July.

Revised initial census of this group - slight confusion only over names remainder day general talks, varicus minor disputes/enquiries etc.etc.

Slept MIGILI R/H.

Thursday, 9th July.

Departed MIGILI FOR EMBETALI - fresh foods for trade - talks by self and Agric. Field Assistant followed by revision of census - minor disputes and enquiries only.

Slept EMBETALI R/H.

Friday, 10th July.

Depart EMBETALI for LANDA - rest house marked by previouski patrol well built except for walls which are sufficient for two stories. Talks - fresh foods for trade - revised census - 2 C.N.M's and various minor disputes.

Slept LANDA R/H.

Saturday, 11th July.

Depart LANDA for TIUNTE- track poor - talks - fresh foods for trade - revised census - minor disputes - routine administration.

Slept TIUNTE R/H.

Sunday, 12th July.

Monday ,13th July.

Depart ATARE for AIJAGAIBA - fresh foods for trade - talks - revised census - disputes/enquiries etc. - routihe administration etc.etc.

Slept AIJAGAIBA R/H.

Wednesday 15th July.

Depart AIJAGAIBA for TANI surveying road route en route - fresh foods- talks - revised census -disputes/enquiries - routine administration. Slept TANI R/H.

Thursday 16th July.

Depart TANI for EGAUWI - carriers via normal track - self with V/C's etc inspecting terrain for road route etc. - fresh foods -talks - revised census - disputes/enquiries -routine administration.

Slept EGAUWI R/H.

Friday 17th July.

Equipment to PADUA rest house - self road surveying arriving back at PADUA late afternoon - fresh foods etc.

Slept PADUA R/H.

Saturday 18th July.

Saturday 18th July.

D.A.S.P. and self talks - revised census - one dispute - departed for KOMO surveying unsuccessfully road route across hill - arrived KOMO 1820 hours.

19th & 20th July.

At KOMO

Tuesday 21st July.

Depart KOMO early morning for PADUA - successful survey of road route - returning KOMO late afternoon.

22nd July to 28th July.

At KOMO.

29th July, Wednesday.

Departed KOMO for YANDALE in light rain - decided not to proceed further - fresh foods etc - general enquiries - one C.N.M. adjourned. Slept YANDALE R/H.

30th July, Thursday.

Continuation C.N.M. at YANDALE. Departed for POROYANDALE carriers via main track - self following ridge surveying and cutting road route eventually to TARI - arrived POROYANDALE late afternoon - fresh foods for trade - routine administration etc. Slept POROYANDALE R/H.

Friday 31st July.

Census revised at POROYANDALE - numerous minor disputes/enquiries - fresh foods - routine administration - road works. Slept POROYANDALE R/H.

Saturday 1st August.

Depart POROYANDALE for TEREJAGA - carriers via main track, self road surveying arriving TEREJAGA late afternoon in heavy rain. Road route along ridge from KOMO excellent but unfortunately mid way leaves main population and proceeds through bush - consequently a new route which stays with the population will be found. Slept TEREJAGA R/H.

Sunday 2nd August.

Survey of two bridge sites - three disputes including one axe wounding - fresh foods for trade - routine administration. Slept TEREJAGA R/H.

Monday 3rd August.

Census revised at TEREJAGA - remainder of day on numerous disputes two only requiring jail sentences - routine administration etc. Slept TEREJAGA R/H.

Tuesday 4th August.

Depart TEREJAGA after hearing one further dispute for TURUBI - fresh foods etc - rest house walls of old 'pit-pit' with now numerous gaps. Strong talks given assembled people and remainder day same repairing rest house - One C.N.M. Slept TURUBI R/H.

Wednesday 5th August.

Census revised at TURUBI - election held for Village Constable of this group - two candidates both tying - no decision made for present. Various disputes - 3 males IHL sentences - routine administration etc. Slept TURUBI R/H.

Thursday 6th August.

Depart TURUBI for EKAIBA - road general survey en route particularly bridge sites- fresh foods for trade - talks -census revised - disputes - routine administration etc.  
Slept EKAIBA R/H.

Friday 7th August.

Depart EKAIBA for KUNGU Rest House - fresh foods for trade - imminent rain so females and children returned houses - afternoon on various disputes/enquiries etc - routine administration.  
Slept KUNGU R/H.

Saturday 8th August.

Talks - census revised at KUNGU - two disputes - investigated absence of aged female and three sons - attended females house - delapidated, supervision construction of new house - departed for PAMI - fresh foods -preliminary talks - routine administration etc.  
Slept PAMI R/H.

Sunday 9th August.

Semi observed at PAMI - all census books counted etc.etc.  
Slept PAMI R/H.

Monday 10th August.

Census revised at PAMI- three disputes heard and settled, 2 further adjourned to MINDIETE - depart PAMI for MINDIETE -fresh foods - routine talks - visited U.F.M. Mission - investigation suicide late afternoon.  
Slept MINDIETE R/H.

Tuesday 11th August.

Census revised at MINDIETE - 2 disputes - depart for YANDALE -fresh foods for trade-talks - disputes/enquiries etc.etc. Inspection immediate road works - routine administration etc. Carriers house fires late afternoon.  
Slept YANDALE R/H.

Wednesday 12th August.

Talks and census revised at YANDALE - arrival at rest house of M.H.A. HANDABE of TARI electorate for talks etc, informs A.D.O. at KOMO on completion of census revision depart for KOMO.

13th August to 25th August.

Varicus station matters at KOMO.

Wednesday 26th August.

Departed KOMO for KURUKUMBUTEI in light rain - carriers having been sent ahead earlier - fresh foods for trade- routine talks etc.  
Slept KURUKUMBUTEI R/H.

Thursday 27th August.

Talks - census revised - all afternoon on essentially two only disputes against Village Constable of this rest house namely adultery, alleged intercourse with female child and a third of pig stealing brought forward. 2 dismissed due to time limitation- third of intercourse with female child to be brought before Supreme Court.  
Slept KURUKUMBUTEI R/H.

Friday 28th August.

Depart KURUKUMBUTEI via new track to IDANI - KURUKUMBUTEI rest house definately not central to thisgroup and new rest house site will be selected next patrol - approx. 4 hours to IDANI - fresh foods- 4 disputes - routine administration etc.etc.  
Slept IDANI R/H.

DIARY Cont.

1964.

Saturday 29th August.

Talks re census, roads, area survey - revised census of IANGALI and TUGUBA 2 groups at IDANI - 5 C.N.M.'s heard and settled - arranged for clearing of tent sites at ANCORE for survey of this area for a new rest house central to these groups - IDANI having been initially constructed as a half way house for the carrying of supplies from TARI to KOMO prior to the airstrip opening.  
Slept IDANI R/H.

Sunday 30th August.

Departed IDANI for ANCORE garden areas - tents erected - fresh foods for trade - inspection area and rest house site selected - commenced constructing framework of same - routine administration etc.etc.  
Slept ANCORE gardens.

Monday 31st August.

Depart ANCORE for TAGITE rest house - fresh foods for trade - talks - area study survey matter - census revised - 2 disputes - routine admin.  
Slept TAGITE R/H.

Tuesday 1st September.

Total of four disputes dealt with - one further with witnesses Police Constable etc. forwarded TARI for medical examination and possibly Supreme Court - investigation and inspection of vine bridge across TAGARI River believed cut down by these people - constructed by previous patrol to allow easy access to TARI. Depart TAGITE for LAITE - fresh foods for trade - prelim. talks etc - routine administration.  
Slept LAITE R/H.

Wednesday 2nd September.

Talks and revision of census at LAITE - various numerous disputes of a minor nature brought forward - fresh foods etc. - books counted - arrival mail late afternoon.

Slept LAITE R/H.

Thursday 3rd September.

I C.N.M. heard - 5 IHL detainees, police constable and interpreter forwarded KOMO - departed for LAJAUKO thence HANDAMANDA - fresh foods for trade - prelim. talks - enquiries - nil disputes.  
Slept HANDAMANDA R/H.

Friday 4th September.

Talks on various matters - revised census - area study survey - road/bridge survey for KOMO/TARI road.

Slept HANDAMANDA R/H.

Saturday 5th September.

Depart HANDAMANDA for new rest house marked out last patrol - JAGWA - track excellent - rest house well constructed - talks - fresh foods for trade - revised census - supervision minor amendments to rest house - election held for village constable - one dispute - routine admin.  
Slept JAGWA R/H.

Sunday 6th September.

Depart JAGWA for KURU - inspected JULUBARI garden area for one wanted male, unsuccessful - continued on to KURU via another track arriving KURU late afternoon in heavy rain - this now makes five different tracks walked to reach this rest house and all atrocious. Fresh foods.  
Slept KURU R/H.

Monday 7th September.

Typed letters and dispatched KOMO for posting. Talks - census revised minor disputes - I CNM - fresh foods - routine administration - books counted - three new toilets constructed for rest house barracks etc  
Slept KURU R/H.

Tuesday 8th September.

Depart KURU for JULUBARU garden area thence via track following TAGARI River flats - this track giving access to wild game to the extent of 1 duck, 1 pigeon, 2 large and three small pigs shot, without having to actually leave the track. Arrived HANDAMANDA late afternoon in heavy rain - decided not to continue on to LAIJAUKO. Slept HANDAMANDA R/H.

Wednesday 9th September.

Depart HANDAMANDA for LAIJAUKO - various talks - fresh foods for trade - revised census - area survey - number of minor disputes none requiring C.N.M. action - routine administration. Slept LAIJAUKO R/H.

Thursday 10th September.

One dispute heard - departed for LAITE thence PARA - track excellent except for PARA section - fresh foods for trade - strong talks given assembled people - remainder of day all PARA's cleaning all tracks etc.etc. - routine administration - books counted. Slept PARA R/H.

Friday 11th September.

Census revised at PARA - talks - area survey - fresh foods - various disputes 3 only requiring C.N.M. - routine admin. etc etc. Slept PARA R/H.

Saturday 12th September.

Depart PARA for AIJAGATE R/H. - talks - census revised of both PELA and WARABIA2 groups - fresh foods for trade - further talks - area survey - minor disputes - routine administration. Slept AIJAGATE R/H.

Sunday 13th September.

Semi observed - books counted - two assault cases requiring medical treatment brought in - investigated and adjourned - fresh foods for trade - routine administration. Slept AIJAGATE R/H.

Monday 14th September.

2 C.N.M.'s at AIJAGATE - depart for TAWANDA - rest house repairs carried out - fresh foods for trade - talks - revised census - area survey - numerous minor disputes/enquiries - routine administration. Slept TAWANDA R/H.

Tuesday 15th September.

Depart TAWANDA after 1 CNM for KOMO via TERJAGA : POROYANDALE and YANDALE - total 6 hours.



SUBJECT: Komo Patrol 3 of 1964/65.

Attached please find one copy of a report on the above patrol conducted by Mr. W.C. McQuilty Cadet Patrol Officer together with copy of covering memorandum, P.R. 3/64-65 of 21st April, 1965, from Assistant District Commissioner TARI.

2. Some comments follow:

- (i) At this juncture I do not intend recommending the establishment of a Local Government Council for the Komo Administrative Area. At the present time District efforts are being concentrated in those areas which offer the greatest economic potential and in which Councils could be established with reasonable chances of becoming financially independent units in the not too distant future. These prerequisites do not exist in the Komo Administrative Area which will be a marginal area even when fully developed.
- (ii) The Department of Agriculture, Stock and Fisheries Field Day held to demonstrate selection and planting of sweet potato and preparation of gardens together with the anti yaws campaign indicate the area is not being neglected. Additionally the TARI road network is being extended to the Komo area.
- (iii) The District Inspector advises that present Education policy is to consolidate and expand existing schools not to establish new schools. Until this policy is changed there appears little possibility of a school for Komo.

3. Mr. McQuilty conducted a useful patrol and has submitted a good report.

Kew Patrol Report No. 1 of 1964/65

Forwarded herewith is a report of a patrol conducted by Mr. H. G. McQuillty, Chief Patrol Officer, which covered the whole of the area administered from Kew Patrol Post.

There were two main objects of the patrol - firstly to accompany the Medical Assistant Mr. J. Harvey who conducted a health survey and anti-junun campaign in the area, and secondly to enable Mr. McQuillty to become familiar with the area administered from Kew.

As a result of reports by the previous O.I.C. Mr. D.J. Crowley of an abnormally high death rate and poor methods of cultivation of subsistence crops - this latter confirmed by an Agricultural Officer, the Department of Health were requested to patrol the area and ascertain whether the high death rate was allied with nutritional disease. I have read the report of the patrol by the Medical Assistant who states that nutritional disease is present. I understand that Health have posted a more capable and experienced medical orderly to Kew and propose to visit the station at regular intervals. The long range plan is for the establishment of a Rural Health Centre.

The patrol was of a routine nature with the emphasis on national work and calls for little comment. The following is submitted for your consideration.

Political Situation. Little can be said about this. I feel that the people would accept area administration. They have seen a little of the neighbouring Tari Council. The cash income in the area is so small that they could afford to pay only a very small tax and such a council would have to be subsidised. In addition it would be necessary to post a more experienced officer to Kew before introducing area administration. (Refer also my comments on Kew Patrol Report No. 2 of 1964/65).

Agriculture. Since the completion of this patrol, the District Agricultural Officer visited the area and conducted a field day which was attended by nearly all Village Constables in the area and a few other people. Sweet potato was planted in a specially prepared garden and methods of selecting runners and planting were carefully explained to the assembly.

The people commented that their own sweet potato runners were not good and that the imported runners, if they bore well, would prove little. For this reason Mr. McQuillty was instructed to plant several mounds with selected runners from local gardens. The District Agricultural Officer expressed the opinion that if the runners were properly selected and planted, the quality and yield should be satisfactory, but probably not as good as the imported planted material.

There is no doubt that good quality sweet potato can be produced in the area. This is done by the members of the Police Department, who trade sweet potato for pigs with the locals.

There is virtually no cash cropping in the area. I favour the establishment of a trial coffee plot near the station, preferably on land belonging to a man of some influence in the area.

Education. There are no schools in the whole of the area. I should like to see a school established at the station in 1955. There are sufficient people living within a short distance of the station to ensure that pupils of the right age would be available. Perhaps this matter could be taken up with the District Inspector, Department of Education.

Roads and Bridges.

It appears from Mr. McQuilty's investigations that quite a good route exists for the construction of a road from the Tordi side to link up with the road from Kano. This is confirmed by my own discussions with various people in the Tolabi area. These people seem quite keen on the road too, and I understand that it will open up a lot of good grazing land.

Mr. McQuilty has conducted quite a useful patrol and submitted a good report. He has settled down at Kano quite well, and on my last visit informed me that he would like to return there after leave. He is due to proceed on leave on 26th May, 1957.

KOMO Patrol Report No. 3-64/65:

INTRODUCTION:

The main objects of this patrol were to escort the TARI European Medical Assistant, Mr.J.Harvey, on a Health Patrol, familiarise self with the road work in the KOMO Administration Area, especially the TARI-KOMO road and to familiarise self with the KOMO people and Administration area. General administration was also carried out.

For further comments concerning the above object, please refer to the relevant sub-headings in the text of this report.

For comments on climate, topography, vegetation and other geographical aspects of the KOMO Administration area please refer to KOMO Patrol Report No. 2-64/65 and the area study therein. These aspects are well covered in the area study so it would be of no further value to cover them again in this report.

RECEPTION OF PATROL:

The Patrol was well received at all Rest Houses. There were no hostile or unliked incidents during the patrol. The people of the KOMO area have come to realise fully the objects of the Administration. This can be seen in the way the people are prepared to leave their old methods of planting sweet potatoe and take on a new and better method ( please refer to MENDI D.A.S.P. Patrol No. 6-64/65), bring their complaints, disputes and differences to the Government Officer at KOMO Patrol Post, etc..

VILLAGES:

Housing in the KOMO area is the usual Highlands type of low, squat house. with separate houses for men and women. These houses are usually of good standard because of the necessity to keep the rain out and any warmth in.

The houses are not combined in villages but in hamlets scattered amongst their gardens and bush.

Water supply is no problem.

VILLAGE OFFICIALS:

There are no recommendation for appointments or terminations of any of the Village Constables.

The Village Constables are of good quality, on the average, considering that KOMO has no very influencial leaders.

POLITICAL SITUATION:

There are no movements, organisations or cults in the KONO area.

There are very few mission establishments in the KONO area but what there are seem to have very little influence on the people except maybe the odd one or two living immediately adjacent to the establishments. All mission establishments at the moment are only staffed with local natives (TARI Huris).

AGRICULTURE:

There is no cash cropping in the KONO area although the groups nearest to KONO station do sell sweet potatoes to the Administration for station police and labourers.

The native foods grown in the area are sweet potato, edible pit pit, bananas, with some taro and Pandanus Nuts.

The introduced vegetables are pumpkins, the most widely grown, corn, tomatoes, spring onions, and even one or two lots of peanuts close to KONO station.

In conjunction with the following remarks please refer to the relevant section in KONO Patrol Report No. 5-62/63 and to MMPI P.A.S.P. Patrol No. 6-64/65.

The sweet potato bought on patrol for the carriers was from fair to poor quality but on only one occasion was the quantity insufficient.

From my own observation of the methods used and from discussions with the highlands police on KONO I have come to the conclusion that the following are the faults in the methods used:

i: Drainage: The people do not build drains around their gardens therefore not lowering the watertable and not allowing the excess water to drain away. The few who do do not maintain the drains and therefore the drains are soon in such a condition that they might as well not been built in the first place. The result of this being water logged gardens.

ii:Mounds: All mounds are very poorly constructed. Some are built by simply turning over the topsoil. This gives a mound of about 2-3" in height of very poorly worked soil. In other areas the soil is dug deeper with the result of a higher mound of about 6" and here again the soil is not worked well. These two types of mounds allow for water logging.

iii:Methods of Planting: There is no system or method of planting. When the sweet potato has been dug the old runners are used again for planting. They are not planted but stuck into the ground in any way at all.

iv:Planting Materials: As stated in the above para., planting material is not selected but the same old runners are used year after year.

v:Fallowing and Rotation: There is no system of fallowing or rotation practised. A garden is dug on a piece of land and after a varying period the garden is just left and forgotten about until it may be used again in the unknown future.

AGRICULTURE: (continued)

To rectify these faults it needs an extensive agricultural extension program to teach the people how to drain their gardens, build higher mounds out of well worked soil, how to select choice sweet potato planting material, how to plant this material correctly, how long to leave a garden lie fallow and how to plant casurinas trees on the fallowing gardens.

This program has been started by building a sweet potato plot on KOMO station. It is expected that within the next few weeks an agricultural officer will visit KOMO, give a talk to the assembled Village Constables and show them the correct method of planting using introduced sweet potato probably from the Eastern or Western Highlands Districts.

Report No. 3. It is then proposed that all Village Constables build along the same lines. When the Village Constables' gardens are well on the way to being established it is hoped that the other people in the groups will now follow suit and will use the Village Constable's garden as a pro-forma and build there own gardens in the same way.

The program cannot stop here but must be followed up by future officers because it is going to take years for the people to get the right technique for fallowing land.

The introduction of cash crops are not recommended at the present although an experimental coffee plot will be started in the near future to see how it will grow in this area. After the people have grasped the correct method of growing sweet potato then it will be the time to introduce cash crops.

As can be seen from the comments in para's. 2 and 3 under this heading there is not a great variety of vegetables grown. It is hoped in the very near future to introduce more European vegetables plus such things as pineapples and paw paw.

LIVESTOCK:

The only livestock in the KOMO area is the native pig. These are highly valued because it is their only source of protein and is also of great wealth used for Bride Price, etc..

When the agricultural officer next visits KOMO he will be approached on the subject of introducing poultry in this area.

FORESTS:

Approximately two thirds of the KOMO Administration area is covered with virgin forest. To my inexperienced eye most of the trees are softwood with maybe one or two varieties of semi hardwoods. One species that stands out from the others is Hoop Pine. This can be found over most of the area but a fairly substantial stand was seen straddling the TAGARI River along the proposed TARI-KOMO road route. This could be cut into flitches and when the road is finished taken to TARI for ripping and cutting into timber.

At the present there are no sawmills or pitsaws operating in this area.

COMPLAINTS AND COURTS:

There were very few complaints made to the patrol. All that were brought forward were settled with what seemed satisfaction to all parties concerned.

There were no Court for Native Matters necessary during the patrol and therefore none were sent to TARI for hearing.

REST HOUSES:

Please refer to the map accompanying KOMO Patrol Report No. 2-64/65 for a list of KOMO Rest Houses.

All Rest Houses were in a good state of repair but some were very small. The necessary instructions were given to the Village Constables to build bigger ones next time the Rest Houses need renewing.

For walking times between Rest Houses please refer to the attached diary.

CARRIERS:

A permanent line of 48 carriers accompanied the patrol for the entire period. These carriers were recruited from the groups bordering onto the station. There was no difficulty in recruiting.

During the patrol there were two long walks, one of 9½ hours and the other 10½ hours. During these walks there were no complaints. These carriers will carry for as long as it is physically possible if the necessity ever arises.

HEALTH:

Mr.J.Harvey, the TARI European Medical Assistant, and an Aid Post Orderly accompanied the patrol. A general health patrol was carried out. The men, women and children were examined by Mr.J.Harvey. Blood slides were also taken for examination after the patrol. Everyone also received a Penicillin injection in an Anti Yaws campaign. All persons for hospitalisation were sent to KOMO to be evacuation to the TARI General Hospital or the Hansenide Colony at HOIERIA near TARI.

There is little value if I make comments on the health in this area as this will be covered well in the patrol report by Mr.J.Harvey E.M.A. therefore for a professional view on the health of the people of the KOMO area please refer to the relevant P.H.D. TARI Patrol Report (the number not known ).

EDUCATION:

There are no Government or mission schools in the KOMO Administration area.

During the patrol I was approached by the Village Constables from PADUA and YANDALE asking for a Primary 'T' school to be established at KOMO station. This request is strongly recommended. The PADUA Rest House.....

EDUCATION: (continued)

.....is 45 minutes and the YANDALE Rest House is 20 minutes walk from the KONO station. At the 1964 census revision PADUA had 57 males and 58 females in the 6-15 years age group. At the same census revision YANDALE had 71 males and 58 females in the same age group. With the full support of the Village Constables concerned and the cooperation of the parents there would be an attendance of 50% or more giving an attendance of 100 or more.

This is a genuine desire to have a school. This has probably been brought on by KONO people visiting TARI and hearing of the TARI people who have been to school and are now employed as Aid Post Orderlies, Native Medical Orderlies, Policemen and also in the Pacific Islands Regiment.

ROADS AND BRIDGES:

At the present moment there are two roads under construction. The TARI-KONO road and a loop road from KONO going through PADUA, EGAWI and TIUNTE Rest Houses. This road will be continued and will eventually come back to KONO via IANDA, ENITALLI and MIGILLI Rest Houses.

The most important road is the TARI-KONO link road. For details of the route of this road please refer to the map attached to KONO patrol report No. 2-64/65. This road has been pegged to the TAGARI River below the HAMANDAMA Rest House. Bridging the TAGARI River will be no problem. At the bridge sight the river runs through a gorge leaving a bridge span of 30-35 feet. This can be quite easily bridged with timbers.

As per verbal instructions from the Assistant District Commissioner, TARI, an attempt was to peg the road from the bridge sight to join up with the road in the TARI area. Approximately 2 miles of this still remains unpegged because most of this is covered with thick bush and would have taken 4 to 5 days to do, the patrol rations would not allow this. However the Local Government Councillors from TELABO and HIWANDA (TARI area) seemed confident that they know where the best route could go so they were told to cut a path along this route and an officer at a later date can confirm, or otherwise this route. While they are waiting for the confirmation they can be working on the section of the road that is pegged.

MISSIONS:

There are three denominations of missions in the KONO area; Roman Catholic, Unavangelised Field Mission and Seventh Day Adventist. At the moment all of these missions are staffed with local natives. The U.F.M. station at MINDIETE is usually staffed with a European and his wife but is now on extended leave in Australia. None of these establishments run a school.

CONCLUSION:

At the conclusion of the patrol all the objectives had been fulfilled except one (see comments under Roads and Bridges).

This patrol has familiarised myself with the area and people and will give me something to work on in the future.



Abovementioned report together with comments of Assistant District Commissioner, Tari, is forwarded herewith for your information, please.

The people of this area appear to be much more stable than previously. Although the total population shows a decrease of one since the last census, births exceed deaths by 16 and the decrease would be accounted for by the migration out of approximately 50 people. There is a slight natural increase of population as against a decrease shown by the previous census.

At present there is little prospect for economic development for these people. The immediate need is for an improvement in the existing methods of subsistence agriculture, and although a start has been made on this it will take time to change the traditional methods.


There are scattered stands of pine right throughout the Tari and Komo areas. Because of their isolation, the economic importance of these stands is virtually nil apart from local usage.

The TARI/KOMO Road when completed will give the area access to a DC-3 airstrip and will permit the carriage of bulky cargo into the station.

The establishment of an Administration School at KOMO has been discussed with the District Inspector. There is no likelihood of a school being established at KOMO for some time.

I do not agree with Mr Wright's remarks on extending the existing aerodrome. A great deal of work is required and this is not warranted at present. An access road to TARI would be more useful.

At present there is little prospect of advancement for these people. The return of the Un evangelised Fields Missionary could possibly help with health and education to a small extent. These folk are a somewhat backward group living in an isolated area which is not particularly good land agriculturally.

FOREST SURVEY - KOMO PATROL POST AREA  
RECOMMENDATION FOR FOREST PLANTING.

I have studied the Patrol Report with interest and am returning it with this memorandum.

The information re the timber stand in the Taguri River catchment programme under consideration in the Southern Highlands. However, we are interested in the establishment of species trials throughout a wide range of altitudes and soil types in the Southern Highlands so that action can be taken at any time to meet future timber needs.

Approximately 13 sites have been selected and in co-operation with officers of your Department, the Department of Agriculture and Education, and various Missions, plots of species considered suitable are being established.

As you will be aware, one of the main problems of commercial forest plantations is their access to a suitable market. At the moment, I cannot forecast any appreciable plantings being undertaken by this Department in the Southern Highlands.





KONO Patrol Report No.4/64-5.

INTRODUCTION:

This patrol covered the whole area administered from KONO Patrol Post. The boundaries of the area are formed by the HANINU and TAGARI Rivers and KARIUS Range. The KARIUS Range and HANINU River diverge in the N.W. the HANINU River then runs into the TAGARI River which converges with the KARIUS Range in the S.E. The N.W. and S.E. corners of the KONO Area are for all practical purposes uninhabited.

The majority of the population lives in the central section, with the larger proportion of these living in the vicinity of the MANANDA BASIN.

The population is located between 3500' ASL and 5500' ASL. The Patrol Post is 4800' ASL.

The area is still in the initial stages of development, the Patrol Post being established in 1961. Since this date extensive patrolling has been done throughout the area. The people have now accepted the Administration and realise fully its objects.

DIARY:

A diary is attached. Field Officers Journal folios nos. 17-20, 1-2, paros. 105-126, 1-13 also refer.

NATIVE SITUATION:

The patrol was received cordially throughout. No difficulties were experienced in buying from the food required to feed the patrol carrier line, large quantities being made readily available.

The population throughout the area at the moment is in a state of flux. Because of the fighting which took place throughout the area prior to the establishment of administration control many groups ~~which~~ broke and became scattered. Now with the Administration firmly established and fighting eliminated, these people are now moving back to their areas of domicile. The migration figures which are high at the moment will probably remain on this level until the people are resettled. This I feel shows complete confidence in the Administration's ability to maintain law and order.

REST HOUSES:

Rest houses throughout the area are of reasonable quality. Instructions were given for several of these to be repaired or rebuilt in the near future. Several of the 28 rest houses in the area will probably be eliminated as some large groups are contemplating moving (See Native Situation). This will allow several groups to be administered from the one rest house.

VILLAGE OFFICIALS:

One recommendation for dismissal is being forwarded under separate cover.

Except for several cases the standard of Village Officials throughout the area is not particularly high.

ROADS AND BRIDGES:

ROADS/ One of the purposes of this patrol was to inspect previously completed and those under construction at the moment. The most important of these being, the one under construction to complete a road link between KONO and TANI. With only one OTTER aircraft

in service at the moment, air transport for items too large to be carried in CESSNA aircraft is almost impossible to obtain and entails a wait of as much as 6 months.

It can be seen therefore, that the completion of the road is imperative if any permanent buildings are to be constructed on KOMO Patrol Post. The road will also facilitate transfer of rations, ex MADANG, from TARI to KOMO.

The KOMO section of the TARI - KOMO road, from KOMO Patrol Post to the TAGARI River, is now nearing completion. Some 6 miles remain to be completed. This consists of a 5 mile section from the TAGARI River to LALTE R/H and a 1 mile section near TEREJAGA R/H.  $\frac{1}{2}$  miles of this last named section descends and ascends to and from the TIMARIA River between TEREJAGA and ALJAGATE R/H's.

The bridging of the TIMARIA and TAGARI Rivers represents the only two major bridges on this section of the road.

I anticipate that I will spend at least one week per month on patrol supervising work on this road.

Work is in hand at the moment to mark the route of a proposed road linking PADUA - PAMI - KUNGU R/H's to the main road at a point between YANDALE and EKAIBA R/H's. This will mean that the only Rest House in the immediate vicinity of the MANANDA BASIN not linked by road will be MINDLETE R/H.

A map of the existing and proposed roads within the area is included in the patrol map appended.

#### LAW AND ORDER:

During the patrol many minor complaints, mainly dealing with pig payments in relation to bride price, were heard and settled.

Three C.H.M. cases, arising out of complaints laid during the patrol, were heard. These were two under Reg. 71(1), one under Reg. 101(a).

In general the people throughout the area are law abiding. The average prison at KOMO is rarely above 6 persons.

#### NATIVE AGRICULTURE:

The people of this area are staunch individualists. This individualism is highlighted in their gardening methods. Men, women and children (over the age of about 8) have their own gardens and neither takes food from the/e/ the other without prior permission. This applies to families also.

The main staple of the area is KAU KAU. The people use the Highland method of mound gardening, though they do it poorly.

The gardening mounds consist mainly of just the top soil with no real effort to work the soil. The mounds are in general no higher than about 6" with little or no effort made towards drainage. When a mound is harvested earth is usually just heaped on top of the old mound which is then replanted. The resultant crop of KAU KAU is of very poor quality with tubers averaging about 6" in length and 2" in diameter.

A trial KAU KAU plot has been established on the station using both local and imported runners. When these are ready for harvesting it will be done publicly so that the locals can see what kind of KAU KAU can be grown using improved methods.

A couple of months prior to this patrol an Agriculture Assistant toured the area to show the people how to plant KAU KAU using the improved mounds. During this patrol enquiries were made to ascertain what had been achieved by this visit.

My findings were;

1. In most groups several young men have made gardens using the new method.

2. The older men appear to be waiting to see the results. From discussions with them the impression was that if results were good they would try the new method.

3. The women show no interest and wish to stick to the traditional method whatever the results.

Apart from KAU KAU the most important staple is PIT PIT. TOMATOES, CORN and PUMPKIN are also grown in fair quantities throughout the area.

#### COMMERCIAL AGRICULTURE:

There appears, for the moment at least, little opportunity for any commercial development in the area. Work is underway at the present to establish a trial coffee plot.

During this patrol many good pine trees, KLINKY and HOOP, were noted in the TAGARI RIVER Valley, near the junction of the TAGARI and HANIBE Rivers. The trees though aren't in sufficient quantities to make it a commercial proposition to mill them. Many of the trees growing here are over 100' high with 648' girth. As these trees grow so well reafforestation of the area with pine, as a future commercial venture, would appear practicable.

A survey by both Forestry and the Soil Survey Division of D.A.S.P. would be required to confirm this before anything concrete was done.

I don't think that any difficulty would be experienced in getting the people to agree to this as this area is a breeding ground for malarial mosquitoes. Very few locals live or garden in the area, most of them living on the slopes above the river.

Once again the main obstacle to development is communications. Until the TARI - KONO road is completed no commercial development can be considered economic.

#### HEALTH:

Though the death rate is still fairly high the people in general are amazingly healthy. Except for a couple of cases of leprosy, which had been detected by the recent P.H.D. patrol and which accompanied this patrol to TARI for treatment, no other cases of sickness which could not be treated by the patrol were encountered.

The main sicknesses treated by the patrol were TROPICAL ULCERS, MALARIA and SCABIES in that order.

The Hospital Orderly MEYA who accompanied the patrol showed himself to be both a conscientious and willing worker.

The only health facilities in the area are those provided by the Aid Post on KONO Patrol Post. Any serious cases are sent to TARI by aircraft.

The staff of the Aid Post at the present is one Hospital Orderly namely NEYA who accompanied the patrol. This means that when the Orderly is on patrol the Aid Post has to be left unattended. During my visit to TARI DR.TAURIKA promised an extra orderly to alleviate this unsatisfactory situation. Money is also being sought to rebuild the Aid Post as the present one is in a bad state of disrepair.

It is hoped also to establish an Aid Post near LAITE R/H this would serve all groups west of the TIMARIA River approx. 1500 people. This would help to lower the high death rate of the groups along the TAGARI River, stretching from TAGITE R/H to KUNU R/H.

The population is now on the increase instead of decrease, the main reason for this being the peoples acceptance of the work of P.H.D. The people come quite willingly to the station aid post for treatment.

#### EDUCATION:

There are no education facilities what so ever within the area and even though several letters have been written on this subject, progress has been anything but encouraging.

From the census figures it can be seen that only 5 people are attending schools outside the area.

The people who I feel are suffering most from this lack of education facilities are the children of station personnel. As schools in the TARI Area are overcrowded these children have no prospects of gaining any type of education.

#### MISSIONS:

There are three missions represented in the area CAPUCIN (CATHOLIC), SEVEN DAY ADVENTISTS, UNEVANGELISED FIELDS MISSION. The influence of these missions is only superficial. Apart from the U.P.M. which is staffed by Europeans with a wife and two children the missions are staffed by natives. The CAPUCIN and S.D.A. missions get irregular visits from Europeans from the TARI and KOMOBA Sub Districts.

None of these missions have made any effort to provide schools.

#### AIRFIELDS:

The Patrol Post has the only airstrip in the area, this is a "c" class strip 2,600' long by 200' wide. Very little trouble would be required to extend the runway another 4-600' to bring this strip up to a "b" standard strip. The strip is a one way strip only.

Because of the tail wind for takeoff which blows constantly here and the 1;35 climb required, to get over rising ground off the end of the strip, a weight restriction for takeoff would be required. This would not matter greatly as very little cargo comes out of KONO, most of it comes in.

As it will be at least 12 months before traffic will be able to use the KONO - TARI Road and the airstrip extension would take 6 months at the most to complete, this I feel is a practical and economic proposition.

This extension would allow Piaggio aircraft to use the strip enabling bulky items too large for Cessnas to be flown

At present these materials can only be brought in boxes which, with only one working in the Territory, requires waiting 6 - 9 months for use of same.

I have discussed this matter with several pilots and they agree that this is a feasible proposition on the condition that a takeoff weight restriction is imposed.

GENERAL:

The most significant thing brought out by this census is the fact that instead of a population decrease of 1.37% the population is now increasing by 0.356%. Both the death rate and birth rate have dropped by 2.587% and 0.861% respectively.

Number of persons working inside and outside the District has increased by 28%.


POLICE:
