Before attaining is present post, he was Ambassador of Mexico to the United States, and Secretary of International Affairs of the Institutional Revolutionary Party (PRI). He is also a specialist on international law, and was often a member of Mexican delegations to United Nations' conferences, attending the U.N. Conference on the Law of the Sea and the Vienna Conference on the Law of Treaties. Since 1967, Sepulveda has been Professor of International Law and of International Organizations at El Colegio de Mexico.
