Unfortunately for us taxpayers, Congress recently passed legislation which will make matters even worse.

In October 1986, they gave amnesty to all illegals who were clever enough to avoid deportation for at least 5 years. As a result, the flood of illegals is now higher than ever before.

Clearly, the Amnesty Law will only promote and condone illegal alien activity. A "quick fix", short-sighted solution.
