Mr. D. Hunt is boosting the S. P. cut off. He has put six or eight weeks of his time in this proposition at his own expense. He is doing a wonderful work.

The main people who are promoting this short out, which cuts off one hundred miles across the continent, are W. P. Cloment. President of the Casa Grando Valley Bank of Casa Grando, Arizona, also W. C. Smith; County Engineer of Pinal County. They have spent thousands of dollars building a road from Casa Grande via Maricopa to Gila Bend, a distance of sixty or seventy miles, mestly by private subscription. It follows the Southern Pacific the ontire distance.

We are vitally interested in this short out. San Diego subscribed nearly \$1600.00 The Clearing House Banks of this city gave \$500.00. I think it is very important to help out on this proposition. Before doing so I would write, if I were you, to Mr. Clement or to Mr. Smith, the County Engineer of Pinal County. But better still, a committee from Imperial Velley should go up there and look it over and see that they are attempting to do and what they are doing and then make up their minds what they should do. As a personal favor to me I wish you would invite one person from El Contro, one from Calexico, one from Imperial, and possibly one from Brawley. I will have a committee of prominent citizens meet you at Gila Bend and show you over the work and what they are intending to do. Let me know if you can arrange this.

It is absolutely necessary that this letter be kopt personal and no publicity given as Phoenix would be wild end for the first time Phoenix is showing a little more friendliness toward San Diego.

Your letter of the 24th inst received, and am taking it up with Mr. Shaw and Travers, and also one in each one of the other towns to see if they cannot get out and quietly raise at lease \$1000 from the Imperial Valley which we hope to be able to send to Mr. Clements by the first of January.

Have noticed the meetings of the parties concerned on the Phoenix and Los Route, and have formed the same conclusion as you, concerning the work. As a matter of information, would appreciate knowing what has become of the Ajo cut off from Tuscon to Yuma, as it was talked of two years ago. Has this been abandoned or are they still working on the same. A number of people I have spoken to have asked me this question and I have been unable to get any satisfactory information.

My dear Mr. Blanchard:

Answering yours of the 28th. I do think it imperative that you send at least \$1,000 to help them out. They are thoroughly responsible men, are carrying a heavy load on their shoulders, and by private subscription or at the expense of Pinal County they have just completed a cracker-jack road covering 35 miles from Casa Grande to Maricopa, and it is the 38 miles in another county for which this money is being raised.

Regarding the Ajo cut off - that is killed. The Copper Co. killed it by refusing to build to the Yuma County line with the result that Yuma County would not build its 25 miles to the Pinal County line for Stoval. However, the rathroad is four miles shorter from Yuma to Tucson following the railroad than to go by way of Ajo, and we are accomplishing the same purpose when we help to complete this S. P. cut off. It also eliminates all grades not to exceed a 2% grade on the way from Yuma to Tucson via Gila Bend and Cusa Grande. Then again it is better to have the route follow the railroad because people travelling East and West feel safer to be nearer a road. There is no danger to life, and it is along the Line of least rosistance.
